

Para-wise comments on behalf of the Respondent No. 1, 2, 3 & 4. Respectfully Sheweth:

# PRELIMINARY OBJECTIONS

- 1. That the Appellant has got no locus standi to file the instant appeal.
- 2. That the appeal is wrong and based on illegal and unlawful presumptions.
- 3. That the Appellant is estopped by his own conduct to file the instant appeal.
- 4. That the appeal is not maintainable in present form.
- 5. That the appeal is time barred.

# FACTS

- 1. Correct to the extent that Appellant was appointed as Veterinary Officer (BPS-17) in the Directorate of Livestock & Dairy Development, Khyber Pakhtunkhwa on 19-02-1987.
- Correct to the extent that Appellant was promoted to the post of BPS-18 on 23-12-2009 and was further promoted to BPS-19 on 23-01-2018 as per rules. (Annexure-A)
- 3. Correct to the extent that Seniority list of the BPS-19 Officers were notified on 25-08-2021, wherein the Appellant was at serial No. 04. Three senior most officers on the top of the list were promoted after the notification of seniority list, therefore, the claim of Appellant is wrong and baseless that they had been promoted prior to the notification of seniority list. (Annexure-B)
- 4. Correct to the extent that Respondent No. 4 issued directions to all the Administrative Secretaries on 17-01-2022 regarding the submission of working papers for promotion of eligible officers for placement before the PSB meeting, wherein the cutoff date was fixed as 18-02-2022 and the date for PSB meeting was communicated to be held in 1<sup>st</sup> week of March, 2022 (Annexure-C). However, later on the date for submission of working papers was further extended to 10-03-2022 (Annexure-D) and the new date for PSB meeting was scheduled on 6<sup>th</sup> & 7<sup>th</sup>, April 2022. (Annexure-E)
- 5. Correct to the extent that case of the Appellant along with others for promotion was forwarded by the Department (Respondent No. 2) to Provincial Selection Board

(Respondent No. 4) for further necessary action. However, the Appellant was not considered for promotion by the competent board as he was retired from service on 29-03-2022 prior to the Provincial Selection Board meeting, which was held on 6<sup>th</sup> & 7<sup>th</sup> April, 2022. (Annexure-F &G)

6. Correct to the extent that the Appellant has addressed an application to the Chief Secretary, Khyber Pakhtunkhwa, on 11-05-2022 and a copy thereof endorsed to the Secretary Agriculture & Livestock Department and Director General L&DD, for consideration. However, it is obvious from the PSB minutes dated 06-04-2022 that the Appellant was not considered for promotion as he was retired from service on 29-03-2022.

### GROUNDS

- A. Incorrect. The Appellant has been dealt with in accordance with law and rules. The PSB meeting was held on 6<sup>th</sup> & 7<sup>th</sup> April, 2022, wherein the Appellant was not in service due to his retirement from service on 29<sup>th</sup> March, 2022. Therefore, he was not considered by the PSB as per rules.
- B. Incorrect. As stated above that the Appellant was not considered being retired from service prior to the PSB meeting. Furthermore, the rest of the candidates in the panel were promoted by the PSB as per rules.
- C. Incorrect. The Respondent No. 4 had initially scheduled the meeting in first week of March but when it was noticed that a lot of working papers from several departments were still awaited for placement before the PSB even after the cutoff date of working paper submission, the last date for submission of working papers was extended to 10-03-2022. Moreover, all the senior most officers in the panel, serving in the department were promoted to BPS-20.
- D. Incorrect. The Appellant has been treated in accordance with the APT Rules, 1989 and relevant FR rules. Furthermore, every case has its own nature and merits and the preferred judgments seem to be not in line with the instant case.
- E. The Appellant was bound to perform his duty in accordance with the terms and conditions of his job. The Appellant's rights have not been violated, and he has been treated under the rules and regulations.
- F. Incorrect. The Respondent No. 4 is authorized to fix the meeting of PSB on any convenient date in best public interest. The meeting of PSB was delayed for the reason that more civil servants could be extended the benefit of promotion to higher scales.
- G. Incorrect. The previous PSB took place in 02-12-2021, wherein two senior most officers of Livestock (Extension) Directorate were promoted from BPS-19 to BPS-20 (Annexure-H). However, one of the officers Dr. Rafi Ullah was given promotion on

notional bases w.e.f. 12-11-2021 (date of his retirement) on 09-12-2021 (Annexure-I). The stance of Appellant that 4 posts were vacant since long is baseless as the next PSB took place on 6th & 7<sup>th</sup> April, 2022 (after 4 months), however, the Appellant was not in service at that time.

- H. The Respondents has acted in accordance with law & rules. The Appellant has been treated in light of the guidelines and directives, issued by the Respondent No.4.
- I. The Respondents may be allowed to place additional grounds/ documents during the course of proceedings.

Keeping in view the above submissions, it is, therefore, humbly prayed that the instant appeal may be dismissed, please.
