APPLICATION FOR RESTRAINING THE RESPONDENTS FROM MAKING PROMOTION TO THE POST OF KANUNGO ON THE BASIS OF DISPUTED SENIORITY TILL THE DISPOSAL OF MAIN APPEAL.

RESPECTFULLY SHEWETH:

- 1. That the appellant has filed an appeal against the seniority list of Patwari which is fixed on 28/03/2023.
- 1. That the appellant has a good prima facie case and all the ingredients are in favour of the appellant.
- 2. That the few posts of Kanungo are lying vacant in the respondent Department and the respondent department prepared working paper for filling said post on the basis of impugned seniority list.
- 3. That the impugned seniority list on the basis of which the respondent department prepared working paper for filling said post is already challenge in this Hon'able Tribunal. Copt of letter is attached.
- 4. That an application has been filed for seeking interim relief among others for appellant till final outcome of the appeal. Obviously, when the dispute about seniority list is has been admitted for regular hearing, therefore it seems just to direct the respondents in case the appellant succeeded in getting his right of seniority in accordance with law then as per Establishment Department Regulation Wing Notification No.SO(Policy)/E&AD/1-16/2017 dated 05-12-2017 amendments in the Khyber Pakhtunkhwa promotion policy, 2009. After sub-para(h) of para IV the following sub-para(i) shall be inserted:

The mere fact that the seniority is sub-juiced will not debar the competent forum to make recommendation. However, in such cases following shall be applicable:

- i. All promotion based on sub-judice seniority will be conditional i.e. subject to final outcome of court cases.
- ii. An officer who gets his seniority restored and becomes senior to already promoted officers in the cadre will be considered for promotion by the relevant board from the date when his junior got promoted.
- iii. In case, the officer expired or retires from service and subsequently, his seniority is restored his case will be considered from proforma promotion along with all financial benefits.
- iv. Juniors promoted on sub-judiced seniority list will be assigned seniority as per final court orders and will be reverted in case there is no vacancy.
- 5. That if the interim injunction was not granted and department will not be restrained from making promotion in this case the appellant will suffer an irreparable loss and will lead to implicitly of litigation.

It is, therefore, most humbly prayed that on acceptance of this application, an interim injunction may kindly be granted to the effect that the respondent be restrained from making promotion against the vacant post of kanungo or make conditional promotion in the respondent department on the basis of impugned seniority list and maintain status quo till final disposal of the main appeal. Any other remedy with this august Tribunal deems fit may also be awarded in favour of appellant.





It may be pointed out that the Patwaris at \$ Nos 1, 2, 3, 4, 5, 6, 8, 10, 14, 15, 17 & 18 in the Seniority list of the year 2022 have either passed partially or not appeared in the Kanango Examination, hence they are not eligible for the said promotion to the post of Girdawar (BPS-11) on A.C.B (seniority list is attached as Amexage-E).

The Patwaris at S. Nos 7, 12, 13 & 16 in the seniority list have already been promoted to the post of Girdawar (BPS-11) on regular basis. However, Patwaris at S. No. 11, 19 & 20 who have also passed Kanungo Examination and fulfills the condition of promotion on A.C.B. It is added that the said Patwaris as mentioned at S. No. 19 & 20 are also working against the post of Kanungo on OPS basis. Furthermore, Kanungo Examination of Mr. Fakher Nawaz mentioned at S. #9 is not declared by DLR Office Peshawar.

The Seniorny List of Patwaris, Synopsis along with original ACRs, Non-involvement Certificates, Kaningo Passed Certificates and Verification Letter from Directorate of Land Records in respect of passed candidates are placed before the DP & SC.
