JUDGMENTHAMID FAROOQ DURRANI, CHAIRMAN:-

1. The appellant was regularized as Female Subject Specialist (BPS-17) on 31.05.2010 by the competent authority. Her grievance is that the seniority list of Female Officers B-17 issued by Elementary & Secondary Education Department, showing seniority of the officers inter-se, as stood on 31.01.2019, did not depict the actual seniority of the appellant. A departmental appeal/representation was submitted against the entry in the impugned list on 03.06.2019 which was not responded to, hence the appeal in hand.

2. Learned counsel for the appellant heard and available record gone through.

3. At the outset, learned counsel was required to show on the list, appended with the memorandum of appeal, the officials being junior to the appellant but placed at a position senior in number to her. Learned counsel could not pinpoint any such officials. Pertinently, the appellant failed to array as private respondents the officials who were purportedly accorded incorrect seniority above the appellant.

4. It is useful to refer to the seniority list impugned by the appellant wherein her name appears at S.No. 516. The date of regular appointment to the post is shown to be 31.05.2010. The entire list, relied upon by the appellant, does not indicate any official regularized to the post after the date of regularization of the appellant, to have been placed as senior to her. The list also depicts that the officers regularized on the same date have been given seniority keeping in view their respective dates of birth. The impugned seniority list, therefore, appears to be in accordance with the provisions of Khyber Pakhtunkhwa Civil Servants Act, 1973 and is not exceptionable.

5. For the foregoing, the appeal in hand does not merit admission for regular hearing and is accordingly dismissed in limine.

File be consigned to the record.

I. That Appellant joined her service as Subject Specialist Teacher in the Elementary & Secondary Education Department Mardan, on contract basis. Her service was regularized vide notification NO. SO (G) E&S/1-85/2009/SS/CONTRACT Dated Peshawar, the 31-05-2010. (Copy of the appointment & regularization notification is Annex "A, B & C")

- II. That the respondent No.03, District Education Officer (Female) Mardan display a seniority list on their official web site, a seniority list of Female Officer BPS-17 Elementary & Secondary Education Department Mardan
- III. That the respondent without informing and notice the appellant, display the seniority list, which came to know to the appellant on 20th of May 2019. (copy of the Seniority list as annexure "D")
- IV. That appellant adversely aggrieved of the aforesaid seniority list of Female Officer BPS-17 Elementary & Secondary Education Department Mardan, she preferred representation/ appeal dated 03-06-2019, which remained un-responded even after laps of 90 days (copy of departmental appeal is annexure-E)
- V. The impugned seniority list is unjustified, illegal, against the principles of natural Justice, ultra vires and the same challenged before this Honourable Tribunal on the following grounds inter alia;

Grounds

1. Because as per the impugned seniority list of Female Officer BPS-17 Elementary & Secondary Education Department Mardan, junior officers are placed senior from the appellant.
2. Because the appellant has not been dealt with according to law and the Khyber Pakhtunkhwa Civil Servant Act 1973.
3. Because the appellants seniority has been adversely affected in the impugned seniority list of Female Officer BPS-17 Elementary & Secondary Education Department Mardan, which is illegal, void abi initio, against the service laws and principles of natural justice.
4. Because the respondents No.03 (District Education Officer) in the impugned seniority list of Female Officer BPS-17 Elementary & Secondary Education Department Mardan, has acted arbitrary manner and against the law.

5. That the respondents No.03 (District Education Officer) has committed glaring illegalities and irregularities on account of impugned seniority list of Female Officer BPS-17 Elementary & Secondary Education Department Mardan.
6. Because placing junior Officers as senior from appellant in the seniority list, the appellant was not afforded a fair opportunity of personal hearing. Thus she was condemned unheard.
7. Because the appellant has an unblemished and clean service record, there is no adverse remarks in my ACR, which affects her seniority.
8. Because due to the impugned/ alleged seniority list of Female Officer BPS-17 Elementary & Secondary Education Department Mardan, a large number of civil servants are adversely affected. Which is against the law.

Prayed

It is, therefore, humbly prayed that impugned the seniority list of Female Officer BPS-17 Elementary & Secondary Education Department Mardan, may kindly be cancelled/ revised as per law and other relief deemed fit may also be graciously granted.

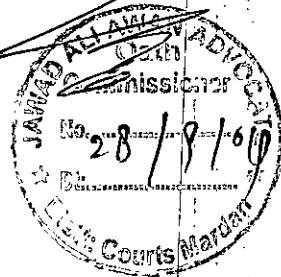

- II. That the Khyber Pakhtunkhwa regularized the services of adhoc or contract employees through the North West Frontier Province Employees (Regularization of Services) Act, 2009.
- III. That consequent upon the said Act, my service was regularized vide notification NO. SO (G) E&S/1-85/2009/SS/CONTRACT Dated Peshawar, the 31-05-2010. (Copy of the notification is Annex "B")
- IV. That the District Education Officer (Female) Mardan display a seniority list on their official web site, a seniority list of Female Officer BPS-17 Elementary & Secondary Education Department Mardan
- V. That on 20th of May 2019, I came to know about the seniority list, and found that I am adversely affected of the aforesaid seniority list of Female Officer BPS-17 Elementary & Secondary Education Department Mardan, On the following amongst many other grounds; inter alia

GROUND:-

1. Because as per the seniority list of Female Officer BPS-17 Elementary & Secondary Education Department Mardan, junior officers are placed senior from me.
2. Because according to Section 8 of Sub-S 4 of the Khyber Pakhtunkhwa Civil Servant Act 1973, seniority of a Civil Servant in a post, service or cadre is to be counted from the date of regular appointment, the said provision of law in a seniority list of Female Officer BPS-17 Elementary & Secondary Education Department Mardan, has been blatantly violated in my case.
3. Because my seniority has been adversely affected in the seniority list of Female Officer BPS-17 Elementary & Secondary Education Department Mardan, which


is illegal, void ab initio, against the service laws and principles of natural justice.




