

Respectfully Sheweth:

Brief Facts grieving rise to the instant Appeal are as under:

- 1. That the Appellant hails from a backward area of District
 Chitral and completed her education through the meager
 resources of her parents with hopes of a bright future.
- 2. That the Appellant applied through Public Service Commission for the post of Secondary School Teacher Female (SST Sc) PBS-16 and after tough competition the Appellant stood successful. Finally the Appellant got a letter of recommendation where the Appellant was recommended to the government for appointment. (Copy of the recommendation is annexure "A").

- 3. That at last the Director Elementary and Secondary Education Khyber Pakhtunkhwa (Respondent No. 4) vide notification dated 28/12/2011 issued the appointment order of the Appellant along with others, hence the Appellant was appointed. (Copy of notification dated 28/12/2011 is annexure "B").
- 4. That the Appellant joined the post and worked from the date of her appointment with punctuality and devotion with full satisfaction of the high-up's as well as taughts.
- 5. That the respondent No. 2 on 13/12/2012 vide letter No. 53758 issued the recommendation of the respondent No. 6 and 7 to the provincial Government and also the recommendation of the Appellant along with one Nilofar Begum was withdrawn declaring it an official mistake. (Copy of letter KPK/PSC/RS-11 53758 is annexure "C").
- That the respondent No. 4 issued the notification dated 17/12/2012 regarding the withdrawal of the notification dated 28/12/2011 on the basis of which the Appellant was appointed. (Copy of notification dated 17/12/2012 is annexure "D").



- 7. That on the basis of the withdrawal order dated 17/12/2012 the respondent No. 5 terminated the services of the Appellant vide order dated 19/12/2012. (Copy of order dated 19/12/2012 is annexure "E").
- 8. That the Appellant want in W.P. No. 3655/2012 before the august Peshawar High Court where the august Court treated the Writ Petition as representation vide order dated 04/01/2013 and directed the appellant to appear before this worthy Tribunal, hence this appeal on the following grounds amongst others, inter alia. (Copy of W.P. No. 3655/2012 and order dated 04/01/2013 is annexure "F").

GROUNDS:

A. That the impugned order dated 17/12/2012 and the recommendation dated 13/12/2012 alongwith notification of termination dated 19/12/2012 are arbitrary, mechanical and based on malafide as well as ulterior motives.



- B. That the petition applied for the post after fulfillment of all the legal requirements and was recommended and appointed against the post on merit.
- C. That the Appellant since the date of her appointment is working against the post and as such valuable rights have accrued to her and should not be punished for wrongs of the other.
- D. That the future of the Appellant has been ruined with the words "official mistake" that too after one year, when a responsible office deals the future of the deserving people in such a casual way it brings nothing but disappointment to the youth of the country, hence this act and conduct needs interference of this august Court.
- E. That the order of withdrawal after the lapse if one year is only to accommodate the nears and dears is without lawful authority and without the rules and regulations heaving no backing of law.
- F. That the impugned orders that is the recommendation, withdrawal order and notification dated 19/12/2012 are



arbitrary, mechanical and without the application of judicial mind to the facts and circumstances of the case.

It is, therefore, humbly prayed that on acceptance of this Appeal the recommendation dated 13/12/2012, notification dated 17/12/2012 and order dated 19/12/2012 may kindly be set aside and notification dated 28/12/2011 may kindly be restored.

OR

Any other relief which this august Court deems appropriate may kindly be awarded to meet the ends of justice.




