This Court could not intervene, in such factual controversy, while writ jurisdiction could only be invoked, if the established right of a person is infringed. No any right of petitioner is taken away by the impugned look-after order, in favour of respondent No.4, therefore, this petition being devoid of merit is disposed of in term that respondents shall fill up the vacant post on regular basis, in accordance with law and rules on the subject, within 60 days.

It is pertinent to mention here that the status of the post of Director, Agricultural Engineering BS-19 was not clear till April, 2021 as the Provincial Government was involved in litigation regarding the age of retirement of Civil Servants and had filed CPLA/Appeal against the judgment of the Peshawar High Court dated 19.02.2020 in Writ Petition No. 5673-P/2019 on account of reinstating of the Khyber Pakhtunkhwa Civil Servants (Amendment) Act, 2019. Therefore, the said vacancy was reserved for the Ex-Director, Agricultural Engineering (now retired from service) vide Government of Khyber Pakhtunkhwa, Agriculture, Livestock and Cooperative Department Notification No. SOE (AD)/20-63/83/Mahmood Jan/Retirement case/462 dated 05.04.2021 (Annexure-A) as per Khyber Pakhtunkhwa-Civil Servants (Amendment) Ordinance, 2021 (Annexure-B).

Furthermore, the Appellant was also involved in a departmental inquiry which was finalized during the month of April, 2021, **(Annexure-C)** while PERs of the Petitioner for the period 19.03.2020 to 31.12.2020 were also pending at his end for which he was already informed by Director, Agricultural Engineering, Khyber Pakhtunkhwa, Tarnab Peshawar vide his office letter No. 4152-64/DAE/Estt: 3/30 dated 12.04.2021**(Annexure-D)** and letter No. 7355-68/DAE/Estt: 3/30 dated 08.06.2021 **(Annexure-E)**.

In view of the above, the promotion case of the appellant was not processed, as the availability of Performance Evaluation Report (PERs) is mandatory for consideration of promotion cases through Provincial Selection Board (PSB). The requisite PERs were received on 09.08.2021 from the Appellant and then the promotion case was processed through Government of Khyber Pakhtunkhwa,

AND WHEREAS the Provincial Assembly is not in session and the Governor of the Province of the Khyber Pakhtunkhwa is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in exercise of the powers conferred by Clause (1) of Article 128 of the Constitution of the Islamic Republic of Pakistan, the Governor of the Khyber Pakhtunkhwa is pleased to make and promulgate the following Ordinance:

Provided that no direction under this sub-section shall be made until the Civil Servant has been informed in writing of the grounds on which it is proposed to make the direction, and has been given a reasonable opportunity of showing cause against the

Explantation .- In this section, the expression "competent authority" means the appointing authority prescribed in rule 4 of the Khyber Pakhtunkhwa Civil Servants Insertion of section 13A of the Khyber Pakhtunkhwa Act No. XVIII of 1973. ---3.
