JUDGMENT

ROZINA REHMAN, MEMBER: The appellant has invoked the jurisdiction of this Tribunal through above titled appeal with the prayer as copied below:

“That on acceptance of this appeal, the respondents may be directed to consider the appellant for confirmation against the post/rank of Sub-Inspector from his due date 17.09.2019 with all back and consequential benefits.”

2. Brief facts of the case are that appellant was appointed as Constable on 07.02.2002. He qualified Public Service Commission examination and was appointed as an ASI in 2010. He was promoted to the rank of Sub Inspector in 2014. He completed all the requisite/mandatory and professional training and

mandatory period for confirmation as SI but fiasco. In support of his claim, reliance was placed on judgments of this Tribunal passed in Service Appeals No. 1021/2015, 1450/2013, 1227/2013 and 462/2018 wherein it was observed that it was the authority to give assignment of the SHO to the concerned official and when the authority failed to give such opportunity, then the role of serving as an independent SHO for one year would have no ground.

5. Conversely, learned AAG submitted that for confirmation in rank of SI, every Sub Inspector was required to fulfill the requisite criteria enshrined in Police Rules 1934 as amended in 2017 coupled with qualifying upper college course. He submitted that the appellant had not fulfilled the requisite criteria, therefore, he was not considered.

6. From the record it is evident that 12 officiating Sub Inspectors were confirmed in the rank of SI w.e.f 17.09.2019 by the Regional Police Officer Mardan on 20.09.2019. Appellant was ignored and his juniors namely Muhammad Kashif, Iftikhar, Muhammad Basheer and others were confirmed in the rank of SI. Feeling aggrieved he filed departmental appeal on 14.10.2019 which was forwarded to the RPO Mardan for further necessary action because the promotion/confirmation of officers in the rank of ASI were dealt within the regions concerned. It is not denied that according to Rule-13.10(2) of police Rules, 1934 no Sub Inspector shall be confirmed in substantial vacancy unless he has been tested for a year of an officiating SI in independent charge of a police station, an independent police post or as Incharge Investigation of a police station or in Counter Terrorism. As per policy guideline No. 1/2013, a pool of suitable officers not below the rank of SI is formed for posting of SHOs at district level by DPO concerned and the officers whose names are placed in


SHO's pool are considered for SHO posting as and when required. Regional Police Officer provided an opportunity to appellant in orderly room held on 26.07.2017 and requested the IGP for repatriation of the appellant to his parent region Mardan for completion of his mandatory period, according to amended rule 13.10(2) Police Rule, 1934 vide letter No. 1020 dated 30.07.2019. Copy of the order was forwarded to DPO Mardan with direction to call explanation from Establishment Clerk of his office for misguidance and posting the officer in an unnotified police post. Explanation was called from Senior Clerk Israr Ali by District Police Officer Mardan on 08.08.2019 which is available on file. Applications in this regard were submitted by the appellant and as per orderly room dated 25.09.2018 his request for posting as I/C police post was sent for proposal. Proposal is also placed on file vide which it was proposed that the appellant may be posted as I/C police post Beroch for completion of his mandatory period. The appellant completed one year period in Elite Force according to Amended Rule 13.10(2) of Police Rules, 1934, whereas he has also to complete one year mandatory period as independent incharge of a police station of a notified police post or as incharge investigation of a police station or in CTD Khyber Pakhtunkhwa. He has also completed the same but the same police post was later on declared as unnotified police post and the appellant was deprived of his confirmation alongwith fellow/colleagues and juniors. Had the relevant authority posted the appellant as an SHO, and had he failed to perform duty despite such posting, then he would have not been found entitled to the relief claimed. Since the omission is on the part of respondents, as such the appellant cannot be deprived of his right to ante-date confirmation as SI w.e.f 17.09.2019 i.e the date on which his colleagues were confirmed.




7. For the reason mentioned above, we allow this appeal and direct the respondents that the appellant be granted ante-date confirmation as SI w.e.f 17.09.2019 i.e the date on which his colleagues were confirmed. Parties are left to bear their own costs. File be consigned to record room.



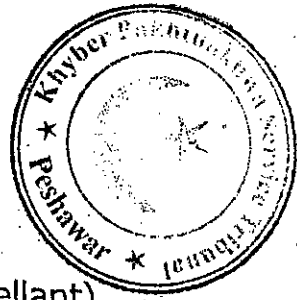

JUDGEMENT: -

Mr. ATTIQ UR REHMAN WAZIR: - Appellant Mr. Nazar Hussain, Inspector Kohat Police has assailed the order dated 27-11-2018, whereby the departmental appeal of the appellant for confirmation and placing his name with colleagues/ batch mates has been rejected.

2. Brief facts of the case are that the appellant initially appointed as ASI on 28-12-2006 and confirmed as ASI on 29-06-2010 from the date of appointment. His name brought on list E and further promoted to officiating basis along with his colleagues dated 24-08-2010. In

meeting held on 06-02-2013, the appellant deferred due to deficiency, while his other colleagues confirmed as SI vide order dated 24-08-2013. The appellant confirmed as SI in subsequent DPC w.e.f. 03-01-2014 instead of 06-02-2013, where his other colleagues were confirmed. That seniority list issued on 29-06-2018, where the appellant placed at Serial No 297, whereas his colleagues are at Serial No 90,91,92 and 93. Appellant filed departmental appeal dated 28-08-2018, rejected on 27-11-2018, hence the instant service appeal with prayers that the impugned order dated 27-11-2018 may be set aside and name of the appellant be placed in confirmation list with his colleagues/batch mates with all back benefits.

3. Written reply/comments were submitted by respondents.
4. Arguments heard and record perused.
5. Learned counsel for the appellant contended that the appellant initially appointed as ASI on 28-12-2006, subsequently confirmed on 29-06-2010 from the date of initial appointment. That the appellant promoted as officiating SI on 24-08-2010. That in a DPC meeting held on 06-02-2013, other colleagues of the appellant were confirmed as SI vide order dated 20-02-2013, whereas the case of appellant was deferred, being not completed PTC posting period. That appellant confirmed as SI in subsequent DPC w.e.f. 03-01-2014 instead of 06-02-2013, where his other colleagues were confirmed. The learned counsel argued that as per minutes of the same DPC dated 06-02-2013, at serial No 2, an officiating SI, Gharib Nawaz deferred in previous DPC dated 15-08-2012 for want of deficiency was confirmed with his colleagues confirmed earlier vide DPC dated 15-08-2012. That the case of the appellant being the same was not



considered by the subsequent DPC and the appellant confirmed with immediate effect inspite of the fact that he was deferred and not superseded. That in case of deferment the seniority is not affected after fulfillment of the deficiency. That it is the legal right of the appellant to be confirmed from the date, his other colleagues were confirmed. That final seniority list issued on 29-06-2018 placed the appellant on Serial No 297, whereas his colleagues/batch mates are at Serial No 90, 91, 92 and 93. That such act of the respondents was discriminatory and against law and the appellant has not been treated in accordance with law; hence, his rights secured and guaranteed under the constitution were badly violated. The learned counsel referred to the judgments of this tribunal in service appeal No 407/2011, 1227/2013 and Service Appeal No 197/2016, where in similar nature cases, relief has been granted by this tribunal. The learned counsel also referred to the judgments of supreme court of Pakistan in 2006 SCMR 1938 and 2002 PLC (CS) 1388. On question of limitation the learned counsel referred to the judgment of supreme court of Pakistan in 2002 PLC (CS) 1388 and 2009 PLC (CS) 178, where on the issue of promotion, pay and other emoluments, limitation would not foreclose his right accrued to him. The learned counsel prayed that in view of the situation, the impugned order dated 27-11-2018 may be set aside and the respondents may be directed to place the name of the appellant in confirmation list with his colleagues/ batch mates by ante dating his confirmation to meet the end of justice with all back and consequential benefits of service.

6. The learned Deputy District Attorney appeared on behalf of official respondents opposed the contention of learned counsel for appellant. He argued that the appeal is badly time barred in the first place as his seniority affected in the year 2014, whereas the appellant preferred appeal in 2018 after issuance of seniority list in 2018. Reliance Civil appeal No 566/2020. The learned Deputy District Attorney further argued that the appellant had not qualified/ completed the mandatory period of posting required for confirmation, hence not confirmed in the DPC meeting. That after completion of mandatory posting period, the appellant confirmed to the rank of SI under section 13.18 of Police Rules 1934. The learned Deputy District Attorney prayed that the instant appeal being devoid of merit may be dismissed.

7. We are conscious of the fact that time limitation needs to be kept in mind, but in the light of judgments of Supreme Court of Pakistan referred to above and in view of provisions of S.23 of Limitation Act 1908, the appellant has a continuous cause of action and issuance of seniority list at belated stage by respondents created a fresh cause of action for the appellant, not knowing the fact that his confirmation in 2014 with immediate effect would entail seniority issue at a later stage. Moreover, deferment shall not debar the appellant from confirmation from the date of his deferment, after making good the deficiency. We did not find anything adverse on record except deferment to substantiate his confirmation on a later date. We also did not notice any other seniority list on record except the revised seniority list issued on 22-06-2018. It also established from the prevailing rules that civil servants selected for promotion to a higher post in



one batch shall, on their promotion to the higher post, retain their inter se seniority as in the lower post. Moreover this Tribunal as well as Supreme Court of Pakistan in number of Judgments have granted relief in similar cases.


8. In the light of facts and circumstances of the present case, the instant appeal is accepted, the impugned order dated 27-11-2018 set aside with the directions to the respondents to place the name of the appellant in confirmation list with his batch mates and accordingly revise the seniority list with all consequential benefits. No orders as to costs. File be consigned to the record room.

JUDGMENT

ATIQ-UR-REHMAN WAZIR MEMBER (E):-

Brief facts of the case are that the appellant was initially appointed as Constable in police department on 24-03-1984 and in due course was promoted to the post of inspector, but was not promoted along with his colleagues to the post of DSP and his case was deferred every time due to want of one year mandatory tenure in special branch/ counter-terrorism department/ investigation wing and completion of advance course. The appellant filed departmental appeal dated 15-02-2018 for his promotion under the plea that his other colleagues, who were also deficient in the concerned training as well as posting were promoted, therefore, the appellant may also be promoted on the same analogy. The appeal however was rejected vide order dated

09-01-2019. In order to meet the mandatory requirement, the appellant requested for his transfer on the concerned posts, but he was not transferred well in time. The appellant however, during the course completed the mandatory advance course as well as mandatory tenure in the required stations and filed service appeal with the prayer that the impugned order dated 09-01-2019 may be set aside to the extent of the appellant and he may be promoted to the rank of DSP with effect from 13-12-2018, when his other colleagues were promoted.

02. Learned counsel for the appellant has contended that the appellant has not been treated in accordance with law; that promotion of the appellant was withheld on flimsy grounds as it was beyond control of the appellant to get posting of his choice or to attend to a course without his nomination by the competent authority; that his other colleagues having the same deficiencies were considered and promoted to the rank of DSP, as is evident from Notification dated 13-02-2008, which is discriminatory; that promotion of the appellant was deferred for certain deficiencies, which have been fulfilled. The learned counsel prayed that the appellant may be promoted from the date, his other colleagues were promoted as well as maintain seniority inter se along with his batch-mates.


03. Learned Additional Advocate General appearing on behalf of respondents has contended that as per clause 13:16(a) of amended police rules, 1934, an inspector shall be promoted to the post of DSP after successful completion of mandatory training and completion of one year tenure in investigation wing or counter-terrorism department or special branch; that the appellant does not fulfill such criteria, hence his case was deferred and he was not promoted in DPC Dated 03-01-2018; that the appellant was treated in accordance with law and he was not discriminated, therefore the instant service appeal being devoid of merit, may be dismissed.


04. We have heard learned counsel for the parties and have perused the record. Contention of the learned counsel for the appellant holds ground, as it

was not within the authority of the appellant to post himself in a desired place or to attend to a course without his nomination by the competent authority. Had the relevant authority posted the appellant in the relevant time and nominated him for such course and had the appellant failed to do so, then the appellant would have not been found entitled to the relief claimed. Since the omission is on part of the respondents, as such the appellant cannot be deprived of his right to ante-date his promotion from the date, when his other colleagues were promoted. We have also found that the appellant in due course has fulfilled the deficiencies and is otherwise eligible for promotion. We have also noted that case of the appellant has been deferred and he is not superseded, so as per rule, on attaining promotion after meeting deficiencies, he will re-gain his due seniority amongst his other batch-mates.

05. In view of the foregoing discussion, the instant appeal is accepted by setting-aside the impugned order dated 09-01-2019 and the appellant is held entitled to promotion from the date, when his other batch-mates were promoted along with all back benefits. Parties are left to bear their own costs. File be consigned to record room.

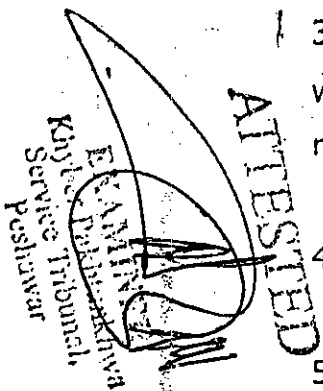
NOOR ALI KHAN, MEMBER.- This appeal has been filed by Shakeel Ahmad, the appellant under Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act 1974, against the order of respondent No. 2 dated 12.11.2012, whereby the application of appellant for confirmation in the rank of Sub Inspector was rejected. It has been prayed that on acceptance of the appeal, the impugned order may be set aside and the appellant be confirmed in the rank of Sub Inspector with retrospective effect enabling the appellant to get equal treatment like his other colleagues.

2. Brief facts of the case as narrated in the memo: of appeal are that the appellant joined the Frontier Reserve Police, on 4.4.1995 as Constable and served efficiently and to the entire satisfaction of his superiors. He was gradually promoted as Assistant Sub Inspector on 28.9.2007 and according to Rule 13.18 of Police Rules 1934, he was confirmed in the rank of ASI and his name was brought on promotion list "E" w.e.f. 1.7.2010 vide order dated 30.7.2010. On 29.1.2009, the appellant was promoted as Sub Inspector and assumed the charge of the post. The appellant was further promoted as Inspector on adhoc basis and posted as Reserve Inspector (Headquarter) Police Lines, Peshawar. The appellant being eligible in all respect, approached the respondent No. 3 for his confirmation/promotion in the rank of Sub Inspector, which was recommended and forwarded to respondent No. 2. The departmental appeal of the appellant was rejected on 12.11.2012 with the remarks that no ASI shall be confirmed in a substantive vacancy in the rank of SI unless he has been tested for at least a year as an officiating SI independent charge of a Police Station in a District other than that in which his home is situated or three years deputation period as Officiating Sub Inspector in Special Branch, PTC Hangu CID according to CPO direction during the year 2000 and two years in investigation/Elite Force as per Standing Orders. Hence the present appeal.

3. The appeal was admitted to regular hearing on 4.12.2012 and notices were issued to the respondents. The respondents have filed their joint written reply and contested the appeal. The appellant also filed rejoinder in rebuttal.

4. Arguments heard and record perused.

5. The learned counsel for the appellant argued that the appellant was promoted as Assistant Sub Inspector on 28.9.2007 and according to Rule 13.18 of Police Rules 1934, he was confirmed in the rank of ASI and his name was brought on promotion list "E". The appellant has been promoted as Sub Inspector on 29.1.2009 and served for sufficient time and eligible for confirmation/promotion in the rank of S.I Substantively. He also qualified upper College Course with excellent service record. As per Police Orders the duties and responsibilities of Frontier Reserve Police are the same as those of Regular Police and in the light of the notification dated 15.1.1988, Police Rules are fully applicable to Frontier Reserve Police. In the financial year 2002-03, the Finance



Department had also declared the FRP as a permanent budgetary force. So the appellant has the fundamental right to be dealt with in the same manner as the officers of the regular police. Under Rule 13.18 of Police Rules 1934, after successful completion of two years as Offtg. S.I he has to be confirmed w.e.f. 1.7.2010.. He stated that the appellant could not post himself as independent SHO to meet the requirement for confirmation. It was the responsibility of the respondents to post him as independent SHO! He produced a copy of judgment dated 23.5.2011, in Service Appeal No. 407/2011 of this Tribunal and stated that in similar circumstances, confirmation has been granted to appellant in the aforementioned service appeal without spending a period of one year independent SHO. The appellant is also entitled to the same treatment. He requested that the appeal may be accepted as prayed for.

6. The learned AAG argued that the appellant was promoted to the rank of ASI on 28.9.2007 and was later confirmed into the same rank on 1.7.2009. He was promoted as SI but on officiating basis on 29.1.2009. For confirmation in the same rank he has to fulfill the requirements under the rules. The appellant has not spent one year as independent SHO which was one of the basic criteria for confirmation as Sub Inspector, hence he was not entitled for confirmation under Police Rules and Standing Orders. Hence his application for confirmation has rightly been turned down by the competent authority. He requested that the appeal may be dismissed.

7. The Tribunal observes that the main issue which falls for determination in the present case is that whether the appellant has rightly been ignored by the respondent department from confirmation/promotion as S.I on the ground of his not fulfilling the requirement to serve as SHO for a period of at least one year outside his home district before he is confirmed as S.I. The appellant was promoted as ASI on 28.9.2007 and according to Rule 13.18 of Police Rules 1934, he was confirmed and his name was brought on promotion list "E" w.e.f. 1.7.2010 vide order dated 30.7.2010. On 29.1.2009, he was promoted as Sub Inspector on officiating basis and assumed the charge of the post. The appellant also passed the Upper College Course and further promoted as Inspector on adhoc basis on 27.8.2010 and posted as Reserve Inspector (HQ) Peshawar, where he still serving in that capacity. It was the prerogative/discretion of the departmental authority to post him as SHO, for which the appellant cannot be held responsible and ^{he will not} suffer for the acts of others. Under Rule 13.18 of Police Rules 1934, he has to be confirmed on successful completion of two

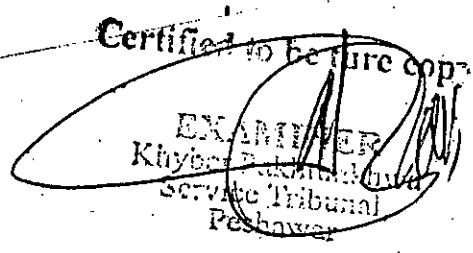
years period of probation or reverted back to his substantive rank. Since the appellant has not been reverted, and has further been promoted as Inspector on adhoc basis, was entitled for confirmation.

8. In view of the above, the appeal is accepted, the impugned order is set aside and the respondent department is directed to confirm the appellant as Sub Inspector w.e.f. 1.7.2010 as per rule 13.18 of Police Rules 1934. Parties are left to bear their own costs. File be consigned to the record.

1. That the appellant was appointed as constable on 07.02.2002 and then qualified the Public Service Commission Examination and was appointed as ASI, in the year 2010 and then the appellant was promoted as SI in the year 2014 and hence he performed his duty up to entire satisfaction of his superiors and no complaint has been filed against him.
2. That the appellant has completed all the requisite/mandatory and professional training and courses.
3. That according to rules for confirmation as SI, the appellant required to complete the two period, one as I/C police post and 2nd period in Elite Force or CTD which was completed by the appellant. The rules will provide at the time of arguments if need.
4. That when appellant was posted as I/C police Post on different station lastly posted at Police Post Dubai Ada from which the appellant was nominated for the Upper Course and the Appellant was proceeded to Hangu College for Upper course. **Copy of posting orders and certificates are attached as annexure-A and B.**
5. That on completion of Upper Course the appellant was returned and wrote applications for posting as I/C to complete his mandatory period which is necessary for confirmation as SI. The case of he appellant was put up for proposal vide orderly room dated 25.09.2018. thereafter, proposal was put up on 26.09.2018 and the remarks was given at S No.2 wherein the appellant was proposed to posted as I/C Police Post Beroch to complete their mandatory period for confirmation as SI. **Copy of applications and proposals are attached as annexure C and D.**
6. That thereafter, the appellant was completed his all the mandatory training at various Police Post as I/C, as per direction of the Estt: Clerk and the appellant filed application for confirmation as SI on completion of period. The regional police officer Mardan has issued order dated 20.09.2019, whereby number of police officer confirmed on the rank of sub-inspector, while the appellant was not confirmed. **Copy of the application and impugned order is attached as annexure-E & F.**
7. That the appellant filed departmental appeal on 14.10.2019 for confirmation as SI But the same was not responded within statutory period of 90 days. **Copy of the departmental appeal is attached as annexure-G.**

8. That now the appellant come to this Hon'ble Tribunal for his claim on the following grounds amongst others.

GROUND:

- A) That the not considering the appellant for confirmation as SI and no decided the departmental appeal of the appellant with in statutory period of 90 days is against the facts, law, rules, norms of Justice and fair Play therefore liable to be set aside.
- B) That the appellant was deprived from his rights of promotion in an arbitrary manner which is the violation of Article-2,4 and 25 of the Constitution of Pakistan.
- C) That the appellant was entitled for confirmation w.e.f from 20.09.2019 but he was deprived from his legal and constitutional right for the fault of others.
- D) That the appellant has completed all the requisite/mandatory and professional training and courses on the instruction That according to rules for confirmation as SI, the appellant required to complete the two period, one as I/C police post and 2nd period in Elite Force or CTD which was completed by the appellant as per direction of the Estt: Clerk. So there was no fault on the part of the appellant. So the appellant is legally entitled for confirmation as SI.
- E) That on completion of Upper Course the appellant was returned and wrote applications for posting as I/C to complete his mandatory period which is necessary for confirmation as SI. The case of he appellant was put up for proposal vide orderly room dated 25.09.2018. thereafter, proposal was put up on 26.09.2018 and the remarks was given at S No.2 wherein the appellant was proposed to posted as I/C Police Post Beroch to complete their mandatory period for confirmation as SI. So which is crystal clear that the department is aware from everything but on malafide intention the appellant was not confirmed as SI. —
- F) That the appellant was not treated according to the law and rules and deprive from the legal right of the promotion.

PRELIMINARY OBJECTIONS

1. That the appellant has not approached this Hon'ble Tribunal with clean hands.
2. That the appellant has concealed the actual facts from this Hon'ble Tribunal.
3. That the appellant has got no cause of action or locus standi to file the instant appeal.
4. That the appellant is estopped by his own conduct to file the instant Service Appeal.
5. That the appeal is unjustifiable, baseless, false, flawless and vexatious and the same is liable to be dismissed with special compensatory cost in favour of respondents.
6. That the Hon'ble Tribunal has no jurisdiction to adjudicate the matter.
7. That the appeal is bad for miss joinder and non joinder of necessary parties.
8. That the appeal is barred by law and limitation.

REPLY ON FACTS

1. Para to the extent of appointment of the appellant as Constable and later on inducted as PASI as well as his further promotion to the rank of Sub-Inspector pertains to record needs no comments, while rest of the para is not plausible because every Police Officer is under obligation to perform his duty up-to the entire satisfaction of his high ups.
2. Para pertains to record, needs no comments.
3. Correct to the extent that for confirmation in the rank of SI, every Sub Inspector is required to fulfill the requisite criteria as enshrined in Police Rules 1934 as amended in 2017 coupled with qualifying Upper College Course.
4. Para pertains to record needs no comments.
5. Para pertains to record needs no comments.
6. Para to the extent of completion of mandatory training at various Police Posts as Incharge. As per the directions of Establishment Clerk is totally baseless because mandatory trainings are not imparted at Police Posts rather the same are imparted in different training institutions as well as Specialized Schools. However, rest of the para pertains to record because all those Sub Inspectors who complete the requisite criteria as enunciated in Police Rules 1934 as amended in 2017 as well as qualification of Upper College Course are eligible to be confirmed in the rank of Sub Inspector by Regional DPC. Moreover, only posting as Incharge Police Post is not sufficient rather posting as Incharge of notified Police Post will be counted towards confirmation in the rank of Sub Inspector, besides other formalities.
7. Para to the extent of filing departmental appeal pertains to record needs no comments.


8. That appeal of the appellant is liable to be dismissed on the following grounds amongst the others.

REPLY ON GROUNDS:

- A. Incorrect. Stance of the appellant is totally ill based because he had not completed the requisite criteria as enunciated in Police Rules 1934 as amended in 2017 therefore, he was not considered for confirmation which is in accordance with law, rules norms of justice. Therefore, the appeal in hand is worth to be dismissed.
- B. Incorrect. As discussed earlier the appellant had not fulfilled the requisite criteria therefore he was not considered. Respondents have not violated any provision of constitution of Pakistan and always acted in accordance with law/rules.
- C. Para already explained needs no comments.
- D. Para to the extent of completion of all requisite/mandatory and professional training and courses pertains to record needs no comments, while rest of the para is totally baseless, because every Sub Inspector is required to fulfill the requisite criteria as enshrined in Police Rules 1934 as amended in 2017 coupled with qualifying Upper College Course. Moreover, stance of the appellant regarding confirmation in the rank of SI on the basis of his posting as Incharge of un-notified Police Posts is devoid of merit being repugnant with rules on the subject.
- E. Para already explained needs no comments.
- F. Incorrect. Appellant has been treated in accordance with law and norms of justice, because the respondent department has no grudge or ill-will against the appellant.
- G. The respondents also seek permission of this honorable tribunal to adduce additional grounds at the time of arguments.

PRAYER:-

Keeping in view the above stated facts and rules it is most humbly prayed that the appeal of the appellant is devoid of legal force may kindly be dismissed with costs please.



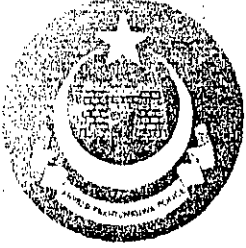
