Counsel for the appellant and Mr. Kabirullah Khattak, Addl. AG for the respondents present. Preliminary arguments have been heard and record perused.

The appellant has invoked the jurisdiction of this Tribunal with the prayer as copied below:-

*"On acceptance of this appeal, the respondents may be directed to consider the appellant for promotion to the post of Junior Clerk under 33% quota fixed by the Government from his due date/availability of fund with all consequential benefits or any other remedy which this august Tribunal deems fit and appropriate that may also be awarded in favour of appellant."*

The appeal was filed on 31.01.2020 and is still going through the course of preliminary hearing. According to the proceedings reflected in order sheet dated 23.12.2020, pre-admission notice was given to the respondents. Therefore, they are in attendance through learned AAG. Private respondents also entered in proceedings through their counsel. In different order sheets, request for adjournment for submission of the written reply has been reflected but no order sheet reflects as to submission of the comments, while parwise comments on behalf of respondents No. 1 & 2 are available in the file. It is asserted vide para-4 of the said comments that the appellant had already filed an appeal No. 303/2014 asking the same relief in which final order was issued by the Tribunal on 27.10.2017 with the decision that the respondents should calculate the quota of the promotees in accordance with the prevalent rules at different stages and then they should consider all those who are eligible and fit for promotion at different stages.



Then in 2018, the appellant filed an Execution Petition No. 42/2018 in Appeal No. 305/2014 for implementation in which the respondents submitted an implementation report. A Copy of this Tribunal's order has been annexed with the said comments. According to titled page of Appeal No. 305/2014 annexed with the order dated 27.10.2017 the prayer in the said appeal was also the same rather verbatim as now in the present appeal and copied above. There is an order dated 30.12.2019 which was passed in execution petition No. 42/2018. According to the titled page of the execution petition as available alongwith certified copy of the said order, the same was filed seeking the implementation of the order dated 27.10.2017 passed in appeal No. 305/2014 by this Tribunal. According to contents of the said order the then learned counsel stated before the Tribunal that after passing of the judgment under implementation another seniority list was issued by the respondents wherein juniors to the petitioner were allocated positions senior to him. Therefore, desire of the petitioner to pursue legal remedy available to him on account of seniority list was pressed into service with the request for consigning the execution proceedings to the record room with the reservation of his rights as stated above. Consequently, the execution proceedings were consigned to the record room with liberty to the petitioner to proceed against the seniority list or any other instruments whereby his service rights were adversely affected.




As far as the prayer in the present service appeal as copied above and in the previous service appeal decided vide order dated 27.10.2017 are concerned, the same are indistinguishable and main contesting parties are also the same. Therefore, the present appeal with the same prayer, having already been adjudicated upon is not maintainable within the meaning of Rule 23 of the Khyber

Pakhtunkhwa Service Tribunal Rules, 1974 and its rejection is inevitable. However, the case of the appellant in view of his previous litigation is required to be reconsidered for further proceedings in execution of the previous order dated 27.10.2017 passed in Service Appeal No. 305/2014. I am mindful of the fact that the petitioner himself requested for consignment of the execution petition in pursuance of his desire to file the present appeal but this Tribunal is vested with power under Rule 27 of the Khyber Pakhtunkhwa Service Tribunal Rules, 1974 to make such order as may be necessary for the ends of justice. It seems that the execution petition No. 42/2018 as filed by the present appellant was got consigned to the record room vide order dated 30.12.2019 because of some misunderstanding or miscomprehension of the scope of the order under execution. The order dated 27.10.2017 passed in Service Appeal No. 305/2014 is still intact and its execution is possible having regard to its letter & spirit. In order to delineate the scope of the executable part of the said order, it is observed that the respondents were directed thereby that they should calculate the quota of promotees in accordance with the prevalent rules at different stages and then they should consider all those who are eligible and fit for promotion at different stages. The spirit of the said order is very much clear that it was aimed at calculation of the quota of the promotees for the relevant posts and to grant them promotion after determination of their eligibility and fitness for promotion at different stages. So it was required on part of the department to demonstrative the compliance of the said order that they should have brought the Working Paper before the Tribunal showing the number of posts available in the quota of the promotees for the relevant posts and then to show whether the petitioner in the execution petition was



eligible for promotion or not. Therefore, while rejecting the present appeal on the principle of *resjudicata*, the execution petition No. 42/2018 is restored for further proceedings in view of the scope of the order dated 27.07.2017 as delineated herein above.

This file be consigned to the record room and file of execution petition No. 42/2018 be recovered from the record and register on its original number for further proceedings on 20/01/2022 before S.B. Copy of this order be filed on E.P File.

**Respectfully Sheweth:**

The facts giving rise to the following Appeal of the appellant are as under:

1. That the appellant joined the respondents department on 28/04/1998. The appellant more than 21 years service with good record throughout

at his credit. (Copy of Appointment Order is attached as annexure "A").

2. That the appellant is highly qualified and has passed SSC, Intermediate, Bachelor of Arts, Typing Course, CT, B.Ed, M.A, Diplomas Mechanical and Electrical & Service Certificate with more than 22 years experience. (Copy of Certificates are attached as annexure "B", "C", "D", "E", "F" & "G").
3. That the Government of KPK has fixed 33% quota for Class-V with SSC Qualification for the promotion to the post of Junior Clerk. But despite of the fixed quota and having eligibility, the appellant was never consider for promotion o the post of Junior Clerk, while other colleagues juniors to the appellant have been considered for promotion as reference Appeal No. 321/2012 and 322/2012. (Copy of the judgment is attached as annexure "H").
4. That appellant filed appeal of such nature without making respondents the junior once as they were not in the knowledge of the appellant so who seniority list submitted by respondents department,

so due coming in to knowledge this appeal has been filed to submit again. (Copy of judgment of Tribunal is attached as annexure "I").

5. That the appellant filed Departmental Appeal for his claim on 27/09/2019 and waited for 90 days, but no reply has been received by the appellant to the appeal so far, hence the present appeal on the following grounds amongst the others. (Copy of Departmental Appeal is attached as annexure "J").

**GROUND:**

- A. That not granting pay benefits of higher post of Junior Clerk and not considering the appellant for regular promotion under 33% quota is against the norms of justice and material on record.
- B. That the appellant is senior most eligible and qualified Class-IV Employee and he is entitled to be promoted as Junior Clerk under 33% reserved quota.

- C. That the appellant has been kept deprived from his legal right of promotion which is not tenable under the norms of justice and fair play as the junior respondents No. 4 to 5, have been already promoted.
  
- D. That the respondent department has never observed 33% quota, rather the department promoted the most junior person under 33% quota who were junior to appellant. Thus, the promotion order issued by the respondent department of the most junior person is highly discriminatory and based on nepotism. (Copy of order of respondents No. 4 to 5 by respondents (impugned) is attached as annexure "K").
  
- E. That, similar appeals have already been decided by this august Tribunal Appeal No. 796/2008 decided on 30/01/2009, Appeal No. 1604/2010 decided on 21/01/2011 and Appeal No. 104/2011, and No. 323/2011 decided on 11/01/2012. Thus, the appellant also deserves the same treatment under the principle of consistency being similarly placed



person. (Copy of the judgment is attached as annexure "L").

- F. That the appellant has not been treated according to law, rules governing the 33% quota of appellant.
- G. That the appellant seeks permission to advance other grounds and proofs at the time of hearing.

JUDGMENT

SULTAN MAHMOOD KHATTAK, MEMBER.- This appeal has been filed by Inamullah, the appellant under Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act 1974 with the prayer that on acceptance of the appeal, the respondents be directed to consider him for promotion to the post of Junior Clerk under 33% quota reserved by the government from due date/availability of the vacancy with all consequential benefits.

2. Brief facts of the case as averred in the memo: of appeal are that the appellant joined the respondent department as Daftari on 2.10.1993. He has more than 18 years service at his credit having passed SSC and F.A examinations. The Government of Khyber Pakhtunkhwa had fixed 33% quota for promotion of Class-IV as Junior Clerks with SSC qualification, but the appellant was never considered for promotion, to the post of Junior Clerk. Feeling aggrieved, he filed departmental appeal on 18.11.2012, which elicited no response within the statutory period of ninety days, hence the present appeal.

3. The appeal was admitted to regular hearing on 22.3.2013 and notices were issued to the respondents. The respondents have filed their joint written reply and contested the appeal. Rejoinder was also filed in rebuttal.

4. Arguments heard and record perused.

5. The learned counsel for the appellant argued that the appellant was appointed as Daftari on 2.10.1993 having the qualification of SSC. He further acquired F.A qualification during service. He further argued that there are sufficient vacancies of Junior Clerk lying vacant in the department and was more deserved to be considered for promotion from the date of availability of vacancies having more than 20 years service at his credit and highly qualified under 33% quota reserved by the government. The learned counsel for the appellant produced a copy of judgment dated 11.1.2012 in Service Appeal No. 104/2011, titled "Zahoor Jan Versus the DCO, Nowshera etc.", wherein the respondent department was directed to consider, the appellant in that appeal alongwith others against the post lying vacant under 33% promotion quota from the date when the vacancies was available. The present appellant is also entitled to the same treatment. He requested that the appeal may be accepted as prayed for.

6. The learned AGP argued that the appellant will be considered for promotion in his own turn under 33% quota in accordance with existing rules/policy and seniority-cum-fitness basis.

7. The Tribunal while agreeing with the arguments put forth by the learned counsel for the appellant accepts the appeal and directs the respondent department to consider the appellant alongwith others for promotion against the post of Junior Clerk from the date when vacancies were available for them within ninety days with all consequential benefits from that date. Parties are left to bear their own costs. File be consigned to the record.

8. This judgment will also dispose of Service Appeals No. 321/2012 titled Muhammad Ayaz, and No. 322/2012, titled Hamid Ali versus the DCO, Nowshera and others, having similar question of law, in the same manner.

**RESPECTFULLY SHEWETH,**

Respondent submits as under.

**Preliminary objections:**

- 1) That the appellant has no cause of action/locus standi to file the instant Service Appeal.
- 2) That the present appeal is bad for non-joinder and mis-joinder of necessary parties.
- 3) That the appellant is estopped by his own conduct, by deed and by law to file the instant appeal.
- 4) That the instant appeal is not maintainable in its present form.
- 5) The present appeal is badly time barred.

**ON FACTS:**

- 1) Pertains to record and subject to proof.
- 2) Para -02 is subject to proof.
- 3) Para -03 incorrect, 33% quota fixed by the govt. of KPK for promotion to clerk from C-IV is conditional with the seniority cum fitness, while the appellant is low at seniority and shall be promoted on his due turn. While the promoted C-IV objected by the appellant were duly promoted by the honorable tribunal judgment in appeal NO.321/2012 & 322/2012 copies of which are already attached by the appellant. (Copy of seniority list is attached as annexure 'A').
- 4) Para-04 is incorrect, making no sense, however it is added that the appellant had already filed an appeal no. 305/2014 asking the same relief in which final order was issued by this honorable tribunal on 27/10/2017 in which it was decided that respondent should calculate the quota of promotees in accordance with the prevalent rules at different stages & then they should consider all those who are eligible & fit for promotion at different stages. Then in 2018 the appellant filed an E.P no 41/2018 in appeal no 305/2014 for implementation in which the respondents submitted an implementation report according to which the petitioner was not fulfilling the criteria of seniority cum fitness In which final order was passed on 30-12-2019

(Copies of service tribunal order, E.P, implementation report and final order are annexure 'B, C' 'D' & E').

5) Para-05 is incorrect, no such appeal has been filed on 27-9-2019.

**ON GROUNDS:**

A)Ground -A is incorrect, the appellant will be promoted by his own turn.

B)Ground -B is incorrect, the appellant is low in the seniority list.

C)Ground -C is incorrect, Respondent No. 4&5 were duly promoted in compliance of the Honorable Tribunal judgment, copies of which are attached by the appellant.

D)Ground -D is incorrect, as explained above.


E)Ground -E is incorrect, every case has its own facts, and the appellant is clearly low in seniority list.

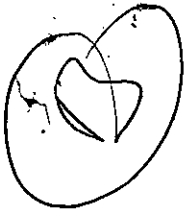





It is, therefore, most humbly prayed that the instant service appeal being meritless, frivolous and vexatious may be dismissed.



