





Counsel for the appellant Mst. Zarsanga Bibi present. Preliminary arguments heard. It was contended by learned counsel for the appellant that the appellant was serving in Education Department as Senior Primary School Teacher Palosai Piran. It was further contended that on the recommendation of Departmental Promotion Committee she was promoted from the post of Senior Primary School Teacher to the post of Primary School Head Teacher vide order dated 24.06.2019 and vide same order she was adjusted at Government Girls Primary School Hakeem Khan Kallay as Primary School Head Teacher. It was further contended that the appellant due to enmity in the said Hakeem Khan Kallay preferred departmental appeal on 29.06.2019 but the same was not responded hence, the present service appeal. It was further contended that since the appellant is having enmity in the area of Hakeem Khan Kallay, therefore, the respondent-department was required to adjust the appellant at Government Girls Primary School Agriculture University Peshawar, Government Girls Primary School Palosi Atozai Peshawar, Government Girls Primary School Regi Peshawar, Government Girls Primary School Police Colony Peshawar, Government Girls Primary School Piran Kalay Peshawar, Government Girls Primary School Mian Jee Bab Peshawar and Government Girls Primary School Tukht Abad Peshawar instead of Hakeem Khan Kallay.

The contention raised by learned counsel for the appellant need consideration. The appeal is admitted for regular hearing subject to all legal objections. The appellant is directed to deposit security and process fee within 10 days, thereafter, notices be issued to the respondents for written reply/comments for 18.03.2020 before S.B.





Appeal under Section 4 of the Khyber Pakhtunkhwa Services Tribunal Act, 1974 against the impugned order of Respondent No 4, wherein the service of the Appellant is transferred from GGPS Palosai Piran to GGPS Hakeem Khan Kalay without considering the basic plea of the Appellant with few others is that the Appellant's husband is charged in a murder case in the local

area of the recent transfer and the Appellant feel threat to her life and life of her children, secondly the Appellant has spent more than 18 years of her services as a single teacher at Garange Payan GGPS (Rural Area). The Appellant spend 1.1/2 years at Palosi Piran (GGPS) that the date of transfer to Piran is 01-01-2018 and the impugned order is made on 24-06-2019

PRAYER IN APPEAL:-

On acceptance of instant appeal, the impugned order of the Respondent No 4 may kindly be set aside and the service of the Appellant may kindly be transferred to any other settled and safe area, where the Appellant could render her service without any threat to her and her children life.

Respectfully Sheweth:-

The Appellant humbly submits as under:-

- 1) The Appellant submitted through instant appeal on following factual and legal grounds.
- 2) That the Appellant served as a single teacher in GGPS Garanga Payan for about 18 years, which is a rural area.
- 3) That on 01-02-2015 the Appellant's husband was charged in a murder case. (Copy of the FIR is attached for quick reference is attached as Annex 'A').

- 4) That on 01st January, 2018 the services of the Appellant was transferred from Garanga Payan to Palosi Piran, on which the Appellant felt satisfied as she was feeling threats to her and her children lift from the hands of the rival party. (Copy of the order is attached Annex 'B').
- 5) That consequently the Appellant children got admission the local area of transfer and Appellant started to live in transfer area comparatively severe, as it is a populated and severe area.
- 6) That astonishingly on 24-06-2019 the Respondent No 4 once again issued the impugned order and transferred the services of the Appellant from GGPS Palosi Piran to GGPS Hakeem Khan Kalay, which is exactly the adjacent area of place of enmity of the Appellant and the Appellant is feeling un-save alongwith her family. (Copy fo the order is attached as Annex 'C').
- 7) That as per law and requirement, the Appellant moved a departmental appeal to Respondent on 29-06-2019, but that is not responded. (Copy of the departmental appeal is attached as Annex 'D').
- 8) That the Appellant extended favour to their near and dear as in the impugned order one Khalida Bibi PHSE eas transferred from GGPS Hassan Ghari to GGPS Nazim Abad in the impugned order dated 24-06-2019 at serial No 75, but

due to nepotism and favoritism another order was made on 03-07-2019 and the service of the same candidate was again transferred from GGPS Nazim Abad to GGPS Hassan Ghari, whereas the genuine case/grievances of the Appellant was once looked. (Copy of the order dated 31st July, 2019 is attached as Annex 'E').

- 9) That it come to the knowledge of the Appellant that many post are laying vacant in different schools like:-
- i. GGPS Agriculture University, Peshawar
 - ii. GGPS Palosi Atozai Peshawar
 - iii. GGPS Regi, Peshawar
 - iv. GGPS Police Colony, Peshawar
 - v. GGPS Piran Kalay, Peshawar
 - vi. GGPS Mian Jee Bab, Peshawar
 - vii. GGPS Tukht Abad, Peshawar
- 10) That feeling extremely aggrieved from the order of Respondent No 4; the Appellant approaches this Honourable Tribunal on the following grounds inter-alia:-

GROUNDS:-

- A) That the impugned order is against the law, facts, norms of justice and material available on record, hence not tenable.
- B) That the impugned order of the Respondent is without considering the ground reality.

- C) That the impugned order of the Respondent is creating threats to the life of Appellant and her children at the hands of rivals.
 - D) That the protection of life of the individual is guaranteed by Constitution of Islamic of Pakistan, 1973.
 - E) That in the present circumstances, it is hazardous for the Appellant to joint duties in the enmity area at risk of her life and kids.
 - F) That the other grounds not here specifically raised may also graciously be allowed to be raised at the time of arguments.



PRAYER:-

Any other relief, which this Honourable Court deems just and appropriate in the circumstances of this case, not specifically asked for, may also be granted in favour of Appellant.


