NO. 171 DATED 25-10-2018 WHEREBY MAJOR PENALTY OF Removel FROM SERVICE WAS IMPOSED UPON THE APPELLANT AGAINST THE LAW, RULES AND SHARIAH AND IS LIABLE TO BE SET ASIDE, THE APPELLANT FEELING AGGRIEVED OF. <u>PRAYER:</u>

That on acceptance of this service appeal both the orders impugned may very kindly be set aside and the appellant reinstated back into service with all back / consequential benefits.

Respectfully Sheweth:

<u>Facts:</u>

i. That the appellant joined the Police Force in the year 2007 and since performed his duties with utmost devotion, regularity and bravely without any complaints either by the authorities or the general public.

ii. That the appellant while posted at Casualty Matta Hospital a person was brought who, as per the statement of the brother, ate some poisonous drug in an attempt of suicide.

iii. That becoming stable a certificate of being stable was got from the doctor on duty and initial questions were asked so as to ascertain the statement of the brother i.e. attempt to suicide, to which the patient answered in affirmative. The appellant then and there recorded the statements of both the patient and his brother.

Copy of the certificate is enclosed as Annexure "A".

iv. That while completing the process the patient expired in the mean while. The brother of the deceased asked for the body to be handed over to him, but the Incharge Umar Hayat refused and asked to call for the father of the deceased.

That upon the arrival of the father the Incharge in presence of the appellant asked in a clear manner the cause of the death and also that if he has any doubt about the death of his deceased son i.e. something else than the alleged suicide and if he doubted any foul play.

vi. That the father answered in negative and confirmed that his son has killed himself on a domestic issue of marriage. The Incharge even asked the father to let them perform the autopsy, but they insisted not to do so and that to handover the corpse without the said procedure.

That thereafter a "Morasal" was sent to the Incharge Police Station Matta for registration of FIR under section 325 PPC, hence FIR 1123 dated 17-09-2018 under section 325 PPC was registered. Copy of the FIR is enclosed as Annexure "B".

viii. That to the utmost ustonishment of the appellant he was issued a charge sheet coupled with statement of allegations relating to not observing the SOPs as autopsy has not been dine

and that this has created problems for the Police Force. Copies of the Charge Sheet and Statement of allegations are enclosed as Annexure "C".

- ix. That the appellant submitted a detailed reply to the same clearly narrating while of the true story, but the same was not considered bald of any reasons.
 - That without issuing any Show Cause Notice the appellant was issued the order of the appellant of from service vide order O.B. No. 171 dated 25-10-2018 as bolt from the blue, as the same is against the law, rules and Shariah. Copy of the order dated 25-10-2018 is enclosed as Annexure "D".

That feeling aggrieved of the same the appellant field a departmental appeal on 30-10-2018, but the same was also not considered and was filed against the law, rules and Shariah vide order No. 524/E dated 10-01-2019. Copy of the appeal is enclosed as Annexure "E" and that of the order dated 10-01-2019 is enclosed as Annexure "F", respectively.

xii. That still feeling aggrieved and having no other option left this honourable tribunal is approached for the redressal of the grievances on the following grounds.

Grounds:

a. That neither have been the codal formalities observed nor due course of law adopted before the imposition of major penalty of *constitution* from service, which is very much against the laws emanating from the commands of the constitution, thus the appellant has not been treated in accordance with the law.

- b. That the appellant has never associated with the farce inquiry, moreover the appellant was neither afforded the opportunity of personal hearing nor any chance of self defence given.
- c. That the respondents have exercised the authority in a colourful, fanciful and arbitrary manner to the utter detriment of the appellant, which the never approves of.
- d. That the appellant has not committed any act of commission or omission which may constitute any offence under any law.
- e. That the appellant still jobless and there is no source of earning the bread and butter for his family.

It is, therefore, very respectfully prayed that on acceptance of this service appeal both the orders impugned may very kindly be set aside and reinstate the appellant back into service with all back / consequential benefits. Any other relief deemed appropriate in the circumstances and not specifically prayed for may also very kindly be granted.

Swat was appointed as Enquiry Officer to conduct proper departmental enquiry against the delinquent Police Officer. The Enquiry Officer reported, that the Head Constable under enquiry had failed to follow SOP in the abovementioned case which created problems for Police.

The Police Officer under enquiry had failed to collect the deceased's clothes for evidence. He has also failed to get the dead body examined which made the case complicated and created problems for Police. His this act is against discipline and unbecoming of a Police Officer. This warrants punishment. Hence, in exercise of the powers vested in the undersigned under Rules 2 (iii) of Police Disciplinary Rules - 1975, I Syed Achfuq Anwar, PSP, District Police Officer. Swat being competent authority, am constrained to award him major bunishment of removal from service.





Preliminary Objections.

- 1. That the appellant has got no Cause of action and locus standi to file the present appeal.
- 2. That the appeal is bad due to misjoinder and nonjoinder of necessary parties.
- 3. That the appeal is barred by Law & limitation.
- 4: That the appellant has not come to the Tribunal with clean hands.
- 5. That the instant appeal is not maintainable in its present form.
- 6. That the appellant has concealed the material facts from this Hon'ble Tribunal.

<u>FACTS:</u>

iii.

i. Correct to the extent that appellant was enlisted in the year 2007 and he was awarded 03 minor punishments for wilful absence from official duty during entire service. List enclosed as annexure "A"

Correct to the extent that one Muhammad Kumail had consumed poison, committed suicide and his dead body was handed over to the legal heirs without conducting postmortem through doctor by the appellant.

Incorrect. Muhammad Kumail and lady Muazima were given poisons by the accused due to fear of Muhammad Pervez etc. Investigations of case FIR No.1126 dated 19/9/2018 u/s 302-202-109-147-149 PPC P.S Matta revealed that the thumb impression of deceased Muhammad Kumail was taken on the report of attempt to commit suicide, as dying declaration statement. Investigation of case FIR No.1123 was conducted by the appeltant but he did fiol take into possession the clothes of deceased Muhammad Kumail no conducted autopsy.

- iv. Incorrect. During treatment at hospital, Muhammad Kumail passed away and the dead body was handed over to legal heirs without conducting autopsy which constitutes malafide and gross misconduct on part of the appellant.
- v. Incorrect. Sohail Khan (brother of deceased) has clearly narrated the whole episode in his confessional statement recorded under section 164-364 Cr.P.C. copy enclosed as annexure "B".
- vi. Incorrect. The appellant was duty bound to conduct autopsy through doctor and then hand over the corpse to legal heirs.
- vii. Correct to the extent that report of attempt to commit suicide of Muhammad Kumail was recorded with the connivance of Sohail Khan (brother of deceased and accused in FIR No.1123) and thumb impression of unconscious Kumail was impressed on the said report. Investigation of the said case was carried out by the appellant but he neither took into possession the cloths of deceased nor conducted autopsy through doctor.
- viii. Correct to the extent that charge sheet coupled with statement of allegation was issued to the appellant after preliminary information report of SP Investigation, wherein concealing actual facts of the murder and misconduct on part of the appellant has been categorically explained. Copy enclosed as annexure "C".
 - ix. Incorrect. The reply of the appellant was not based on facts and found unsatisfactory.
 - Incorrect. All opportunities of defence and personal hearing as required under KP Police Disciplinary Rules-1975, were provided to the appellant but he failed to disprove the charges and appropriate punishment was awarded to him.
- xi. Incorrect. Departmental appeal of appellant was examined in the light of facts and circumstances of inquiry and rejected in accordance with rules and facts of the case.
- xii. The appellant has wrongly challenged the legal and valid orders of the respondents before the honorable tribunal through unsound reasons/grounds.
- GROUNDS:
 - a. Incorrect! The appellant has been treated in accordance with law/rule i.e KP Police Disciplinary Rules-1975 and facts. All the codal formalities under the rules were observed before imposition of punishment against the appellant.
 - b. Incorrect. All the opportunities of self defence and personal hearing were provided to the appellant under the rules.





It is submitted for kind perusal that as evident from Case FIR I dated 17/09/2018 u/s 325-PPC PS Matta on 17/09/2018 complainant Muha Kumail S/O Muhammad Parvez R/O Kwaray Kharerai Matta in victim condition re to ASI Umar Hayat at Casualty Hospital Matta to the effect that he on the heartless discouragement to his life has attempted to commit suicide by taking poisonous tak drug at his home on his own sweet will. The report in shape of murasila having t impression of the complainant / victim duly supported by his brother namely s Khan was sent to Police Station Matta by ASI Umar Hayat showing consciousness victim was incorporated into FIR cited as subject. Similarly, the injury sheet prepar the said ASI was accordingly handed over to the Doctor Anwar of Civil Hospital Mat medico legal opinion.

Later on the whole episode of the suicide was transpired durin Enquiry initiated U/S 174-CrPC vide Daily Diary No.54 dated 18/09/2018 Police St Matta by SI Rahim Khan regarding similar sudden death of Mst: Muazzama D/O Khan R/O Sinpora Matta by taking poisons as per report lodged by complainant N Khan s/o Nosherawan. The actual facts ascertained during the course of En revealed that on the doubt of illicit relations between both the deceased Mst: Muazz and Muhammad Kumail, they have been gone to death by giving poisons to dece Muhammad Kumail by his brother Sohail Khan (accused) due to fear of Muham Parvez etc, while the deceased lady through violence as well as electric shots by accurate (1) Shah Room (2) Abdul Aziz (3) Asaf Khan (4) Nadar Khan (5) Saiful ah Rs/O Sin Matta and instead of to report real facts to the Police have concealed the offence. In lights of the facts so surfaced proper case vide FIR No.1126 dated 19/09/2018302/202/109/147/149-PPC FS Matta has been registered.

Furthermore, confessional statement of Sohail Khan (accu recorded u/s 164/364 CrPC in the court of Illaga Qazi / Judicial Magistrate M District Swat revealed that his brother (deceased) was unconscious or cied but the Po have placed his thumb impression under the suicide statement as dying declarate which was given to ASI Umar Hayat.

It is worth mentioning here that after dispatching the murasilated in the Police Station Matta, ASI Umar Hayat was aware of the death of de Muhammad Kumail as he had been handed over the dead body as evident from dector's report but he did not bother to collect his clothes or to request the door Postmortem and handed over the dead body of the deceased to the legal heirs we Postmortem examination. Similarly, IHC Gul Muhammad of PS Matta while investige the instant case did not bother himself to collect the clothes of the deceased Muhammad for the doctor for the doctor for the autopsy.

Preliminary Objections:

That all the preliminary objections are incorrect, baseless and against the law, rules and Shariah, hence are specifically denied. Moreover the appellant the has got the prima facie case in his favour and has Honourable Tribunal well within time with clean hands and this honourable Tribunal has got the jurisdiction to adjudicate upon the same.

<u>On Facts:</u>

Para 1 of the comments as drafted is irrelevant to the extent that the appellant has got bad entries as the same has got no nexus with the case in hand.

ii. Para 2 of the comments being admission, hence needs no reply.

iii. Para 3 of the comments as drafted is incorrect, baseless and against the facts, moreover the same is based on misstatements, hence the para is denied specifically.

iv. Para 4 of the comments as drafted is also incorrect, baseless and against the facts. The body was handed over due to the insistence of the legal heirs and their denial to conduct any autopsy, thus the para is denied.

Para 5 of the comments as drafted is irrelevant as the statement / report given to the police at hospital was that of suicide and nothing else, thus the para is denied.

vi. Para 6 of the comments as drafted is incorrect and devoid of merits, hence denied, as the cause of death was certain.

Para 7 of the comments as drafted is incorrect, vii. maneuvered and against the facts. The report of the suicide was made by the legal heirs and the thumb impression was got will the deceased was conscious and that too after the approval of the doctor, the factum of the murder was subsequent much latter to the incident, thus the para is denied.

Para 8 of the comments as drafted also is incorrect viii. and devoid of merits as the factum of murder was the result of another report lodged much latter and the incident at the hospital has got no nexus with the same as the first report was of a suicide only. Moreover the charge sheet and statement of allegations never find any mention of the alleged murder, thus the para is denied.

- b. Ground B of the comments as drafted is also incorrect, baseless and based on misstatements and concealments of facts, thus the same is denied specifically.
- c. Ground C of the comments as drafted is baseless, incorrect, devoid of merits and based on misstatements. The appellant has never been treated in accordance with the law and rules on the subject and has been made to suffer on account of colourful and arbitrary use of authority to the utter detriment of the appellant, thus the para is denied specifically as well.
- d. Ground D of the comments as drafted also is incorrect and devoid of merits as the appellant has never concealed any of the materials relating to the issue, as is clear from the record, thus the para is denied as well.

e. Ground E of the comments as drafted also is incorrect, baseless and reflecting the colourful and arbitrary use of the authority as well, thus the para is denied.



He also failed to get the dead body examined rather handed over the same to legal herrs without carrying out autopsy.

He was issued a charge sheet and statement of allegations vide this office No. 89/PA. dated 01-10-2018 and Addl: SP. Swat was appointed as Enquiry Officer to conduct proper departmental enquiry against the delinquent Police Officer. The Enquiry Officer reported that the Head Constable under enquiry had failed to follow SOP in the abovementioned case which created problems for Police.

The Police Officer under enquiry had failed to collect the deceased's elothes for evidence. He has also failed to get the dead body examined which made the case complicated and created problems for Police. His this act is against discipline and unbecoming of a Police Officer. This warrants punishment. Hence, in exercise of the powers vested in the undersigned under Kules 2 (iii) of Police Disciplinary Rules - 1975, I Syed Ashfaq Anwar, PSP, District Police Officer. Swat being competent authority, am constrained to award him major punishment of removal from service.
