Khan on 19-09-2006, CT Examination on 11-07-2007, MA Examination on 06-01-2010, B. Ed Examination on 10-02-2010, M. Ed Examination on 15-02-2013 and MA on 16-01-2014 with credit. (Copies as Annex "A")

2. That appellant was appointed as PTC on 26-11-1999 and her name was placed at S. No. 59 of the said order. (Copy as Annex "B")

- 3. That the department prepared seniority list of CT's (F) teachers in North Waziristan Agency and the name of appellant was placed at S. No. 25. (Copy as Annex "C")
- 4. That the office finalized list of CT's (F) for promotion of HCT / CT to SST. The name of appellant was placed at S. No. 17 for the purpose. (Copy as Annex "D")
- 5. That on 02-11-2017, notification was issued wherein the candidates from S. No. 01 to 13 were promoted to the post of SST and the name of appellant was dropped / deferred for no legal reason. Here it would be not out of place to mention that in the said notification, candidate at S. No. 01, 11, 12 and 13 were not included in the list of promotion. (Copy as Annex "E")
- 6. That on 13-12-2017, Director Establishment wrote letter to all Agencies Education Officers in FATA now district to complete working papers for promotion of various Teaching Cadres to the post of SST's who were previously deferred due to one or other reason. The date of DPC will be conveyed after completion of documents. (Copy as Annex "F")
- 7. That appellant had submitted all the documents including Service Book with the then Assistant Agency Education Officer NWA Miranshah but perhaps he has not brought the same on surface for promotion before the DPC and as a consequence she submitted representation on 15-03-2018 before the authority for promotion to the post of SST, B-16. (Copy as Annex "G")
- 8. That the Agency Education Officer submitted working paper before DPC for promotion to the said post of the deferred candidate's females general for the purpose and the name of petitioner was figured at S. No. 03. (Copy as Annex "H")
- 9. That on 20-03-2018, R. No. 01 issued order of promotion to the post of SST's. Appellant was again ignored for no reason being senior. (Copy as Annex "I")
- 10. That on 26-03-2018 and 16-08-2018 appellant submitted representations before R. No. 02 for the purpose but the same met dead response till date. (Copy as Annex "J")

Hence this appeal, inter alia, on the following grounds:

GROUNDS:

- a. That appellant has not only the requisite educational qualification for the post but much over and above the same.
- b. That before making promotion to the next higher grade/post, it was the duty of the office concern to inform the heads of the schools to submit the required documents for promotion but no such action was taken by the office concerned and appellant was deprived from promotion for no legal reason.
- c. That the department included other candidates in the promotion list who were not figured in the seniority list for the purpose.
- d. That the colleagues who were even junior to appellant were promoted to the post SST B-16 and appellant was ignored for legal reason.
- e. That appellant had submitted all the required documents to the office of Assistant Director Education Miran Shah but he kept the same for no legal reason and did not bring the same before the DPC for the purpose.
- f. That depriving someone from promotion is a major punishment and appellant was given the said punishment for no legal reason but due to the lapses of the department.

It is, therefore, most humbly prayed that on acceptance of appeal, order dated 20-03-2018 be modified and appellant be promoted to the post of SST B-16 or as the case may be, with such other relief as may be deemed proper and just in circumstances of the case.





- 8. Their academic/professional certificates and degrees will be refer to the concern Board/University by depositing usual fee charges for necessary verifications and their salary will not be drawn until and unless their verifications are received.

Comments on behalf of respondent No. 1, 2, 3

Respectfully Sheweth.

Preliminary Objection.

- 1. That the appellant has got no cause of action, locus standee, to file the instant appeal
- 2. That the appellant has not come to this Honorable court with clean hands.
- 3. That the appellant has estopped by his own conduct to bring the instant appeal.
- 4. That the appellant has concealed material facts from the Honorable Court. In June
- 5. That the appellant is not maintainable in the present form.

On facts.

- 1. No comments. Subject to proof.
- 2. According to the service book of the appellant, she has been appointed as PST teacher on 26.11.1999, and she has taken charge as PST on 28.11.1999.
- 3. Incorrect. Notification No.SO (PE) 4-5/SSRC/Meeting/2013/Teaching Cadre Dated 24.07.2014 regarding Service Recruiting Rules of Teaching Cadre From BPS-12 to BPS-17 on both male & female side was issued. (Copy of the Notification is attached as Annexure-A) In this regard a process of up-gradation/ promotion of various categories of teachers in the education department of farmer FATA were started in the year of 2017. As regard the promotion of Sr.CT Teachers (Male/female) to SST, it has been stated in the notification on page 2, that Seventy five % by promotion on the basis of senioritycum-fitness from the district concerned in the following manner: (a) forty % from amongst the Senior Certified Teachers (Sr.CT) on the basis of Seniority-cum-fitness with at least five years service as Sr.CT/CT and having qualification mentioned in Column No-3. Actually, according to the service book of the petitioner, she was converted from PST to CT and appointed as untrained CT teacher dated 14.09. 2005. And later on, on 14.07.2007 she passed CT certificate and so she became regular CT teacher on 14.07.2007. While making the seniority of the appellant, she should be considered from 14.07.2007. But on the contrary, On the occasion of making working paper for the promotion from Sr.CT/CT to SST in the year 2017, the appellant was included into the working paper on the basis of fake date of regular CT, as 28.11.1999, which is her date of taking over charge as PST rather than the date of her regular posting as CT teacher. (Copy of the working paper is attached as Annexure-B). While her regular CT date is 14.07.2007. Though she failed to submit her original service book before the departmental promotion committee, and thus she was deferred. (Copy of the office order is attached as Annexure-C) And again in the promotion of the deferred candidates, the

DPC was held in 2018, a working paper for the deferred male & female teachers was prepared for DPC. According to that too, the appellant was put on S.No.3. Although she was included into the working paper according to the same fake date of regular CT. For the second time too, the appellant failed to submit the required documents to the member of the committee for DPC. As a result the appellant again failed to get promotion. It should be remembered that in both the working papers attached herewith, her date of regular CT is fake and wrong. (To help this Honorable court, a Copy of the Service Book is attached as a valid proof as Annexure-D).

- 4. Incorrect. That in the 2nd DPC, the respondent department finalized a working paper for the promotion of Sr.CT/CT teachers to SST, In that the appellant was on No.18 in the seniority list. This time her date of regular CT was corrected, and she was included into the seniority list according to the genuine date of regular CT, i.e. 14.07.2007. There were 03seats for promotion to SST and the appellant was on Serial No.7 in the working paper (Copy of the working paper attached as Annexure-E). So due to her low seniority position, she was not recommended for promotion for the third time as well. Similarly, in Oct. 2019, in the DPC, the appellant was put into the working paper on S. # 08, having seniority position on S. # 16 in the seniority list (Copy of the Working Paper attached as Annexure-F) This time also the appellant has low seniority position and there are only 03 seats for promotion. Thus she may not be promoted. It is necessary to mention that the DPC has been completed but the notification for promotion may yet to be issued.
- 5. Incorrect. Correct to the extent that in 2017, the appellant was deferred due to her non-submission of her service book before the committee for DPC. So she failed to get promotion although was included into the working paper on her fake date of regular CT.
- 6. Incorrect. Correct that the appellant was deferred in 2017 but she was given a chance to reappear before the committee for DPC. But she once again failed to submit the required documents, ACR & Service Book and so she failed to get promotion.
- 7. Incorrect. That the plea of the appellant is just the allegations against the respondent department. Actually she was deferred by the committee at FATA Secretariat, Peshawar.
- 8. Correct that the appellant was included into the working paper, mentioned on S. No.3 in 2018. And she was due to be promoted to SST, but she failed to submit the required documents, ACR & Service Book before the committee for DPC. It should be remembered that if the respondent department had any ulterior motives to deprive the appellant from promotion, it would not include her into the working paper.
- 9. Incorrect. Though all the deferred candidates were included into the working paper for promotion, but the candidate on S.NO.3 & 4 again failed to submit the required documents ACRs & service books. And so they did not get promotion.
- 10. Incorrect. The appeals of the appellant before the high ups were not based on strong grounds, therefore, such appeals were not considered.
- 11. Keeping in view the above facts, the instant appeal may kindly be dismissed on the following grounds.

Grounds:

- a. Incorrect, that the basic requirement for promotion is the seniority position of the appellant, which she lakes.
- b. Here the appellant accepts that she was not informed on time about the promotion; otherwise she would submit her documents on time. It means that she was herself at fault to submit her service book and other documents for promotion. Actually notices are displayed on the notice Board of the main Office for promotions etc.
- c. Incorrect. All qualified and deserving candidates are included into the merit list for promotion. And such lists are displayed on the notice board and checked by the teachers without any difficulties.
- **d.** Incorrect. Those who have already been promoted to the post of SST are senior to the appellant.

- e. Incorrect. The allegation of the appellant in this para is just for the defamation of the respondents. The fact is that she has always been included into the working paper, but in the first 2 DPCs held in 2017 & 2018 she failed to submit her documents, ACR and Service book. Resultantly, she failed to get promotion, although she was included into the working paper on the basis of fake/wrong date of regular CT.
- f. Incorrect. Promotion is given on the basis of seniority. At the moment the appellant is not that much senior to be promoted to the post of SST.

g. The respondents seek the permission of this Honorable court to advance other points at

the time of arguments



- 1. That appellant passed PTC examination from the Education Department on 31-03-2002. She passed her BA examination from Gomal University D.I. Khan on 19-09-2006, CT Examination on 11-07-2007, MA Examination on 06-01-2010, B. Ed Examination on 10-02-2010, M. Ed Examination on 15-02-2013 and MA on 16-01-2014 with credit. (Copies as Annex "A")
- 2. That appellant was appointed as PTC on 26-11-1999 and her name was placed at S. No. 59 of the said order. (Copy as Annex "B")

- 3. That the department prepared seniority list of CT's (F) teachers in North Waziristan Agency and the name of appellant was placed at S. No. 25. (Copy as Annex "C")
- 4. That the office finalized list of CT's (F) for promotion of HCT / CT to SST. The name of appellant was placed at S. No. 17 for the purpose. (Copy as Annex "D")
- 5. That on 02-11-2017, notification was issued wherein the candidates from S. No. 01 to 13 were promoted to the post of SST and the name of appellant was dropped / deferred for no legal reason. Here it would be not out of place to mention that in the said notification, candidate at S. No. 01, 11, 12 and 13 were not included in the list of promotion. (Copy as Annex "E")
- 6. That on 13-12-2017, Director Establishment wrote letter to all Agencies Education Officers in FATA now district to complete working papers for promotion of various Teaching Cadres to the post of SST's who were previously deferred due to one or other reason. The date of DPC will be conveyed after completion of documents. (Copy as Annex "F")
- 7. That appellant had submitted all the documents including Service Book with the then Assistant Agency Education Officer NWA Miranshah but perhaps he has not brought the same on surface for promotion before the DPC and as a consequence she submitted representation on 15-03-2018 before the authority for promotion to the post of SST, B-16. (Copy as Annex "G")
- 8. That the Agency Education Officer submitted working paper before DPC for promotion to the said post of the deferred candidate's females general for the purpose and the name of petitioner was figured at S. No. 03. (Copy as Annex "H")
- That on 20-03-2018, R. No. 01 issued order of promotion to the post of SST's. Appellant was again ignored for no reason being senior. (Copy as Annex "I")
- 10. That on 26-03-2018 and 16-08-2018 appellant submitted representations before R. No. 02 for the purpose but the same met dead response till date. (Copy as Annex "J")

Hence this appeal, inter alia, on the following grounds:

GROUNDS:

- a. That appellant has not only the requisite educational qualification for the post but much over and above the same.
- b. That before making promotion to the next higher grade/post, it was the duty of the office concern to inform the heads of the schools to submit the required documents for promotion but no such action was taken by the office concerned and appellant was deprived from promotion for no legal reason.
- c. That the department included other candidates in the promotion list who were not figured in the seniority list for the purpose.
- d. That the colleagues who were even junior to appellant were promoted to the post SST B-16 and appellant was ignored for legal reason.
- e. That appellant had submitted all the required documents to the office of Assistant Director Education Miran Shah but he kept the same for no legal reason and did not bring the same before the DPC for the purpose.
- f. That depriving someone from promotion is a major punishment and appellant was given the said punishment for no legal reason but due to the lapses of the department.

It is, therefore, most humbly prayed that on acceptance of appeal, order dated 20-03-2018 be modified and appellant be promoted to the post of SST B-16 or as the case may be, with such other relief as may be deemed proper and just in circumstances of the case.
