



Counsel for the appellant Muhammad Ismail present. Preliminary arguments heard. It was contended by learned counsel for the appellant that the appellant is serving in Police Department as Junior Clerk in the office of District Police Officer (Bannu). It was further contended that the appellant received letter dated 03.07.2018 wherein adverse remarks regarding Annual Confidential Report with effect from 28.4.2017 to 31.12.2017 was received against the appellant. It was further contended that adverse remarks was regarding the period with effect from 28.04.2017 to 31.12.2017 but the same was received to the appellant through letter dated 03.07.2018 after a delay of more than eleven months. It was further contended that the appellant filed departmental appeal on 17.07.2018 which was rejected on 25.10.2018 and thereafter, filed mercy petition on 12.11.2018 which was rejected on 06.12.2018 and received to the appellant on 10.12.2018 hence, the present service appeal on 07.01.2019. It was further contended that before the impugned adverse remarks neither any opportunity of counseling or warning was provided to the appellant nor the adverse remarks was communicated to the appellant within the stipulated period therefore, the impugned adverse is illegal and liable to be set-aside.

The contention raised by the learned counsel for the appellant needs consideration. The appeal is admitted for regular hearing subject to all legal objections. The appellant is directed to deposit security and process fee within 10 days, thereafter, notice be issued to the respondents for written reply/comments for 26.03.2019 before S.B.





G. That the appellant has not been provided opportunity of fair trial as guaranteed by Art 10-A of the constitution of Islamic Republic of Pakistan 1973.


