





SERVICE APPEAL UNDER SECTION 4 OF KPK SERVICE TRIBUNAL ACT 1974, FOR DECLARATION TO THE EFFECT THAT THE SPECIAL ALLOWANCE @ 20% WHICH HAS ALREADY BEEN GIVEN TO SOME EMPLOYEE OF THE DEPARTMENT AND DISALLOWING TO PETITIONERS IS DISCRIMINATORY, PERVERSE, AGAINST THE LAW AS WELL AS IS IN VIOLATION OF ARTICLE 25 OF CONSTITUTION OF ISLAMIC REPUBLIC OF PAKISTAN 1973 WITH THE PRAYER THAT THE SAME MAY BE GRANTED TO THE APPELANTS FROM THEIR DUE DATE.

Respectfully Sheweth:-

- That the Appellants are the permanent/ regular employees of the District Office, Social Welfare, Special Education & Women Empowerment Department Abbottabad and performing their functions since the date of their appointment. (List of date of appointment is attached as ANNEXURE-A)
- 2. That the Appellants are supervised by Provincial Secretariat and Directorates of Social Welfare Special Education and women Empowerment Department KPK. (Organogram of Secretariat and Directorate is attached as **ANNEXURE-B**)
- 3. That the Appellants are the executor/implementing body of policies/activities lay down by the Provincial Secretariat and Directorate. It is the primary and utmost responsibility of the District Office to execute all the functions of Provincial Secretariat and Directorate at District level in its true spirit. The Appellants leave no stone unturned to complete the Herculean Task. That the said department is a vital sector in National Development.(Activities of Secretariat and Directorate are attached as **ANNEXURE-C**)
- 4. That the Appellants are directly supervising two Prime Institutions under its direct control i.e. "SPECIAL EDUCATION INSTITUTE"& "WOMEN EMPOWERMENT INSTITUTE". Apart from manifold functions it has two-fold major approaches i.e. Public Sector Development& Voluntary Sector Program. It does not only focus on poor communities and neglected

Segment of our society but also to eradicate Social Evils. (Structure of the said institutions is attached as **ANNEXURE-D**)

- 5. That the Appellants have the onerous onus on its shoulders to cater all these activities irrespective of any cast, colour and creed. That the appellants have to burn the mid-night oil in the line of Duty.
 - 6. That the Government of NWFP (Now Khyber Pakhtunkhwa) Finance Department under Notification NO. FD (SOSR II) 8-57/2005.Endst: No. & date even Dated Peshawar 01/11/2006 sanctioned the grant of Special Allowance @ 20% of the initial basic Pay Scale to the physically blind regular staff (Both Teaching and ministerial staff) of Special education Institutions in N.W.F.P working under the control of Zakat, Usher, Social Welfare and Women Development Department N.W.F.P with immediate effect. (Notification is attached as ANNEXURE-E)
 - 7. That the Government of Khyber Pakhtunkhwa Finance Department is providing special Allowance to the Government Blind Institutes in Swabi, Mardan, Abbottabad, Swat and D.I Khan under Notification Endst: No. & of even Dated Peshawar the 25/05/2010. (Notification is attached as **ANNEXURE-F**)
- That the Appellants approached the office of the respondent No 2, The Secretary Social Welfare Special Education & Women Empowerment Department Khyber Pakhtunkhwa Peshawar, for grant of special allowance @20% to all staff of Social Welfare Department but all in vain. (copy of appeal is attached as ANNEXEURE-G)
- 9. That the impugned Notifications, NO. FD (SOSR II) 8-57/2005.Endst: No. & date even Dated Peshawar 01/11/2006 and Endst: No. & date even Dated Peshawar the 25/05/2010 are not implemented with its true spirit which are discriminatory in the eyes of law, hence, same is liable to be implemented in the instant department inter-alia on the following grounds:

<u>GROUNDS</u>

1

- a. That the allowances allowed through the impugned notifications does not have limited scope up to sections of parent Department of Social Welfare, Special education and Women Empowerment. But the refusal to the Appellants is without having lawful justification.
- b. That non-inclusion of the Appellants department in the impugned list amounts to penalizing the Appellants by not considering their worth and scope of work which negates the natural justice.

- c. That the Appellants feeling aggrieved had filed departmental representation to respondent No. 2 for doing the needful but in vain because till now nothing was done.
- d. That the act of respondents is against the law, discriminatory, perverse and negation of fundamental rights of the Appellants.
- e. That the instant Appeal is filed well within time after following all the required Codal formalities.

It is therefore humbly prayed that instant Appeal may kindly be accepted and the respondents may be directed to grant special allowance @20% to the Appellants from the date of the receipts of NOTIFICATION.

Any other relief which this Hounourable Tribunal deems fit and appropriatemay kindly also be granted.
