The petitioner submits as under:

- 1. That the petitioner while serving as Data Processing Supervisor at District Swat was dismissed from service on 09-01-2018.
- 2. That the petitioner filed Service Appeal before this honorable tribunal against the impugned order dated 09-01-2018 of DPO Swat which was Accepted and the impugned order dated 09-01-2018 was set aside and the petitioner was reinstated into service, and the respondents were directed to conduct de novo enquiry strictly in accordance with law within the period of Ninety days from the date of receipt of this judgement. The issue of back benefit shall be subject to the outcome of de novo enquiry. It is pertinent to mention here that the stipulated time period for conducting the de novo enquiry is already elapsed and no any order of the respondents have been concluded yet which also amounts to the violation of the order of this honorable tribunal. (Copy of order dated 10-01-2019 of this honorable Tribunal is attached here as Annex A).



- 3. That the petitioner was reinstated and joined the duty on 25-02-2019, then, the petitioner was summoned by the DPO Swat and issued a charge sheet in which the Addl. SP Swat Khankhel was nominated as Enquiry Officer for the purpose of de novo enquiry. The enquiry officer submitted his findings report on 29-03-2019 and recommended the petitioner for minor punishment as already suffered punishment. Then, the recommendations of the Enquiry Officer was sent by DPO Swat to Addl. IG Headquarters vide letter No. 93/PA dated 12-04-2019 duly received by Addl. IG Headquarters, and then, the Addl. IG Headquarter referred the case/finding report of the Enquiry Officer to AIG Legal for expert opinion who responded on 22-05-2019 with the recommendation to issue a fresh charge sheet to the petitioner and committee be constituted for this purpose consisting of IT Experts who shall conclude their enquiry within fifteen days, subject to the approval of the Addl. IG Headquarter. It is pertinent to mention here that all the enquiry documents are in the possession of the Enquiry Officer and Addl. IG Headquarter and the petitioner requested the said documents for the purpose of filing this application, but the same were refused to be provided to the petitioner, hence, not attached herewith this instant petition. While, note sheet regarding the opinion and recommendations of AIG Legal and order dated 25-02-2019 along with better copies are attached herewith as Annex B & C.
- 4. That on 30-05-2019 Addl. IG Headquarter ordered the de novo enquiry of the petitioner with immediate effect but the same was already conducted by Addl. SP Swat but the same was ignored/skipped in the mentioned order and it did not make any reference to the de novo enquiry which had already been conducted by Addl. SP Swat. It is further averred that time so prescribed and directed by this August Tribunal has been elapsed and the respondents have badly failed to comply with the directions so issued by this honorable tribunal in judgment dated 10-01-2019. The said directed enquiry has been used as a rolling stone to humiliate and degrade the petitioner and his professionalism as the de novo enquiry is already conducted but skipped and ignored in the fresh order of the Addl. IG Headquarter dated 30-5-2019, moreover, the time prescribed by this honorable tribunal has already been elapsed and no further extension has been taken by the respondents which is in total violation of the judgment of this honorable tribunal, and, any such order or enquiry conducted after the expiration of the time so provided, would be totally illegal and in violation as per the spirit of the judgment of this honorable court dated 10-01-

2019. (Copy of order dated 30-05-2019 of Addl. IG Headquarter alongwith better copy is attached herewith as Annex D).

- 5. Delinquent official Nadeem Iqbal (Data processing supervisor swat) was dismissed form service by DPO swat of the allegation that while his posting as data entry Incharge for documentation of NCP Vehicles tried to intrude into the system with the intention to steal and manipulate the data. He was dismissed from service by DPO Swat, he lodged Service Appeal against the order of DPO Swat. The honorable tribunal accepted his appeal vide judgment 10-01-2019. The operative paras 4 and 5 of the judgment are reproduced as under:

- 4. Record available on the case file revealed that the appellant was appointed by the Addl. Inspector General of Police while the proceedings were initiated and finalized by the DPO Swat who was otherwise not competent to proceed in this case, impugned order passed by the DPO Swat was corum-non-judice and void ab-initio. As the entire proceedings became null and void due to non preservince of rules so we did not deem it appropriate to touch other aspects of the case.
- 5. As a sequel to above, the appeal is accepted, the impugned order dated 09-01-2018 is set aside and the appellant is reinstated in service. The respondents are directed to conduct a de-novo enquiry strictly in accordance with the law within a period of 90 days from the day of receipt of this judgment.

Addl. SP Khankhel was nominated as enquiry officer for de-novo purpose, appellant was reinstated by DPO Swat for the purpose of de-novo proceedings. Charge sheet was issued by DPO Swat, enquiry officer submitted enquiry report dated 29-03-2019 and held him guilty and recommended him for minor punishment as already suffered punishment. Findings of the enquiry officer were received by DPO Swat video letter No. 93/PA dated 04-02-2019. The case was referred to AIG Legal for expert opinion who submitted his report vide Para 13 of the ante note sheet that as per IT Riles 2014, the appointing authority for BPS-16 is Addl. IG Headquarter and the service tribunal in its judgment dated 10-01-2019 has also declared the impugned order of DPO Swat void ab-intio due to this flaw.

In view of above, fresh charge sheet may be issued and enquiry committee consisting of an IT experts may be constituted to conclude the enquiry within 15 days, if approved.
