JUDGEMENT: -

Mr. ATTIQ UR REHMAN WAZIR: - Appellant Mr. Nazar Hussain, Inspector Kohat Police has assailed the order dated 27-11-2018, whereby the departmental appeal of the appellant for confirmation and placing his name with colleagues/ batch mates has been rejected.

2. Brief facts of the case are that the appellant initially appointed as ASI on 28-12-2006 and confirmed as ASI on 29-06-2010 from the date of appointment. His name brought on list E and further promoted to SI on officiating basis along with his colleagues dated 24-08-2010. In DPC

meeting held on 06-02-2013, the appellant deferred due to deficiency, while his other colleagues confirmed as SI vide order dated 24-08-2013. The appellant confirmed as SI in subsequent DPC w.e.f. 03-01-2014 instead of 06-02-2013, where his other colleagues were confirmed. That seniority list issued on 29-06-2018, where the appellant placed at Serial No 297, whereas his colleagues are at Serial No 90,91,92 and 93. Appellant filed departmental appeal dated 28-08-2018, rejected on 27-11-2018, hence the instant service appeal with prayers that the impugned order dated 27-11-2018 may be set aside and name of the appellant be placed in confirmation list with his colleagues/batch mates with all back benefits.

3. Written reply/comments were submitted by respondents.

4. Arguments heard and record perused.

5. Learned counsel for the appellant contended that the appellant initially appointed as ASI on 28-12-2006, subsequently confirmed on 29-06-2010 from the date of initial appointment. That the appellant promoted as officiating SI on 24-08-2010. That in a DPC meeting held on 06-02-2013, other colleagues of the appellant were confirmed as SI vide order dated 20-02-2013, whereas the case of appellant was deferred, being not completed PTC posting period. That appellant confirmed as SI in subsequent DPC w.e.f. 03-01-2014 instead of 06-02-2013, where his other colleagues were confirmed. The learned counsel argued that as per minutes of the same DPC dated 06-02-2013, at serial No 2, an officiating SI, Gharib Nawaz deferred in previous DPC dated 15-08-2012 for want of deficiency was confirmed with his colleagues confirmed earlier vide DPC dated 15-08-2012. That the case of the appellant being the same was not

considered by the subsequent DPC and the appellant confirmed with immediate effect inspite of the fact that he was deferred and not superseded. That in case of deferment the seniority is not affected after fulfillment of the deficiency. That it is the legal right of the appellant to be confirmed from the date, his other colleagues were confirmed. That final seniority list issued on 29-06-2018 placed the appellant on Serial No 297, whereas his colleagues/batch mates are at Serial No 90, 91, 92 and 93. That such act of the respondents was discriminatory and against law and the appellant has not been treated in accordance with law; hence, his rights secured and guaranteed under the constitution were badly violated. The learned counsel referred to the judgments of this tribunal in service appeal No 407/2011, 1227/2013 and Service Appeal No 197/2016, where in similar nature cases, relief has been granted by this tribunal. The learned counsel also referred to the judgments of supreme court of Pakistan in 2006 SCMR 1938 and 2002 PLC (CS) 1388. On question of limitation the learned counsel referred to the judgment of supreme court of Pakistan in 2002 PLC (CS) 1388 and 2009 PLC (CS) 178, where on the issue of promotion, pay and other emoluments, limitation would not foreclose his right accrued to him. The learned counsel prayed that in view of the situation, the impugned order dated 27-11-2018 may be set aside and the respondents may be directed to place the name of the appellant in confirmation list with his colleagues/ batch mates by ante dating his confirmation to meet the end of justice with all back and consequential benefits of service.

6. The learned Deputy District Attorney appeared on behalf of official respondents opposed the contention of learned counsel for appellant. He argued that the appeal is badly time barred in the first place as his seniority affected in the year 2014, whereas the appellant preferred appeal in 2018 after issuance of seniority list in 2018. Reliance Civil appeal No 566/2020. The learned Deputy District Attorney further argued that the appellant had not qualified/ completed the mandatory period of posting required for confirmation, hence not confirmed in the DPC meeting. That after completion of mandatory posting period, the appellant confirmed to the rank of SI under section 13.18 of Police Rules 1934. The learned Deputy District Attorney prayed that the instant appeal being devoid of merit may be dismissed.


7. We are conscious of the fact that time limitation needs to be kept in mind, but in the light of judgments of Supreme Court of Pakistan referred to above ~~and~~ in view of provisions of S.23 of Limitation Act 1908, the appellant has a continuous cause of action and issuance of seniority list at belated stage by respondents created a fresh cause of action for the appellant, not knowing the fact that his confirmation in 2014 with immediate effect would entail seniority issue at a later stage. Moreover, deferment shall not debar the appellant from confirmation from the date of his deferment, after making good the deficiency. We did not find anything adverse on record except deferment to substantiate his confirmation on a later date. We also did not notice any other seniority list on record except the revised seniority list issued on 22-06-2018. It also established from the prevailing rules that civil servants selected for promotion to a higher post in

one batch shall, on their promotion to the higher post, retain their inter se seniority as in the lower post. Moreover this Tribunal as well as Supreme Court of Pakistan in number of Judgments have granted relief in similar cases.

8. In the light of facts and circumstances of the present case, the instant appeal is accepted, the impugned order dated 27-11-2018 set aside with the directions to the respondents to place the name of the appellant in confirmation list with his batch mates and accordingly revise the seniority list with all consequential benefits. No orders as to costs. File be consigned to the record room.

**RESPECTFULLY SHEWTH:
FACTS:**

1. That the appellant was appointed as ASI on 28.12.2006. Ever since his appointment the appellant performed his duties as assigned to him with full devotion and honesty and there is no complaint whatsoever regarding his performance. **(Copy of order dated 28.12.2006 is attached as Annexure-A)**
2. That the appellant was confirmed as ASI on 29.06.2010 from the date of appointment and his name was also brought on promotion list E and further promoted to to SI on officiating basis along with his colleagues/batch mates vide order dated 24.08.2010. **(Copies of 29.06.2010 and 24.08.2010 are attached as Annexure-B&C)**
3. That on 06.02.2013, meeting on DPC was held where colleagues/juniors were confirmed as Sub Inspector vide order dated 20.02.2013, while the appellant was differed being not completed PTC posting period. **(copies of DPC meeting minutes and order dated 06.02.2013 are attached as annexure-D&E)**
4. That the appellant was confirmed as SI vide order dated 10.01.2014 with effect from 03.01.2014 instead of 06.02.2013 where his colleagues/ batch mates were confirmed. **(Copy of order dated 10.01.2014 is attached as annexure-F)**
5. That due to belated confirmation of the appellant, the seniority of the appellant was also effected as the respondent department issued the final seniority list on 29.06.2018 where in the appellant was placed at SNo.297, while his colleagues/ batch mates are placed at S No.90, 91, 92, 93 respectively. **(Copy of seniority list is attached as annexure-G)**
6. That the appellant filed departmental appeal against the impugned seniority list, which was rejected on 27.11.2018 for good grounds. **(Copies of departmental appeal and rejection order are attached as annexure-H&I)**
7. That now the appellant come to this august tribunal on the following grounds amongst others.

GROUND:


- A) That the rejection dated 27.11.2018 and impugned seniority list dated 29.06.2018 are against the law, facts, norms of justice and material on record, therefore not tenable.
- B) That the appellant has not been treated in accordance with law and hence his rights secured and guaranteed under the constitution were badly violated.


- C) That the appellant was differed and was not superseded, therefore, it is the legal right of the appellant to confirm from the date and assign his due seniority from the date when his colleagues/juniors were confirmed and have given seniority after fulfilling the criteria for confirmation.
- D) That reason on which the appellant was differed from confirmation as SI was fulfilled, therefore there remain no ground to deprive the appellant from confirmation from the date on which his colleagues/ batch mates were confirmed i.e 06.02.2013.
- E) That the appellant was discriminated, because his colleagues and juniors to him have been confirmed as SI w.e.from 06.02.2013 and the appellant has been ignored for no fault on his part due to which his seniority also effect.
- F) That by not restoring the original seniority of the appellant it will violation of fundamental right of the appellant and will great miscarriage of justice.
- G) That the appellant has good service record and there was no impediment to confirm him as SI from his due date and restore his original seniority.
- H) That the appellant seeks permission to advance others grounds and proofs at the time of hearing.


It is, therefore most humbly prayed that the appeal of the appellant may be accepted as prayed for.

- E. That colleagues of the petitioner namely Fazal Hanif, Muhammad Yousaf, Nazeer Khan and Abid Khan etc were confirmed as Sub Inspector on the due date i.e. 06.02.2013.
- F. That the petitioner after making good the deficiency was also required to be confirmed on 06.02.2013 alongwith his colleagues but the petitioner is sheer violation of the rules was confirmed on 10.01.2014.
- G. That the belated confirmation of the petitioner has significantly affected seniority of the petitioner and also impugned the seniority List published on 29.06.2018.
- H. That in the impugned seniority list the petitioner is placed at serial No. 297 while his colleagues are placed in serial Nos. 90, 91, 92, 93 respectively.

- I. The impugned seniority list published on 29.06.2018 has affected inherent rights of the petitioner, therefore, he has become aggrieved and following are some of the grounds of representation.

Grounds:-

1. That the impugned seniority list of inspectors and sub Inspectors on list "F" of KPK Police as it stood on 22.06.2018 and published / Circulated vide No. 618-36/E-II dated 29.06.2018 is against law, facts and evidence on the record.
2. That it is very crystal clear that petitioner was recruited alongwith ASI Fazal Hanif at serial No. 91, Muhammad Yousaf at serial No. 92 and Abid Khan at serial No. 93 of the seniority list.
3. That though at the time of confirmation of the petitioner, the petitioner was differed being not completed PTC posting but it is also an admitted fact that the said deferment is not to suppose to affect the seniority of the petitioner.
4. That as soon as the deficiency is made good it is the requirement of the law / rules that the affectee shall be placed at the original place of seniority.
5. That seniority is the inherent right of a civil servant which cannot be affected by any deficiency or lacuna.
6. That as stated above, colleagues of the petitioner namely Fazal Hanif, Muhammad Yousaf, Nazir Khan and Abid Khan were confirmed as SI on 06.02.2013 and admitted to list "F" on 13.08.2013, the petitioner being their colleague and having made good the deficiency was also required and deserve to be confirmed as SI and admitted to the list "F" on 06.02.2013 and 13.08.2013 respectively.
7. That instead of the above, the petitioner in sheer violation of the rules was confirmed in the rank of SI on 10.01.2014 and admitted to the list "F" on 05.11.2014.
8. That upon removal of the deficiency i.e completion of the PTC Posting Period the petitioner should have been restored at his original seniority with colleagues but due to the reason best known to the concerned, the petitioner has been deprived of his original seniority.
9. That by not restoring the original seniority of the petitioner, the authority has infringed his inherent and fundamental right.
10. That the revised seniority list of Inspectors and sub Inspectors on list "F" of KPK Police as it stood on 22.06.2018 circulated vide No.618-36/E-II, dated 29.06.2018 needs to be revised.
11. That the Impugned seniority list is not accordance with law and justice.

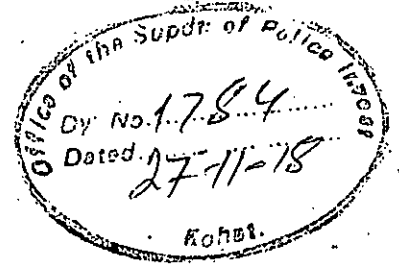

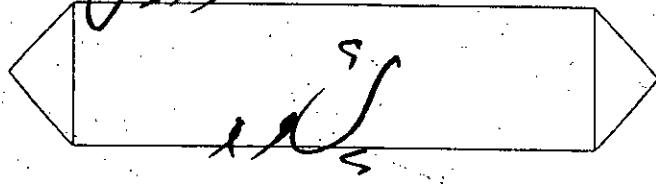

PARAWISE COMMENTS ON BEHALF OF RESPONDENTS.

Respectively Sheweth:-

Parawise comments on behalf of respondents are submitted as under:-

Preliminary Objections:-

- a. That the appellant has got no cause of action.
- b. That the appellant has got no locus standi.
- c. That the appeal is not maintainable in the present form under section 4 of Khyber Pakhtunkhwa, Service Tribunal Act.
- d. That the appeal is not maintainable for misjoinder and non-joinder of the parties.
- e. That the officials with whom seniority, the appellant is aggrieved have not been placed as respondents, hence the appeal is not maintainable in the present form.
- f. That valuable rights of the other officials of the impugned seniority list are involved, and they are necessary party, but the appellant deliberately avoided to implead them as, respondents hence the appeal is defective in eyes of law.
- g. That the appellant had not filed departmental appeal / representation against the impugned order, hence the appeal is bad in the eyes of law.
- h. That the appeal is time barred.

ON FACTS:-

1. Pertains to record, hence no comments.
 2. Pertains to record, however, it is submitted that confirmation rules of Assistant Sub Inspector, are very much clear as envisaged in Police rules 12.2(3), 12-8 and 13.18.
 3. Pertains to record. However, it is added that the appellant had not qualified / completed the mandatory period of posting required for confirmation. Therefore, the appellant was not confirmed in the Departmental Promotion Committee for the deficiency described in the minutes of the meeting.

4. After completion of mandatory posting period, the appellant alongwith others was confirmed to the rank of sub inspector as required under Police Rules 1934, 13.18. Hence, the appellant was redressed in accordance with the existing rules.
5. Incorrect, the appellant was confirmed to the rank of sub inspector in accordance with relevant law and rules. Furthermore, on completion of mandatory requirements, the appellant was placed at seniority list F of Khyber Pakhtunkhwa Police at his due seniority number / place.
6. The departmental representation of the appellant was unjustified and against the mandatory rules envisaged for impugned confirmation. Hence the plea of the appellant was not worth consideration.
7. Incorrect, as, If the appellant was aggrieved from the order of Respondent No. 2, he was at liberty to approach respondent No. 1, but he did not approach and directly filed service appeal before this Honorable Tribunal, which is bad in eyes of law.


ON GROUNDS:-


- A. Incorrect, as the impugned order dated 27.11.2018 and impugned seniority list dated 29.06.2018 are in accordance with law, facts, norms of justice & material on record, hence, tenable in the eyes of law.
- B. Incorrect, the appellant was treated in accordance with Police Rules 1934 i.e 12.2(3) and 13.18.
- C. Incorrect, the appellant had not qualified the requisite criteria i.e completion of the mandatory period. Therefore, he was deferred from confirmation during DPC held on 06.02.2013. However, on completion of the requisite period he was considered for confirmation which is in accordance with law / rules.
- D. Incorrect, the appellant was rightly differed during impugned DPC, however confirmed soon after completion of the requisite criteria in the subsequently DPC held.
- E. Incorrect, the appellant was treated in accordance with rules and no question of any discrimination occurs.
- F. Incorrect, the seniority list F has been maintained in accordance with the rules and the appellant was placed correctly on due seniority term / place. Therefore, no fundamental right of the appellant is violated.
- G. Irrelevant, confirmation and seniority of government servant / Police officers is being maintained in accordance with law & rules.

H. The respondents may also be allowed to advance other grounds, if any during hearing of instant appeal.

In view of the above facts and available record, it is submitted that the appeal in hand being devoid of merits and without any substantiate, may graciously be dismissed with cost.


