Further it is added that as per Ruls-17 (2) of APT Rules, 1989 it is clear that seniority and various cadre of Civil Servants appointment by Initial Recruitment vis-a-viz those appointed otherwise shall be determined with the reference to the dates of their regular appointment to a post in that cadre provided if two dates are the same, the person appointed otherwise shall rank senior to the person appointment by the initial recruitment.
3. Incorrect. The appeal of the appellant is well in time.

8. Denied. Matter related to Court.
9. Correct to extant that the seniority of the employees whom were selected through Public Service Commission were determined on the basis of merit list maintained by the PSC. Remaining contention of the respondent is incorrect and misleading. Moreover the respondent department violated the principal of estoppel by disturbing the seniority position of the appellant after lapse of more than 8 years. The respondents not challenge the seniority list which was issued time to time but challenge after 8 years malafidely at the time of promotion of the appellant. Further the contention of respondent is already rejected by the supreme court of Pakistan in similar nature case. The contention of respondent also be neglected in light of Section 17(2) of APT rules 1989, as per Ruls-17 (2) of APT Rules, 1989 it is clear that seniority and various cadre of Civil Servants appointment by Initial Recruitment vis-a-viz those appointed otherwise shall be determined with the reference to the dates of their regular appointment to a post in that cadre provided if two dates are the same, the person appointed otherwise shall rank ~~as~~ senior to the person appointment by the initial recruitment. Copy of the seniority list are attached as Annex-R, R1 & R2.

It is pertinent to mention here that before the Special Committee inquiry committee was constituted for the purpose of determination of seniority which was concluded in favour of appellant and recommended that the seniority position of promoted officer deserve to ~~be~~ place ahead of all those initial recruited which is a matter equity, justice and fair play and is also near to the rules. Further it is added that as per Ruls-17 (2) of APT Rules, 1989 it is clear that seniority and various cadre of Civil Servants appointment by Initial Recruitment vis-a-viz those appointed otherwise shall be determined with the reference to the dates of their regular appointment to a post in that cadre provided if two dates are the same, the person appointed otherwise shall rank to the senior to the person appointment by the initial recruitment.
