

**RESPECTFULLY SHEWETH:**

**Preliminary Objections:**

(A-E) All objections raised by the respondents are incorrect and baseless. Rather the respondents are estopped to raise any objection due to their own conduct.

**FACTS:**

1. Admitted correct by the respondent Department as service record has already in custody of the respondent department. Moreover, the appellant was promoted in DPC meeting held on 10.10.2012 which is evident from the recommendation of the DPC and from the letter dated 23.10.2012 which was issued to Director General Technical Education and Manpower Khyber Pakhtunkhwa, Peshawar wherein the DG Technical Education was directed to submit the posting/proposal of the promoted candidates under intimation to this Department immediately. Thereafter the Deputy Director (Admn) submit posting proposal of the promotees wherein the appellant was at Sr. No. 9 vide letter dated 07.11.2012. So it is clear that the appellant was promoted on 10.10.2012 but posting order of the appellant was issued on 14.12.2012. **Copy of the DPC minutes, letter dated 23.10.2012 and posting proposal is attached as Annex-R, R1 & R2.**
2. Admitted correct by the respondent Department as service record has already in custody of the Respondent Department.

4. Incorrect and misleading. While para-4 of the appeal is correct. Moreover, as per Ruls-17 (2) of APT Rules, 1989 it is clear that seniority and various cadre of Civil Servants appointment by Initial Recruitment vis-a-viz those appointed otherwise shall be determined with the reference to the dates of their regular appointment to a post in that cadre provided if two dates are the same, the person appointed otherwise shall rank senior to the person appointment by the initial recruitment. So the contention of the respondent regards the promotee place between initial recruiters is totally illegal and against the law. Which is further clarified by the Judgment of the Supreme Court of Pakistan wherein clearly stated that factors light the dates of the recommendation or selection by PSC is not used as a tool for determination of seniority but seniority is related only to the actual dates of promotion and initial appointment. Further it is added that the minutes of the Special Committee attached hereby with the comments not based on true facts. It is pertinent to mention here that before the Special Committee inquiry committee was constituted for the purpose of determination of seniority which was concluded in favour of appellant and recommended that the seniority position of promoted officer deserve to be place ahead of all those initial recruited which is a matter equity, justice and fair play and is also near to the rules. **Copies of the appointment order of Abdul Rashid is attached as Annexure-R3**
5. Admitted correct by the respondent Department as service record has already in custody of the Respondent Department.

**GROUNDS:**

- A) Incorrect. While Para-A of grounds of the appeal is correct.

Moreover, as per Supreme Court Judgment the right of the appellant is clearly violated by the respondents hence the appellant has right to be placed senior to the private respondents as per judgment of the Supreme Court of Pakistan. Further it is added that some of the private respondents at the time of promotion of the appellant even not called for interview so the private respondent has no right to be claimed seniority over

appellant. Copy of the interview letter is attached as Annex-R4.

- D) Incorrect, while Para-D of the appeal is correct. Moreover the seniority list was disturbed after lapse of 08-Years which is not permissible in the eyes of law and as per judgment of the Supreme Court of Pakistan. Further it is added that some initial recruiters (so-called batch) were promoted to the post of BPS-18 but no objection has been raised by the respondents but when letter was issued by Section Officer-PSB for promotion of the appellant then malafidely respondents agitated the matter of seniority only to deprive the appellant for promotion to the post of BPS-18. Copy of the promotion order is attached as Annex-R5

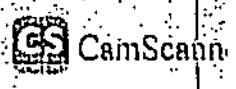

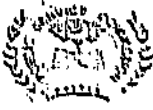

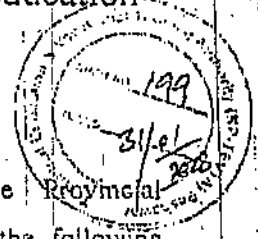
