Likewise inquiry report dated 17.08.2021 (*Annex:-Rj/1*).
- 4-7. Incorrect hence not admitted. While detailed assertions have made in the memo of the Service Appeal.

### <u>Grounds:</u>

A-F. Incorrect, the grounds as mentioned in Reply are not upto the mark as contended by the answering Respondents while the grounds embodied in the writ petition are well reasoned based upon prevailing laws.

It is, therefore, humbly prayed that the reply of answering Respondents may graciously be rejected and the appeal as prayed for may graciously be accepted with costs.

INQUIRY REPORT

#### BACKGROUND OF THE CASE

Salaries of the following Class-IV employees of Elementary & Secondary Education Department, Khyber were stopped during the militancy at Bara District Khyber formerly Agency by the then DEO. Khyber w.e.f the dates mentioned against each employee:-

Their salaries were released in compliance of the Judgment dated 15:05:2019 of the Hon ble Peshawar High Court, Peshawar from the month of August, 2019(F/A). However, the remaining due salaries from the date of stoppage to July, 2019 are still not paid to them. They are claiming their pending saturies to be paid to them.

Before paying them the stopped salaries, the Directorate of Education Merged Areas. Khyber Pakhtunkhwa, Peshawar desired for knowing reasons for stoppage of their salaries, lest there be any legal hurdles and release of the pending salaries to them may result in an illegal action. To avoid any such action, the matter needs to be probed properly, therefore, the Directorate constituted the following Inquiry Committee, vide Notification No. 4042-46/E-Mieneral file/Khyber dated 30.03.2021:-

#### PROCEEDINGS OF THE INOURY

The Inquiry Committee visited the schools of posting of the employees concerned and checked their respective service record available in the schools. Relevant record at the D.E.O khyber was also consulted. All the four employees were also heard in person, Judgment of the Hon ble Peshawar High Court (PHC). Peshawar was seen in detail F/A.

### PERSONAL HEARING

The said employees were called upon for personal hearing used questionning and interview as inquiry tools. The mentioned employees were personally heard 200 dated 29/05/2021 at DEO Khyber at Jamrud. Their respective stations were also visited for further verification. The written statements in the form of questionnaires are attached (F/B).

### FINDINGS OF THE INOURY COMMITTEE

Based on the above available record position and procedure adopted the Inquiry Committee, the Committee recorded the following findings:-

1. All the four employees are regular / permanent employees of the department. Their initial dates of entry into service are as under:-

2. They were / are regular in attendance of their duties in their respective schools and no complaint against any of them has been raised or received during their service. Their salaries had been stopped w.e.f the dates mentioned above without any reason.

- Upon their appends to the authorities, though needless under the then prevailing circumstances, their salaries could not be released.
- 4. They approached the Hon'ble PHC, Peshawar for release of their salaries. The PHC allowed their writ petition based on statement of the concerned ADEO, Bara, Khyber, Mr. Walkeed Ullah in the court declaring them as regular employees and payment of salaries to them.
- 5. Despite judgment of the Hon'ble PHC. Peshawar in their favor, they could not be paid salaries. On this, they filed CoC proceeding in the same court, whereupon, receiving orders from the court, their salaries were released from the month of Aug, 2019 but again the remaining stopped salaries were not paid to the officials concerned.
- 6. Prior to this inquiry, two other inquiries have also been conducted (F/C) by the inquiry committee comprised of Mr. Muhammad Zahid V.P GHS koi Sher Haider. An another inquiry was conducted by Mr. Sher Zaman HM GHS Badshah Mir Killi BZK landi kotal where under, the non-payment has been declared illegal and immediate payment of pending salaries to the above mentioned employees has been recommended.

### RECOMMENDATION OF THE INOUIRY COMMITTEE

Based on the above findings of the Inquiry Committee, the Committee strongly tecommends payment of remaining pending salaries to the above named four employees, being their due right in all respects and in the eyes of law without any further delay as the facts onrecord disagrees with the stoppage of salaries and non-payment of remaining salaries.
