JUDGMENT

KALIM ARSHAD KHAN CHAIRMAN: Facts of the case as narrated in the memo and grounds of appeal are that the appellant was appointed as Fitter on Malakand Division Director 14.03.1985 in the office Deputy Agriculture/Extension; that a post of foreman (BPS-11) had fallen vacant due to the retirement of one Akhtar Munir, Mechanic foreman; that the appellant being senior most, the petitioner was transferred and posted from the office of respondent No.3 to the office respondent No.4 and adjusted on the said post and till then, the appellant was working as Foreman (BPS-11); that the appellant was working as Foreman (BPS-11) but his salary was not fixed on the said post; that the appellant filed an application for promotion on 31.01.2018 to respondent No.2 which was dismissed on 29.10.2019 and then filed departmental appeal to respondent No.1 on 25.11.2019 which was not responded within the stipulated period of ninety days, hence the instant service appeal on 24.02.2020.

- 2. On receipt of the appeal and its admission to full hearing, the respondents were summoned. Respondents put appearance and contested the appeal by filing written reply raising therein numerous legal and factual objections. The defence setup was a total denial of the claim of the appellant.
- 3. We have heard learned counsel for the appellant and learned Assistant Advocate General for the respondents.
- 4. The Learned counsel for the appellant reiterated the facts and grounds detailed in the memo and grounds of the appeal while the learned Assistant Advocate General controverted the same by supporting the impugned order(s).

- Through the instant appeal, the appellant wants promotion from the post of 5. fitter (BPS-05) to the post of foreman/Mechanic (BPS-11). He rests his claim by alleging that vide notification No. SOE(AD)VI-106/2010/Swat dated 30.01.2012 the appellant was transferred and posted from the office of the Executive District Officer, Swat to the Directorate General Agriculture (Research) Khyber Pakhtunkhwa against the vacant post of Mechanic where he had been working for years and gained sufficient experience that is why he was justified to claim promotion. The respondent department had regretted the claim of the appellant by contending that the post of the Mechanic required three years Diploma of Associate Engineering (Mechanical). Furthermore, there were no service structure/rules in the department for promotion from the post of Fitter to the post of Foremen/Mechanic. It was further contended that the appellant was illiterate person and was not possessing the prescribed qualification, therefore, his claim could not be honored being unjustified and not covered by the rules. When confronted with the situation, the learned counsel for the appellant could not controvert the situation. This being so,
