Mr. Riaz Paindakheil learned Assistant Advocate General present.</p> <p>2. The appellant (SDEO) has filed the present service appeal against the order dated 22.10.2019 whereby he was transferred from Timergara Dir Lower to Samarbagh Dir Lower and against the order dated 08.11.2019 in relation to his transfer to Munda Dir Lower. Departmental appeal filed by the appellant was rejected vide order</p>

4.3.2020

dated 25.11.2019.

3. Learned counsel for the appellant argued that in the year 2011 the appellant was appointed as Assistant District Officer (ADO) through Public Service Commission and promoted as SDEO on 28.10.2018; that on 29.08.2019 the appellant was transferred to Tehsil Khall Dir Lower however on the acceptance of departmental appeal the appellant was retained at Timergara vide order dated 11.09.2019; that once again the appellant was transferred to Samarbagh Dir Lower vide impugned order dated 22.10.2019 and then within a short span of time, the appellant was again transferred to Munda Dir Lower vide impugned order dated 08.11.2019; that feeling aggrieved the appellant filed departmental appeal however the same was rejected vide order dated 25.11.2019 hence the present service appeal. Further argued that the impugned transfer orders are against law and norms of justice; that the impugned repeated posting transfer orders are premature being issued in violation of transfer posting policy; that the impugned orders were issued on political motivation of MPA and as such are highly unethical and undesirable.

4. As against that learned AAG argued that the appellant is holding a Provincial Cadre Post and is bound to perform duty wherever the department posts him; that the appellant is performing his duties within the same district; that there was no element of political interference in the issuance of impugned orders; that a civil servant has no right to claim posting of his choice.

5. Arguments heard. File perused.

6. Perusal of file reflects that the appellant served at Timergara Dir Lower as SDEO (Management Cadre) w.e.f 01.11.2018. Vide order dated 29.08.2019 the appellant was transferred from Timergara Dir Lower to Khall Dir Lower, however he was retained at Timergara in Dir Lower vide order dated 11.09.2019. Then vide order dated 22.10.2019 the appellant was again transferred to Samarbagh Dir Lower and then vide order dated 08.11.2019 he was transferred to Munda Dir Lower. Contention of the appellant is that due to interference of local MPA the appellant was transferred to Khall, then to Samarbagh and then transferred to Munda Sub Division. In the year 2019 four orders were issued in respect of the posting of the appellant. Learned AAG remained unable to demonstrate any valid reason for repeated transfer posting orders within a short span of time. As per posting transfer policy the normal tenure of posting at one station is two years.

7. In the light of above the impugned orders are set aside and the respondents are directed to let the appellant complete his remaining normal tenure at Timergara Dir Lower w.e. f 01.11.2018. The present service appeal is accepted in the above noted terms. Parties are left to bear their own costs. File be consigned to the record room.

1. That the appellant is permanent resident of Dir Lower and was appointed initially on the post of CT vide dated 19/11/1986.
2. That after the appellant was selected SST (Sc) by the public service commission vide appointment order dated 07/11/1994.
3. That the appellant being as SST also worked as Litigation in charge on behalf of DEO Dir Lower as well as director of Education KPK till 04/05/2011.
4. That after the creation of management cadre the appellant being eligible was appointed as ADO (Assistant District Officer) by the public service commission on 05/05/2011.
5. That the appellant was later on promoted as SDO on 28/10/2018 and was served the respondents department for the best of his ability and no complaint whatsoever has been raised from any quarter.
6. That on 29/08/2019 the appellant was transferred as SDEO to Tehsil Khal. **(Copy of notification/transfer order are attached as annexure "A").**
7. That the appellant filed an appeal which was allowed and the appellant was retransferred/adjusted at SDEO office Timergara vide order dated 11/09/2019. **(Copy of retransfer/adjustment order is attached as annexure "B".)**

8. That once again the appellant was transferred vide notification dated 20/10/2019 to Samarbagh Dir Lower as SDEO. **(Copy of notification dated 20/10/2019 is attached as annexure "C")**.
9. That after of short span of time the appellant was again transferred to Munda Dir Lower vide notification dated 08/11/2019. **(Copy of notification dated 08/11/2019 is attached as annexure "D")**.
10. That the appellant impugned the same an appeal before the respondent No.3 who mark the same to secretary Education/respondent No.1.
11. That the secretary concerned/respondent No.1 after alleged consultation rejected the appeal vide order dated 25/11/2019. **(copy of impugned order is attached is annexure "E")**
12. That feeling aggrieved the appellant have no other remedy except to file the instant appeal on the following grounds.

GROUNDS:

- A. That the impugned transfer order is against the law on subject, rules, transfer policy hence not maintainable and liable to be set aside.
- B. That the impugned order comes in the domain of repeated transfer which is against the law hence be declared unlawful and be struck down.

C. That the existing tenure as per Khyber Pakhtunkhwa service servant act 1973 is three years of settle area and one and half year for unattractive/hard area, but the official respondents mere on political exertion passed the impugned notification as against the act ibid so the impugned order is liable to be set aside.

D. That the appellant after appointment is working in the department and there is no complained whatsoever against so such illegal transfer orders of appellant is against the fundamental right guaranteed by the constitution of Pakistan

E. That the impugned order based on mala fide and ulterior motives and the authority failed to give any justification qua his unlawful action so the impugned transferred order is not sustainable.

F. That the civil servant/appellant repeatedly transferred from one place to another in short span of time through political motivation hence the order passed by the concerned authority is highly un-ethical and undesirable so such act of the respondent be set as null and void.

G. That any other grounds be raised with the permission of this Hon'ble tribunal as not specifically asked.

It is, therefore very humbly prayed that on acceptance the instant appeal all the impugned transfer order (dated 08/11/2019 and 22/10/2019) may kindly be set aside declared illegal, against the
