



Joint Execution Petitions Nos. 177/2022 & 298/2022 titled Amjad Hussain & Others VS Govt of KPK & others and Muhammad Tufail & Others VS Government of KPK & Others received through diary Nos. 2148 and 2149 dated 25-06-2022 regarding implementation of judgment dated 12-07-2021 passed in Service Appeal No. 12889/2020 by Honorable Tribunal Khyber Pakhtunkhwa Peshawar.

The case is regarding payment of conveyance allowance during summer and winter vacations.
