



Learned counsel for the appellant referred to the reply of the official respondents especially paras-5,6 and 8 of the reply on facts and was fair enough to say that at the time of filing of this appeal, the appellant was holding a contractual post but her services were regularized during the pendency of this appeal vide notification bearing Endst: No. 4781-85/A-17/Regularization/SST/2022 dated 02.12.2022. He submitted that he would advise the appellant to file an application for protection of her pay because being a contract employee she could not get her desired relief. As regard this appeal he does not press. Dismissed accordingly. The appellant is at liberty to seek rerdressal of her grievances of pay protection by moving the competent authority. Consign.

Terms and Conditions:-

Abbottabad (Female) SST Regularization-2022

- 1 Their services shall be governed by the Khyber Pakhtunkhwa Civil Servant Act, 1973, the Khyber Pakhtunkhwa (Appointment, Deputation, Posting and Transfer of Teachers, Lecturers, Instructor and Doctors) Regularity Act, 2011, and such rules and regulation as may be issued from time to time by Government.
- 2 Their services will be considered regular and they shall be eligible for pension/deduction of GP Fund in term of Kyber Pakhtunkhwa Civil Servant Act, 1973, as amended in 2013, however, the teachers appointed on or after 07/06/2022 shall be dealt with Section (2)(2) of the Khyber Pakhtunkhwa (Ammdement) Act, 2022.
- 3 Their services are liable to termination on one month notice from either side. In case of resignation without notice, their one month pay/allowances shall be forfeited to the Government.
- 4 They shall posses the same qualification and experience required for the subject post on regular basis as specified in Section (3)(a) of the Act.
- 5 Their regularization shall not affect the service promotion quota of all service cadres as specified in Section (3) (c) of the Act.
- 6 They shall be entitled for seniority and pay from the date of initial appointment on Adhoc/Contract basis as specified in Section (3) (d) of the Act.
- 7 They shall perform duty for at least three years from the date of taking over charge where they were appointed/posted initially.
- 8 The regularization shall not be in favor of those teachers who have not taken over charge, remained absent from duty and resigned from service.
- 9 The Teacher, Regularized through this notification, shall be confirmed after successful completion of In-service mandatory training as specified in their Service Rules notified vide notification No SO(PE)4-5/SSRC/Meeting/2012/Teaching Cadre/2017 dated 07/03/2018 within two consecutive attempts otherwise the appointment orders of the candidates failed to qualify induction program within two consecutive attempts shall be considered as withdrawn/cancelled from the date of declaration of result of the second attempt made in the induction program.
- 10 DEOs are directed to check/verify the documents/extension orders ets service of the regularized teachers once again with the criteria mentioned for regularization. If the teachers don't meet the criteria their service shall be considered as ceased.
