WIOAR AHMAD, J.- Petitioner has filed the instant constitutional petition under Article 199 of the Constitution of Islamic Republic of Pakistan, 1973 praying for the following relief;

“ It is, therefore, humbly prayed that on acceptance of this writ petition in the light of aforementioned submissions, this Court may kindly issue appropriate writ to the concerned authority to include the petitioner in the alleged seniority list and consider her for promotion to higher scale/position according to her entitlement.”

2. In essence, the main grievance of the petitioner is with regard to inclusion of her name in the seniority list and her promotion to the higher scale/position. The case was heard at considerable length, whereafter, the learned counsel for the petitioner requested that he would feel satisfied if the petition in hand is treated as an appeal and may be sent to the Khyber Pakhtunkhwa Service Tribunal for redressal of grievance of the petitioner.

ON FACTS

1. That para-1 is correct to the extent that the petitioner was inducted against the Subject Specialist BPS-17 vide Notification dated 10-03-2008 by the Respondent Department.
2. That para-2 is incorrect & misleading on the grounds that the Respondent Department has prepared & maintained a seniority list pertaining to the subject Specialist in BPS-17 of Teaching cadre under the mandatory provision of section B of civil Servants ACT 1973 and on the basis of the same those subject Specialist who have submitted their respective PERs/ACRs well in time to the Respondent Department where is the petitioner has not submitted her PERs/ACRs intentionally. Hence, she has been dropped from promotion vide the impugned Notification dated 04/05/2018 by the Respondent Department. Hence, the claim and stand of the petitioner is baseless and without any cogent reason and justification. **(Copy of the said Notification dated 04/05/2018 is (Annexure-A))**
3. That para-3 is correct to the extent of issuance of the impugned Notification dated 04/05/2018, whereas, rest of the para regarding grant of promotion to the juniors of the petitioner is baseless as she has not submitted her PERs and ACRs to the Respondent Department for working papers intentionally. Hence, she has not been promoted vide the said Notification. However, her seniority is still in her batch mates as evident from the seniority list maintained by the Respondent Department along with her colleagues. **(Copy of the Seniority list is (Annexure-B)).**

4. That para-4 is incorrect & misleading on the grounds that act of the Respondent Department with regard to the impugned Notification dated 04/05/2018 is within legal sphere and liable to be maintained that is why the Departmental appeal of the petitioner has been rejected on merits of the case
5. That para-5 is legal, However, the Respondent No 2 further submit on the following grounds
Inter-alia:

ON GROUNDS:-

- a) Incorrect & not admitting, the act of the Respondents with regard to the impugned Notification dated 04/05/2018 is within legal parameter & relevant policy
- b) Incorrect & not admitted. The petitioner has not submitted her PER/ACT to the Respondent Department intentionally. Hence, she has not been promoted vide the said Notification by the Respondent Department against the H/M in BPS-18 post from the said date.
- c) Incorrect & not admitted. The petitioner has been treated as per Law, Rules & relevant Policy in the instant case, However, the stand of the petitioner is baseless and without any cogent proof and justification. Hence, liable to be rejected.
