#### **JUDGEMENT**

FAREEHA PAUL, MEMBER (E): The service appeal in hand has been instituted under Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974, against the order dated 23.09.2020 of District Police Officer Abbottabad, whereby the appellant had been dismissed from service and order dated 27.11.2020 of the Regional Police Officer, Hazara Region, Abbbottabad whereby appellant's departmental appeal had been filed. Both the orders dated 23.09.2020 and 27.11.2020 have been impugned by the appellant with the prayer to reinstate him in service from the date of dismissal with all consequential back benefits of service.

- Brief facts of the case, as given in the memorandum of appeal, are that the appellant was enrolled as Constable on 09.06.2005 in the Police Department. He, while posted at Police Lines Abbottabad, was involved in FIR No. 537 dated 24.12.2016 under Sections 302/324/148/149 PPC registered at Police Station Nawansher Abbottabad. Complainant party of FIR No. 537 on 24.12.2016 at 07:00 pm came to the house of the appellant, called the inmates out and started quarreling with them. In the meanwhile, they stated indiscriminate firing upon the appellant and others as a result of which he was injured and caused death of some other persons also. Resultantly another FIR No. 538 dated 26.12.2016 under Sections 324/148/149 PPC got registered by the appellant at Police Station Nawansher Abbottabad. On 24.12.2016 the appellant, who was injured also, got arrested and admitted to hospital from where he was discharged on 25.02.2017 and was put in the jail till 24.03.2017 when he was released on bail. Since 24.12.2016, the appellant was placed under suspension by DPO Abbottabad, which ended on 24.10.2018 and he was assigned duty and was attached with the Model Trial Court of Magistrate at Abbottabad. During that period, on 16.01.2017, he was served with a charge sheet and statement of allegations vide No. 35/PA, by DPO Abbottabad. DSP Aziz was nominated as Inquiry Officer with the directions to submit his report within twenty-five days. Based on the findings of that report dated 21.02.2017 appellant was dismissed from service vide order dated 23.09.2020. His departmental appeal was also filed vide order dated 27.11.2020.
- Respondents were put on notice who submitted written replies/ comments on the appeal. We have heard the learned counsel for the appellant as well as the learned Assistant Advocate General and perused the case file with connected documents in detail.

- 4. Learned counsel for the appellant contended that he had been dismissed from service without following the procedure i.e neither any showcause notice was issued nor the appellant had been given an opportunity of personal hearing. He further argued that the competent authority of the appellant did not wait for the final decision of the criminal case registered against him. He presented the judgment dated 22.12.2021 of the Additional Session Judge/Judge MCTC Abbottabad in case of the appellant titled State through Amanullah Khan S/O Ghulam Khan (Complainant) Vs Sohrab Khan S/O Zardad Khan and Others (Accused facing trial) in case vide FIR No. 537 dated 24.12.2016 and read out the concluding paras 17 and 18 as follows:
  - "17. In the given circumstances, the prosecution has failed to prove its case against the accused facing trial qua ocular account and even could not manage to establish the chain of events which could prove commission of offence by the accused facing trial beyond reasonable doubt. In the instant case the evidence so produced by the prosecution is so deficient that accused facing trial cannot be convicted on the basis thereof.
  - 18. Resultantly, in case FIR No. 537 dated 24.12.2016 under Sections 302/324/337-D/337-F(ii)/148/149 PPC, accused facing trial namely Sohrab Khan, Sajawal Khan, Murad Khan and Safdar Khan sons of Zardad Khan, Faisal Khan son of Safdar Khan are acquitted of the charges levelled against them."
- 5. The learned Assistant Advocate General relied on the reply given by the respondents and reiterated the stance that a criminal case had been registered against the appellant.
- 6. It is proved from record that an FIR No. 537 dated 24.12.2016 was registered against the appellant and he was put behind the bars and further stated that he was on bail since 24.03.2017. Record further reveals that disciplinary proceedings were initiated against the accused based on that FIR. It transpires from the Inquiry Report

that the appellant was not given a fair chance to present his case before the Inquiry Officer. Inquiry Report (one page) annexed with the reply indicates that neither any written statement from the appellant had been obtained nor was he given any opportunity of personal hearing. Based on the report, he was dismissed from service by the District Police Officer Abbottabad and his departmental appeal was also rejected by the Regional Police Officer, Hazara Region Abbottabad. The judgement of learned Additional Sessions Judge/Judge MCTC, Abbottabad presents an altogether different picture, wherein the appellant was acquitted of the charges levelled against him (and others). It is observed that the competent authorities of the appellant should have waited for the final outcome/decision of the court in the criminal charges levelled against him, before going to an extreme verdict of dismissal from service.

- In view of all the record and evidence placed before us, we allow the appeal in hand and set aside the impugned orders dated 23.09.2020 and 27.11.2020 and direct the respondents to reinstate the appellant with all consequential back benefits of service. Period of his absence, if any, shall be treated as leave of the kind due. Cost to follow the event. Consign.

SERVICE APPEAL UNDER SECTION-4 OF KPK SERVICE TRIBUNAL ACT 1974 AGAINST ORDER DATED 23-09-2020 OF THE DISTRICT POLICE OFFICER ABBOTTABAD WHEREBY THE APPELLANT HAS BEEN "DISMISSED FROM SERVICE" AND ORDER DATED 27-11-2020 OF THE REGIONAL POLICE OFFICER HAZARA REGION ABBOTTABAD WHEREBY APPELLANT'S DEPARTMENTAL APPEAL HAS BEEN FILED.

PRAYER: ON ACCEPTANCE OF INSTANT SERVICE APPEAL BOTH THE IMPUGNED ORDERS DATED 23-09-2020 AND 27-11-2020 OF THE RESPONDENTS MAY GRACIOUSLY BE SET ASIDE AND APPELLANT BE RE-INSTATED IN SERVICE FROM THE DATE OF DISMISSAL WITH ALL CONSEQUENTIAL SERVICE BACK BENEFITS.

Respectfully Sheweth:

1. That appellant was enrolled as Constable on 09-06-2005, thus has rendered 16 years service in the police department. He always performed his assigned duties with devotion, dedication and honesty to the entire satisfaction of his officers. He was awarded Commendation Certificates and Cash Rewards on occasions for his tremendous services. He has meritorious service record at his credit.



- 2. That appellant while posted at Police Lines Abbottbad was wrongly and falsely involved in FIR No. 537 dated 24-12-2016 U/S-302/324/148/149 PPC registered at Police Station Nawansher Abbottabad. (Copy of FIR dated 24-12-2016 is attached as Annexure-"A").
- 3. That complainant party of FIR No. 537 was aggressive one as on 24-12-2016 at about 0700 p.m. when appellant & his other inmates house. were in their opposite/complainant party came to their house and called them out and started quarreling with them. In the meanwhile they started indiscriminating firing upon the appellant and others which seriously injured him and also caused death of their own persons as well as that of other passengers etc. The appellant and his injured relatives were taken to hospital where he was admitted. In this regard an FIR No. 538 dated 26-12-2016 U/S-324/148/149 PPC was got registered by appellant at Police Station Nawansher Abbottabad. If the site plán is seen/examined it will itself disclose that opposite party was aggressive and had assaulted and raided the house of appellant. (Copies of FIR No. 538 dated 24-12-2016 and Site Plan are attached as Annexure "B & C").
- 4. That on 24-12-2016, the appellant was arrested and admitted to the Hospital. On 25-02-2017 appellant was discharged from Hospital and was put into the Jail till released on bail on 24-03-2017. Thereafter appellant remained under medical treatment as out-door patient. (Medical treatment record as indoor & outdoor patient is attached as Annexure- "D").



- 5. That since 24-12-2016, the appellant was placed under suspension by the DPO Abbottabad. On 24-03-2020 after discharge from Hospital and release on bail the appellant remained present on duty in police lines Abbottabad. Appellant's suspension was ended and he was assigned duty from 24-10-2018. Appellant was attached to "the Model Trial Court of Magistrate at Abbottabad" where he was awarded with Commendation Certificate by the then Honorable Chief Justice of Pakistan Mr. Justice Asif Saeed Khan Khosa and Honorable Chief Justice of Peshawar High Court Peshawar Mr. Justice Wagar Ahmed Seth in appreciation of his performance rendered as Naib Court. (Copy of Commendation Certificate is as Annexure- "E").
- 6. That during the course of admission in Hospital, the appellant was served with a charge, sheet by DPO Abbottabad which was replied. But appellant now does not remember the contents of said Charge Sheet and its reply as he could not retain copies of the same. However, due to ill health & serious injuries the appellant was not in concentration of mined at that time.
- 7. That it is very astonishing that when appellant had performed his duties for about 04 years and without waiting the decision his criminal case from the Court of Law and also without issuing of any Show Cause Notice and affording opportunity of personal hearing he was suddenly dismissed from service by the DPO Abbottabad vide order OB No. 234 dated 23-09-2020. (Copy of dismissal order dated 23-09-2020 is attached herewith as Annexure "F").



- 8. That the appellant is totally innocent and had wrongly and falsely been implicated in the criminal case because opposite party was aggressive and had assaulted and raided the house of appellant, and had seriously injured him along with his other inmates and passengers etc. Even then no heed was given to appellant's request and had been awarded with major penalty of dismissal from service by departmental authorities without waiting and receiving decision of criminal case from the court of law and without any cause and justification that too without conducting proper inquiry.
- 8. That afore mentioned order of the DPO Abbottabad was appealed against before the Regional Police Office Hazara Region Abbottabad but the same had been *filed* vide order dated 27-11-2020 and that too without giving any consideration to the grounds taken by appellant in the memo of appeal. (Copies of departmental Appeal and order 27-11-2020 are attached as Annexure-"G & H"), hence instant service appeal, inter alia, on the following amongst other:-

#### **GROUNDS:**

- a) That orders dated 23-09-2020 and 27-11-2020 of respondents are illegal, unlawful, against the departmental rules & regulation, issued in a cursory, whimsical and arbitrary manner, hence are liable to be set aside.
- b) That no proper departmental inquiry was conducted.



No Show Cause Notice was issued. Copy of inquiry report, if any, was also not provided to him. Even opportunity of personal hearing was not afforded to the appellant and he was condemned unheard.

- That according to law/verdicts of apex courts and c) Police rules, the District Officer departmental Abbottabad was legally bound to have waited the decision of appellant's criminal case from the Trial Court with regard to his innocence or guiltiness before passing punishment order impugned here in service appeal. Appellant has been penalized in a cursory and arbitrary manner without adhering to rules & procedure laid down by law for dispensation of justice at preliminary stages of departmental inquiries; hence impugned orders are liable to be turned down straightaway.
- d) That as he was falsely roped in FIR thus during the course of investigation appellant was not found involved in the very criminal case by the Investigation Officer due to which he has been granted bail by the Honorable Court.
- e) That the appellate authority has also failed to abide by the law and even did not take into consideration the grounds taken in the memo of appeal. Thus the impugned order of appellate authority is contrary to the law as laid down in Police Rules read with section 24-A of General Clause Act 1897 and Article 10A of the Constitution of Islamic Republic of Pakistan 1973.



f) That instant service appeal is well within time and this honorable Service Tribunal has got every jurisdiction to entertain & adjudicate upon the lis.

#### **PRAYER:**

It is, therefore, humbly prayed that on acceptance of instant Service appeal order dated 23-09-2020 and 27-11-2020 of respondents may graciously be set aside and the appellant be reinstated in his service from the date of dismissal with all consequential service back benefits. Any other relief which this Honorable Tribunal deems fit and proper in circumstances of the case may also be granted.





This order will dispose off departmental appeal under Rule 11-A of Khyber Pakhtunkhwa Police Rules, 1975 submitted by Ex. LHC Shorab Khan of District Abbottabad against the punishment order i.e. Dismissal from Service awarded by DPO Abbottabad vide OB No.234 dated 23.09.2020.

Brief facts leading to the punishment are that the appellant while posted at Police Lines, Abbottabad involved himself in a criminal case vide FIR No.537 dated 24.12.2016 u/s 302/324/148/149 PPC PS Nawansher.

The appellant was issued charge sheet alongwith summary of allegations and DSP Investigation, Abbottabad was deputed to conduct departmental enquiry vide Endst. No. 35/PA dated 16-01-2017. The EO held the appellant responsible of misconduct vide Memo No. 12/Reader dated 21-02-2017. The appellant was heard in person, however he failed to advance any cogent reason in his defence. Consequently, DPO Abbottabad awarded him major punishment of dismissal from service. Hence, the appellant submitted this present appeal.

After receiving his appeal, comments of DPO Abbottabad were sought and examined perused. The undersigned called the official in OR and heard him in person. However, he failed to advance any convincing reason in his defence. In addition to this, it is evident from the relevant record that the official deliberately involved himself in a criminal offence despite been part of a disciplined force. The misconduct on the part of the official was not only proved through departmental enquiry but also during course of investigation. Therefore, in exercise of the powers conferred upon the undersigned under Rule 11-4 (a) of Khyber Pakhtunkhwa Police Rules, 1975 the instant appeal is hereby filed with immediate effect.
