SERVICE APPEAL UNDER SECTION 4 OF KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974, AGAINST THE OFFICE ORDER NO.1604-06/GE DATED 21/09/2017, OFFICE ORDER NO.139 DATED 10/04/2018 AND OFFICE ORDER NO.2179/UWS DATED 22/04/2019, WHEREBY THE APPELLANT WHO RETIRED FROM FOREST DEPARTMENT KPK ON 07/04/2018 ATTAINING THE AGE OF SUPERANNUATION, HAS NOT BEEN PAID HIS PENSION / POST RETIREMENT EMOLUMENTS BY THE BUDGET AND ACCOUNTS (PENSION) DEPARTMENT GOVT OF KPK (RESPONDENT NO.2), WHICH IS ILLEGAL, PERVERSE, ARBITRARY, UNILATERAL, AGAINST THE SETTLED LAW, RULE AND POLICY, LIABLE TO BE SET ASIDE. APPELLANT IS FULLY ENTITLED TO RECOVER HIS PENSION COMMUTATION / POST RETIREMENT EMOLUMENTS AS PER POLICY OF THE GOVT OF KPK IN VOGUE. *ON ACCEPTANCE OF INSTANT APPEAL*, RESPONDENTS / FOREST DEPARTMENT GOVT OF KPK, PESHAWAR MAY GRACIOUSLY BE DIRECTED TO EXONERATE THE ILLEGAL AND UNFOUNDED ALLEGATIONS LEVELED AGAINST THE APPELLANT REGARDING MISSING TIMBER AND STOLEN KALASHNIKOV AND RESPONDENTS BE DIRECTED TO RELEASE THE PENSION / POST RETIREMENT EMOLUMENTS OF THE APPELLANT FORTHWITH IN THE BEST INTEREST OF JUSTICE ALONWITH THE COMPENSATION AT THE RATE, PREVAILING AT PRESENT IN THE COMMERCIAL BANKS OF PAKISTAN.

Respectfully Sheweth,

Facts giving rise to the instant petition are as under:-

- 1. That, the Appellant is a respectable citizen of Pakistan who served in the Forest Department of Govt of KPK, for 40 years and retired on 07/04/2018 at the age of superannuation. (Copy of the retirement order is attached as Annexure "A")
- That, since petitioner's retirement on 07/04/2018, till date the Appellant has not been paid his pension / post retirement emoluments by the Budget &Accounts (Pension) Department Govt of KPK (Respondent No.2).
- That, Chief Conservator of Forests, Central Southern Region-I KPK (Respondent No.3) vide impugned retirement order dated 10/04/2018,

instructed Chief Conservator of Forests Region-II, Abbottabad (Respondent No.4) to recover an amount of Rs.72,490/- from Appellant for an alleged missing timber as well as one number Govt Kalashnikov stolen from Range office Shergarh before submission of Appellant's pension case. The same copy was also sent to Director Budget and Accounts, Govt of KPK Forestry Environment and Wildlife Department (Respondent No.2)

- 4. That, an enquiry was held against Mr. Dost Muhammad, Forester Shergarh, who was involved in missing timber case. After the inquiry, the inquiry officer found Dost Muhammad guilty/responsible for the missing timber. However, Dost Muhammad Khan was exonerated on the basis of an appeal and personal hearing from the charges and instead Appellant was held guilty / responsible for the missing timber without affording the Appellant a chance / opportunity of personal hearing, which is against the prescribed Rules/ Procedure. (Copies of the Appeal submitted by Dost Muhammad and other documents are attached as Annexure "B")
- 5. That, Divisional Forest Officer Agror Tanawal Forest Division Oghi, District Mansehra (Respondent No.7) issued office order dated 21/09/2017, illegally holding the Appellant guilty / responsible for missing timber from Central Sale Depot Mansehra worth Rs. 72,490/and directed the appellant to immediately deposit the said amount into Govt treasury failing which, disciplinary proceedings will be initiated against the appellant under the provisions of E&D Rules 2011. (Copy of

the letter dated 21/09/2017 issued by DFO Agror Tanawal Forest Division Oghi, District Mansehra is attached as Annexure "C")

- 6. That, the Appellant submitted a detailed reply dated 18/04/2017 to DFO Agror Tanawal Division, District Mansehra (Respondent No.7) denying the charges leveled against the Appellant. (Copy of the reply dated 18/04/2017 by the Appellant is attached as Annexure "D")
- 7. That, on receipt of retirement order, when appellant applied to obtain NOC from Agror Tanawal Forest Division (Respondent No.7) the Appellant was refused NOC and instead he was asked to remit an amount of Rs. 72,490/- as recovery of missing Timber as well as price /value of stolen one number Govt Kalashinkov (Rs. 100,000/-) without conducting any enquiry to this effect.
- 8. That, Appellant had also submitted a written application /Appeal dated 06/11/2018 to Chief Conservator Forests Peshawar (Respondent No.3) denying his involvement in the alleged missing timber worth Rs. 72,490/- as well as one number Kalashnikov (worth Rs.100,000/-), which was stolen from the Range Office Shergarh for which an FIR of theft was also lodged in Police Station Oghi, District Mansehra. (Copy' of the application alongwith enclosures is attached as Annexure "E")
 - That, Divisional Forest Officer Unhar Watershed Division Mansehra (Respondent No.6), issued office order dated 22/04/2019 to the

Appellant with the direction to deposit the outstanding amount of Rs. 172,490/- (Rs.72,490/- for missing timber as well as Rs. 100,000/- for one number stolen Kalashnikov) into Govt Treasury or supply an affidavit on stamp paper regarding deduction of amount in question from his pension commutation so that petitioner's pension case could be re-submitted to the Budget & Accounts Officer Environment (Respondent No.2) for issuance of pension admissibility certificate. (Copy of letter dated 22/04/2019 sent to the Appellant by Respondent No.6 with regard to deposit the outstanding amount of Rs. 172,490/-, is attached as Annexure "F")

- 10. That, it is pertinent to mention that a theft took place at Range office Shergarh in 2012 in which a Govt Kalashnikov and cash amount Rs. 120,000/-, (recovered from defaulters) were stolen. An FIR dated 17/10/2012, was lodged with Police Station Oghi to this effect. However, the Appellant deposited an amount of Rs. 120,000/- from his own pocket to make good the amount which was stolen from the Range Office, Shergarh. The concerned DFO was informed accordingly about the theft as well as registration of FIR with PS Oghi.
- 11. That, despite clear Rules on payment of pension to Govt Servants, the Appellant is being denied / delayed his rightful pension / post retirement emoluments on the basis of frivolous and unfounded allegations for which no formal enquiry has been conducted by the Forest Department, instead directly held the Appellant guilty / responsible for the missing timber as well as stolen Kalashnikov to which the Appellant had given detailed reply in his application as mentioned in Para-6 & 8 above.

- 12. That, feeling aggrieved by the high handedness and illegal action of the Forest Officials, the Appellant preferred a Writ Petition before the Hon'ble Peshawar High Court, Abbottabad Bench and the Hon'ble Peshawar High Court Abbottabad Bench, graciously converted the same writ petition in to Service Appeal and sent it to Khyber Pakhtunkhwa Service Tribunal for its decision in accordance with the law. (Copy of the Writ Petition alongwith the Judgment / order of Hon'ble Peshawar High Court Abbottabad Bench dated 07/11/2019 is attached as Annexure "G")
- 13. That, under the direction of Peshawar High Court, Abbottabad bench, the appellant approaches to this Hon'ble Service Tribunal for redressal of his grievances, inter-alia on the following grounds amongst others:-

GROUNDS:-

- That, stoppage of petitioner's pension, without any reason, is illegal, unlawful and against the Govt Servants (Efficiency and Disciplinary Rules 2011.
- ii. That, the Appellant has served unblemished for almost 40 years in the Forest Department and such baseless allegations of missing timber worth Rs. 72,490/- without conducting any enquiry or proving any misconduct on the part of Appellant as well as recovery of Rs. 100,000/- for the stolen one number Govt Kalashnikov is constant source of mental agony and stress.

- iii. That, the Appellant has been condemned un-heard, which is violative of the principle of natural justice and as much as the Forest Department's high officials did not follow the prescribed procedure and charge sheeted the Appellant without any incriminating evidence regarding the missing timber as was as stolen Govt Kalashnikov.
- iv. That, Appellant's detailed reply to Respondent No.7, has not been paid any heed by the Forest Department officials nor Appellant was provided an opportunity of Personal Hearing. Instead Forest Department issued order to Appellant for depositing Rs. 172,490/- without giving any reason.
 - v. That, Appellant's application /appeal to Respondent No.3 has not been considered so far. Resultantly Appellant is suffering an irreparable loss to his goodwill and reputation as well as facing extreme financial hardships due to stoppage of his pension/ post retirement emoluments.
 - vi. That, this high handedness and illegal and unlawful act on the part of respondents, is causing delay into release of the pension / post retirement emoluments of the Appellant which is causing grave inconvenience and financial problems to the petitioner.
 - vii. That, this Honourable Court has to determine the quantum of financial sufferings and mental agony being faced by the Appellant at the hands of rigid, illegal and unlawful acts committed by the forest officials / Respondents.

- ix. That, without conducting any formal enquiry, how can Forest Department hold the Appellant guilty/responsible for an act/omission and blamed the Appellant for an unfounded and baseless allegation of missing timber as well as stolen Kalashnikov for which an FIR had already been registered with the concerned Police Station.
- x. That, rest of the points would be raised at the time of arguments.

It is, therefore, humbly prayed that on acceptance of instant Service Appeal, respondents / forest department Govt of KPK; Peshawar, may graciously be directed to exonerate the illegal and unfounded allegations leveled against the Appellant regarding missing timber and stolen Kalashnikov and Respondent No.2, i.e. Budget and Pension Department of Govt of KPK Peshawar, be graciously directed to release the Pension / Post retirement emoluments of the Appellant forth with, in the best interest of justice.

BRIEF HISTORY OF THE CASE

Consequent upon detection of shortage in timber transported from various localities of Agror Tanawal Forest Division to Central Timber Sale Depot Mansehra through Form-D, Mr. Dost Muhammad Forester was charge sheeted vide DFO Agror Tanawal Forest Division endorsement No.3871-73/GE, dated 16/02/2016 and Mr. Muhammad Riaz DFO Siran was appointed as an Enguiry Officer to initiate disciplinary proceedings against the accused official.

After detail enquiry under the domain of Khyber Pakhtunkhwa Government Servants (E&D) Rules, 2011 and in pursuance with the recommendation of Enquiry Officer contained in enquiry report, the DFO Agror Tanawal in the capacity of Authority after completion of coddle formalities imposed recovery of Rs.72490/- on the accused Forester on account of shortage of 72.49 Cft Kail timber at prevailing market rates of Rs.1000/- vide office order No.396, dated 15/6/2017.

Being aggrieved, Mr. Dost Muhammad Forester preferred an appeal dated 06/7/2017 before the undersigned being Appellate Authority which was sent to DFO Agror Tanawal vide Conservator of Forests, Upper Hazara Forest Circle letter No.240/GE, dated 11/7/2017 for comments. In compliance, the DFO Agror Tanawal Forest Division Oghi vide his letter No.630/GE, dated 10/8/2017 furnished para-wise comments with the following recommendations:

- a. The instant appeal may be valued and thumbed up.
- b. In order to ascertain the factual position of the missing timber, DFO Siran may be approached to get the matter probed through present Incharge Sale Depot Mansebra.

The appellant also heared in person on 8/9/2017 as per provision of rules during which he substantiated and reviewed his stance as mentioned in the appeal.

DISCUSSION

According to the rules and procedure in vogue, it was the prime responsibility of SDFO Shergarh to arrange transportation of seized/confiscated or departmentally procured timber either from Sub-Divisional headquarter or elsewhere to Timber Sale Depot at Mansehra through Form-D to be signed under his own signature and then assigned the task to any official to accompany the vehicle loaded with timber upto the mentioned destination and get the said consignment acknowledged from Depot Incharge on Form-F. Thereafter it was sole responsibility of SDFO Shergarh to prepare lot and transmit lot-wara to Divisional Office for its further processing for disposal/sale under the settled procedure. The appellant in compliance with the directives of his incharge, SDFO Shergarh, has transported 21 Kail Scants=73.29 Cft from Shergarh Forest Sub-Division to Central Sale Depot Mansehra alongwith other consignment through Form-D bearing No.28 and handed over the same in Central Sale Depot Mansehra by obtaining proper Form-F bearing No.99/20 on 23/6/2012 which indicates that the appellant Mr. Dost Muhammad Forester accomplished the assigned task most swiftly. It was the liberty of SDFO Shergarh to prepare proper sizewara of timber/lot for submission to Divisional Office and to ensure its disposal through open auction on scheduled date but he failed.

CONCLUSION

The crux of the above discussion invariable concludes that the appellant has accomplished the assigned task properly and dedicatedly therefore the punishment so awarded by the DFO Agror Tanawal is not justified. It was the liberty of SDFO Shergarh to follow the matter with regard to disposal of mentioned consignment after its receipt in Central Timber Sale Depot Mansehra for which he shall be asked for.

ORDER

Keeping in view the above discussion and conclusion, the undersigned in the capacity of Appellate Authority do hereby order that:

- 1. The DFO Agror Tanawal Forest Division Oghi office order No.396, dated 15/6/2017 is hereby set-aside and Mr. Dost Muhammad Forester is exonerated from the charges which resulted into the recovery of Rs.72490/-.
- 2. The Depot incharge as recommended by the DFO Agror Tanawal in his referred letter is not responsible for the mentioned timber. The SDFO Shergarh shall have to consult record pertaining to the said timber and its further status. In case of failure recovery should be made from the then SDFO Shergarh after fulfillment of prerequisites as per rules.



BUDGET AND PENSION DEPARTMENT OF GOVT OF KPK. **PESHAWAR, BE DIRECTED TO RELEASE THE PENSION #** POST RETIREMENT' EMOLUMENTS OF THE PETITIONER. Facts giving rise to the instant petition are as under :-

- That, the petitioner is a respectable citizen of Pakistan who served in the Forest Department of Govt of KPK, for 40 years and retired on 07/04/2018 at the age of superannuation.
- 2) That, since petitioner's retirement on 07/04/2018, till date the petitioner has not been paid his pension / post retirement emoluments by the Budget & Accounts (Pension) Department Govt of KPK (Respondent No.3).

> That, Chief Conservator of Forests, Central Southern Region-I KPK- (Respondent Nord), lissued petitioner's retirement order on 10/04/2018 with a copy forwarded to Chief Conservator of

Forests Region-II, Abbottabad with instructions to recover an amount of Rs. 72,490/- from petitioner for an alleged missing timber as well as one number Govt Kalashnikov stolen from Range office Shergarh before submission of petitioner's pension. case. The same copy was also sent to Director Budget and Accounts, Govt of KPK Forestry Environment and Wildlife Department. (Copy of the refirement order, is attached as Annexure "A")

- 6. That, Divisional Forest Officer Unhar Watershed Division Mansehra (Respondent No.7), sent a letter dated 22/04/2019 to the petitioner with the direction to deposit the outstanding amount of Rs. 172,490/- (regarding missing timber as well as one number stolen Kalashnikov): into Govt Treasury so that petitioner's pension case could be re-submitted to the Budger & Accounts Officer Environment (Respondent No.3) for issuance of pension admissibility certificate. (Copy of letter dated 22/04/2019 sent to the petitioner by Respondent No.7 with regard to deposit the outstanding amount of Rs. 172,490/-, is attached as Annexure "C")
- 7. That, petitioner had submitted a written application dated 06/11/2018 to Chief Conservator Forests Peshawar denying his involvement in the alleged missing timber worth Rs. 72,490/- as well as one number Kalashnikov (worth Rs.100,000/-), which was stolen from the Range Office Shergarh for which an FIR of theft was also lodged in Police Station Ogi, District Mansehra.
 (Copy of the application alongwith enclosures is attached as Annexure "D")



8. That, a theft took place at Range office Shergarh in 2012 in which a Govt Kalashnikov and cash amount Rs. 120,0007-, (recovered



from defaulters), was stolen. An FIR dated 17/10/2012, was lodged with Police Station Ogi to this effect. The petitioner deposited an amount of Rs. 120,000/- from his own pocket to make good the amount which was stolen from the Range Office; Shergarh.

9. That, despite clear Rules on payment of pension to Govi Servants, the petitioner is being denied / delayed his rightful pension / post retirement emoluments on the basis of frivolous and unfounded allegations for which no formal enquiry has been conducted by the Forest Department, instead directly charge sheeted the petitioner for the missing timber as well as stolen Kalashnikov to which the petitioner had given detailed reply in his application as mentioned in Para-7 above. (Reply submitted by the petitioner to Divisional Forest Officer Agror Tanawal Forest Division Mansehra denying all the allegations in detail, "opy is attached as Annexure "E"):

That, it is perfinent to mention that an enquiry was held against Mr. Dost Muhammad, Forester Shergarh, who was alleged for the same missing timber, however, Dost Muhammad Khan was exonerated on the basis of an appeal and Personal heating from the charges and instead Petitioner was held guilty / responsible for the missing timber without affording the petitioner a chance / opportunity of personal hearing, which is against the prescribed Rules/ Procedure. (Copies of the Appeal submitted by Dost



Muhamamd and other, relevant document are attached as Annexure "F")

11. That, no other efficacious remedy is available to the petitioner, hence this writ petition inter-alia on the following grounds amongst others:-

<u>GROUNDS:-</u>

- That, stoppage of petitioner's pension, without any reason, is illegal, unlawful and against the Govt Servants (Efficiency and Disciplinary Rules 2011 (Rule-5).
- ii. That, the petitioner has served unblemished for almost 40 years in the Forest Department and such baseless allegations of missing timber worth Rs. 72,490/- without conducting any enquiry or proving any misconduct on the part of petitioner as well as recovery of Rs. 100,000/- for the stolen one number Govt Kalashnikov is constant source of mental agony and stress.
- That, the petitioner has been condemned un-heard, which is violative of the principle of natural justice and as much as the Forest Department's high officials did not follow the prescribed procedures and charge sheeted the petitioner without any incriminating evidence regarding the missing timber as was as stolen Govt Kalashnikov.
- iv. That, petitioner's detailed reply against the charge sheet has not been paid any heed by the Forest Department officials nor

petitioner was provided an opportunity of Personal Hearing. Instead Porest Department issued order to petitioner for depositing Rs. 172,490/- without giving any reason. (Annexure "G")

- v. That, this high handedness and illegal and unlawful act on the part of respondents, is causing delay into release of the pension / post retirement emoluments of the petitioner which is causing grave inconvenience and financial hardship to the petitioner.
- vi. That, this Honourable Court has to determine the quantum of financial sufferings and mental agony being faced by the petitioner at the hands of rigid, illegal and unlawful acts committed by the forest officials / Respondents.
- vii. That, the petitioner's pension / post retirement emoluments are held by the respondents illegally for which petitioner needs to be compensated at the current rate of interest as prevailing in the commercial banks.
- viii. That, petitioner also reserves a legal right to claim heavy damages against the Forest Department/Respondents for illegally /

> ix. That, without conducting any formal enquiry, how can forest depart charge sheet the petitioner and blamed the petitioner for an unfounded and baseless allegation of missing timber as well as

stolen Kalashnikov for which an FIR had already been registered with the concerned Police Station.

That, rest of the points would be raised at the time of arguments.

xi. That, proper court fee is attached and notices has been sent to the respondents. (Copies of Notice and Postal receipt are annexed as Annexure ('C'')

It is, therefore, humbly prayed that on acceptance of instant writ petition, respondents / forest department Govt of KPK, Peshawar, may graciously be directed to exonerate the illegal and unfounded allegations leveled against the petitioner regarding missing timber and stolen Kalashnikov and respondent no.3, i.e. Budget and Pension Department of Govt of KPK Peshawar, be directed to release the Pension / Post retirement emoluments of the petitioner forthwith, in the best interest of justice.
