That the facts forming the background of the instant service appeal are arrayed as udner; -

- 1. That the appellant is senior most Girdawar, presently serving as Girdawar, Tehsil Lower Tanawal, District Abbottabad. Copy of posting order of Girdawar is annexed as Annexure "A" and Seniority list of Girdawar is annexed as Annexure "B".
- 2. That as per seniority cum fitness, the appellant is to act as Naib Tehsildar against the vacant posts on his own pay till formal promotion of the appellant.
- 3. That the appellant was detailed as Girdawar in Settlement Tehsil Havelian vide order No. 736-43 dated 24/01/2012. Copy of order dated 24/01/2012 is annexed as Annexure "C".
- 4. That respondent No. 4 posted respondent No. 7 as

 Naib Tehsildar Settlement Havelian, District

 Abbottabad vide order No. 2374-79 dated

 02/04/2018. Copy of order dated 02/04/2018 is

- 6. That during the pendency of departmental appeal of the appellant, respondent No. 6 was posted as Naib Tehsildar Settlement vide impugned order No. 2980-81 dated 21/05/2018. That respondent No. 6 is junior to the appellant as well. Therefore, departmental appeal was also filed against the 21/05/2018 impugned order dated vide departmental appeal dated 10/06/2018. - b) That when law prescribe something which is to be done in a particular manner that must be done in that manner and not otherwise.
 The appellant being senior to respondent No. 5 is entitled to be posted as Naib Tehsildar Havelian on the principle of seniority cum fitness.
- c) That respondents department has led the appellant to the place which is utterly unknown to the principle of jurisprudence, natural justice and good governance.
- d) That the matter relates to the terms & conditions of service. Therefore, the
 Honourable Tribunal has jurisdiction to entertain the instant service appeal.

e) That the legal and factual points shall be urged at the time of arguments with the permission of this Honourable Tribunal.

In view of the above, it is prayed that on acceptance of the instant appeal impugned order dated 28/08/2018 of respondent No. 5 may graciously be setaside and respondents may be directed to post the appellant as Naib Tehsildar Settlement Tehsil Havelian, District Abbottabad on the principle seniority cum fitness.
