Counsel for the appellant Mr. Muhammad Isa Khan Kha, Advocate is present. Preliminary arguments heard. Learned counsel for the appellant argued that the appellant was appointed as Khalasi/Naib Qasid (BPS-03) in Pakistan Forest Institute vide order dated 03.03.2004. It was further argued that 33% quota on the basis of seniority-cum-fitness was reserved for promotion to the post of Junior Clerk (BPS-11) from amongst the Daftari (BS-04), Naib Qasid (BS-03) and Khalasi (BS-03) including the holders of other equivalent posts with seven years service as such and who passed Secondary School Certificate Examination, as prescribed under serial No. 93 of Pakistan Forest Institute Recruitment and Promotion Rules, 2019. It was added that respondents were going to fill the vacancies of Junior Clerk by making promotion from amongst all those who possess Secondary School Certificate irrespective of their category and for that purpose joint tentative seniority list was prepared on 06.03.2019, therefore, the appellant assailed the matter before the hon'ble Peshawar High Court, Peshawar in Writ Petition No. 4280-P/2019 but during the pendency of that Writ Petition the respondent promoted private respondents No. 4 & 5 vide order dated 01.08.2019 therefore, the appellant filed departmental appeal on 21.08.2019 but the same was not responded within the stipulated statutory period of 90 days, hence, the instant service appeal on 19.12.2019. Learned counsel for the appellant further contended that tentative seniority list has no legal value under the law and it is issued for the purpose to ask objection (s) thereon and to be finalized and later on circulated to all concerned under Section-8 of the Civil Servants Act 1973. That private respondents No. 4 & 5 were promoted from other category (appearing at serial No. 130 of the rules ibid) in utter disregard to rules and policy on the subject which needs rectification.

The contentions raised by learned counsel for the appellant need consideration. The instant appeal is admitted for regular hearing subject to all legal objections. The appellant is directed to deposit security and process fee within 10 days, thereafter, notice be issued to the respondents for written reply/comments for 05:10.2020.

APPEAL U/S 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE ORDER DATED 01.08.2019, WHEREBY RESPONDENTS NO.4 AND 5 HAVE BEEN PROMOTED

Sheweth:

Registrari

That the appellant was appointed on 03.03.2004 (Annex "A") in prescribed manner as Khalasi/ Naib Qasid (BPS-03) in the respondent-department and as such, has rendered services of more than decade in one and the same scale.

Re-submitted to and filed.

That the services of the employees in the respondentdepartment are regulated by the Pakistan Forest Institute Service Rules, 2019 notified on 16<sup>th</sup> April, 2019 (Annex "B"), hereinafter referred to as the Rules.

That the next post in the hierarchy to which the appellant can be promoted is that of Junior Clerk (BPS-11), and 33% quota is reserved by the Rules for the promotions amongst the Daftari

(BPS-04), Naib Qasid (BPS-03) and Khalasi (BS-03) with 07 years' experience as such.

- 4) That numerous vacant posts of Junior Clerk were available in the respondent-department since long, but the respondents were taking no steps to fill the same and to afford a chance of promotion to the appellant. The said indifference of the respondents prompted the appellant and other similarly placed employees to make an application collectively on 26.02.2019 (Annex "C") requesting for their promotion in their own hierarchy.
- That it was learnt that the respondents were going to fill the vacancies of Junior Clerk by making promotions from amongst all those who possess the matric certificate, irrespective of their category, and for that purpose joint tentative seniority list (Annex "D") was prepared on 06.03.2019.
- That it led the appellant to file application dated 11.06.2019, requesting for preparation of a separate seniority list of the Daftari, Naib Qasid & Khalasi, as required by the Rules; its relevant portion reads as follows:

"NOTE: For the purpose of promotion, there shall be maintained a common seniority list of Daftaris, Naib Qasids & Khalasi, with reference to the date of their acquiring the Secondary School Certificate"

- 7) That as the seniority was purposely not disclosed to Employees including the appellant, they moved a joint application dated 15.07.2019 (Annex "E") under RTI, whereafter the aforesaid joint tentative seniority list was supplied to the appellant with covering letter dated 22.07.2019 (Annex "F")
- 8) That up till now, no final seniority list of the appellant's category, as per Rules has been issued and the respondents were bent upon to promote employees of other categories, like Mali, Driver, Cleaner, Arm Guard etc against the vacant positions of Junior Clerk.
- 9) That the matter was assailed in WP No.4280-P/2019 (Annex"G"), but during the pendency of the stated writ petition, the promotion order dated 01.08.2019 (Annex "H") was issued whereby respondents No.4 & 5 have been promoted from the other category; against which the appellant filed

departmental appeal dated 21.08.2019 (Annex "I"), which has not been responded within the statutory period, hence the instant appeal, inter alia, on the following grounds:-

#### **GROUNDS:**

- a. That as tentative seniority list has no legal value under the law, therefore, it cannot be depended upon for promotion purposes.
- b. That for promotion of the employees the final determination of their seniority inter se is essential and that is possible only after issuance of the final seniority list in accordance with the law and rules on the subject.
- c. That in the instant matter, no such exercise has been taken and the employees' final seniority is yet to be determined.
- d. That it is apart that the final seniority list has not been prepared/ issued, the tentative list supplied to the petitioners is violently offending against the Rules, ibid, because the Rules provide for maintaining a common seniority list of Daftaris, Nabi Qasids and Khalasi only and none else, whereas, the list supplied is joint one and it includes other categories, such as Malis, Arms Guards, etc.
- e. That the promotions being made against the posts of Junior Clerks from amongst all the categories is a clear violation of the right conferred on the appellant by law.
- f. That the other employees, such as Mali, Driver, Cleaner and Armed Guard, who are wrongly included in the joint seniority list, have their own hierarchy and line of promotion under the Rules, ibid.
- g. That the appellant has not been dealt with in accordance with law, rather he has been meted out with gross discrimination without any plausible reason and justification.
- h. That the conduct/ act of the respondents is in direct conflict with the law and rules on the subject and it is bound to land the appellant in unnecessary litigation, hence it needs interference by this hon'ble Tribunal.
- i. That the respondents Nos.4 & 5 have been promoted from the other category in utter disregard of rules and policy on the subject, hence it needs rectification.



j. That the appellant seeks leave of the Tribunal to urge additional grounds at the time of arguments.

Prayer

in this view of the matter, it is, therefore, prayed that on acceptance of this appeal, this hon'ble tribunal may graciously be pleased;

- i. to set aside the impugned promotion order of respondent Nos.4 & 5 dated 01.08.2019;
- ii. to direct the respondents to prepare a separate seniority list of the Daftaris, Naib Qasids and Khalasi as mandated by the Rules and to consider only those named categories for promotion against the vacancies of Junior Clerk including the appellant; and
- iii. to grant any other remedy to which the appellant is found fit in law, justice and equity.

WRIT PETITION UNDER ARTICLE 199 OF THE CONSTITUTION OF THE ISLAMIC REPUBLIC OF PAKISTAN, 1973.





#### Sheweth;

- 1) That the petitioners-were appointed in prescribed manner in the capacity of Khalasi/ Naib Qasid (BPS-03) in the respondent-department on the dates mentioned against their respective names, and each of them has rendered service of more than a decade in one and the same scale.
- 2) That the services of employees in the respondent-department are regulated by the Pakistan Forest Institute Service Rules, 2019 notified on 16<sup>th</sup> April, 2019 (Annex "A"), hereinafter referred to as the Rules.
- 3) That the next post in the hierarchy to which petitioners can be promoted is that of Junior Clerk (BPS-11), and 33% quota is reserved by the Rules for the promotion amongst the Daftari (BS-04), Naib Qasid (BS-03) and Khalasi (BS-03) with 07 years' experience as such.
- 4) That numerous vacant posts of junior clerk were/ are available in the respondent-department since long, but the respondents were taking no steps to fill the same and afford a chance of promotion to the petitioners. The said indifference of the respondents prompted the petitioners to make an application collectively on 26.02.2019 (Annex "B") requesting for their promotion in their own hierarchy.
- That it was learnt that the respondents were going to fill the vacancies of junior clerk by promotion from amongst all those who possess the Matric Certificate, irrespective of their category, and for that purpose joint tentative seniority list (Annex "C") was prepared on 06.03.2019.
- 6) That it led the petitioners to file individual applications dated 11.06.2019 (Annex "D"), requesting for preparation of a







separate seniority list of the Daftari, Naib Qasid & Khalasi, as required by the Rules; its relevant portion reads as follows:-

"Note: For the purpose of promotion, there shall be maintained a common seniority list of Daftaris, Naib Qasids and Khalasi, with reference to the date of their acquiring the secondary school certificate"

- 7) That as the seniority list was purposely not disclosed to the petitioners, they moved a joint application dated 15.07.2019 (Annex "E") under RTI, whereafter the aforesaid joint tentative seniority list was supplied to the petitioners with a covering letter dated 22.07.2019 (Annex "F")
- 8) That uptil now, no final and separate seniority list of the petitioners' category, as per the Rules, has been issued and the respondents are bent upon to promote employees of other categories, like Mali, Driver, Cleaner, Arm Guard, etc, against the vacant positions of Junior Clerk.
- 9) That feeling aggrieved and having no other adequate and efficacious remedy, the petitioners do seek indulgence of this hon'ble Court for redress, inter alia, on the following:-

#### **GROUNDS:**

- A. That as tentative seniority list has no legal value under the law, therefore, it cannot be depended upon for promotion purposes.
- B. That for promotion of the employees the final determination of their seniority inter se is essential and that is possible only after issuance of the final seniority list in accordance with the law and rules on the subject.








- C. That in the instant matter, no such exercise has been taken and the employees' final seniority is yet to determined.
- D. That it is apart that the final seniority list has not been prepared/ issued, the tentative list supplied to the petitioners is violently offending against the Rules, ibid, because the Rules provide for maintaining a common seniority list of Daftaris, Nabi Qasids and Khalasi only and none else, whereas, the list supplied is joint one and it includes other categories, such as Malis, Arms Guards, etc.
- E. That the intending promotions being made against the posts of Junior Clerks from amongst all the categories is a clear violation of the right conferred on the petitioners by law.
- F. That the other employees, such as Mali, Driver, Cleaner and Armed Guard, who are wrongly included in the joint seniority list, have their own hierarchy and line of promotion under the Rules, ibid.
- G. That petitioners have not been dealt with in accordance with law, rather they have been meted out with gross discrimination without any plausible reason and justification.
- H. That the conduct/ act of the respondents is in direct conflict with the law and rules on the subject and it is bound to land the petitioners in unnecessary litigation, hence it needs interference by this hon'ble Court.
- I. That the petitioners seek leave of the Court to urge additional grounds, after the stance of the respondents becomes known to them.





In this view of the matter, it is, therefore, prayed that on acceptance of this petition, this hon'ble Court may be pleased:

- i. to declare the impugned action/ commission and conduct of the respondents as illegal, void ab initio, against the Rules, without lawful authority and of no legal effect;
- ii. to direct the respondents to prepare a separate seniority list of the Daftaris, Naib Qasids and Khalasi as mandated by the Rules and to consider only these named categories for promotion against the vacancies of Junior Clerk;
- iii. to prohibit and restrain the respondents from considering any category of employees other than Daftaris, Naib Qasids and Khalasi for promotion against the posts of Junior Clerk; and
- iv. to grant any other relief to which the petitioners are found fit in law, justice and equity.

#### INTERIM RELIEF

Graciously, the respondents may be restrained from making promotion on the posts of Junior Clerk on the basis of the joint tentative list till final disposal of the instant writ petition.



Appeal against the promotion order dated 01.08.2019, whereby some irrelevant employees (Malis) have been promoted on posts of Junior Clerk

Sir,

With due respect and reverence, it is submitted.

- 1. That the impugned order is illegal and unlawful for the following reasons:
  - i. Only tentative seniority list has been prepared, which was not circulated to the employees according to law;
  - ii. The appellant obtained its copy under RTA.
  - The list transpired that it was not only tentative but also employees of other categories were joined therein in violation of serial No.93 of the PFI Rules, 2019, according to which for the purpose of promotion to the post of Junior Clerk a common seniority list of only Khalasis, Daftaries and Naib Qasids has to be maintained.
  - iv. No promotion could be made on the basis of a tentative seniority list.
  - v. Objections of the appellant filed against the tentative seniority list have not been answered.
  - vi. The other categories of employees included in the joint tentative seniority list, like Mali, Cleaner, Driver, Armed Guard, Workshop Attendant, Plant Collector, Plant Mounter etc have their own hierarchy of promotion.
  - vii. The writ petition against the subject issue was already pending in High Court, copy whereof was already provided to the worthy Director General, PFI, therefore, he was obliged under the law to have waited for the decision of the writ petition.
- 2. That the appellant has not been treated in accord with Rules, ibid, and has wrongly been left out from promotion, though eligible and qualified on all respects.

Therefore, it is humbly requested that the impugned promotion order dated 01.08.2019 may kindly be set aside to the extent of Serial Nos.1 & 7, the Malis and direction may be made for considering the appellant for promotion against the post of Junior Clerk (BPS-11).
