Incorrect: Respondent No. 3 proposed total eight vacant posts of SST BPS (16) for promotion, Working paper was placed before the DPC for promotion to SST BPS (16) on 31.07.2021.it is pertinent to mention here that the appellant wants promotion to SST BPS.16 (Bio-Chem) while his appointment was made on

bachelor degree while he by himself submitted before his appointment. The Respondent No.3 recommended the appellant for promotion on the condition to provided NOC for pursuing B.Sc. Degree, but the appellant did not provided the NOC with in the stipulated time .copy of the working papers is attached (Annex-A)

- 6. Incorrect: Respondent No.3 revised the vacant posts and purposed total eighteen numbers of vacant posts of SST BPS-16 in the 75% quota for promotion of in service teachers at calculation of 4% quota for A.T. No seat was procured under the service rules whereas at the time meeting of DPC could also not held (copy of the relevant documents is annexure-B).
- 7. As explained in Para.6
- 8. Incorrect : The next DPC meeting was held on dated 26.10.2022 and the above mentioned revised total eighteen vacant posts of SST BPS (16) was proposed for promotion. According to the service rules of the subject teachers' 25 % quota for initial recruitment and 75% quota for the in-service teachers along with 4% share of Arabic teachers, for the subject above meeting was held on dated 03.12.2022 where zero percent share was granted to the cadre of Subject teachers on the available vacant post SST (BPS- 16). Copy of the Notification of promotion is attached as Annex .C
- 9. Incorrect: It is pertinent to mention here that the appellant has passed B.A exam from Peshawar University. The appellant did his BSc from Allama Iqbal University. The appellant was appointed on the basis of B.A qualification as an Arabic Teacher. Working papers were placed before the DPC meeting and proposed for promotion of SST BPS.16 (Bio-Chem) which was held on 3.12.2022. The Additional Director (Estab) Directorate of E&SE, KP explained the agenda items and briefed the forum regarding the issues raised in promotion cases

due to double degree holders' Additional subject of B.A and BSc, the representative of law and Establishment Department observed that the prescribed rules are reflects Bachelor Degree as prescribed qualification only. After threadbare discussion, the forum agreed to consider only the degree which is entered in the Service book of the teacher for the first time, for promotion. Appellant was not eligible for promotion and deferred. Copy of the decision about B.A-B.Sc. degree and Notification of promotion is attached Annex .D.E

10. Incorrect.

GROUNDS.

- A. incorrect: That the appellant is not eligible under the Govt Khyber Pakhtunkhwa service Rules 2012 for promotion to the post of SST BPS-16 (Bio-Chem) under 4% promotion quota of Arabic teachers cadre whereas under 4% quota of A.T no seat was procured after calculation.
- B. That the appellant has been treated by the respondent department in accordance with law and rules and not violated Article-4 and 25 of the constitution of Islamic republic of Pakistan 1973.
- C. That the appellant was not promoted to the post of SST (Bio-Chem) (BPS-16) under 4% promotion quota on the ground being in controversy of obtained the B.A degree before the appointment and B.SC degree after the appointment in his service period.
- D. That as per the seniority the appellant most senior in seniority list of (A.T) cadre for SST. BPS.16 (General) but the Appellant wants his promotion to SST.BPS.16 (Science) on the ground being in controversy to obtain the B.A degree before his appointment and B.Sc. degree after the

the ground being in controversy to obtain the B.A degree appointment and B.Sc. degree appointment in his service period, therefore the appellant was not promoted to SST.BPS.16 (Science).






