Prayer:-

On acceptance of this service appeal, order Endst. No. 23811/15 dated 31-10-2017, may kindly be set-aside and the appellant be promoted to the post of District Revenue Accountant BPS-14 in accordance with the Government of K.P Revenue & Estate Department notification dated 23-01-2015, from the

date of impugned promotion order of respondent No. 7 with all consequential back benefits by setting aside the impugned order of Departmental Appellate Authority dated 15-01-2018.

Respectfully Sheweth:

Brief facts of the case give rise for filing the instant service appeal are as under.

1. That the appellant was appointed vide appointment order dated 24-03-2005 as a Patwari and vide subsequent order dated 31-03-2005 the appellant was posted as a Naib Tehsil Accountant at Tehsil Puran, District Shangla. (Copy of appointment order dated 24-03-2005 is attached herewith as Annexure "A", Copy of posting order dated 31-03-2005 is attached herewith as Annexure "B")
2. That the appellant served as Naib Tehsil Accountant from 31-03-2005 to 01-08-2013 with full satisfaction of his ability and devotion, where after vide order dated 02-08-2013 the appellant was transferred and was posted as Tehsil Accountant at Tehsil Puran District Shangla, performed his duty till date. (Copy of the transfer order is attached herewith as Annexure "C", Copy of ACR is attached herewith as Annexure "D")
3. That according to Government of K.P Revenue & Estate Department notification dated 23-01-2015 the Naib Tehsil Accountant shall be appointed by transfer from amongst the Patwaris, where after the Naib Tehsil Accountant shall be promoted to the post of Tehsil Accountant on the basis of seniority-cum-fitness from amongst the Naib Tehsil Accountants having three years service as such and so to the post of District Revenue

Accountant by promotion, on the basis of Seniority-cum-fitness, from amongst the Tehsil Accountant of the District with least three years service as such. (Copy of notification dated 23-01-2015 is attached herewith as Annexure "E")

4. That despite fulfilling the requisite service experience and fitness for the post of District Revenue Accountant, the official respondents illegally appointed respondent No. 7 in sheer violation of the ibid notification vide impugned order dated 31-10-2017. (Copy of the impugned order Endst: No. 23811/15 dated 31-10-2017 is attached herewith as Annexure "F")
5. That the appellant being aggrieved from the order of respondent No. 2 preferred a departmental appeal, well within time, which was rejected by the respondent No. 1 vide impugned order dated 15-01-2018 communicated to the petitioner on 26-01-2018. (Copy of departmental appeal is attached as Annexure "G", Copy of impugned order of Departmental Authority is attached as Annexure "H")
6. That the petitioner having no other adequate remedy preferred the instant service appeal on the following amongst other grounds;

GROUND:-

- a. That both the orders of the respondents No. 1 and 2 dated 31-10-2017 and 15/01/2018 are illegal, void ab-initio and against the spirit of notification dated 23-01-2015, hence not maintainable.
- b. That the respondent No. 7 was appointed on 02-12-2010 as Patwari and was transferred and posted as Tehsil Revenue

Accountant vide order dated 05-01-2016 in sheer violation of the notification of Government of K.P.K Board of Revenue and Estate Department. According to the notification the respondent No. 7 was required to performed his duty as a Naib Tehsil Accountant, but, by passing the same position the respondent No. 7 was transferred as Tehsil Accountant, which is against the mandate of service structure prescribe by the ibid notification. (Copy of transfer order dated 05-01-2016 is attached as Annexure "I")

- c. That according to seniority list of Patwaris revised on 31-05-2013 the name of the appellant is reflected at serial No. 34 of the seniority list whereas the name of respondent No. 7 promoted vide impugned order is reflected at serial No. 55, thus the respondent No. 7 is most junior from the appellant. But it is astonishing to note that the official respondents prepared a seniority list of Tehsil Accountant by mysteriously missing the name of appellant from the seniority list revised on 31-12-2016. (Copies of seniority list dated 31-05-2013 & 31-12-2016 are attached herewith as Annexure "J" & "K")
- d. That is rightly noticed by Assistant Secretary Estate Department in his working paper prepared in respect of the promotion of respondent No. 7, that respondent No. 7 has not completed three (3) years length service as Tehsil Accountant, as respondent No. 7 was transferred to the post of Tehsil Revenue Accountant Alpuri vide order dated 05-01-2016, the respondent No. 7 was not competent to be promoted to the post of District Revenue Accountant, as according to notification District Tehsil Accountant having at least three years service shall be promoted to the post of

District Revenue Accountant BPS-14. But the official respondent No. 7 appointed the respondent No. 7 illegally and refused the appellant his vested right under the law on subject. (Copy of working paper is attached as Annexure "L")

- e. That the inaction of respondents upon the departmental appeal of the appellant and disposed of the same without showing any reason established malafide on the part of respondents. So their orders are against the norms of justice and liable to be recalled.
- f. That as per the seniority list, prepared by the respondents deprived the appellant from the promotion to the post of District Revenue Accountant BPS-14 being the most senior in the cadre of Tehsil Accountant throughout District is entitled to be promoted as such.
- g. That the respondents passed the impugned office order dated 31-10-2017, while closed their eyes and intentionally deprived the appellant from promotion, which is against the service rules, as well as Civil Servant Act, of 1973 and notification dated 23-01-2015.

- i. That the respondents did not bothered to communicate the impugned seniority list prior to impugned promotion order dated 31-10-2017.

It is, therefore, humbly prayed that On acceptance of this service appeal, order Endst. No. 23811/15 dated 31-10-2017, may kindly be set-aside and the appellant be promoted to the post of District Revenue Accountant BPS-14 in accordance with the Government of K.P Revenue & Estate Department notification dated 23-01-2015, from the date of impugned promotion order of respondent No. 7 with all consequential back benefits by setting aside the impugned order of Departmental Appellate Authority dated 15-01-2018.

Under the Tehsildar/Naib Tehsildar Service Rules, the post of District Revenue Accountant shall be filled in by promotion on the basis of seniority from amongst Tehsil Accountant with at-least 03 years service. In order to fill up the post of District Revenue Accountant in District Shangla, final seniority list of Tehsil Accountant of Shangla District is at (Annexure -C).

**PRELIMINARY OBJECTIONS.**

1. The appellant has got no cause of action.

**Reply of Facts:-**

1. Correct according to the documents. Thus the appellant was posted as NTRA by the respondent No. 05/DC, Shangla on 31-03-2005.
2. Correct according to the documents. It is submitted that the post of TRA BPS-07 is a Sub Divisional cadre post and the post of TRA Puran Sub Division is still vacant.
3. Correct according to the documents/records.
4. Incorrect. The respondent No. 07 was correctly appointed as TRA Alpuri in BPS-07 strictly in accordance with the rules and regulations.
5. No comments.
6. The appellant has got no cause of action of filing instant appeal.


**Grounds:-**


- a. Incorrect as narrated in para-4 of the facts above.
- b. Incorrect as narrated in Para-4 of the facts above.

- c. Incorrect. So far the claim of the appellant with regard to the seniority is concerned, it is true that the appellant is senior to the respondent No. 07. However, as per service rules communicated by the Board of Revenue, Khyber Pakhtunkhwa, vide No. 1942/Estt:I/135/SSRC dated 23/01/2015, the post of TRA is to be filled by promotion on the basis of seniority cum fitness from amongst NTRAs having three years service as such. As the respondent No. 07 had joined the cadre of TRA vide Deputy Commissioner Shangla order No.158-69/8/2-Estt:/DC/SH dated 05/01/2016, while the appellant still occupies the cadre of Patwari not TRA/NTRA. As such the claim of appellant is not tenable.
- d. Incorrect, due to non-completion of the required length of service (i-e 03 years) the promotion of the respondent No. 07 is still on acting charge basis not on regular basis. However, the eligibility of the respondent No. 07 is stronger as compared to the appellant.
- e. Incorrect, the respondent acted according to law.
- f. Incorrect. In fact the appellant does not belong to the cadre of Tehsil Revenue Accountant. He belongs to the cadre of Patwaris. He during his entire service, has drawn his salaries against the post of Patwari.
- g. Incorrect, the appellant was treated according to rules.
- h. Incorrect, as replied above.
- i. Incorrect, the appellant was treated according to rules.






Respectfully Sheweth;

The respondent No. 7 submits as under:

**PRELIMINARY OBJECTIONS:-**

1. That, the appellant has no cause of action and locus standi to challenge the impugned order of answering respondent.
2. That the answering respondent was posted as Patwari in BPS-09, he opted to join the post of Tehsil Revenue Accountant (TRA) and was posted as such in BPS-07, in this respect he submitted his affidavit and proper deductions were also made from the answering respondent, which are still deducting (Copies of Service book, pay role and affidavit are annexure A).
3. That initial order of respondent No. 7, as TRA was issued on 05-01-2016 on regular basis, which has not been challenged properly before any competent authority or court and in departmental appeal, the appellant has only prayed for setting aside of order dated 31-10-2017, which is on acting charge basis and now the answering respondent has been promoted as District Revenue

(2)

Accountant (DRA) on regular basis after recommendation of Departmental Promotion Committee (DPC) vide order dated 12-02-2019, which has not been challenged by appellant till date, so, the instant appeal of the appellant has become infructuous.

**OBJECTIONS ON FACTS:**

1. Para No.1 of the appeal to the extent of appointment as Patwari is correct, while adjustment / posting as Naib Tehsil Accountant (NTA) on 31-03-2005 was a temporary arrangement in his own pay scale, therefore, confer no vested right of promotion as DRA, as he is still listed in the promotion list as Patwari in his own pay scale.
2. Para No. 2 of the appeal is correct to the extent that, order dated 02-08-2013 is just a transfer order and not the promotion order, as some Patwaris have been transferred as field staff, while some other have been posted / adjusted as NTRA / TRA in their own pay scales, this arrangements does not confer any right of their promotion, which is clear from the very purpose mentioned in the same order. And annexing of ACRs with the appeal is extraneous as how the appellant got copies of the ACRs.
3. Para No. 3 of the appeal to the extent of rules is correct, but the appellant cannot seek promotion to the post of TRA, as a matter of right, as he has not opted to transfer his services permanently to the post of NTRA as in the case of answering respondent. The appellant worked temporarily as NTRA in his own pay scale i.e. Basic Pay Scale 09, while the answering respondent has been properly reverted to BPS-07 as TRA on his own option and in the same line now he has been promoted to the post of DRA.

4. Para No. 4 of the appeal is incorrect, as the appellant has never ever opted to be posted as NTRA and his adjustment was only a temporary arrangement, as in the erstwhile rules, a mandatory training of 7 weeks was compulsory, as the *ibid* rules were applicable to the appellant, while there were no such provision in the new rules, where under the posting and promotion of the answering respondent has been made.
5. Para No. 5 of the appeal is incorrect, as the appellant has never challenged the initial order of the answering respondent dated 05-01-2016, as TRA on regular basis, while challenged the order dated 31-10-2017, of the answering respondent, which is on acting charge basis, which cannot confer any right on the appellant to challenge the same.

**OBJECTIONS OF GROUNDS**

- A. Ground **a** of the appeal is incorrect. The impugned order is correct and the departmental appeal of the appellant is badly time barred, furthermore, the initial order of answering respondent dated 05-01-2016, as TRA on regular basis has not been challenged in the departmental appeal.
- B. Ground **b** of the appeal is incorrect, as the appellant has not challenged the very initial order on regular basis as TRA of the answering respondent, therefore, he cannot challenge the subsequent order made on the strength of the initial order.
- C. Ground **c** of the appeal is incorrect, as the seniority list referred is not of the regular TRAs, but

that of Patwaris, which cannot confer any right for promotion in the other line i.e. RAs. The name of the appellant is missing in the seniority list of TRAs, because the same list has been prepared amongst the regular TRAs and not that of Patwaris, who have been temporarily adjusted as TRAs, because they are drawing their salaries in BPS-09.

D. Ground **d** of the appeal is incorrect. The answering respondent's service as TRA was less than 3 years, therefore, he was appointed as DRA on acting charge basis and not on permanent basis, now after conducting proper procedure, as the answering respondent completed more than 3 years as DRA, therefore, has been promoted to DRA on permanent basis vide order dated 12-02-2019 (Copy of order dated 12-02-2019 is annexure B).

E. Ground **e** of the appeal is incorrect, as the official respondents are working in accordance with law and there is no malafide or injustice on their part.

F. Ground **f** of the appeal is incorrect, as the appellant has not opted to be reverted to BPS-07 and be appointed as TRA, while respondent No. 7 opted the same, so, the name of the appellant is missing from promotion list of TRAs, prepared for 2016, furthermore, his name is still existing in the seniority list of Patwaris, as from the year 2005, he is enjoying the basic pay scale of Patwaris and was not ready to revert to lower scale, while the name of the answering respondent is not existing in the seniority list of Patwaris, issued on 31-12-2018, because he was posted as TRA on regular basis, therefore, his name is missing after his appointment

as TRA in the seniority list of Patwaris, hence, the appellant is blowing hot and cool in the same breath, as enjoying the higher pay scale and also wants to be promoted in the other line, which is not permissible and tenable in the eye of law (Copy of seniority list dated 31-12-2017 is annexure C).

G. Ground **g** of the appeal is incorrect. Detail reply has been given in the preceding para.

H. Ground **h** of the appeal is incorrect, as the appellant has not been appointed as TRA on regular basis then no question arises regarding any ACR.

I. Ground **i** of the appeal is incorrect, hence denied.

**In view of the above, it is therefore, very humbly prayed that, on acceptance of the instant written reply, the titled service appeal may kindly be dismissed with heavy cost.**
