- Correct to the extent of promotion order rest of the para is denied being incorrect. The promotion order has been issued in accordance with law. (Copies of notification no. SOE.IV (E&AD)/1-5/2014 dated: 18<sup>th</sup> July, 2019, typing test results, merit list, DSC committee minutes are annexed as annexure" C,D,E,F").
- 6. Para No. 6 is incorrect as the appellant fabricated the matter and intentionally deviating to waste the precious time of court and defendants. Rest of the points raised in para 06 are incorrect as the merit list was displayed on Notice Board.
