PRAYERS:-

On acceptance of this appeal the both, the original and subsequent appellate impugned orders passed by the respondent No. 1 dated <u>25-03-2015</u> may be set-aside and the appellant be re-instated in services with all back benefits and allied allowances.

RESPECTFULLY SHEWETH:-

2015 Store

- That the appellant belongs to a respectable family of village Kikki, (Bannu) and has joined the services and served the prisons Department as Senior Clerk for about 23/24 years with great zeal and enthusiasm and no adverse remarks whatsoever has ever been assigned to him from any quarter.
- 2. That surprisingly, the respondent No. 3 unexpectedly and all of a sudden became annoyed for the reason best known to him and besides disgracing the appellant publically, also recorded adverse remarks in his annual ACR/PER for two years consecutively. The appellant was expelled from his office to outside the jail and by relegating/demoting him from the post of senior clerk was assigned the duties of head of the Sweepers but the appellant did assume the shameful duty being the order of his Boss.
- That the appellant was given Show Cause Notice wherein proper inquiry was dispensed with for no good reason. (Copy of the Show Cause Notice is annexure "A").
- 4. That the appellant submitted his reply to the Show Cause Notice but without affording any opportunity of personal hearing, the major penalty of reduction to <u>lowest stage</u> in present time scale for three years was awarded/imposed vide first/original impugned order dated 25-03-2015 communicated/handed over to the appellant dated 26-04-2015, passed by the respondent No. 2. (Copy of the reply to the show cause notice and the original impugned order are annexure "B" & "c" respectively).
- 5. That the appellant in the given circumstances, preferred the departmental appeal before the respondent No. 1 which was dismissed vide appellate impugned order dated 25-03-2015

communicated/handed over to the appellant informally dated 26-04-2015. (Copy of the departmental appeal and impugned order thereon are annexure "p" & " ϵ " respectively).

6. That the appellant while aggrieved of the impugned order and having no other adequate remedy available in the circumstances of the case, approaches this august Tribunal for setting-aside the impugned orders-with consequential relief of his re-instatement in service with all back benefits and allied allowances on the following amongst other grounds inter-alia.

<u>G R O U N D S:-</u>

- a. That the impugned order passed by the respondent No. 1 whereas the appeal of the appellant for his re-instatement in service was dismissed, is against the facts, circumstances and law on the subject.
- b. That the impugned order has been passed in the exercise of colorful authority which is unlawful, without lawful authority, without jurisdiction, un-Islamic, un-constitutional, against the norms of equity and natural justice.
- c. That admittedly the appellant has committed no offence whatsoever and the allegations leveled in the Show Cause Notice have no concern/relevancy whatsoever with the appellant.

In reference to the first allegation given in the Show Cause Notice with regards to the stoppage of the monthly pay in r/o one Waseem Akram Warder, It is respectfully stated that an order written by hand was issued by the Assistant Superintendent Jail to the appellant, conveying the order of respondent No. 3, to stop the monthly pay of certain Warders (Properly named therein) wherein the name of Warder Waseem Akram was not mentioned and the appellant did stop the pay as per written orders but could not stop the pay of Warder Waseem Akram. Hence the appellant can never be held responsible for the payment of monthly pay to the said Warder Waseem Akram. (Copy of the order written by hand, is annexure "r").

Similarly in reference to the allegation at serial number (ii) of the Show Cause Notice, it is respectfully submitted that the Warder namely Abid Yaqoob was received on transfer from District Jail Kohat to Central Jail Bannu and as per his Last Pay Certificate (LPC) he was paid up-to 30-06-2013 (AN) from Kohat. The said LPC (at the bottom) also envisages his arrival report dated 03-07-2013 duly indorsed by the respondent No. 3 dated 04-07-2013. Furthermore, the concerned Line Muharrior Central Jail Bannu had also directed the appellant by conveying the order of respondent No. 3 to release the entire monthly pay and be paid to the transferee namely Warder Abid Yaqoob. (Copy of the LPC and order written by hand to release the pay is annexure "q" & " μ " respectively). In such factual circumstances, if both the orders are kept in juxtaposition with the Show Cause Notice, no "inference except innocence of the appellant could be drawn.

d. That the appeal of the appellant has been dismissed with a single stroke of pen and no speaking order has been passed so the fate of the appellant should not be left on the mercy of the respondents.

- e. That no proper enquiry has been conducted and the statements of the concerned PWs and even the statement of the appellant have not been recorded at least to establish the allegations against the appellant.
- f. That no statement of the PWs have been recorded on oath in presence of the appellant and the appellant has never been given a chance of cross examination and thus no credibility could be relied upon which has no value in the eyes of law if any such statement is produced by the respondents.

- g. That the respondent No. 2 while passing the impugned order has never bothered to requisition the service file of the appellant and at least should see the length of spot-less service for about 23/24 years rendered by the appellant and in such a circumstances both the impugned orders having no value in the eyes of law which are liable to be set-aside.
- h. That no chance of personal hearing which is mandatory one, has ever been given to the appellant either by the respondent No. 2 prior to the original impugned order was passed nor by the respondent No. 1 before passing the appellate impugned order.
- i. That valuable right was accrued to the appellant whereas his fundamental valuable rights have been encroached by the respondents No. 2 & 1 on their personal whims & wishes and such encroachment is hit by the command of the constitution of the Islamic Republic of Pakistan 1973.
- j. That further submissions will be advanced at the time of hearing the appellant at the bar.

In view of the foregoing facts, circumstances and submissions, it is therefore humbly prayed that on acceptance of this appeal, both, the original and appellate impugned orders may be set-aside and the appellant may be re-instated in services with all back benefits and allied allowances.

Any other remedy if available may also be extended in favour of the appellant to meet the ends of justice. Λ





Kincly refer to your show cause notice No. Nil dated Nil received on C2.7.2014 on the subject cited above

Para wise reply is submitted as under:-

- 1. It is submitted that though I am Senior Clerk and at that time the duty of pay branch was assigned to me but the resignation of warder Waseem Akram was neither received in the pay branch nar marked to the pay branch by the DDO for necessary action but rather the resignation was received to the "Line Officer" being the officer incharge of watch & ward staff as pointed out subsequently. So I was not responsible for the stoppage of pay. Moreover, the pay and allowances drawn have been recovered from the defaulter and no actual lost has been made to the "Public Exchequer".
- 2. It is incorrect that the pay of Mr. Yaqqob Warder was pertaining to the period of District Jail Kohat. Form the LPC of Mr. Yaqoob Warder is indicating that the whole period pertains to the Central Prison Bannu as is evident he has been relieved of his duties from District Jail Kohat on 30.06.2013 and assumed his duty in Central Priscri Bannu on 23/12/2014. Only the intervening period between relinquishment and assumption of charge in Bannu is two months and required sanction for extension in joining time.

Therefore, the charges of fraud is baseless, unfounded and melafide. Furthermore because it will be proper to mention here that notice of inquiry was not served upon met however, the inquiry officer called me at the last working time to appear before him and where the inquiry officer recorded my statement from the general discussion made between mine and him containing some on the record and some off the record facts. Thus giving no chance for defense statement in my favour o have been prepared systemically prefer in written shape. The inquiry report has been prepared in hap-hazart ignoring the important points.

Keeping in view the above position the charges leveled against me are one sided and prejudice.

It is therefore very hurribly requested that the inquiry report and baseless charges be withdrawn.

Had the Superintendent Central Prison Bannu was of the view that pay of Warder Abid Yaqoob hould not be disbursed to him, the acquitance roll for onward submission to the accounts office
- 5. Being subordinate official ham not record holder on my general correspondence and when ever any letter pertaining to my field is received the same is marked to me by the authority for compliance where as in this case no such letter/directions have been received regarding the stoppage of pay of the warder Abid Yaqqobiand therefore, no fault lies upon my shoulders.



- t is the bounding Principles' laid down by the court in deferent ruling as whenever Major penalty is to be inflected upon any official/officer then Proper opportunity will be provided to the defaulter officers/officials for his defense including final show cause notice accompanied with the findings of the inquiry officer, but in my case all these provisions have blatantly been violated and inflected major penalty upon me ignoring the principal defaulter.
- 7 It will be proper to mention hear that notice of inquiry was not served upon me, however, the inquiry officer called me at the last working time to appear before him and where the inquiry officer recorded my statement from the general discussion made between mine and him containing some on the record and some off the record facts. Thus giving no chance for defense statement in my fever to have been prepared systematically prefer in written; shape. The inquiry report has been prepared in hap hazard ignoring the important points.

I have not committed any crime nor indulged in any mal practice but I have been made scape-goat for the entire dilemma. The charges leveled against me have not proved during the course of inquiry proceedings but even then I have been blamed for the same.

Prayer:-

In the light of the above facts and circumstances it is requested that the order of the inspector General of Khyber Pakhtuhkhwa Prisons may be set aside and major penalty may be removed from my service record or a denovo inquity may be ordered, as I am fully and completely innocent in the instant case and that the main responsible defaulter officer i.e. Superintendent Jail Bannu may be panelized for such blunder, mishap and inefficiency towards his job.







That the appellant has got no cause of action.

ii. That the appeal is incompetent and is not maintainable in its present form.

Incorrect, misleading. Though the appellant served Prisons Department for more than two long decades yet it is on record that his track service record is not so neat and clean as claimed in his appeal as evident from "Annex-A".

The plea of the appellant is without any logic because there exists proper mechanism with regard to resolution of any issue on account of adverse entry in the PER of the incumbent. As far as assigning of any official task / duty is concerned, it is upto the competent authority to assign him the task fit for him hence there is no space to regret any assigning official task. Moreover, in the official arena there is no such assignment to which one can call a shameful assignment, it is nothing but the self assumed prestige to underestimate or overestimate any official duty / assignment.

Incorrect. It is the lame excuse of the appellant using such terminology after the conduct of proper departmental proceedings / findings thereof and imposition of penalty of "Reduction to lowest stage in present time pay scale for three years".

Incorrect, mis-leading. As elaborated in preceding Para, Departmental proceeding made with regard to the Show Cause Notice and Charges framed thereafter and on the

basis of recommendation made by the inquiry officer, the penalty was imposed upon the appellant.

Incorrect, the departmental appeal was accordingly processed but having no sound footing, it was accordingly could not acceded to, thus was filed.

No comments however, the plea of the appellant is not based on facts.

- A. Incorrect, the departmental appeal was accordingly processed but having no sound footing, it was accordingly not acceded to, thus filed.
- B. Incorrect, on the basis of recommendation / findings of the inquiry, the competent authority while considering all other materials / matters available on record has finally awarded a penalty as required under the law and relevant rules.

Incorrect, being involved in an intentional fraud in respect of non payments to the concerned quarters and thus sustaining loss to the Public Exchequer. Incorrect plea of the appellant that name of warder Waseem was not included in the hand written orders that is why his pay was not stopped, if considering this plea of the appellant then why he did not bring the matter of non-payment of monthly salary of an absent warder for long. Keeping his pay with himself for no reason as long as it was detected by the concerned authority is in it-self sufficient proof of his guilt. Furthermore, transfer cases have their own patent rules which are mandatory for all officials and there is no need of taking fresh orders from any authority because the documentary proof resolve all such issues without any complications.

Incorrect, the departmental appeal was accordingly processed but having no sound footing it could not acceded to and was filed.

- As elaborated in the preceding Paras, that as per laid down procedure proper inquiry was conducted and after fulfilling all codal formalities, the penalty was imposed upon the appellant.
 - Incorrect, misleading, as elaborated in Para-"E", the laid down procedure was properly adopted and all required steps were taken in proper and judicious manner.

In order to know the factual position of the case, Mr.Samiullah Deputy Superintendent cum-Superintendent District Jail Kohat was directed to proceed to Central Prison Bannu and conduct a detailed inquiry in the matter and fix clear cut responsibilities on the shoulder of officer/official at fault with specific charges/rules violated in the matter and submit his report vide this office letter No.3/2-J-91/12640-WE dated 14-5-2014 (copy enclosed). The officer concerned submitted his inquiry report for further necessary action vide his letter No.1541-WE dated 05-6-2014 (copy enclosed). According to the said report, he fixed responsibility on the shoulder of appellant. As required, Show Cause Notice was served upon the accused official under Rule-5(1)(a) read with rule-7 of E&D Rules 2011 through Superintendent Central Prison Bannu vide this office letter No.17390-WE Dated 25-6-2014 (copy enclosed). The accused official furnished his reply but the same were found un-satisfactory, however, before passing final orders the opportunity of personal hearing was also afforded to him vide this office letter No.19887 dated 23-7-2014 (copy enclosed).

As the charges stood proved against the accused official, upon completion of procedural formalities, he was awarded the major penalty of "Reduction to lowest stage in present time pay scale for three years" vide this office order No.26276 dated 23-10-2014(copy enclosed).

FIEDINGS:

The indersigned came to know that there were irregular with lawyal of pay of warders namely Waseem Akram and Abid Yaqoob. Waseen, Akram tendered his resignation on 22/01/2014 copy of Roznamcha is attached as Anioxure 10° as above, but his pay under the rules, was not stopped by the Soular elerk for which he was served with explanation notice vide Superiorundent of the No. 1514 dated 16/04/2014. Following his orders the Senior Clerk represented the buy of the Warder Waseem Akram to the tune of Rs. 38197/- for the booths of January and February and deposited the same on chahan (10, 01) dated 17/04/2014 into the Opterminent treasury(copy panexed as Anioyure 12° above.

Similarly, Warder Abid Yaqoob absented hin self. from Internment Center Kohat on 710097/2013 and his pay was stopped at Internment Center from 1/05/2013 and he was relieved for Central Prison Bannu on 2/12/2013 in his absentia and her reported arrivel at C.P.Bannu on 23/12/2014. The senior Clerk draw the pay of the Warder Abid Yaqoob'at C.P. Bannu for seven months' collectively metuding the period of his duty at Intermment Center Kohat in which he was totally absent from the duty without the sanction of the competent authority. The source pay of the warder Abid Yaqoob is attached as annexure "G" which is full of Hunders'r along with pay roll attached as annexure "E" as above. Further the Senior clerk is baned non-cutering the main gate and entrusted with the job which is nor related to him i.e., supervision of class 1V staff.

Recommendations:

After perusal of the statements given by the officers/officials and commining ground realities the undersigned came to the following conclusion and proposes the blowing recommendations in the best interest of the jail administration.

That warder Abid Yaqoob remains continuously absent from the cury and he is still at large and he also received his pay irregularly for sever, months, therefore, he may be awarded major penalty along with recovery of seven months pay from him.

That concerned Senior Clerk Muhammad Latif was allotted the daty of 2) Pay-incharge who irregularly draw the pay of the staff which shows negligence on his part thus he has violated Rule No. 15,16 and 23 of GFR. But is he has rectified his blunder and recovered the amount from one warder Wascem Akram and diposited into Government treasury as mentioned above but irregular with dratvel of pay to the tune of Rs.117294/ is still pending to the warear relaid Yet, sob for which the Senior Clerk is mainly responsible as he draw the pay of District Kohat in District Bannu which is clear violation of Rule 80.71 of Traisury Rules read with rules quoted above. The case is that of only recovery mander Aria Yaqoob, therefore, the Senior Clerk Muhammad Latif may É be evaluated things penalty and be transferred on administrative groups, to any other jail as there is already mistrust between Superintendent and clerk. concerned, so that the clerk concerned may efficiently perform his duty at any other jail.

REJOINDER ON BEHALF OF THE APPELLANT.

REPLY TO THE PRELIMINARY OBJECTIONS:-

- i) Incorrect. The appellant has a good case arguable and is sanguine of its success while having proper cause of action.
- ii) Incorrect. The appeal is competent and maintainable and has never been filed on malafide intention rather it has filed on bonafide intention.
- iii) Incorrect. No rule of estopple is attracted in the instant appeal
- iv) Incorrect: The Appellant has proper locus-standi while filing the instant appeal.
- v) Incorrect. All the necessary parties have been arrayed as parties therein.
- vi) Incorrect. The Appeal in hand is well within time.

FACTS :-

- 1) Incorrect. Reply to Para-1 is ambiguous and misconceived. The appellant being highly eligible, having put more than two decades of spotless services has never committed any irregularity or illegality. As for as the document annexure-A with the comments/reply is concerned, it is a mere statement of the complainant having nothing to support and no such complaints/documents have been appended thereto.
- 2) Incorrect. The respondents have departed from the legal issue and have assumed the role of interpreter/analyst and have given misconceived reply having no overlapping status on the plea of the appellant.

3) Incorrect. It is not a lame excuse whereas the illegality and incurable irregularity is floating on the surface of the record and the appellant has never been treated in accordance with law.

- 4) Incorrect. As explained in Para-3 above.
- 5) Incorrect. The departmental representation has never been considered legally and except to file the appeal with a single stroke of pen no legal reply has been given. Neither the departmental appeal has ever been given any legal weight nor has a chance of personal hearing ever been bestowed in order to unearth the actual facts.
- 6) Incorrect. The plea of the appellant is legally very transparent and appealable to the prudent mind.

GROUNDS.

(ئ

- a) Incorrect. The departmental representation has never been considered legally and except to file the appeal with a single stroke of pen no legal reply has been given. The departmental appeal has never been given any legal weight.
- b) As explained in the preceding Paras, the reply to Para-b is ambiguous, misconceived and denied. The major punishment on such malicious, vexatious, and frivolous grounds is against the canon of law and is liable to be set-aside.
- c) Incorrect. Neither a single penny is embezzled or misappropriated nor any fraud either committed or detected and no loss of a single penny has ever been sustained to government exchequer in the instant case at the hands of the appellant. The replying respondents have exaggerated the allegations over allegations which have no overlapping status on the evidence so furnished or demanded by the appellant as law shall follow its own course. The record of both the Jails regarding the transfer of the official concerned if kept in juxtaposition; it will automatically eliminate the allegation leveled against the petitioner/Amellant.
- d) Incorrect. As explained in Para-a above.
- e) Incorrect. The appellant has never been associated in the so-called inquiry nor has the appellant ever been given a chance of crossexamining the PWs.

- f) Incorrect. As explained in Para-e above. It is further added that no statement of the PWs in presence of the appellant have been recorded on oath and the appellant has never been given a chance of cross examination and thus no credibility could be relied upon which has no value in the eyes of law.
- g) Incorrect. That the respondent No. 2 while passing the impugned order has never bothered to requisite the service file/record of the appellant and at least should see the length of spot-less services for about 23/24 years, rendered by the appellant. No chance of personal hearing which is mandatory one, has ever been given to the appellant either by the respondent No. 2 prior to the original impugned order was passed nor by the respondent No. 1 before passing the final impugned order and in such a circumstances both the impugned orders having no value in the eyes of law which are liable to be set-aside.
- h) Incorrect. As explained in Para-f & g above.
- i) Incorrect. As explained in the preceding Paras, the reply to Para-i is ambiguous, misconceived and denied. The major punishment on such malicious, vexatious, and frivolous grounds is unlawful, without lawful authority, against the law on the subject and against the fundamental rights of the appellant guaranteed by the constitution and is liable to be set-aside.

j) Legal.

It is therefore humbly prayed that the comments submitted by the respondents be set at naught and the appeal of the appellant may graciously be accepted by redressing her grievances as prayed for in the appeal.
