Parawise Comments on Behalf of the Respondent No 1-3

Respectfully shewith

Preliminary objections

1. That the Appellant is not an aggrieved person within the meaning of Section 4 of the Service Tribunal Act, 1974.
2. That the Appellant has no cause of action / locus standi.
3. That the Appellant has not come to this Honorable Tribunal with clean hands.
4. That the Appellant has filed this instant Service Appeal just to pressurize the respondents.
5. The present Service Appeal is liable to be dismissed for non-joinder/mis joinder of necessary parties.
6. That the instant Service Appeal is against the prevailing law and rules.
7. That the Appellant has filed this instant Service Appeal on malafide motives.
8. That the instant Appeal is **badly time barred**.
9. That the instant Service Appeal is not maintainable in the present form, and above in the present circumstances of the issue.
10. That the Appellant has been estopped by his own conduct.
11. That the Appellant has concealed the material facts from this honorable tribunal.

FACTS

1. That the Para No.1 pertains to record, hence no comments.
2. That the Para No.2 is incorrect and denied. The Appellant has no clear service record. He remained absent from his duty time and again during his entire service which is evident from the copies of the teachers attendance register of the School and the ASDEO report therein. Even in September 2004 and October 2004 he remained absent for many days

and obtained salaries without any duty. (**Copies of attendance register attached as annexure A**)

3. That the Para No.3 is correct.
4. That the Para No.4 is correct as the appeal of the Appellant was badly time barred.
5. That the Para No. 5 is correct to the extent of filing of instant Service Appeal, the rest of the para is incorrect and denied. The Appellant is not an aggrieved person within the meaning of Section 4 of the Service Tribunal Act, 1974. Moreover, the instant Service Appeal of the Appellant is once again badly time barred and bereft of any merit, hence, liable to be dismissed inter-alia following grounds.

GROUNDS

- A. That the Para No. A is incorrect and denied. The respondent department has not acted against the norms of services, laws and rules.
- B. That the Para No. B is incorrect and denied. The Appellant remained wilfully absent from duty and was a habitual irregular in his duties. He remained absent for a number of occasions which is evident from attendance register and reports of IMU and ASDEO concerned. It is further clarified before this Honorable Tribunal that the Appellant has illegally and without performing duty has received monthly salaries and resultantly caused a huge financial loss to the public exchequer. (**Copies of ASDEO Report and log book attached as annexure B**)
- C. That the Para No. C is absolutely incorrect and denied. The Appellant himself remained absent from his duty and was rightly removed from service. No Article of the constitution provides protection to such inefficient and irregular civil servants and the respondent department has not violated any article of the constitution.
- D. That the Para No. D is incorrect and denied. Show cause notice as well call notice were served upon the Appellant and being reported by IMU for continues so many months, therefore, the competent authority being satisfied that there needs no enquiry, issued removal from service order in respect of the Appellant. (**Call Notice as Annexure C**)
- E. That Para No. E is incorrect and denied. Detail reply has already been given in the foregoing paras.
- F. That Para No. F is incorrect and denied. No discrimination has been made with the Appellant by the respondent department.
- G. That the Appellant wants to obtain illegal and unjust benefit of the rules as narrated in para No. G of the instant Service Appeal. The Appellant wants undue favor of the rules in such a belated stage for the fault of his own.
- H. That Para No. H is incorrect and denied. The competent authority being satisfied with the reports of absenteeism and service record of the Appellant was rightly removed from service. It is further to be noted by this Honorable tribunal that if the Appellant was aggrieved of the



- removal order, he should have submit departmental appeal for redressal of his grievances (if any) within the stipulated time. Hence, his appeal being badly time barred is liable to be dismissed on this score alone.
- I. That Para No. I is the repetition of above paras, hence, no comments.
 - J. That Para No. J is incorrect and denied. The worthy Apex Court has not guaranteed the undue rights of anyone in such a manner and after such a long time.
 - K. That Para No. K is correct to the extent of qualifying service for pension but the Appellant wants to use this statement for his own benefits without considering other relevant rules and procedures. The benefits of pension on the basis of minimum qualifying service of 10 years is only applicable to those civil servants who gets honorable retirement i.e pre-mature retirement, medical ground retirement etc whereas the Appellant has got no retirement but he was removed from service and there are no rules that on removal from service the Appellant could be granted pensionary benefits.
 - L. That detail reply of this para has already been given in the foregoing paras.
 - M. That the respondent also seek permission of this Honorable Tribunal to raise/argue further grounds at the time of arguments.

It is, therefore, very humbly prayed that the instant Service Appeal of the Appellant may be dismissed with cost in favor of the respondents.




