Learned counsel for the appellant argued that the appellant was serving as PST at GGPS Habibullah Korona when promoted as PSHT (BPS-15) in the same school vide order dated 2.3.2013 followed by adjustment order dated 13.5.2013. That the appellant is serving in the said school since then. That private respondent No. 4 was initially transferred against the post occupied by the appellant vide order dated 22.5.2014 which order was cancelled on the intervention of the appellant vide order dated 31.5.2014 but the same was again restored vide impugned order dated 5.6.2014. That the appellant preferred departmental appeal on 12.6.2014 followed by a civil suit which was returned for want of jurisdiction and hence the instant service appeal on 26.5.2015 i.e soon after return of the civil suit.

That that appellant is entitled to retain the post of PSHT at GGPS Habibullah Korona and the transfer/posting of private respondent No. 4 was politically motivated, unjust and not tenable in the eye of law.

Appeal Under Section-4 of KPK Service Tribunal Act, against the order dated 05.06.2014, whereby the order dated 22.05.2014 in respect of the posting of respondent No.4 as PSHT BPS-15 at GGPS Habibullah Korona Jehangera Nowshera vice the appellant has been restored against which the departmental appeal dated 12.06.2014, of the appellant has not been respondent despite the lapse of statutory period.

Prayer in Appeal:

On acceptance of this appeal the order dated 05.06.2014 may please be set aside and the appellant has since already took over the charge of PHST (BPS-15) at Habibullah Korona in pursuance of her promotion and adjustment orders dated 02.03.2013 and 13.05.2013, as such she may be allowed to continue her duty as PHST at GGPS Habibullah Koroona or any other remedy being Just and proper under the circumstances of Case.

Respectfully Submitted:

1. That the appellant was initially appointed as PTC Teacher in the respondents department. It is pertinent to mention that the appellant remain posted at different station as and when directed / posted. Lastly she was posted at GGPS Habibullah Korona Jehangera ,Nowshera.
2. That while serving in the said capacity the appellant was promoted as PSHT BPS-15 vide promotion order dated 02.03.2013 since the appellant was the senior most at her School at GGPS Habibullah Korona therefore, on her promotion to the post PSHT BPS-15, under the up gradation /promotion policy she was adjustment at same School vide adjustment order dated 13.05.2013. The appellant took over charge of higher post and started performing her duties. It is pertinent to mention here that vide the same orders the Respondent No. 4 was also promoted as PSHT (BPS-15) and on her promotion she was posted at GGPS Katti Maina, (Jhanghira) Nowshera. *(Copies of promotion order dated 02.03.2013, order dated 13.05.2013 and charge report is attached as annexure A , B & C)*
3. That in the mean time the appellant also approached the respondent for fixation of her pay in the higher post i.e in BPS-15 against which she has been promoted and working, the appellant was however, verbally assured that her grievance will be redressed.
4. That the appellant while agitating the matter of her pay, one respondent No.4 who happened to be a political favorite, she exerted political pressure and managed to get herself posted/transfer as PHST at GGPS Habibullah Korona on the recommendation of MPA PK-15 Mr.Idress Khan vide order dated 22.05.2014. It is pertinent to mention though the appellant was posted/promoted as PHST at GGPS Habibullah Korona and as such the post of PHST was occupied by her , however vide the order dated 22.05.2014 the post of PHST BPS-15 was wrongly shown as vacant. *(Copy of order dated 22.05.2014 is attached as Annexure D)*
5. That the appellant approached the Respondent No.3 and explained the position that the post being occupied by her on her promotion as PHST BPS-15, thereafter the respondent No.3 while realizing her mistake vide order dated: 31.05.2014 withdrawn/cancelled the order

dated 22.05.2014. *(Copy of order dated 31.05.2014 is attached as Annexure E)*

6. That again due to the political pressure of the respondent No.4 the order dated 22.05.2014 was restored in favour of the Respondent No.4 vide order dated 05.06.2014. *(Copy of order dated 05.06.2014 is attached as Annexure F & C)*
7. That the appellant submitted her departmental appeal, however it was not responded. Thereafter due to a wrong advice the appellant bonafiedly file a civil suit in the court of Senior Civil Judge Nowshera, the same was however return to the appellant vide order dated 14.04.2015 due to lack of Jurisdiction. *(Copies of Departmental appeal, Civil Suit and order dated 14.04.2015 is attached as Annexure G-H&I)*
8. That the impugned order is illegal, unlawful, without lawful authority against law and facts, politically motivated, and against the transfer and posting policy hence liable to be set aside inter alia on the following grounds:

GROUND OF SERVICE APPEAL:

- A. That the appellant has not been treated in accordance with law her rights secured and guaranteed under the law are badly violated.
- B. That the impugned transfer orders are illegal, unlawful, void ab-initio, without lawful authority, hence liable to be set aside.
- C. That the appellant has not been allowed to complete her tenure and thus the order impugned is violation of transfer posting policy of the Govt and the judgment of the apex court reported in PLD 1995 SC Page No 530 and PLD 2013 Supreme Court Page No 195. *(Copy of the Transfer and posting policy is attached as Annexure J)*
- D. That in the impugned order dated 05.06.2014, the post of PSHT-15 at GGPS Habibullah Kuroona was shown vacant, despite the fact that the appellant was already promoted and adjusted against the said post vide orders dated 02.03.2013 and 13.05.2013. Thus the impugned transfer order dated 05.06.2014, is a wrongful and ambiguous order and is not implementable.


- E. That the promotion of the appellant was made by the competent authority, she has duly performed her duties against the said higher post albeit the respondents have also malafidly not fixed the salary of the appellant in the higher post.
- F. That the impugned order is also passed in violation of the Rationalization policy of the Respondents since the appellant was the senior most, therefore on her promotion as PSHT BPPS-15, she was retained at her own school, however due to political pressure of the respondent No.4, the post at GGPS Habibullah Kooruna was shown vacant and she was posted vice the appellant which amounted to clear violations of the respondents department own policies. *(Copy of the Rationalization policy is attached as Annexure K)*
- G. That during the posting of the appellant at GGPS Habibullah Kuroona, her performance remained commendable and there was no complaint whatsoever regarding her performance.
- H. That in fact there exist no exigencies of service nor the order of transfer can be termed as in the public interest, rather it was issued in violation of law and transfer / posting policy of the Provincial Govt in favour of the political favorite Respondent No. 4, who has used political influence for her choice positing.
- I. That in fact exerting political pressure in obtaining choice posting amount to misconduct under the Govt. Servants Conduct Rules, 1987, thus the transfer order is liable to be set aside on this score alone.
- J. That the impugned transfer order is illegal, unlawful, without lawful authority and passed without jurisdiction, not in the prescribed period, in violation of transfer and posting policy.
- K. That the order dated 13.05.2013 of the appellant were made by the competent authority, the appellant duly took charge of her new post and performed duties, thus the legal and competent order cannot be cancelled / withdrawn in such an abrupt manner, moreover the respondents are also bond under the law to fix the salary of the appellant in the promoted post i.e PSHT BPS-15, from the date of her promotion.
- L. That the Respondent without carrying of law issued frequent transfer orders and thus has made the appellant a rolling stone.





1. That the appellant has today filed the accompanied appeal before this honorable tribunal in which no date of hearing is fixed so far.
2. That the applicant prays for the condonation of delay if any in filing the instant appeal inter alia on the following grounds:-

GROUND OF APPLICATION

- A. That the prior to the institution of this appeal the applicant due to a wrong advice filed civil suit before the Court of Senior Civil Judge Nowshera for the redressal of her grievance which was disposed off in following words:

“.....Hence, in light of the above , it is held that this court is not competent to entertain the present suit as it has got no jurisdiction to adjudicate upon the matter in issue which falls within the exclusive domain of the service tribunal. The suit of the petitioner/plaintiff is therefore, returned. Parties are left to bear their own costs.

Muharrir of this court is directed to do the needful as per law...”


- B. That thereafter the petitioner approached this Hon'ble Court within time. Since the applicant diligently pursuing her remedy, her case deserves to be decided on merits and the delay if any should be condoned. In this respect SCMR 1990 Page 1 is worth perusal.

- C. That valuable rights of the appellant are involved in the instant case, moreover the appellant throughout agitated the matter firstly before the department and then bonafidely before the Civil Court, hence the delay if any in filing the instant case deserves to be condoned.
- D. That the delay if any in filing the instant appeal was not willful and deliberate hence deserves to be condoned.
- E. That under the law time consumed in filling and pendency of appeal before the wrong forum must be excluded for the purpose of limitation.
- F. That it has been the consistent view of the Superior Courts that causes should be decided on merit rather than technicalities including limitation. The same is reported in 2014 PLC (CS) 1014, 2003 PLC (CS) 769.

ANNEX-I

This order of the court would dispose of an application submitted under Order 07, Rule 11 of the code of civil procedure for rejection of the plaint on the ground of lack of jurisdiction.

Arguments on the application heard and record perused.

Perusal of the record reveals that the petitioner/ plaintiff has brought the instant suit against the respondents/defendants whereby she has challenged the orders bearing endorsement No 104-08 dated Nowshera the 22.05.2014 and office order No 369-72 dated 05.06.2014 on the ground of its being wrong, illegal and ineffective upon rights of the petitioner/plaintiff and has also sought for the issuance of perpetual injunction for restraining the respondents from transferring her to any other school.



Respondents/defendants were summoned amongst whom defendants No. 1 & 2 were placed and proceeded ex-parte whereas respondent/defendant No 3 instead of submitting written statement, submitted the instant petition for rejection of the plaint Under Order 07, Rule 11 of the code of Civil Procedure.

No doubt the matter in issue pertains to the transfer of the petitioner which is definitely covered by the terms and conditions of her service and as per Article 212 of the constitution of Pakistan 1973, it falls within the exclusive jurisdiction of the service tribunal. Here wisdom is drawn from various judgments of the superior courts which has categorically held with the posting and transfers falls within the terms and conditions of the service of a civil servant which cannot be entertained and adjudicated upon in the civil courts.

Hence, in light of the above, it is held that this court is not competent to entertain the present suit as it has got no jurisdiction to adjudicate upon the matter in issue which falls within the exclusive domain of the service tribunal. The suit of the petitioner/plaintiff is therefore, returned.

Parties are left to bear their own costs.

Muharrir of this court is directed to do the needful as per law.

File be consign to record room after its completion and necessary compilation.

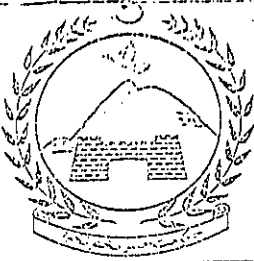

POSTING/TRANSFER POLICY OF THE PROVINCIAL GOVERNMENT:

- i) All the posting/transfers shall be strictly in public interest and shall not be abused/misused to victimize the Government servants
- ii) All Government servants are prohibited to exert political, Administrative or any other pressures upon the posting/transfer authorities for seeking posting/transfers of their choice and against the public interest.
- iii) All contract Government employees appointed against specific posts, can not be posted against any other post.
- iv) Existing tenure of posting/transfer of three (03) years for settled areas and two (02) years for unattractive/hard areas shall be reduced to two (02) years for settled areas, 01½ years for unattractive areas and one year for hard areas. *(See as set in...)*
- v) *2 years tenure retained vide P-06 for un-attractive/hard areas*
- vi) While making posting/transfers of officers/officials up to BS-17 from settled areas to FATA and vice versa approval of the Chief Secretary, Khyber PakhtunKhwa needs to be obtained. Save Tehsildars/Naib Tehsildars within a division in respect of whom the concerned Commissioner will exercise the same power. Whereas, in case of posting/transfer of officers in BS-18 and above, from settled areas to FATA and vice versa, specific approval of the Governor, Khyber PakhtunKhwa shall be obtained.

Provided that the power to transfer Political Tehsildars and Political Naib Tehsildars within FATA between different divisions shall rest in Additional Chief Secretary FATA.

- vi (a) All Officers/officials selected against Zone-I/FATA quota in the Provincial Services should compulsorily serve in FATA for atleast eighteen months in each grade. This should start from senior most scales/grades downwards in each scale/grade of each cadre.
- vii) Officers may be posted on executive/administrative posts in the Districts of their domicile except District Coordination Officers (D.C.Os) and DPOs/Superintendent of Police (SP). Similarly Deputy Superintendent of Police (DSP) shall not be posted at a place where the Police Station (Thaana) of his area/residence is situated.

- viii) No posting/transfers of the officer's/officials on detailment basis shall be made.
- ix) Regarding the posting of husband/wife, both in Provincial services, efforts where possible would be made to post such persons at one station subject to the public interest.
- x) All the posting/transferring authorities may facilitate the posting/transfer of the unmarried female government Servants at the station of the residence of their parents.

- a) To ensure the posting of proper persons on proper posts, the Performance Evaluation Report/annual confidential reports, past and present record of service, performance on post held presently and in the past and general reputation with focus on the integrity of the concerned officers/officials be considered.
- b) ✓ Tenure on present post shall also be taken into consideration and the posting/transfers shall be in the best public interest.

xiv) Government servants including District Govt. employees feeling aggrieved due to the orders of posting/transfer authorities may seek remedy from the next higher authority / the appointing authority as the case may be through an appeal to be submitted within seven days of the receipt of such orders. Such appeal shall be disposed of within fifteen days. The option of appeal against posting/ transfer orders could be exercised only in the following cases.

- i) ✓ Pre-mature posing/transfer or posting transfer in violation of the provisions of this policy.
- ii) Serious and grave personal (humanitarian) grounds.

2. To streamline the postings/transfers in the District Government and to remove any irritant/confusions in this regard the provision of Rule 25 of the North West Frontier Province District Government Rules of Business 2001 read with schedule - IV thereof is referred. As per schedule-IV the posting/transferring authorities for the officers/officials shown against each are as under:-

Contrary to the Policy, Store Keepers, Cashiers, Accountants and other ministerial staff remains posted in their particular field for long time, which may result in misuse of this position, due to which not only public exchequer may sustain loss but general public also suffers. The Provincial Government has taken serious notice of this situation & decided that all Administrative Secretaries and DCOs may submit a certificate within one month to the effect that above mentioned officials, having completed three years on their posts, have been adjusted on posts other than those they held previously.

- iii. At the time of entry in service, all civil servants be asked to give 4 options from unattractive areas.
- iv. After a stint of service in unattractive area, employees may be offered option to serve in district of choice.

7 PLACEMENT POLICY.

In order to utilize the expertise of the officers who have received foreign training in various fields, the provincial Government has decided to adopt the Placement Policy, approved by the Prime Minister of Pakistan, and make it a part of its Posting/Transfer Policy. Placement Policy is as follows:-

- i) All placements would be made on the basis of merit and keeping in view the needs of the organization.
- ii) The first priority in placement must go the parent organization of the participant from where the individual had applied. This will be in

consonance with the concept of establishing the "Need" for the department and fulfilling the need through "capacity building for the organization.

- iii) In order to follow the "bottom up approach" for Devolution, the priority within departments must go to the Districts, the Provinces and than the Federal Government.
- iv) The second priority in placement should go to up-grading the existing training Institution within the country. The knowledge gained by the officers, will be of immense value to bring about a qualitative change in the training institutions. The following proposals are made in this regard:
 - a) Permanent posting of an officer to the training institutions for 2-3 years;
 - b) Temporary attachment with the training intuitions for 3 to 6 months for some research project, on helping in developing case studies;
 - c) Earmarked as a visiting faculty member for specific subject.
- v) Individuals posted to their parent organizations will also organize training for their subordinates within the department, in order to transfer the knowledge and bring about a qualitative change internally;
- vi) The Normal tenure of posting as already provided in the policy would be ensured;
- vii) No participant should be allowed to be posted on deputation to multinational donor agencies for at least 5 years;
- viii) No participants will decline/represent against his/her posting.
