**Respectfully Sheweth,**

1. That the captioned Service Appeal is pending adjudication before this Hon'ble Tribunal and is fixed for 26/05/2023.
2. That in the titled appeal the appellant has challenged the vires of the service rules which are ultra vires of the law rules on the subject.
