REPLY BY RESPONDENTS NO. 1 &2.

Respectfully Sheweth:-

PRELIMINARY OBJECTIONS:-

- 1. That the appeal is badly barred by law & limitation.
- 2. That the appeal is bad for mis-joinder and non-joinder of necessary and proper parties.
- 3. That the appellant has not come to Hon'ble Tribunal with clean hands.
- 4. That the appellant has no cause of action and locus standi to file the instant appeal.
- 5. That the appellant is estopped by his own conduct to file the instant appeal.
- 6. That the appellant has concealed the material facts from Hon'ble Tribunal.
- 7. That the appeal is not maintainable being devoid of any merit.

REPLY ON FACTS:-

- Correct to the extent that the appellant was appointed as constable in the year 1988 in the
 respondent department. However, the performance of appellant during service was not
 upto the mark and earned 05 bad entries, 02 Minor and 02 Major punishments on his
 credit on different occasions during his service.
- 2. Para pertains to personal information and service record of the appellant.
- 3. Correct to the extent wherein the appellant admitted that he was given promotion/confirmation in list "D" rightly in accordance with law/rules and with his colleagues. The appellant was promoted to the rank of officiating ASI with his colleagues vide notification No.35982/EC-I dated 16.06.2008. (Copy of notification is attached as A).
- 4. Incorrect. The real facts of the Para are that the appellant was proceeded departmentally on charges of being misused his official authority by threatening and preventing one Amjid Ali from marrying and also developed illicit relation with mother in law of Amjid Ali. In this regard he was issued charge sheet and proper departmental enquiry was conducted against him. During the course of enquiry the charges leveled against him were proved. After completion of all codal formalities he was awarded the major punishment of time scale for the period of 03 years vide OB No.710 dated 24.02.2011. However, on his departmental appeal the punishment order was set aside by the appellate authority due to his long service of about 23 years vide order dated 11.03.2013 (copy of punishment order and departmental appeal are attached as B,C).

- 5. Incorrect. His confirmation and his "E" list seniority has been correctly ante-dated and there is no hard fast rule that a police Officer will be placed with his batch-mates in seniority of all rank because often promotion leads to earlier confirmation. Furthermore, promotion of offg; Sub Inspector from list "E" is also made on available vacancy. Hence, the appellant was deferred from confirmation in the rank of ASI due to major punishment of time scale as well as non availability of ACRs for the year 2008, 2009, 2010, 2011 and 2012, which were mandatory for confirmation/Promotion(copy of notification is attached as D). Later on the appellant was given revised seniority and confirmation in the rank of ASI and promotion to list E with his other colleagues vide notification No.15761/EC-I dated 10.12.2014.(copy of notification is attached as E).
- 6. As explained in the above Para. Seniority of the appellant was then revised and confirmed in the rank of ASI and promotion to list "E" with his other colleagues mentioned in the Para. The appellant was also promoted to the rank of Offg: SI with his other colleagues promoted on 10.03.2012. Further, Colleagues of the appellant were confirmed in the Rank of SI after completion of their mandatory period. Confirmation in the rank of S.I requires completion of eligibility criteria under Rule 13-10 (2) of Police Rules 1934 amended 2017, which provides that "no sub inspector shall be confirmed in a substantive vacancy unless he has been tested for at least a year as an officiating SI in independent Incharge of PS, a notified post, or as Incharge investigation of a PS or CTD". Furthermore, confirmation in the rank of SIs is not made on the basis of seniority rather it is done subject to fulfillment of laid down criteria. (Copy of rule and revised seniority of ASI and offg: SI are attached as F, G, H).
- 7. Incorrect. In fact the appellant was differed from promotion/confirmation due to the punishment of time scale and non availability of ACRs. However, after termination of his punishment order, the appellant was given revised seniority/promotion in the rank of ASI and offg: SI with his other colleagues. Confirmation in the rank of SI requires completion of laid down criteria and those SIs who fulfill the said qualification are confirmed in the rank of SI. However, he will also be confirmed in the rank of SI subject to fulfillment of the laid down criteria mandatory under Rule ibid.
- 8. Correct, pertains to record.
- 9. Pertains to record.
- 10. Incorrect. As explained in the above paras. Further, the appellant was not considered for confirmation to the rank of SI due to non completion of mandatory periods as per the rules ibid. Thus his departmental appeal was rejected /filed based on incomplete mandatory periods. The appellant will be confirmed with his colleagues after completion of his mandatory periods.
- 11. That the appellant was treated in accordance with prescribed law/rules and he was not discriminated, therefore, the instant Service Appeal may be dismissed on the following grounds:-

REPLY ON GROUNDS:-

- A. Incorrect. Appellant has been treated strictly in accordance with law/rules and no legal right has ever been violated.
 - B. The appellant has been treated as per law/rules and no Article of Constitution of Pakistan 1973 has been violated by the replying respondents. However it is worth to clarify that promotion and confirmation amongst employees of respondent department have been made in accordance with law/rules and no pick and choose formula is followed.
 - C. Incorrect as explained in the proceeding paras.
 - D. Incorrect. No legal due rights of the appellant have ever been violated by the replying respondents, while dealt him strictly in accordance with law/rules.
 - E. Incorrect. As explained in the preceding paras. The point raised by the appellant having no legal footings as promotion/confirmation in the KPK police are given to those SIs who fulfill the said qualification/criteria, the appellant did not fulfill the laid down criteria mandatory for confirmation in the rank of SI hence he is required to fulfill the provisions laid down for gaining seniority with his colleagues.
 - F. Incorrect. In the instant case, no irregularity has been occurred. Furthermore, replying respondents are duty bound to follow law/rules and no right of the appellant has been violated. His request for confirmation as SI is devoid of merit. In fact under rule 13.10(2) of Police Rules, he is not entitled for confirmation as SI.
 - G. Incorrect. Para already explained in detailed in the proceedings para. However the replying respondents did not stop any one from the promotional courses which was due on their parts nor violated any rules regarding his promotions. The appellant making lame excuses as he was not interested to complete his tenure for promotion to the next higher rank. Actually only those officials confirmed in the next higher ranks who fulfill the laid down criteria and confirmation/promotion of no one considered without completion of requisite criteria. The appellant after completion of the laid down criteria will be promoted to the rank of SI as per law/rules in vogue.
 - H. Incorrect. Para established no malafide on the part of answering respondents. As per contention of appellant that his other colleagues have been promoted to the rank of SI, so he was also at liberty to qualify the mandatory courses for promotion to the rank of SI, but due to non completion of mandatory periods for promotion to the rank of SI, the appellant was not considered for promotion. Further, Replying respondents are duty bound to follow law/rules enumerated in the constitution of Pakistan 1973 and no right of the appellant has been violated. Actually as explained confirmation in the rank of Sub Inspector is subject to fulfillment of Rule 13.10 (2) and Standing Orders issued by the Provincial Police Officer from time to time and no pick and choose formula is followed.
 - I. That respondent may also be allowed to advance any additional ground at the time of hearing of the appeal.

PRAYERS:-

It is, therefore, most humbly prayed that in light of the above facts and submissions the appeal of the appellant being devoid of merits and legal footing and may kindly be dismissed with costs please.

This office order will dispose off departmental appeal of ASI Mohammad Sher who was awarded the punishment of time scale for a period of 03 years under RSO by SSP (Ops) Peshawar vide OB No.710 dated 24/2/2011.

The allegations levelled against him were that he while posted as Moharrar ASI at PS Kotwali called complainant Amjad Ali to PS and threatened him not to contract marriage with Mst: Robama. Besides, the appellant also developed illicit relation with mother-in-law of Amjad Ali (complt:). He illegally and unlawfully raided the house of Amjad Ali on the day of Walima and misused his official Authority.

After departmental proceedings and issuance of SCN he was awarded the above punishment.

Being aggrieved with the order passed by SSP/Ops, he preferred departmental appeal and denied the allegations. The appellant stated in his appeal that a complaint was made in PS Kotwali by Chand Bibi mother of Mst: Rubama against Amjad Ali that for kidnapping of her daughter along with cash and ornaments. The complaint was marked to SI Muhammad Ilyas on 13.10.10 for inquiry and after conducting inquiry a case was registered against Amjad Ali vide FIR No. 495 u/s 379/109 and he was also arrested.

He was called in O.R. on 6/3/2011 and heard him in person. The relevant record was perused. The appellant has 23 years long service at his credit with no major/minor punishment. The punishment awarded to him is harsh and there is heavy financial loss on monthly pay due to which his family is badly affected.

In view of the position explained above, the punishment order passed by SSP-Ops: is hereby set-aside.

On the grounds that an enquiry conducted by Deputy Inspctor General of Police ASI Muhammad Sher Enquriy & Inspections, Khyber Pakhtunkhwa Peshawar vide his office memo No.1348/E&I, dated 05.11.2010 that the mother-in-law of the complainant made a report against Amjid All r/o Urmer Payan in PS Kotwali at the instigation of ASI Muhammad Sher, as (Moharrir) PS Kotwali. Before his marriage with Mst. Robama, she was called by ASI Muhammad Sher (Moharrir) and was threatened not to contract marriage with him (applicant) and tried to develop illicit relation with his wife. ASI Moharrir Muhammad Sher misused his power, and on the day of Walima raided the house of the applicant illegally and un lawfully, as ASI Muhammad Sher was not accompanied by lady constable or the local police of PS Urmar, besides, no entry regarding the raid at his house was made in the daily dairy of police station Urmar by ASI Muhammad Sher Moharrir of PS Kotwali. The matter caused injuries and also snatched golden ornaments from them. The people of the locality gathered there and on seeing this illegal cruelty, started firing at ASI Muhammad Sher who left the spot and run away. The applicant was challaned under section 107/151 CrPc by the local police of PS Urmar. ASI Muhammad Sher, Moharrir of PS Kotwali admitted that at the time of raid, ASI was present with police party in plain clothes. According to the contents of enquiry report, it has been established that ASI Muhammad Sher Moharrir PS Kotwall and SI Muhammad Ilyas have violated their lawful authority for some ulterior motive. Furthermore, ASI Muhammad Sher is continuously misusing his official position and threatening the applicant for dire consequences. He lodged a complaint against him to his seniors. Being a member of disciplined force he involved himself in immoral activities and earns a bad name for the

They were issued charge sheet with statement of allegations and a departmental department. enquiry was initiated while SP/City, Peshawar was appointed as Enquiry Officer.
