WRITTEN REPLY ON BEHALF OF RESPONDENT NO.8

Respectfully Sheweth:

Preliminary Objections:

- 1. That the appellant has got no cause of action to file the instant appeal.
- 2. That the appellant has not come to this Hon'ble Tribunal with clean hands.
- 3. That with due respects this Hon'ble Tribunal lacks jurisdiction to entertain the instant appeal.
- 4. That the petition is bad in law and facts.
- 5. That the appellant concealed the material facts from this Hon'ble Tribunal.
- 6. That the Respondent No.8 has rightly been promoted being eligible for the promotion as per rules and has already assumed charge of his duties but the appellant making hindrance for performing lawful duty, hence, this is based on wrong facts and liable to be dismissed.
- 7. That the appellant is estopped by his own conduct.
- 8. That the promotion order has been issued by worthy / competent authority of the department and against that order no appeal has been made to the high ups, the appeal of the appellant is premature and liable to be dismissed on this score alone.
- 9. That all the replying respondents are qualified and eligible for promotion that's

- why they have been promoted as per law and rules.
- 10. That all the necessary and proper parties have not been impleaded in the instant case, hence the petition is liable to be dismissed.
- 11. That the authority as per law & rules issued promotion orders of the eligible employees, on the basis of seniority-cum-fitness from the Sub-Engineers having B-Tech Degree (Hons) at the time of appointment and those who have passed / got Degree during service like appellant as per the latest amendment in APT Rules-1989 clearly that "for the purpose dictates promotion, the seniority of B.Tech (Hons) Degree holders shall be reckoned from the date of appointment or acquiring the Degree, whichever is later;" have no right of promotion on the quota of B-Tech Degree holders Sub-Engineers. (Copy of amended rules are attached as annexure-A)
- 12. That the appeal is time barred.

ON FACTS:-

- 1. Para No.1 needs no reply, however, the respondent No.8 was appointed as B-Tech (Honors) Sub-Engineer in the year 2013 and since his appointment, he was performing his duty with great devotion and honesty, whatsoever, assigned to him and no complaint has been filed regarding his performance till date. As per law / rules, respondent No.8 was eligible and entitled for promotion to the post of Sub Divisional Officer (BPS-17) and has rightly been promoted to the said post by the department and accordingly, he has taken over the charge and performing his duties as such.
- 2. Para No.2 is famed with a view to misguide this Hon'ble Tribunal by concealing the material facts. In fact the appellant was diploma holder at the time of joining the Department as Sub-Engineer and during service completed his B-

Tech Degree after the regular appointment of the Respondent No.8 and similar others. The department has maintained separate seniority for B-tech Degree holders Sub-Engineers and Diploma Holder Sub-Engineers, that's why initially, the appellant was in the seniority list of Diploma Holder, which have their quota for promotion. As per rules, the appellant have obtained B-Tech Degree during service and respondent No.8 was holding the B-Tech degree at the time of his appointment, that's why the respondent No.8 was rightly promoted as per law & Rules.

- 3. Para No.3 of the appeal is wrong, incorrect and baseless, hence, expressly denied and the detailed reply has been given in the preceding para.
- 4. Para No.4 is incorrect and misconceived. It is clarified that the appellant was firstly placed in the seniority list of Sub-engineer (11) diploma holder (DAE), wherein 20% quota is reserved for promotion to the post of SDO. It is also worth mentioning that the appellant acquired his B-Tech Degree in the year 2016 and then was placed in the seniority list of B-Tech degree holders. The stance of appellant is not valid as the respondent No.8 had acquired his B-Tech from the Government College Technology affiliated with the then NWFP University of Engineering & Technology Pakistan in 2004 (4 years program). If the appellant has not acquired the Degree of B-Tech (Hons) prior to the private respondents, he would not have been placed in the seniority of B-Tech Degree holders. It is important to

mention here that respondent No.8, joined PHE 15/08/2013 as Department on graduate and his name has been included by the respondent-Department in the seniority list of B-Tech holders accordingly as per the prevailing rules. However, the appellant was reflected in seniority list of diploma holders and 20% quota is reserved for their promotion. The appellant after acquiring his B-tech degree during service, he was included in seniority of holders. The B-Tech Degree respondent the Department promoted answering respondent on merit in the light of PHE Service Rules framed by Standing Service Rules Committee (SSRC) which is a competent forum comprising the Establishment Department, the Finance Department and the PHE Department.

- 5. Paras No.5 & 6 subject to proof, hence, need no comments.
- 6. Para No.7 subject to proof, hence, needs no comments.
- 7. Para No.8 not related to answering respondent, hence, need no comments.
- 8. Para No.9 is wrong and incorrect, hence, expressly refuted because the answering respondent is B-Tech Engineer and presently, serving the department as SDO and has got his degree much earlier from the degree obtained by the appellant that's why he is not entitled for promotion as per rules and regulations.
- 9. Para No.10 is wrong and incorrect that the appellant has no cause of action to file the instant appeal.

GROUNDS:-

A. Grounds A & B are denied. The amendments in the Rule made by the

competent authority in accordance with law and rules and pursuant thereto, the promotion of the answering respondent has been made and the allegations leveled in Ground-A&B are false and baseless.

- B. Ground-C incorrect and misconceived. Every Department has its own service rules and the service rules of other department. However, C&W Department also framed new service rules, which is also supporting the answering respondent.
- C. Ground-D is wrong, incorrect and baseless hence, expressly denied. The appellant misleading his Hon'ble Tribunal, as the appellant was placed in seniority list of Diploma Holders Sub-Engineers appointed by initial recruitment in accordance with the merit assigned by the commission or as the case may be and the promotion quota of Diploma Holders is 20% while the respondent No.8 is a direct graduate and his seniority was reflected in the list of B-Tech Degree Holders and the promotion quota of B-Tech degree holders is 8% and appellant acquired his B-Tech degree later on during service, that's why he was not eligible / entitled for promotion.
- D. Ground-E is wrong, incorrect and baseless hence, expressly denied, the answering respondent is well qualified and eligible for promotion, hence, the competent authority rightly promoted the answering respondent as per law and rules.
- E. Grounds F & G are denied. The appellant is obliged under the civil servants Act, 1973 to accept every legal order of the competent authority as and when required. More so the appellant is not eligible on any score for promotion.

- B. Ground-C incorrect and misconceived.

- C. Ground-D is wrong, incorrect and baseless hence, expressly denied. The appellant misleading his Hon'ble Tribunal, as the appellant was placed in seniority list of Diploma Holders Sub-Engineers appointed by initial recruitment in accordance with the merit assigned by the commission or as the case may be and the promotion quota of Diploma Holders is 20% while the respondent No.8 is a direct graduate and his seniority was reflected in the list of B-Tech Degree Holders and the promotion quota of B-Tech degree holders is 8% and appellant acquired his B-Tech degree later on during service, that's why he was not eligible / entitled for promotion.
- D Ground-E is wrong, incorrect and baseless hence, expressly denied, the answering respondent is well qualified and eligible for promotion, hence, the competent authority rightly promoted the answering respondent as per law and rules.
- E. Grounds F & G are denied. The appellant is obliged under the civil servants Act, 1973 to accept every legal order of the competent authority as and when required. More so the appellant is not eligible on any score for promotion.

F. Ground H is denied. The stance taken in this para is self denying for the reason that in the alleged promotion order all the incumbents were not arrayed as necessary parties and no where it has been mentioned that the appellant is senior and eligible with all respects, hence the appeal is merits rejection / dismissal.

IT IS. THEREFORE, MOST HUMBLY PRAYED THAT THE APPEAL BEING WITHOUT ANY SUBSTANCE MAY KINDLY BE DISMISSED WITH COSTS.



 - (b) five percent (5%) by promotion, from amongst the holders of the posts of Sub-Engineer who possess Degree of B.E or B.Sc Engineering (Civil, Mechanical or Electrical) at the time of their joining service and have passed Departmental Professional Examination, with 03 (three) years service as such;
 - (c) three and half percent (3.5%) by promotion, from amongst the holders of the posts of Sub-Engineer who acquired Degree of B.E or B.Sc Engineering (Civil, Mechanical or Electrical) during service and have passed Departmental Professional Examination, with 03 (three) years service as such;

Provided that if no suitable candidate is available for promotion, then the post

shall be filled in the manner, as prescribed at clause (b) and vice-versa;

[d) four percent (4%) by promotion, from amongst the holders of the posts of Sub[Duter]: 20/1/2623 Engineer who have acquired B.Tech (Hons) four (04) years degree during service and have passed Departmental Professional Expressional Expres years service as such;
