

Brief facts of the present service appeal are that the appellant is serving in Education Department and was posted/transferred as District Education Officer (Female) Nowshera vide order dated 26.04.2016. Later on the appellant was transferred from the aforesaid post and her services were placed at the disposal of Directorate of E&SE with immediate effect vide order dated 03.04.2017. The appellant also filed departmental appeal on 04.05.2017 but the same was not responded hence, the present service appeal.

- 3. Learned counsel for the appellant contended that the appellant was transferred to the post of District Education Officer (Female) Nowshera vide order dated 26.04.2016. It was further contended that the appellant has performed her duty for 11 months and 3 days efficiently and without any single complaint from the higher authorities. It was further contended that vide order dated 03.04.2017 the appellant was again transferred from the post of District Education Officer (Female) Nowshera and placed her services at the disposal of Directorate of E&SE with immediate effect. It was further contended that the said transfer order was not passed in public interest but to victimize the appellant without assigning any reason and after transfer of the appellant the said post is still vacant. It was further contended that the said impugned transfer order is premature and in violation of transfer posting policy therefore, the impugned transfer order is illegal and liable to be set-aside.
 - 4. On the other hand, learned Assistant Advocate General for the respondents opposed the contention of learned counsel for the appellant and contended that the appellant has completed her tenure and the respondent-department has rightly transferred the appellant. It was further contended that the appellant being civil servant is legally bound to serve anywhere transferred/posted by competent authority and prayed for

dismissal of appeal.

5. Perusal of the record reveals that the appellant is serving in Education Department and was transferred by respondent-department to the post of District Education Officer (Female) Nowshera against the vacant post vide order dated 26.04.2016. The record further reveals that the appellant was again transferred by the respondent-department on 03.04.2017 from the said post and placed her services at the disposal of Directorate of E&SE. The record further reveals that the appellant has only served as DEO (F) Nowshera for a period of 11 months and 3 days meaning thereby that the appellant was transferred prior to completion of her normal tenure. Furthermore, the transfer of the appellant was made neither in the public interest nor exigency of service rather issued in utter violation of Posting/Transfer Policy notified by the Provincial Government. The said post is still vacant and additional charge has been assigned DEO (M) Nowshera. As such, we are constrained to accept the present service appeal and set-aside the impugned transfer order dated 03.04.2017. Parties are left to bear their own costs. JUDGMENT

MUHAMMAD AMIN KHAN KUNDI, MEMBER: - Counsel for the appellant present. Mr. Riaz Ahmed Payanda Khel, Assistant Advocate General for the respondents also present. Arguments heard and record perused.

Brief facts of the present service appeal are that the appellant is serving in Education Department and was posted/transferred as District Education Officer (Female) Nowshera vide order dated 26.04.2016. Later on the appellant was transferred from the aforesaid post and her services were placed at the disposal of Directorate of E&SE with immediate effect vide order dated 03.04.2017. The appellant also filed departmental appeal on 04.05.2017 but the same was not responded hence, the present service appeal.

- Learned counsel for the appellant contended that the appellant was transferred to the post of District Education Officer (Female) Nowshera vide order dated 26.04.2016. It was further contended that the appellant has performed her duty for 11 months and 3 days efficiently and without any single complaint from the higher authorities. It was further contended that vide order dated 03.04.2017 the appellant was again transferred from the post of District Education Officer (Female) Nowshera and placed her services at the disposal of Directorate of E&SE with immediate effect. It was further contended that the said transfer order was not passed in public interest but to victimize the appellant without assigning any reason and after transfer of the appellant the said post is still vacant. It was further contended that the said impugned transfer order is premature and in violation of transfer posting policy therefore, the impugned transfer order is illegal and liable to be set-aside.
- On the other hand, learned Assistant Advocate General for the respondents opposed the contention of learned counsel for the appellant and contended that the appellant has completed her tenure and the respondent-department has rightly transferred the appellant. It was further contended that the appellant being civil servant is legally bound to serve anywhere transferred/posted by competent authority and prayed for dismissal of appeal.

Perusal of the record reveals that the appellant is serving in Education Department and was transferred by respondent-department to the post of District Education Officer (Female) Nowshera against the vacant post vide order dated 26.04.2016. The record further reveals that the appellant was again transferred by the respondent-department on 03.04.2017 from the said post and placed her services at the disposal of Directorate of E&SE. The record further reveals that the appellant has only served as DEO (F) Nowshera for a period of 11 months and 3 days meaning thereby that the appellant was transferred prior to completion of her normal tenure. Furthermore, the transfer of the appellant was made neither in the public interest nor exigency of service rather issued in utter violation of Posting/Transfer Policy notified by the Provincial Government. The said post is still vacant and additional charge has been assigned DEO (M) Nowshera. As such, we are constrained to accept the present service appeal and set-aside the impugned transfer order dated 03.04.2017. Parties are left to bear their own costs. File be consigned to the record room.

A meeting of the Scrutiny Committee was held on 28-02-2018 at 14:00 hours in the office of Additional Secretary (Opinion) Law Department under his Chairmanship to determine the fitness of the subject case for filing of appeal / CPLA in the proper forum. Additional Advocate General (Mr. Wilayat Khan) was also present during the meeting being representative of Advocate General Khyber Pakhtunkhwa.

The meeting started with the recitation from the Holy Quran and thereafter 2. Chairman of the Committee invited the representative of E&SE Department Mr. Fazle Subhan Section Officer (Lit-II) to apprise the Committee about the background of the case which they did accordingly. The representative informed the Scrutiny Committee that the respondent department has officers of management cadre in BPS-18 (Female) & have been posted against the DEO(F) Post in the Province for imparting modern & better teaching learning as well as administrative services to the concerned stack holders at their respective door steps in view of the Educational Emergency Agenda of bringing positive changes 1 & developments in Education Sector. That the appellant has rightly been posted against the Principal BPS-19 post in accordance to her cadre of teaching & in view of the placement committee meeting held under supervision of the competent authority in the instant case. That the appellant has experience of heading a District Education Sector of being an officer of teaching cadre in BPS-19. Hence here transfer from Management Cadre post to a Teaching Cadre post was in accordance with the current policy of the Govt. That the appellant was adjusted against the DEO(F) post Nowshera on stop gape arrangements till the arrival of formal / regular officer of management cadre on the analogy of right man for right job. Hence the plea of the appellant regarding sticking to the post of i her choice for which she is not competent & eligible was its self violation of the relevant policy of the placement committee framed by the Provincial Government hence the respondent department further submit on the following grounds:-

GROUNDS:-

3. The grounds proffered by the representative were that the appellant has been treated as per law, rules & placement committee policy vide the impugned notification dated 03-04-2017 by the respondent department which was legal & liable to maintained in favour of the grounds that the appellant is basically an officer of BPS-19 from Teaching Cadre for School Administration. That the appellant was not competent & entitled for the posting against an administrative post in the respondent Department on the grounds of being a Teaching Cadre officer and her adjustment against . DEO(F) Nowshera Post was only for the purpose of stop gape arrangement & till the arrival of a regular management cadre(F) officer.

DECISION:-

- 4. After threadbare discussion it was decided with consensus by the Scrutiny Committee that the subject case was a fit case for filing of appeal / CPLA in the Supreme Court of Pakistan.
- 5. The representative of **E&SE Department** was advised to approach the office of Advocate General along with complete record of the case for doing the needful within the period of limitation under intimation to this Department.
