Respectfully Sheweth:

1. That the Appellant , on the basis of their respective requisite qualification, were appointed in the Health Department in the capacity of dispenser/compunder /Dresser, the then combined cadre BPS-06 and joined the service on 21.11.1989
2. That the Provincial cabinet, vide its decision dated 22.06.2000, has declared the combined cadre of dispenser / compunder / dresser as dying cadre which has been replaced with the new and existing nomenclature of pharmacy technician.
3. That Respondent / Medical Faculty through advertisement in the leading daily's, invited

Applications from in service candidate as well as fresh candidates for two years Bachelor Degree of Science in Pharmacy Technology and the Appellant, being employees of the Respondents/department, applied, through proper channel, for admission and the Appellant, on the basis of their merit positions, were selected in B.Sc in Pharmacy Technology, Session 2004-2005 by the Respondent/department with issuance of proper NOCs in their favour, followed by sanction of study leave.

4. That the Appellant have successfully completed their B.Sc in Pharmacy Technology and have passed their examination. **(Copies of the Degrees are annexed Annex A-A/4)**
5. That Respondent / department vide notification No. SOH-III/8-60/05 (Paramedics) dated 25.08.2006 approved eight stages paramedics service structure of the then NWFP now Khyber Pakhtunkhwa Paramedics staff. **(copy with enclosure annexed as annexure B)**
6. That Respondent / department vide notification bearing No SOH-III/8-60/05 dated 7th January 2008 laid down the method of recruitment, qualification and other conditions specified in column No 3 to 5 of the Appendix. **(Copy of the notification with appendix is annexed C)**

7. The Respondent / department vide notification bearing No SOH-III/8-60/05 (paramedics) dated 09.05.2012 withdraw the notification bearing no SOH-III/8-60/05 (paramedics) dated 25.08.2006 (Annexure B) and restored notification bearing No SOH-III/8/60/05 dated 10.05.2006 with additions, mentioned in the notification dated 09.05.2012. **(Copy of the notification is annexed as annexure D - D/1)**
8. That vide notification dated Peshawar, the 14th October 2016, the Khyber Pakhtunkhwa faculty of Paramedical and Allied Health Service Bill, 2016 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 26th September 2016 and assented to by the Governor of the Khyber Pakhtunkhwa on 6th October, 2016, has been published as an Act of the Provincial Legislature of the KP. **(copy of the Act is annexed is annexure E)**
9. That Respondent / department vide notification No. SOH-III/HD/3-5/2014 dated the 10th May, 2016 in supersession of all notifications issued in this behalf by the Health Department in consultation with Administrations / Establishment Department and the Finance Department has laid down the method of recruitment specified in column 3 to 5 of the Appendix to the posts of Paramedical staff in the

Health Department Specified in column 2 of the said appendix. **(Copy of the notification with appendix is Annexed as Annexure F)**

10. That Respondent / Finance Department vide Notification No. SO(FR)FD/7-3/2015/paramedics dated 11.08.2015 has up-graded all the paramedics staff with immediate effect in the terms and conditions mentioned therein the notification *ibid.* **(copy of notification dated 11.08.2015 annexed as Annexure F/1)**
11. That Respondent / department had issued provisional Seniority list of the paramedics on 22.08.2017, and ignored the Appellant , so the Appellant filed their respective departmental appeals. **(Copies of the Departmental Appeals are annexed as Annex G-G4)**
12. That Respondent/Department vide minutes of the meeting held on 22.01.2018 under the chairmanship of Secretary Health Department rejected the appeals of the Appellant , copy of which was communicated to the Appellant through DG Health Services Peshawar where after the same has been served upon the Appellant on 23.02.2018. **(Copies of the minutes dated 22.01.2018 and letter bearing no SOH-III/8-60/2017 (qualified**

paramedics) dated 21.02.2018 are annexed as annexure H-H1)

13. That Respondent / department through Notification No. SOH-III/8-60/2018 dated 01.02.2018 and Notification No. SOH-III/8-60/2018 dated 23.02.2018 has up-graded the posts of similarly placed paramedics and promoted them to BPS-17. **(Copy of notifications annexed as annexure H2 - H3)**

14. That the Appellant invokes the appellate jurisdiction of this Hon'ble Tribunal for the redressal of their grievances on the following grounds, inter alia:

GROUNDS:

- A. That the Appellant have more than 24 years spotless services at their credit.
- B. That after advertisement and invitation of Application by the Respondent/Medical Faculty, the Appellant , on the basis of their merit position, were selected and was followed by issuance of proper NOC by the Respondent / Defendant and sanction of study leaves.
- C. That B.Sc in Pharmacy of Medical Faculty Khyber Pakhtunkhwa is the highest qualification in the Health Department, having the same curriculum /

course as that of B.Sc Pharmacy of the University even the teaching staff were the professors of the Medical colleges who thought the Appellant during the course.

- D. That the Appellant have been discriminated as the post of similarly placed Paramedics, having the B.Sc degree qualification of the Medical Faculty Khyber Pakhtunkhwa, have been up-graded to BPS-17 and the Appellant having the same B.Sc degree of the Medical Faculty have been ignored.
- E. That the Appellant have been deprived of their fundamental rights of education guaranteed by the constitution of Pakistan.
- F. That Respondents/department have violated the golden principles of equal treatment.
- G. That the acts of Respondent / department have vanished the very purpose of the rules/service structure of the paramedics.
- H. That B.Sc in Pharmacy degree of the Medical Faculty has the protection of the Khyber Pakhtunkhwa faculty of Paramedical and Allied Health Services Act, 2016 as envisaged in section 17(5) in terms as:-

“The Degree, Certificate or diploma already granted by the Medical Faculty till the

commencement day of this Act, shall deem to be void"

- I.** That 20% quota of the posts of technologist pharmacy are lying vacant since 2005.
- J.** That the exclusion of the names of the Appellant from the qualified paramedics seniority list is the utter violation of the law, rules and regulation and it has adversely effected the future of the Appellant .
- K.** That any other ground, with leave of the Hon'ble Tribunal will be raised at the time of final hearing of the appeal.

It is, therefore, humbly prayed that on acceptance of this appeal, the Appellant may please be up-graded to BPS-17 from the date as other similarly placed paramedical staffs have been up-graded with all back benefits, the names of the Appellant , being qualified, may also be included in the seniority list of the qualified paramedics at their due position and place.

Any other relief, of which the Appellant are entitled to in the fact and circumstances of the case, may also awarded / granted in favour of the Appellant against Respondents.

In supersession of this Department's Notification of even number dated 10th May 2006 and in pursuance of the decision taken by the Provincial Cabinet in its meeting held on 27th December, 2005, the Competent Authority is pleased to approve eight stage Paramedics Services Structure of NWFP as follows:-

- (1) The existing 57 different categories of Paramedics at annex A are restructured into 14 cadres as annexure B.
- (2) In all the aforesaid cadres/specialties, the posts in various pay scales shall be integrated/categorized and re-designated as under:-

i)	Posts in BPS-5 to BPS-9 in all specialties	Junior Technicians (BPS-9)
ii)	Posts in BPS-10 to BPS-12 in all specialties	Technicians (BPS-12)

iv)	Posts in BPS-15 to BPS-16 In all specialties	Chief Technicians (BPS-16)

vii)	Posts in BPS-19 in all specialties	Chief Technologist (BPS-19)

The words "clinical" shall be mentioned with the categories of posts meant for Paramedics working in the hospitals and "Primary Health Care" with the paramedics working in the field along with mention of specific specialty (e.g. Junior Clinical Technician (Radiology) and Junior Primary Health Care Technician (Multi-Purpose)).

- (4) Seniority of the incumbents of the posts in the 14 cadres so merged shall be caused on the basis of scale wise seniority as well as date of regular appointment in the pay scale. (e.g. in joint seniority list of BPS-12, the officials already in BPS-12 will be senior and the officials in the lower pay scales shall be accordingly placed step by step in the list, invariably keeping intact the inter-se-seniority of the incumbents in the same pay scales).
- (5) Promotions to the posts in BPS-18, 19 and BPS 20 shall be made on the basis of joint seniority list. The joint seniority list of all the 14 cadres shall be caused at BPS-17 level, keeping in view, the principles laid down in section 8 of the NWFP Civil Servants Act, 1973 and Rule-7 of the NWFP Civil Servants (Appointment, Promotion and Transfer) Rules, 1989.

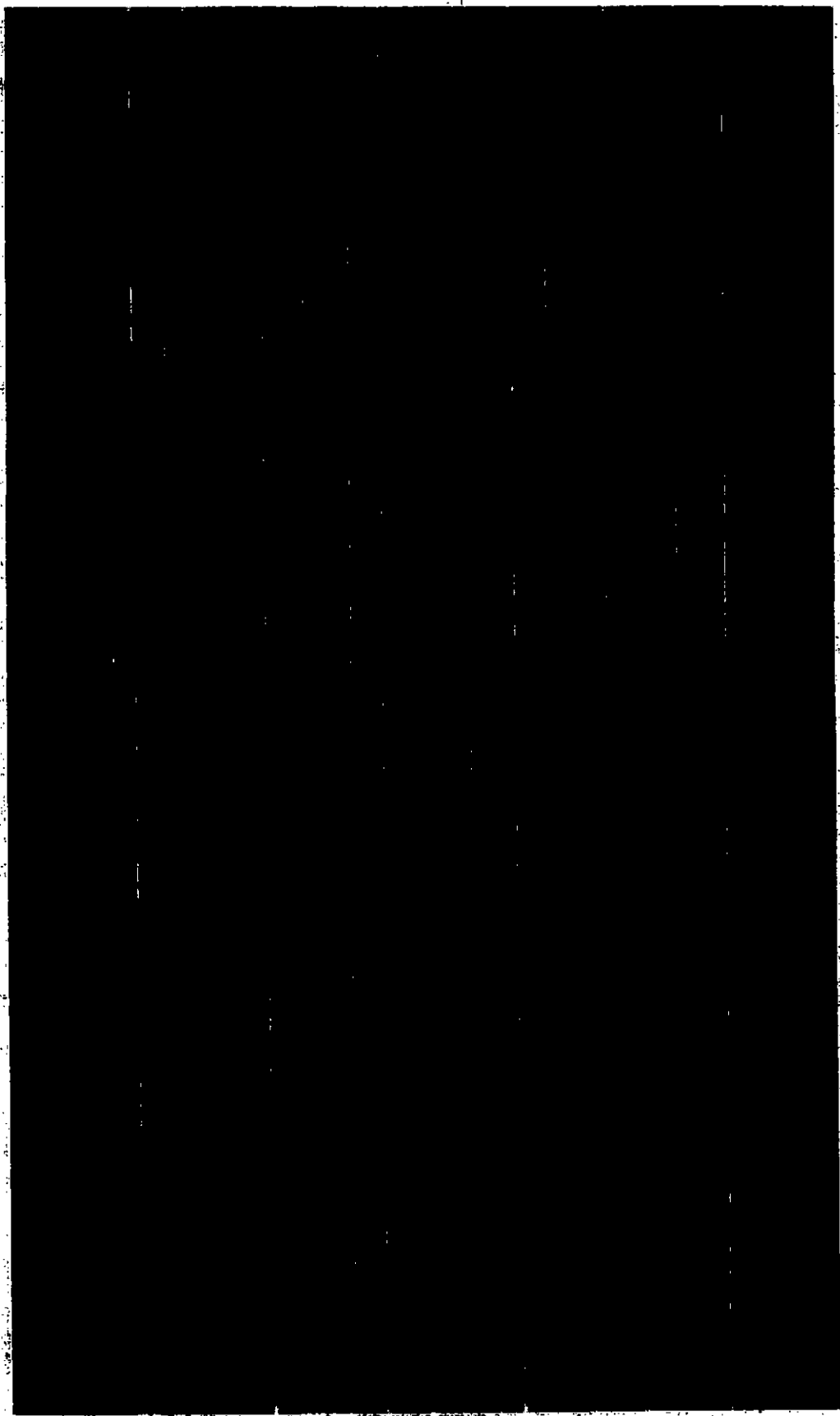
1. The existing 57 different categories of paramedics as mentioned in annexure A to this notification are restructured into 14 cadres as per annexure B.
2. In all the aforesaid cadres/specialties, the posts in various pay scales shall be integrated/categorized and re-nomenclature as under:-

The words "clinical" shall be mentioned with the categories of posts meant for paramedics working in the hospitals and "Primary Health Care" with the paramedics working in the field alongwith mention of specific specialty (e.g. Junior Clinical Technician (Radiology) and Junior Primary Health Care Technician (Multi Purpose).

The number of Posts in BPS-20, BPS-19, BPS-18, BPS-17, BPS-16, BPS-14, BPS-12 and BPS-9 shall be according to the proportionate ratio based on the total 8965 posts as mentioned in the provincial budget book for financial year 2005-2006. 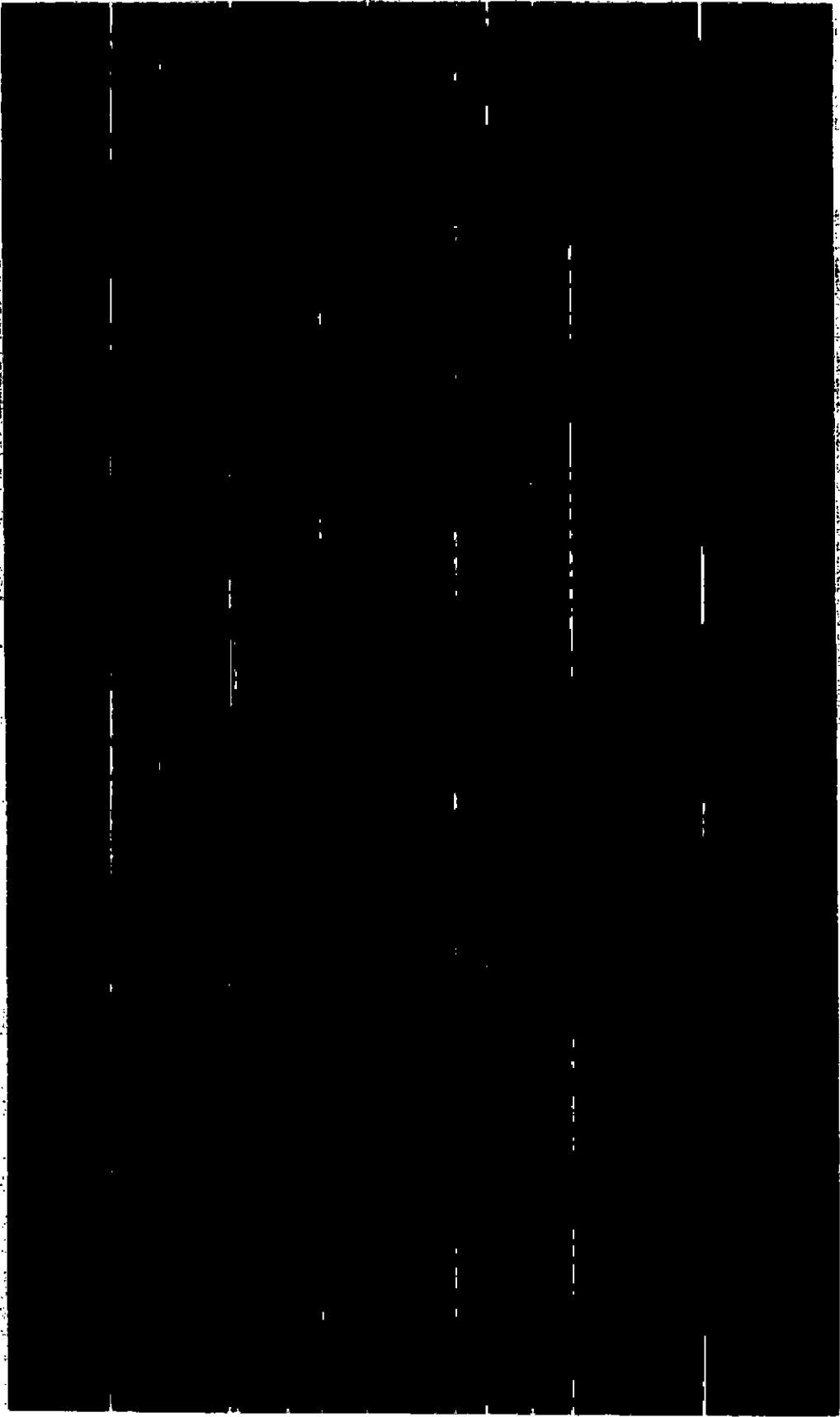

However additional post shall be created for any of the left over personals of paramedics cadre (if any). Moreover, subsequent creation of posts in any of the 14 paramedics cadres in any scales shall also be included in the aforesaid proportionate ration of posts in the 8 tiers formula. The proportionate ratios of posts in BPS-12 and above shall be modified accordingly as and when new creation of posts are made in BPS-9 in each of the 14 cadres subsequently.

4. Seniority of the incumbents of the posts in the 14 cadres so merged shall be caused on the basis of scale wise seniority as well as date of regular appointment in the pay scale, (e.g in joint seniority list of BPS-12. The official already in BPS-12 will be placed on the top of the list and the officials in the lower pay scale shall be accordingly placed step by step in the list, invariably keeping intact the inter-se-seniority of the incumbents in the same pay scales)
5. In the first instance, the higher post in the re-structured 14 paramedics cadres as per annexure C shall be filled in by way of promotion as one time exercise, where after the service rules duly prescribed as at annexure D shall be followed in subsequent promotion/initial recruitment.
6. Promotions in the post in BPS-18, 19 and BPS-20 shall be made on the basis of joint sonority list. The Joint seniority list of all the 14 cadres shall be caused at BPS-17 level keeping in view the principles laid down in section 8 of the NWFP civil servants (ACT), 1973 read with Rule-17 of the NWFP civil servants (appointment, promotion and transfer) rules, 1989.
7. The aforesaid paramedics service structure into 14 cadres shall also be applicable mutatis-mutandis to the paramedics working in FATA and employees working in Districts, all autonomous, semi autonomous and corporate bodies.
8. There shall be a council of Paramedics to be notified separately.
9. The approved implementation committee and anomaly committee shall also be notified separately.
10. This eight stage paramedics service structure will replace all existing categories, cadres, structures and nomenclatures and will cancel all such cadres/categories rules and regulations etc which are in contravention to the approved paramedics service structure. WHEREAS it is expedient to re-constitute and re-organize the Khyber Pakhtunkhwa Medical Faculty established under the Medical Degrees Act, 1916 (Act No. VII of 1916) for the purpose of giving it necessary autonomy, raising its standard of training, examination, research, and improving its administration and to regulate, promote and streamline the education, training, examination and registration of paramedics and allied health professionals pertaining to preventive, promotive, curative, rehabilitative, environmental and occupational health sectors in the Province and for matters incidental thereto and ancillary herewith;

It is hereby enacted as follows:

1. Short title, extent and commencement.—(1) This Act may be called the Khyber Pakhtunkhwa Faculty of Paramedical and Allied Health Sciences Act, 2016.

(2) It shall extend to the whole of the Province of the Khyber Pakhtunkhwa.

(3) It shall come into force at once.

2. Definitions.—In this Act, unless the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them, that is to say—

(a) "Chairperson" means the Chairperson of the Governing Body;

(b) "Chief Executive Officer" means the Chief Executive Officer of the Faculty, appointed under section 7;

(c) "Controller of Examinations" means the Controller of Examinations of the Faculty appointed under section 9;

(d) "Faculty" means the Medical Faculty, which is re-constituted and re-organized under section 3 of this Act;

(e) "Fund" means the Fund established under section 10;

(f) "Governing Body" means the Governing Body of the Faculty, constituted under section 5;

(g) "Government" means the Government of the Khyber Pakhtunkhwa;

(h) "institution" means institution which is imparting training in the field of paramedical and allied health sciences both in public and private sectors;

(i) "Medical Faculty" means the Medical Faculty established in pursuance of the Medical Degree Act, 1961 (Act No. VII of 1961);

(j) "paramedics" means a person who provides supportive service under the relevant laws for diagnostic, therapeutic, preventive, promotive and rehabilitative field in health care delivery system and has undergone a prescribed course of training in recognized institution and is registered as paramedics under this Act or paramedics council;

(k) "prescribed" means prescribed by rules or regulations made under this Act;

60

- (l) "Registrar" means the Registrar of the Faculty appointed under section 8;
- (m) "regulations" mean regulations made under this Act;
- (n) "rules" mean rules made under this Act; and
- (o) "section" means the section of this Act.

3. Re-constitution of the Faculty.---(1) After the commencement of this Act, the Medical Faculty shall be re-constituted and re-organized in accordance with the provisions of this Act and shall be known as the Khyber Pakhtunkhwa Faculty of Para-Medical and Allied Health Sciences.

(2) The Faculty shall be a body corporate having perpetual succession and a common seal and shall sue and be sued by the said name.

(3) The Faculty shall have the power to acquire and hold both movable and immovable property. The Faculty, with prior approval of Government, lease, sell or otherwise transfer immovable property which vests in or has been acquired by it.

4. Powers and functions of the Faculty.---The Faculty shall-

- (a) consider the annual report of the Faculty, approve the annual budget and as the case may be, revise budget estimates of the Faculty;
- (b) approve financial resources and development plans of the Faculty;
- (c) sanction expenditures as may necessary for carrying out the functions of the Faculty;
- (d) receive and manage property transferred and grants, donations, gifts, bequests, trust, endowments and other subscription whether made generally or for specific purpose, and to invest any fund representing such property, grants, bequests, trusts, gifts, donation endowments or contributions in such manner as it may deem fit;
- (e) invest any money belonging to the Faculty including any unutilized income in any of the securities described in section 20 of the Trust Act, 1882 or in the purchase of immovable property or in such other manner as it may prescribe;
- (f) grant affiliation in the prescribed manner to institutions in private sector which apply to the Faculty for affiliation or, as the case may be, de-notify the affiliation already granted in such a manner, as may be prescribed.

- (g) create, upgrade, re-designate or abolish such administrative posts, in the Faculty as deem necessary and expedient;
- (h) constitute various committees for specialized functions as may be prescribed;
- (i) appoint members to various committees of the Faculty;
- (j) approve the policies and procedures pertaining to the quality of academic programmes and oversee the quality and relevance of the Faculty's academic programmes and to review the academic affairs of the Faculty, as and when necessary;
- (k) approve the policies, procedures pertaining to student related functions including expulsions, punishments, examinations and certification, etc in Institutions;
- (l) approve the policies and procedures assuring quality of teaching and research in an affiliated Institutions;
- (m) hold examinations in the Institutions and grant diplomas, certificates, scholarships, exhibitions, medals and prizes to students of the institutions etc;
- (n) prescribe courses of studies or curricula for training in the affiliated institutions;
- (o) prescribe standards, educational qualification, scoring criteria to ascertain the eligibility and merit of the candidates for admissions and training in the institutions;
- (p) register the successful candidates after receiving such diplomas and certificates issued by the Faculty and renewal of the registration on five yearly basis;
- (q) provide for the printing and publication of research and other work;
- (r) provide training in the field of paramedical and allied health services;
- (s) issue No Objection Certificate to the paramedics qualified or registered with the Faculty for practicing in his/her relevant field or discipline under the supervision of a medical practitioner authorized by the Pakistan Medical and Dental Council subject to general policy of Government;
- (t) prescribe the terms and conditions for appointment of the officers and other staff or employees of the Faculty;

- (u) award financial assistance to students in need, fellowships, scholarships, bursaries, medals and prizes under the prescribed conditions and procedure;
- (v) provide the academic development through innovation of new disciplines or specialized fields keeping in view the requirement of the society or market in the health sector or, as the case may be, the advancement of health technology in the relevant fields;
- (w) impart Mother and Child Health education and training to paramedical staff;
- (x) demand and receive such fees and other charges as it may determine;
- (y) arrange for such refresher courses of paramedical and auxiliary staff and alumni on such terms and conditions as may be prescribed;
- (z) registration of paramedics;
- (aa) award equivalence to diplomas or certificates awarded from abroad or national institution, bodies or hospitals etc. in accordance with the prescribed standards; and
- (ab) perform such other functions as may be prescribed.

5. Constitution of the Governing Body.—(1) The administration, management and general control of the Faculty and its affairs shall vest in the Governing body, which shall exercise all powers and perform all acts and functions that may be exercised or done by the Faculty.

(2) The Governing Body, shall consist of-

- (a) Secretary to Government, Khyber Pakhtunkhwa Health Department; Chairperson
- (b) Chief Executive Officer of the Faculty; Member
- (c) Additional Secretary, Finance Department; Member
- (d) Additional Secretary, Establishment Department; Member
- (e) Director General, Health Services; Member
- (f) Director, Provincial Health Services Academy; Member

(3) The Governing Body may co-opt any expert in the relevant field for a initiative on need basis who shall not have a casting vote.

6. Meeting of the Governing Body.---(1) Meeting of the Governing Body shall be called by the Chairman on such date and at such place, as he may deem appropriate.

(2) The Governing Body shall meet once every quarter.

(3) Meeting of the Governing Body shall be presided over by the Chairman, or in his absence, a member to be nominated by the Chairman.

(4) Quorum for the meeting shall be one-third of the total membership of the Governing Body.

7. Chief Executive Officer.---(1) The Chief Executive Officer shall be posted by Government for a period of three years from amongst the eminent health professionals or academicians or from amongst the employees of Government in BPS-20 and above.

(2) The Chief Executive Officer shall be the principal executive and academic officer of the Faculty and shall ensure that the provisions of this Act, the rules and regulations to be framed thereunder, are faithfully observed and the decisions of the Governing Body are promptly implemented, in order to promote the order of the Faculty. He shall have powers necessary for this purpose, including administrative control over all employees of the Faculty.

(3) The Chief Executive Officer of the Faculty may, in a situation that in his opinion requires immediate action, ordinarily not in the competence of the Chief Executive Officer, take such action and forward, within seventy-two hours, a report of the action taken to the Chairman, who shall direct such further action as is considered appropriate.

(4) The Chief Executive Officer shall present to the Governing Body, an annual report regarding such information as pertaining to the academic year under review, as may be prescribed, including disclosure of the relevant facts pertaining to Academics, Curricula, Research and Administrative and financial affairs.

8. Registrar.---(1) The Registrar of the Faculty shall be posted by Government for a period of three years from amongst eminent health professionals or academicians.

- (2) The Registrar shall be a full time officer of the Faculty and shall
- (a) be head of the administration wing of the Faculty and be responsible for provision of secretarial support to the Chief Executive Officer.
 - (b) maintain a register of students for various study courses or trainings and examinations in the prescribed manner, and
 - (c) perform such other functions as may be assigned by the Governing Body or as may be prescribed.

9. Controller of Examinations.---(1) The Controller of Examinations shall be posted by the Government for a period of three years from amongst eminent health professionals or academicians.

(2) The Controller of Examinations shall be a full time officer of the Faculty and shall be responsible for all matters related to the conduct of examinations, compilation of results and issuance of a gazette thereof.

(3) He shall ensure the conduct of examinations and matters related thereto in a transparent, with utmost objectivity and academically sound manner.

(4) He shall perform such other functions, as may be prescribed.

10. Fund.---(1) The Faculty shall have a Fund to be known as the Khyber Pakhtunkhwa Faculty of Paramedical and Allied Health Service Fund, which shall be credited the Government allocations, grants, donations, trusts, endowments, contributions or subscription and fees receive from the affiliated institutions, students registration and examination fees and all other sources.

(2) Government shall make budgetary allocation to the Faculty in incremental order till alternate arrangements are made by the Faculty through its own resources.

11. Audit and Accounts.---(1) The accounts of the Faculty shall be maintained and audited in such form and in such manner as may be prescribed.

(2) All the funds of the Faculty shall be credited to the Faculty accounts, to be maintained in a scheduled bank as per Government policy issued from time to time.

- (3) Provision shall be made for internal audit of finances of the Faculty.
- (4) The annual statement of accounts of the Faculty shall be prepared in conformity with the generally accepted accounting principles and shall be signed by the Chief Executive Officer. The annual audited statement of accounts so prepared shall be submitted to the Director Local Fund Audit for his observations.
- (5) The observations of the Director Local Fund Audit, if any, together with annotations as the Accounts Officer of the Faculty may make, shall be considered by the Governing Body within six months of the closing of the financial (6) year.
- (6) Accounts of the Fund shall be audited by the Auditor General of Pakistan.
12. Appointment of Officers.—The Governing Body may employ officers and such other staff or employees in service of Faculty in such manner and on such terms and conditions as may be prescribed.
13. Public Servants.—All employees of the Faculty shall be deemed to be public servants within the meaning of section 21, of the Pakistan Penal Code, 860 (Act No. XLV of 1860).
14. Rules.—Government may make rules for carrying out the purposes of this Act.
15. Regulations.—The Board of Governor may make regulations, not inconsistent with the provisions of this Act and the rules made there under for carrying out the purposes of this Act.
16. Removal of difficulties.—If any difficulty arises in giving effect to any of the provision of this Act, Government may give such directions as it may consider necessary for the removal of such difficulty.
17. Repeal and savings.—(1) The Notification No. SOIII(T) 4-16/77, dated September, 1977, issued under the Medical Degrees Act, 1916 (Act No. VII of 1916) through which the Medical Faculty was established, is hereby repealed.
(2) Notwithstanding the repeal of the Notification ibid under sub-section (1), all employees serving with the affairs of the Faculty, who are holding various posts till the enactment of this Act shall be deemed to have been validly appointed to these posts on regular basis on the commencement of this Act, having the same qualification and experience for the said posts.
(3) The institutions in private sector, already affiliated with the Medical Faculty before the commencement of this Act shall be deemed to be affiliated with the Faculty under this Act.
(4) All rules, regulations and orders made or issued under the repealed Notification shall continue unless altered, amended or repealed under this Act or the rules made thereunder.

NO. SO(FR)/FD/7-3/2015/Paramedics: The competent authority has been pleased to upgrade all the Paramedics Staff appointed under Khyber Pakhtunkhwa Civil Servants Act 1973, with immediate effect.

- I. All the incumbents Paramedics in BS-09 are upgraded to BS-12. In future the initial recruitment will be made in BS-12 instead of BS-09 and the Administrative Department shall immediately amend the service rules through SSRC accordingly.
- II. The incumbents presently serving in BS-12 & BS-14 are allowed 02 steps upgradation respectively with relaxation of condition of 10 years service in the same grade stipulated in the existing upgradation policy.
- III. The Paramedics presently serving in BS-16 and BS-17, having 05 years service in the respective pay scales, are allowed an allowance at the rate of fixation of pay in next grade.
- IV. The Administrative Department shall further streamline the service structure of BS-16 and above through the mechanism of SSRC.

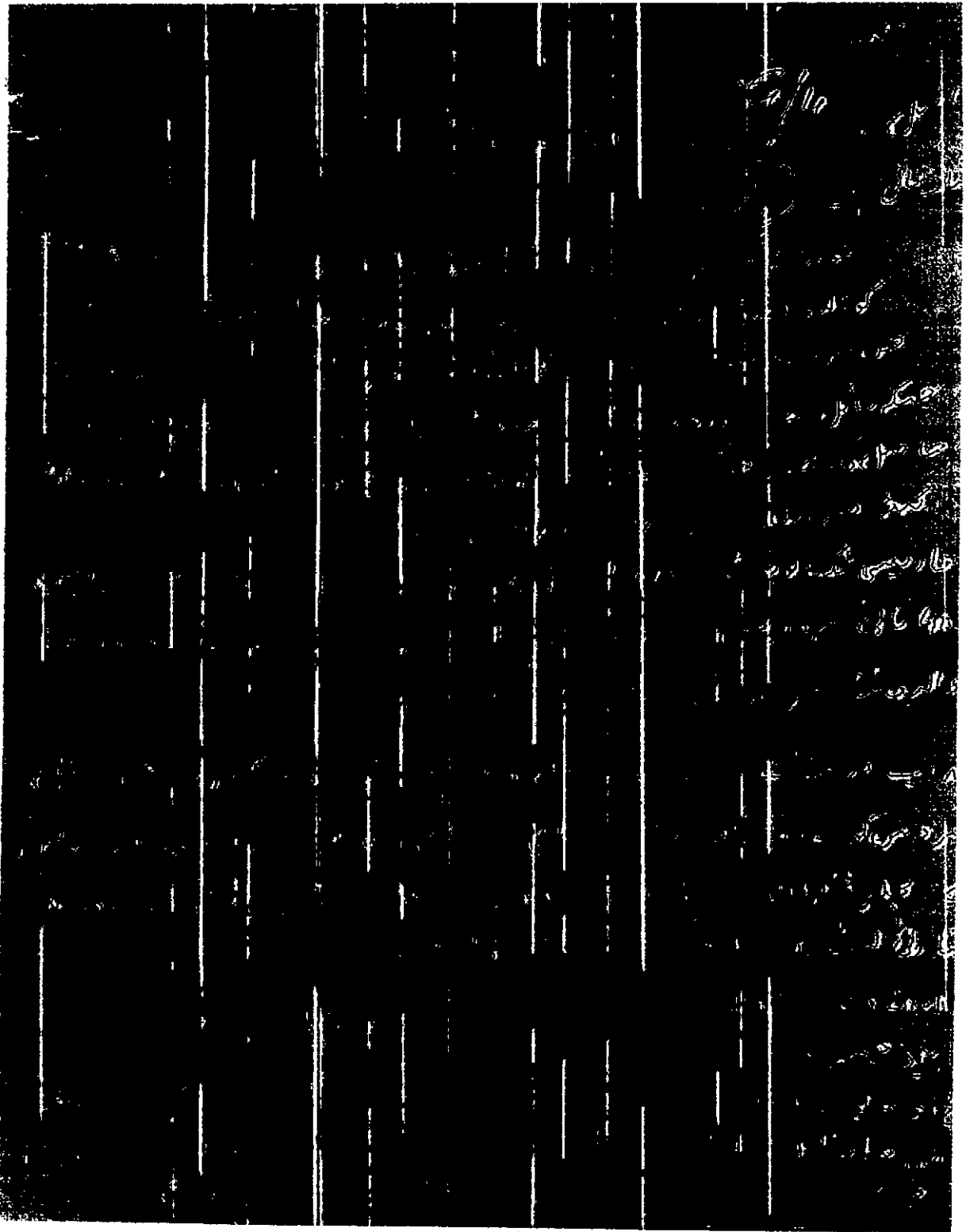

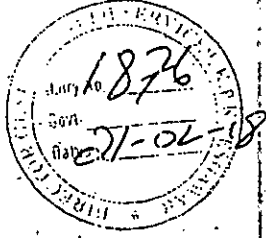

The meeting started with recitation from the Holy Quran and the chair welcomed the participants.


Mr. Bakhtiar Ali, Section Officer (Lit-I), Health explained the background of the case stating that 20% quota has been reserved for promotion to the post of PHC Technologist/Clinical Technologist BS-17 for those Paramedics having qualification "At least Second Class Bachelor's Degree in the relevant technology from a recognized University/Institution" as per approved service rules notified by Health Department on dated: 10-05-2016. Accordingly the seniority list of qualified paramedics was prepared & circulated by Director General, Health Services, Khyber Pakhtunkhwa, Peshawar and the subject case was placed before the DPC scheduled for 05-01-2018 in Health Department. Meanwhile, those paramedics who had attained their degrees from Medical Faculty moved an appeal to Secretary Health requesting for inclusion of their names in the seniority list of qualified paramedics and the meeting of DPC was therefore postponed till the decision of their appeal.

After threadbare discussion the forum arrived at a conclusion that since Medical Faculty is not a degree awarding body/institution as it is not registered with any chartered university/institution recognized by HEC as per the criteria of Higher Education Commission. Therefore, the forum is of the considered opinion that those degree holders

who have earned their degrees from Medical Faculty cannot be considered for promotion in the category of qualified paramedics. Moreover, the Chair directed Director General, Health Services, Khyber Pakhtunkhwa, Peshawar to move the promotion case of qualified paramedics whose degrees are valid being awarded by universities/institutions duly registered/recognized by HEC and the same may be placed before upcoming DPC for consideration at the earliest.




