**NO. SO(FRD)/7-12015/Paramedics** The competent authority has been pleased to upgrade all the Paramedics Staff appointed under Khyber Pakhtunkhwa Civil Servants Act 1973, with immediate effect.

- I. All the incumbents Paramedics in BS-09 are upgraded to BS-12. In future the initial recruitment will be made in BS-12 instead of BS-09 and the Administrative Department shall immediately amend the service rules through SSRC accordingly.
- II. The incumbents presently serving in BS-12 & BS-14 are allowed 02 steps upgradation respectively with relaxation of condition of 10 years service in the same grade stipulated in the existing upgradation policy.
- III. The Paramedics presently serving in BS-16 and BS-17, having 05 years service in the respective pay scales, are allowed an allowance at the rate of fixation of pay in next grade.
- IV. The Administrative Department shall further streamline the service structure of BPS-16 and above through the mechanism of SSRC.
- V. Pay of existing incumbents of the posts shall be fixed in higher pay scales in a stage next above the pay in the lower pay scale.

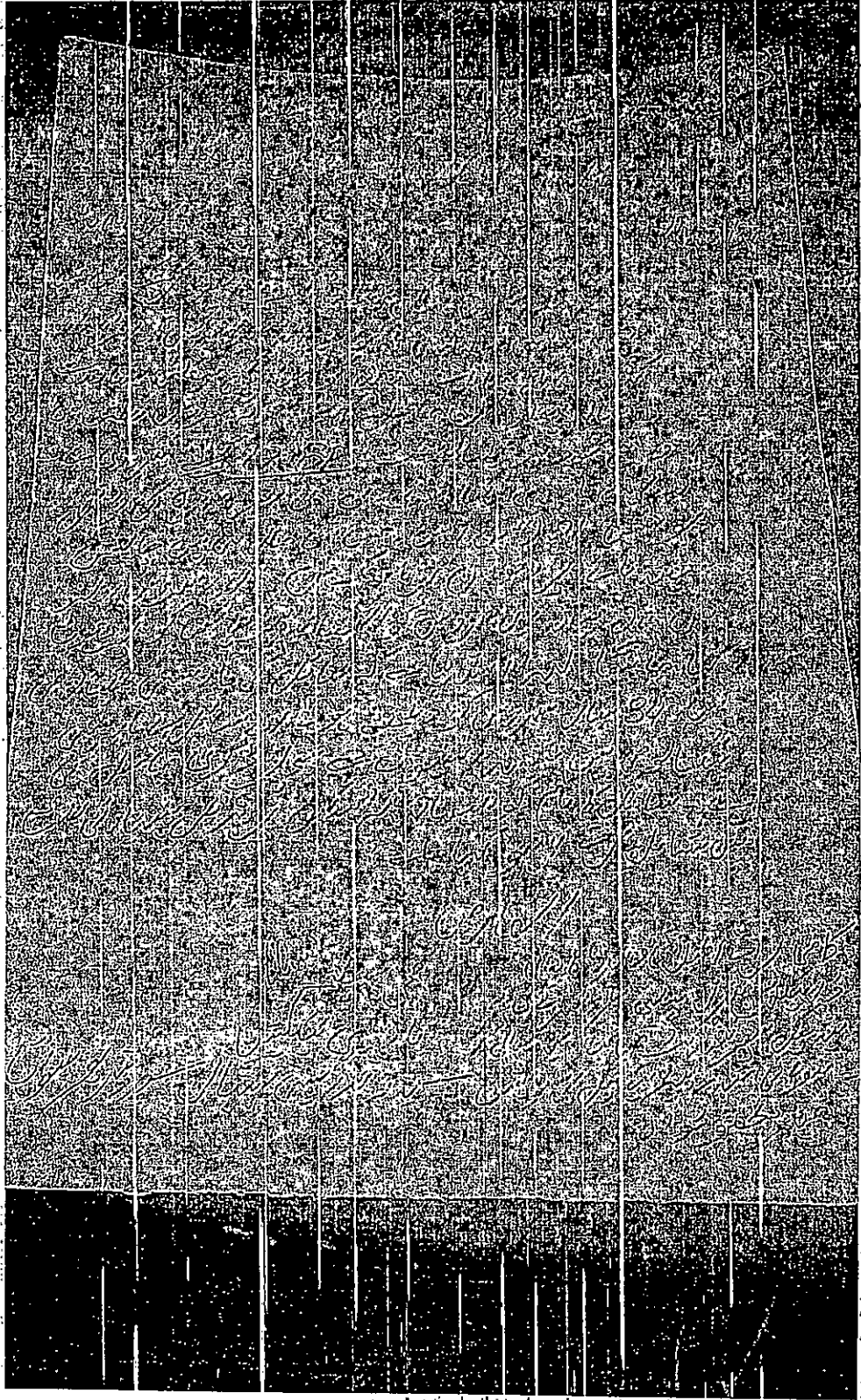

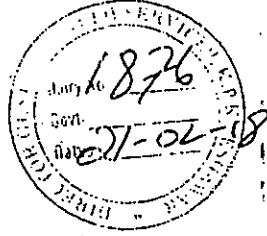

The meeting started with recitation from the Holy Quran and the chair welcomed the participants.



I am directed to refer to your letter No. 17303/AE-VI, dated: 26-10-2017 on the subject noted above and to state that Administrative Department regrets its inability to accede to the request of Directorate General, Health Services, Khyber Pakhtunkhwa with regards to the inclusion of those qualified paramedics (Pharmacy) who have obtained their degrees other than Pharmacy in the seniority list of qualified Paramedics of Pharmacy cadre for the purpose of promotion to the post of Clinical Technologist BS-17 due to the following reasons/grounds:-

- i) It would be tantamount to changing/converting the cadre of Pharmacy Technologist into other specialty which falls within the jurisdiction of Finance Department.
- ii) Service Rules clearly states that "At least 2<sup>nd</sup> Division Bachelor Degree in the relevant technology from a recognized University/Institution. So, their inclusion would amount to scrapping the relevancy from the service rules which is the domain of Standing Service Rules Committee (SSRC).
- iii) Their inclusion might affect the seniority list of other incumbents having similar specialty in BS-17 as it is in contravention to maintain a separate seniority list in BS-17 for other specialty in lieu of Pharmacy Technologist.
