Respectfully Sheweth;-

The facts forming the background of the instant service appeal are appended below;-

- 1. That the appellant was posted as Naib Tehsildar Settlement vide order No. 7846-7551 dated 12/07/2019. Copy of transfer order is attached as Annexure "A".
- 2. That the appellant has been repatriated from the post of Nabi Tehsildar Settlement Havelian and transferred the respondent No. 6 in place of the appellant, as Niab Tehsildar Settlement Havelian, vide impugned order 16359-65/ DLR/LR-V/SO(M) dated 18/11/2019. Copy of repatriation order of the appellant is attached as Annexure "B".
- 3. That the appellant filed departmental appeal against the impugned order No. 16359-65/DLR/LR-V/SO(M) dated 18/11/2019. Copy of departmental appeal dated 22/11/2019 is attached as Annexure "C".
- 4. That the departmental appeal of the appellant yet to be replied by the department, hence the instant

service appeal in file inter-alia on the following grounds.

GROUNDS;

- a) That the repatriation order of the appellant and transfer of respondent No. 6 in place of the appellant is perverse, discriminatory, premature and against the law and the same is liable to be set-aside.
- respondent No. b) earlier -6 was repatriated from the post of Naib Tehsildar Havelian to DC Office Abbottabad on the basis of a complaint against him vide order dated 03/06/2019. Copy of order dated 03/06/2019 is annexed as Annexure "D". Therefore respondent No. 6 once repatriated on the complaint cannot be posted against the same post within a period of 04 months. Therefore, impugned repatriation order of the appellant dated 18/11/2019 is liable to be set-aside.

- c) That it is pertinent to note that the appellant has qualified the departmental examination of Naib Tehsidlar conducted in the year 2019, whereas the respondent No. 6 has been declared failed in the departmental examination of Naib Tehsildar Copy of result of departmental examination of 2019 is annexed as Annexure "E".
- d) That as per departmental examination wherein, the appellant has been declared qualified as the right to be promoted against the vacant post of Naib Tehsildar Settlement Havelian. Copy of departmental examination of Naib Tehsildar certificate of the appellant is annexed as Annexure "F".
- repatriated by the respondents department being qualified candidate/ employee for the post of Naib Tehsildar. Therefore, the impugned repatriation order dated 18/11/2020 is liable to be cancelled.

f) That service appeal is within the period of limitation and this Honourable Court has jurisdiction to entertain the appeal of the appellant under Article 212 of the constitution of Islamic Republic of Pakistan 1973.

It is therefore humbly prayed that on acceptance of the instant service appeal of the appellant impugned repatriation order no. 16359-65/DLR-V(SO)DM dated 18/11/2019 may be set-aside and respondents department may graciously be directed to restore the appellant as Niab Tehsidlar Settlement Havelian.
