APPEAL UNDER SECTION-4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE IMPUGNED NOTIFICATION DATED 18.9.2019 WHEREBY THE 100% PROMOTION QUOTA RESERVED FOR THE CADRE OF THE APPELLANT HAS BEEN REDUCED TO 75% AND AS SUCH THE REST OF 25% HAS BEEN ALLOCATED TO THE CADRE OF FIELD ASSISTANT AND AGAINST NO ACTION TAKEN ON THE DEPARTMENTAL APPEAL OF APPELLANT WITHIN THE STATUTORY PERIOD OF NINETY DAYS

PRAYER:

That on acceptance of this appeal the impugned Notification dated 18.9.2019 may kindly be declared as Ultra Vires, illegal, unconstitutional and ineffective upon the rights of the appellant. That the respondents may kindly be directed to restored the 100% promotion quota of the appellant to the posts of Deputy Directors Soil Conservation, Deputy Director Planning, Deputy Director Soil Survey and District Officers Soil Conservation (BPS-18) and as such the appellant may kindly be considered for promotion to the higher scale of BPS-18. Any other remedy which this august Tribunal deems fit that may also be awarded in favour of the appellant.

R/SHEWETH:
ON FACTS:

- 1- That appellant was appointed as Soil Conservation Assistants (BPS-17) vide Notification dated 7.9.2018 through proper recommendations of the Khyber Pakhtunkhwa Public Service Commission, Peshawar. Copy of appointment Notification is attached as annexure **A.**
- 2- That appellant since from the date of appointment till date is serving the respondent department quite efficiently, whole heartedly and up to the entire satisfaction of his superiors.
- 3- That the respondent Department issued Notification dated 18-04-2018 whereby proper service structure for the employees of the respondent Department has been approved/ notified and according to the said service structure the employees of respondent Department have been categorized in twenty Five (25) different cadres for the purposes of seniority and their prospects of promotions. Copy of Notification is attached as annexure **B.**
- 4- That, in the above mentioned notified service rules/structure the posts of Deputy Directors Soil Conservation, Deputy Director Planning, Deputy Director Soil survey and District Officers Soil Conservation shown at Serial No.3 of the appendix has been given the method of recruitment under Column No.5 which is as under:
“by promotion on the basis of seniority-cum-fitness from amongst the Assistant Directors (planning Supervisory), Soil Conservation assistants, Soil Conservation assistants (Technical), Soil survey Research Officer and Assistant Soil Survey Research Officer having five years service as such with minimum qualification as prescribed in column No.2, against serial No.4 of the said Notification through joint seniority list”. Copy of the Notification is attached as annexure C.
- 5- That according to the above mentioned service rules employees belonging to the said mentioned cadres were promoted from time to time on the basis of joint seniority lists.
- 6- That unfortunately vide impugned Notification dated 18.9.2019 the 100% promotion quota reserved for the

appellant has been reduce to 75% and as such the rest of 25% has been allocated to the cadre of Field Assistant which would certainly affect the seniority and promotion of the appellant and the other cadres to BPS-18 because according to the mentioned rules a Field assistant (BPS-9) with a diploma course of three years after metric will be promoted to BPS-18 and run the DDO office without a specialized degree will not validate the running of post of purely technical in nature and supervising over post Graduates and PhD Degree holders. Copy of the impugned Notification is attached as annexure **D.**

7- That the amendment in service rules will also pave way for awarding charge of the DDO post to incapable Field assistants in own pay and scale. That a simple bachelor degree holder will hold the post of Director/ District Officer Soil & water Conservation (BPS-18) without any relevant field/professional degree. Copies of the service structures are attached as annexure **E.**

8- That feeling aggrieved from the Vires of the impugned notification/service structure dated 18-09-2018 the appellant filed Departmental Appeal/Representation before the competent authority i.e. respondent No.1 on which no response have so far been received. That so much so after filing the said Departmental appeals the respondent No.5 starts pressurizing the appellant on one way or on the other. Copies of Departmental Appeal and other related documents are attached as annexure **F and G.**

9- That the appellant and his colleagues feeling aggrieved from the inaction of the respondents by not deciding the departmental appeal of the appellant and his colleagues and having the apprehension regarding promotion of the other cadre, knocked the door of Peshawar High Court but during the pendency of the said writ petition the statutory period of ninety days has been elapsed. Copy of the writ petition is attached as annexure **H.**

10- That, appellant having no other adequate remedy but to file the instant writ petition on the following grounds amongst the others.

GROUND:

A- That the impugned notification/service Rules issued vide dated 18-09-2019 is Ultra Vires, facts, law, norms of

natural justice and materials on the record hence not tenable and liable to be modified/amended.


- B-** That appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the constitution of Islamic Republic of Pakistan 1973.
- C-** That the treatment meted out to the appellant is a clear violation of the Fundamental Rights of the appellant as enshrined in the Constitution of Pakistan 1973.
- D-** That, the appellant has been discriminated by the respondents on the subject noted above and as such the respondents violated the Principle of Natural Justice.
- E-** That the impugned Notification dated 18.9.2019 due to which the promotion quota of the appellant has been reduced to 75% and as such the rest of 25% has been allocated to the cadre of Field Assistant is not tenable under the law and rules and would certainly affect the seniority and promotion of the appellant and the other cadres to BPS-18 because according to the mentioned rules a Field assistant (BPS-9) with a diploma course of three years after metric will be promoted to BPS-18 and run the DDO office without a specialized degree will not validate the running of post of purely technical in nature and supervising over post Graduates and PhD Degree holders.
- F-** That according to Article-38 (e) of the Constitution of Pakistan 1973 state is bound to reduce disparity in the income and earnings of individuals including persons in the services of the Federation. That in light of the mentioned Article the appellant is on strong footing.
- G-** That the respondents acted in arbitrary and malafide manner while issuing the impugned Notification dated 18.9.2019.
- H-** That the amendment in service rules will also pave way for awarding charge of the DDO post to incapable Filed assistants in own pay and scale. That a simple bachelor degree holder will hold the post of Director/ District Officer Soil & water Conservation (BPS-18) without any relevant field/professional degree.

- I- That the impugned Notification dated 18.9.2019 of the respondent department is violative Section-9 of the Civil Servant Act, 1973 read with Rule-7 of the Appointment, Promotion and Transfer Rules, 1989.
- J- That the petitioner seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore most humbly prayed that the appeal of the appellant may kindly be accepted as prayed for.

Note: For the purpose of promotion, there shall be maintained a joint seniority list of the Daftaris, Naib Qasids, Chowkidars, Field Workers, Grass Cutters, Packers, Shepherds, Ploughmans, Animal Attendants, Cattle Attendants, Irrigation Attendants, Gawalas, Head Gawalas, Sweepers, Malis, Gardeners, Milk Men, Feed Mill Labours, Cook, Attendants and Shed Attendants with reference to the dates of their acquiring the Secondary School Certificate or equivalent qualification: Provided that: (i) if two or more officials have acquired the Secondary School Certificate or equivalent qualification in the same session, the inter se seniority in the lower post shall be maintained for the purpose of determining seniority in the higher post; and (ii) where a senior official does not possess the requisite qualification at the time of filling up a vacancy, the official next junior to him possessing the requisite qualification shall be promoted in preference to the senior official or officials.

With due respect, it is submitted that I am working in Soil & Water Conservation Department since 11-09-2018 (initial recruitment), as a Soil Conservation Assistant (BPS-17), having qualification of B.Sc. Agricultural Engineering from UET Peshawar with Pakistan Engineering Council's (PEC) Reg. No. AGRI/03902.

According to the service rules of Soil & Water Conservation Department (wing of Agriculture Department) notified vide notification No. SOE(AD)II(2)429/2015-16/SC, dated 18th April 2018, PART-I under heading "PROFESSIONAL STAFF", serial No. 03, for promotion to Deputy Directors/District Officers Soil Conservation (BPS-18), the minimum qualification is prescribed in column No. 03 against serial No. 04, which states in Para (ii) that "at least second class Bachelor's Degree in Agricultural Engineering from a recognized University".

The above mentioned rules were amended and notified vide notification No. SOE(AD)II(2)429/2019/SC, dated 18th September 2019, beside other amendments, the mentioned Para (ii) of column No. 03 against serial No. 04, defining minimum qualification for serial No. 03, has been eliminated completely. It means that, the Agricultural Engineers working in this department in BPS-17 are Not Eligible for promotion to BPS-18. Although the same mentioned Para (ii) is present in the approved amendments by the committee, but removed from the notified amendments.

There are several Agricultural Engineers, working as Soil Conservation Assistants/Officers (BPS-17) and playing their vital role in engineering related structural activities of the department. They have been precluded from promotion to the posts of Deputy Directors/District Officers Soil Conservation (BPS-18).

Secondly, in the amended service rules, the promotion quota to the said posts of serial No. 03 (BPS-18) has been decreased from 100% to 75% for Soil Conservation Assistants/Officers BPS-17 (Initial Recruitment) and 25% is allotted to the Filed Assistants of the department having general Bachelor degree. The Deputy Director/District Officer (BPS-18) post is a responsible and technical post for which a professional degree is prerequisite. This allotment has suffered my seniority and my provisional rights of promotion to BPS-18. Moreover, no such rules have been notified in any of the other sister departments.


Therefore, it is requested in your honor; kindly accept my departmental appeal by reviewing and re-notifying the amended service rules to include the stated missing Para (ii) of column No. 03 against serial No. 04, defining minimum qualification for serial No. 03 and resuming 100 % promotion quota of BPS-17 (Initial Recruitment) to the posts of Deputy Director/District Officer (BPS-18).

ON FACTS:**

- 1- That petitioners are the bonafide & Law abiding citizens of Pakistan and hailing from respectable families of their localities. Copies of the CNIC's are attached as annexure **A.**
- 2- That petitioners were appointed as Soil Conservation assistants (BPS-17) vide Notification dated 7.9.2018 through proper recommendations of the Khyber Pakhtunkhwa Public Service Commission, Peshawar. Copies of appointment Notification is attached as annexure **B.**
- 3- That petitioners since from the date of appointment till date are serving the respondent department quite efficiently, whole heartedly and up to the entire satisfaction of their superiors.
- 4- That the respondent Department issued Notification dated 18-04-2018 whereby proper service structure for the employees of the respondent Department has been approved/ notified and according to the said service structure the employees of respondent Department have been categorized in twenty Five (25) different cadres for the purposes of seniority and their prospects of promotions. Copy of Notification is attached as annexure **C.**
- 5- That, in the above mentioned notified service rules/structure the posts of Deputy Directors Soil Conservation, Deputy Director Planning, Deputy Director Soil survey and District Officers Soil Conservation shown at Serial No.3 of the appendix has been given the method of recruitment under Column No.5 which is as under:
"by promotion on the basis of seniority-cum-fitness from amongst the Assistant Directors (planning Supervisory), Soil Conservation assistants, Soil Conservation assistants (Technical), Soil survey Research Officer and Assistant Soil Survey Research Officer having five years service as such with minimum qualification as prescribed in column No.2, against serial No.4 of the said Notification

through joint seniority list". Copy of the Notification is attached as annexure D.

6- That according to the above mentioned service rules employees belonging to the said mentioned cadres were promoted from time to time on the basis of joint seniority lists.

7- That unfortunately vide impugned Notification dated 18.9.2019 the 100% promotion quota reserved for the petitioners has been reduce to 75% and as such the rest of 25% has been allocated to the cadre of Field Assistant which would certainly affect the seniority and promotion of the petitioners and the other cadres to BPS-18 because according to the mentioned rules a Field assistant (BPS-9) with a diploma course of three years after metric will be promoted to BPS-18 and run the DDO office without a specialized degree will not validate the running of post of purely technical in nature and supervising over post Graduates and PhD Degree holders. Copy of the impugned Notification is attached as annexure E.

8- That the amendment in service rules will also pave way for awarding charge of the DDO post to incapable Filed assistants in own pay and scale. That a simple bachelor degree holder will hold the post of Director/ District Officer Soil & water Conservation (BPS-18) without any relevant field/professional degree. Copies of the service structures are attached as annexure F.

9- That feeling aggrieved from the Vires of the impugned notification/service structure dated 18-09-2018 the petitioners filed Departmental Appeal/Representation before the competent authority i.e. respondent No.1 on which no response have so far been received. That so much so after filing the said Departmental appeals the respondent No.5 starts pressurizing the petitioners on one way or on the other. Copies of Departmental Appeal and other related documents are attached as annexure G and H.

10- That, petitioners having no other adequate remedy but to file the instant writ petition on the following grounds amongst the others.

GROUND:

A- That the impugned notification/service Rules issued vide dated 18-09-2019 is Ultra Vires, facts, law, norms of

natural justice and materials on the record hence not tenable and liable to be modified/amended.

- B- That petitioners have not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the constitution of Islamic Republic of Pakistan 1973.
- C- That the treatment meted out to the petitioners is a clear violation of the Fundamental Rights of the petitioners as enshrined in the Constitution of Pakistan 1973.
- D- That, the petitioners have been discriminated by the respondents on the subject noted above and as such the respondents violated the Principle of Natural Justice.
- E- That the impugned Notification dated 18.9.2019 due to which the promotion quota of the petitioners have been reduced to 75% and as such the rest of 25% has been allocated to the cadre of Field Assistant is not tenable under the law and rules and would certainly affect the seniority and promotion of the petitioners and the other cadres to BPS-18 because according to the mentioned rules a Field assistant (BPS-9) with a diploma course of three years after metric will be promoted to BPS-18 and run the DDO office without a specialized degree will not validate the running of post of purely technical in nature and supervising over post Graduates and PhD Degree holders.
- F- That according to Article-38 (e) of the Constitution of Pakistan 1973 state is bound to reduce disparity in the income and earnings of individuals including persons in the services of the Federation. That in light of the mentioned Article the petitioners are on strong footing.
- G- That the respondents acted in arbitrary and malafide manner while issuing the impugned Notification dated 18.9.2019.
- H- That the amendment in service rules will also pave way for awarding charge of the DDO post to incapable Filed assistants in own pay and scale. That a simple bachelor degree holder will hold the post of Director/ District Officer Soil & water Conservation (BPS-18) without any relevant field/professional degree.

- I- That the impugned Notification dated 18.9.2019 of the respondent department violated Section-9 of the Civil Servant Act, 1973 read with Rule-7 of the Appointment, Promotion And Transfer Rules, 1989.
- J- That the petitioner seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that on acceptance of this writ petition the impugned Notification dated 18.9.2019 may kindly be declared as Ultra Vires, illegal, unconstitutional and ineffective upon the rights of the petitioners. That the respondents may kindly be directed to restored the 100% promotion quota of the petitioners to the posts of Deputy Directors Soil Conservation, Deputy Director Planning, Deputy Director Soil survey and District Officers Soil Conservation (BPS-18) **OR** the respondents may kindly be restrained not to act upon on the impugned Notification dated 18.9.2019 till the disposal of the Departmental appeals of the petitioners or till the expiry of ninety days period on the Departmental appeals of the petitioners.

Any other remedy which this august Court deems fit that may also be awarded in favor of the petitioner.

INTERIM RELIEF:

That the respondents may kindly be restrained not to act upon on the impugned Notification dated 18.9.2019 till the disposal of the Departmental appeals of the petitioners or till the expiry of ninety days period on the Departmental appeals of the petitioners.



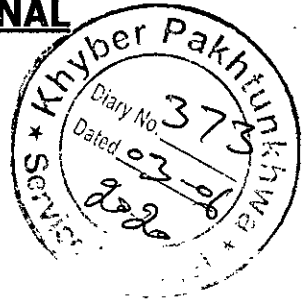

Preliminary Objections:

1. That the appellant has got no cause of action to file the instant appeal.
2. That the appellant has not come to this Honorable Tribunal with clean hands.
3. That the appellant has concealed the material facts from this Hon'ble Tribunal.
4. That the appellant has no cause to challenge the rules.

RESPECTFULLY SHEWETH:

FACT

1. Correct
2. Correct
3. No comments
4. Correct but on the basis of the same notification dated 18/04/2018 at serial No.4 column No;4 recruitment of Assistant Director Planning (Supervisor) Soil Conservation Assistant and Soil Conservation (Technical),(a) 25 % quota has been fixed on the basis of seniority cum fitness from amongst Field Supervisor having 5 years as such or 25 years total service as Field Assistant & above (b) 75% by initial recruitment.

- 5. Correct.
- 6. Incorrect. From time to time, amendments in the service rules are made by Government. As the said Notification dated 18.09.2019 regarding revised service rules has been passed by the government in consultation with the Establishment, Law & Finance Department in the best interest of public service and for better opportunities to the employees. From the Notification dated 18.09.2019, no one has been affected from their promotion. As the appellants have less than 2 years service, as per seniority list, at this stage, they are not entitled for promotion to the post of Deputy Director, Soil Conservation, Deputy Director (Monitoring), Deputy Director, Soil Survey, District Officers Soil Conservation. In the said Notification, 75% quota have been reserved for the cadre of the appellants. They will avail benefit of promotion according to seniority-cum-fitness, having at least Second Class Master's Degree in Agriculture (Soil Services) or at least Second Class Bachelor's Degree (Hons) in Agriculture with (Soil Science) from a recognized University with five years as such.
- 7. Incorrect. It is the responsibility of the state to provide enabling environment to all its cadres' employees which include ensuring of better promotion opportunities across the board. According to Notification No.SOE (AD)II (2) 429/2019/SC, Deputy Director, Soil Conservation , Deputy Directors (Planning). Deputy Director (Monitoring) Deputy Directors Soil Survey, District Officers Soil Conservation.
 - (a) Seventy five percent by promotion on the basis of seniority -cum fitness, form amongst the Soil Conservation Assistant Soil Conservation Assistant (Technical). Soil Conservation Officers Soil Survey Research Officers and Assistant Soil Survey Research officers having at least Second class Master's Degree in Agriculture (Soil Sciences) or at least Second Class Bachelor's Degree (Hons) in Agriculture with (Soil Sciences) from a recognized University with five years' service as such and.
 - (b) Twenty- five percent by promotion on the basis of seniority- cum fitness form amongst the Soil Conservation Assistant having at least Second class Bachelor's Degree from a recognized University with twenty five years total service as Field Assistant and above.

Note: For the purpose of promotion a joint seniority list of the Soil Conservation Assistant Soil Conservation Assistant (Technical). Soil Conservation Officers and Assistant Soil Survey Research Officers and Assistant Soil Survey Research Officers, shall be maintained and.

This is not the first case but such cases had already been existing in various department of the Government of Khyber Pakhtunkhwa like Health, Police and Civil Secretariat. In Health department Technologist & PHC Technologist can be promoted to senior Technologist (BPS-18) and on 50% share by promotion on the basis of seniority cum fitness among the technologist & PHC Technologist with 5 years' service as such the relevant technology with at least BS honor/ BS (04 years) in relevant Technology . Nurse & ASI can got promotion to BS 20 & BS 18 in health & Police department respectively.(Copy attached annexure "A") Similarly there are evidences of the recruiters appointed as Personal Assistant, Private Secretary & senior private secretary who are enjoying the Additional private Secretaries (BPS-19) (Copy attached Annexure "B") in the important administrative departments of the civil Secretariat of Khyber Pakhtunkhwa.

The Field Assistant, Soil Conservation Inspector , Field Supervisor promoted to Soil Conservation Assistant (BPS-17) with at least Bachelor Degree from university also supplemented by at least 20 years technical field experience in soil conservation are quite capable/ office and to run independent office of soil conservation at district level.

During the 3 years diploma course the field Assistant are thought the basic course soil science, water Management Agriculture Engineering, Plant protection, Agriculture Extension, Food Technology , Horticulture and Livestock etc.

The incumbents (Field Assistant, Soil Conservation Inspector, Field Supervisor) and Soil Conservation Assistant can't directly got promoted to the post of Deputy Director Soil Conservation, Deputy Director Planning, Deputy Director Monitoring, Deputy Director Soil Survey and District Officer Soil Conservation BPS-18 but for the post of Soil Conservation Assistant (BPS-17) and then promoted to the post of Deputy Director Soil Conservation, Deputy Director Planning, Deputy Monitoring, Deputy Soil Survey and District Conservation Assistant BPS-18.

The Field Assistant, Field Supervisor check technical feasibilities prepare Engineering estimates, supervise the construction works on site in addition to maintain working relations with all stake holder .

8. Incorrect. The departmental appeal of the appellants was considered by the department. In the said Notification, 75% promotion quotas have been reserved for promotion to the appellant. The respondent No.5 has never pressurized the Petitioners but always thought for their better future carrier planning which is evident from the nominations of the petitioners for various technical courses at regional / national levels. (copies of nominates attached- Annexure- C)
9. Incorrect. The appellant has not aggrieved from the inaction of the respondent department, they will be treated according to rules and regulation.
10. No comments.

GROUND:

- A) Incorrect. The said Notification is in accordance with law & Rues, which has been issued in Consultation with Establishment & Finance Departments.
- B) Incorrect. The appellant has been treated according to Law and rules and will be treated as per government policy.
- C) Incorrect. No violation has been made by the respondent department to the appellants.
- D) Incorrect. No discrimination has been done by the respondent department.
- E) Incorrect. The Notification dated 18.09.2019 has been issued in accordance with law and rules.
- F) First portion of the Para is legal, however last sentence is completely incorrect and the appellant has no strong footing.

- G) As mentioned in Para-E above.
- H) Incorrect hence denied. According to the Notification dated 18.09.2019, seventy five percent promotion quota have been reserved amongst the Soil Conservation Assistants, Soil Conservation Assistants (Technical), Soil Conservation Officers, Soil Survey Research Officers and Assistant Soil Survey Research Officers having at-least second class Master's Degree in Agriculture (Soil Sciences) or at least Second Class Bachelor's Degree (Hons) in Agriculture with (Soil Sciences) from a recognized University with five years' service as such and twenty five percents quota have been reserved for promotion amongst the Soil Conservation Assistants having at least Second class Bachelor's Degree from a recognized University with twenty five years total service as Field Assistant and above.
- I) Incorrect there is no violation of Section-9 of Civil Servant Act-1973 read with rules of the appointment, promotion & Transfer Rules,1989.
- J) Legal.

It is, therefore, prayed that the appeal of the appellants is devoid any legal footings, may kindly be dismissed with costs.



NOTIFICATION

Peshawar dated the 6th December 2012.

No SOE-IV(E&AD)/1-35/2012:- In exercise of the powers conferred by section 26 of the Khyber Pakhtunkhwa Civil Servants Act, 1973 (Khyber Pakhtunkhwa Act No. XVIII of 1973), Government of the Khyber Pakhtunkhwa is pleased to make the following rules, namely:

PART-I

GENERAL

1. Short title, application and commencement.---(1) These rules may be called the Khyber Pakhtunkhwa Civil Secretariat (Private Secretaries) Service Rules, 2012.

(2) These rules shall apply to the recruitment and promotion of Stenographers, Senior Scale Stenographers, Personal Assistants, Private Secretaries and Senior Private Secretaries in the Secretariat, subject to the provisions of rule 5 of these rules.

(3) These shall come into force at once.

2. Definitions.---(1) In these rules, unless the context otherwise requires, the following expression shall have the meaning hereby respectively assigned to them that is to say:

(a) "*existing Personal Assistants*" mean Personal Assistants, who were serving as such on regular basis in Secretariat on the date of commencement of these rules;

(b) "*existing Private Secretaries*" mean Private Secretaries, who were serving as such in BPS-16 on regular basis in the Secretariat on the date of commencement of these rules;

- (c) "Schedule" means Schedule attached to these rules;
- (d) "Secretariat" means Civil Secretariat as defined in clause (r) of rule (2) of the Khyber Pakhtunkhwa Rules of Business, 1985; and
- (e) "service" means the Secretariat (Private Secretaries) service.

(2) Words and expressions used but not defined in these rules shall have the same meanings as are assigned to them in the Khyber Pakhtunkhwa Civil Servants Act, 1973 (Khyber Pakhtunkhwa Act XVIII of 1973), and Khyber Pakhtunkhwa (Appointment, Promotion and Transfer) Rules, 1989, or any other rules of Government for the time being in force.

PART-II
RECRUITMENT

3. **Composition of service.**---The service shall comprise of the posts specified in the Schedule and such other posts as may be determined by Government from time to time.

4. **Method of appointment.**---Method of appointment, qualifications and other conditions applicable to a post in the service shall be such as laid down in column 3 to 5 of the Schedule.

5. **Option as one time exercise.**---(1) The existing Private Secretaries (BS-16) shall, within a period of sixty (60) days of the notification of these rules, exercise their option to join Provincial Management Service, failing which they shall be deemed to have opted for the service. Those Private Secretaries who opt for Provincial Management Service shall remain in BPS-16. However, their promotion to Provincial Management Service shall be governed according to the Provincial Management Service rules. The option once exercised shall be final.

(2) The existing Personal Assistants shall, within sixty (60) days of the notification of these rules, exercise their option to join Provincial Management Service.

which they shall be deemed to have opted for the service. The option once exercised shall be final.

(3) A joint seniority of such existing Private Secretaries and Personal Assistants who opt for Provincial Management Service shall be maintained and the Private Secretaries shall rank senior to the Personal Assistants:

Provided that their inter se seniority shall remain intact.

(4) The Personal Assistants, on their promotion, from Senior Scale Stenographer, within sixty (60) days, shall exercise option to join Provincial Management Service and those who do not exercise such option shall remain in the service. The option once exercised shall be final.

(5) The seniority of the Personal Assistants who opt for Provincial Management Service shall separately be maintained for the purpose of their promotion as Provincial Management Service officer according to their ratio specified for the said Service in the Provincial Management Service rules.

6. Application of general rules.---In all matters not expressly provided for in these rules, the terms and conditions of service of persons in the Khyber Pakhtunkhwa Civil Secretariat (Private Secretaries) service shall be such as have been provided in the Khyber Pakhtunkhwa Civil Servants Act, 1973 (Khyber Pakhtunkhwa Act No. XVIII of 1973), and Khyber Pakhtunkhwa (Appointment, Promotion and Transfer) Rules, 1989 or rules, as may be prescribed by Government from time to time.
