PRELIMINARY OBJECTIONS

1. The Appellant has got no locus standai and cause of action to file the instant petition.

- 2. That the Appeal is barred by law and limitation.
- 3. That the Appellant has concealed the material facts from Honorable Service Tribunal.
- 4. That this Honorable Tribunal has got no jurisdiction to entertain the present appeal.

FACTS:

- 1. Correct to the extent that the Appellant was serving as Subedar Major, Levies Force Hangu
- 2. Correct to the extent that PATA Levies Force Regulation 2012 was issued to the Provincially Administered Tribal Areas and was implemented on Federal Levies Force stationed at Settled Districts of Khyber Pakhtunkhwa in the light of Home & tribal Affairs Department, Khyber Pakhtunkhwa letter No. F. SO(Levies)/HD/F.SD/1-2/2013/62609 Dated:19-11-2015 and SAFRON Division, Islamabad letter No.F.10(5)-LK/2006 Dated:11-11-2015. (copy attached as Annex A & B)
- 3. Correct. As explained in para-02.
- 4. Correct. But the said rules were implemented on Provincial Levies only while the Levies in District Hangu was Federally administered and has been absorbed into Province with effect from 18-03-2019 (copy attached as Annex-C)
- 5. Correct. But the said rules were implemented on Provincial Levies while the Levies in District Hangu was Federally administered.
- 6. Correct. The said rules have no explanation/details regarding service length/age of Subedar Major in Schedule-IV and was implemented only on Provincial Levies while the Levies in District Hangu was governed under Federal Levies Force Rules 2012 Amended 2013.
- 7. Correct. But District Hangu is a settled area since its inception and erstwhile FATA rules / acts are not applicable on District Hangu. The Federal Levies Force Hangu was absorbed into Province vide Section Officer (LK&B) SAFRON Division Islamabad letter No. F.8 (1)-LK/2019 dated: 18-03-2019 (copy attached as Annex-D).
- 8. Correct. But the said rules were implemented on erstwhile Federally Administered Tribal Area Levies, while the Levies in District Hangu was neither Federally Administered Tribal Area Levies nor Provincially Administered Tribal Area.
- 9. Correct. But the Khyber Pakhtunkhwa Levies Force Act, 2019 was not implemented on District Hangu Levies but on erstwhile Federally Administered Tribal Area and Provincially Administered Tribal Area (names of Districts mentioned in the Notification) (copy attached as Annex-E).
- 10. Correct. But the same Notification dated: 14-07-2020 was cancelled/repealed as it was hurting a huge number of Levies Force Personnel.
- 11. The Notification No. SO (Police-II) HD/1-3/ dated: 14-07-2020 was repealed because an enormous number of Levies Personnel were aggrieved as they, then, had a less chance of promotion existence above Notification. In order to provide opportunities (promotion etc.) to Levies Personnel another No. SO (Police-II)HD/MKD/Levies/Misc./2020 dated: 22-03-2021 (copy attached as Annex-F), was issued wherein Basic Pay Scales of Levies Force Personnel were not upgraded due to



financial impulse of the Government. However, after non acceptance / unfamiliar among the Levies Force Personnel of Khyber Pakhtunkhwa, the Government issued an additional Notification No. SO (Police-II) HD/1-3/FEDERAL LEVIES 2021 dated: 21-10-2021 (copy attached as Annex-G), wherein the Basic Pay Scales of Levies Force along with age of retirement was extended.

12. As per Notification of dated: 21-10-2021, the appellant had completed length of service i.e. 03 years service as Subedar Major and as in the light of Peshawar High Court Peshawar writ petition No.5092-P/2021 interim relief was granted to the appellant and after dismissal of case, the appellant was retired from service on 01-02-2023(copy attached as Annex-H).

It is pertinent to mention here that after introduction of Amendment in Federal Levies Force Rules 2012 Amended 2013 on dated: 25-08-2016, a large number of Force personnel in the province had been retired and at that time the appellant alongwith others has lodged application with plea that rank service notification issued by Home Department may be kept intact for the benefit of Force personnel for rapid promotion and in lieu of the said Notification the appellant was promoted as Subedar Major. (copy attached as Annex-I).

- 13. Honorable Peshawar High Court Peshawar vide its Judgment dated: 29-11-2022 has adviced that the appellant/petitioner may approach Honorable Service Tribunal, if aggrieved.
- 14. Pertains to record.
- 15. No violation of fundamental rights have been done.
- 16. Incorrect. The petitioner has not submitted any single application regarding the subject matter at any competent forum.
- 17. That the respondents also seek permission to raise further points at the time of arguments.

It is therefore requested that on acceptance of instant Parawise comments, the appeal of the appellant may kindly be dismissed.

I am directed to convey that consequent to the 25th Constitutional Amendment, the Federally Administered Tribal Areas (Erstwhile FATA) and Provincially Administered Tribal Areas (Erstwhile PATA) stand merged in the Province of Khyber Pakhtunkhwa, and therefore, the President Islamic Republic of Pakistan or the Federation cannot make Regulations for erstwhile FATA anymore. All the functions performed by the Erstwhile FATA Secretariat, its Secretaries and Directorates also stand transferred to the concerned Departments of Government of Khyber Pakhtunkhwa.

- 2. The Federal Levies Force, Regulation, 2012 has been repealed through Khyber Pakhtunkhwa Levies Force Transition Ordinance ORD. NO, I of 2019 on 12th March, 2019 whereby the said Force stands provincialized. NO, II of 2019.
- 3. Now therefore, all the administrative, legal and ancillary matters, including service appeals, promotions and litigation in respect of both the forces i.e. Levies Force and Khasadar Force have been transferred to the Government of Khyber Pakhtunkhwa and its relevant forums from 12th March, 2019, the date of the issuance of above said Ordinances.

No. PA/Khyber Pakhtunkhwa/Bills-68/2019/7010.— The Khyber Pakhtunkhwa Levies Force Bill. 2019 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 12th September. 2019 and assented to by the Governor of the Khyber Pakhtunkhwa on 12th September, 2019 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

THE KHYBER PAKHTUNKHWA LEVIES FORCE ACT, 2019. (KHYBER PAKHTUNKHWA ACT NO. XXXV OF 2019)

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa, (Extraordinary), dated the 16th September, 2019).

AN ACT

to provide for the maintenance of Khyber Pakhtunkhwa Levies Force and to enable its transition to Khyber Pakhtunkhwa Police,

WHEREAS after Constitution (Twenty-fifth Amendment) Act. 2018 (Act No.XXXVII of 2018), the erstwhile Federally Administered Tribal Areas have been merged in the Province of the Khyber Pakhtunkhwa, and Federal Levies Force, established under the Federal Levies Force Regulation, 2012, working in the said areas, has lost its legal status for working in the merged districts and sub-divisions.

its nunctions in the merged districts and sub-divisions and to regulate and maintain it under the administrative control of the Government of Khyber Pakhtunkhwa:

AND WHEREAS to achieve the objectives it is expedient to give legal status to the Federal Levies Force in the inerged districts and sub-divisions and to re-visit its institutional structure and functional assignment for effective discipline, better performance and optimal utility:

It is hereby enacted as follows:

- 4. Short title, application, extent and commencement,—(1) This Act may be called the Khyber Pakistunkhwa Levies Force Act, 2019.
 - (2) It shaft apply to all the members of Levies Force.
- (3) It shall extend to the districts and sub-divisions of the Province of Khyber Pakhumkinya as provided in the Schedule.
 - (4) It shall come into force at once.

Definitions.---In this Act, unless there is anything repugnant in the subject or context,

- (a) "Code" means the Code of Criminal Procedure, 1898 (Act of V of 1898);
- (b) "Commandant" means the Commandant of the Levies Force:
- (c) "Department" means the Home and Tribal Affairs Department of the Government of Khyber Pakhtunkhwa:
- (d) "Deputy Director General" means the Deputy Director General of the Levies Force:
- (c) "Director General" means the Director General of the Levies Force:
- (f) "Government" means the Government of the Kliyber Pakhtimkhwa;
- (g) "Levies Force" means the Federal Levies Force, established under the repealed regulation and re-constituted, regulated and maintained under this Act:
- (h) "Police" means the Kliyber Pakhtunkhwa Police;
- (i) "prescribed" means prescribed by rules.
- "Provincial Police Officer" means the Provincial Police Officer of Khyber Pakhtunkhwa Police:
- (k) "public agency" means any department of Government, attached department, public authority, commission or autonomous body, scrup under any statutory instrument, or public sector company or body corporate, owned, controlled or linanced by Government;

- (m) "rules" mean rules made under this Act; and
- (n) "Schedule" means the Schedule appended to this Act.
- 3. Reconstitution and maintenance of Levies Force.—(1) On commencement of this Act, the Levies Force shall be re-constituted and maintained by Government in accordance with the provisions of this Act and shall be known as the Khyber Pakhtunkhwa Levies Force, consisting of-
 - (a) the Director General:
 - (b) the Deputy Director General;
 - (c) the Commandant; and
 - (d) all existing strength of members of the Levies Force working in the merged districts and sub-divisions, as specified in the Schedule.
- (2) The Director General, Deputy Director General and the Commandant shall be the officers of the Police.
- (3) The District Police Officer shall be assigned the additional charge of the Commandant in the same district.
 - (4) The Regional Police Officer shall be assigned the additional charge of the Deputy Director General in their Police Region.
 - (5) The Deputy Director General, who shall be appointed by Government, in consultation with the Provincial Police Officer, in such manner and on such terms and conditions as may be prescribed.

Explanation: For the purpose of this section, Regional Police Officer and District Police Officer shall have the same meanings as are given to them, respectively, in the Khyber Pakhtunkhwa Police Act. 2017 (Khyber Pakhtunkhwa Act No. II of 2017).

- 4. Superintendence, administration and control of the Levies Force,---(1) The overall power of superintendence of the Levies Force shall yest in Government.
- (2) The general administration and operational control of the Levies Force shall vest with the Director General to be exercised by him either directly or through the Commandant in the district.
- 5. Powers and duties of the Levies Force,---(1) Notwithstanding anything contained, in any other law for the time being in-force, the Levies Force shall have the parallel policing powers as are assigned to the Police under the Code.
- without prejudice to the generality of the forgoing policing powers under subsection (1), the Levies Force shall perform such institutional or organizational functions and duties as provided under the Khyber Pakhtunkhwa Police Act. 2017 (Khyber Pakhtunkhwa Act No.II of 2017).
 - 6. Liabilities of officers and members of the Levies Force.--(1) It shall be the duty of every member of the Levies Force to obey and execute all lawful orders and instructions, issued to him by the Compandant or one other 1975 and 1975

- (2) The Levies Force shall be an essential service and every member thereof shall be liable to serve whenever he is required to serve by the Director General.
- 7. Constitution of Selection and Promotion Committees,---Government shall notify the Selection and Promotion Committees for recruitment and promotion of employees of the Levies Force.
- 8. Postings, transfers and distribution of the Levies Force.--(1) The Commandant shall be competent to post and transfer members of the Levies Force within the district.
- (2) The Director General shall be competent to post and transfer members of the Levies Force from one district to another.
- (3) Subject to the decision of the Department, a sufficient number of members of the Levies Force shall be placed at the disposal of the District Administration in performing its legally mandated functions.
- 9. Absorption.---(1) Notwithstanding anything, contained in any other law for the time being in force, the members of the Levies Force may be absorbed in the Police, subject to the procedure as may be determined by Government.
- (2) Until their absorption in the Police, the members of the Levies Force shall be governed by their existing terms and conditions of service under the Federal Levies Force (Amended) Service Rules, 2013.
- 10. Assistance and support to Government functionaries.—On the requisition of the District Administration, the Commandant shall provide assistance and support to the District Administration and Heads of all public agencies in the District, required for performing their official duties.
- 11. Power to make rules.---Government may make rules for carrying out the purposes of this Act.
- 12. Act to override other laws,---The provisions of this Act shall be in force notwithstanding anything repugnant or contrary contained in any other law for the time being in force.
- 13. Indemnity.---Except as otherwise expressly provided in this Act, no suit, prosecution or other legal proceedings shall lie against any member of the Levies Force, Government or any other authority for anything which is done in good faith or intended to be done under this Act or the rules.

Explanation: The phrase "good faith" shall have the same meaning as given to it in section 52 of the Pakistan Penal Code, 1860 (Act No.XLV of 1860).

- 14. Removal of difficulties.—If any difficulty arises in giving effect to any of the provisions of Act, the Departmentmay notify a committee to take a decision not inconsistent with the provisions of this Act, as may appear to it to be necessary for the purpose of removing the difficulty.
- 15. Repeal and savings.--(1) The Federal Levies Force Regulation. 2012and the Khyber Pakhtunkhwa Levies Force Ordinance. 2019 (Khyber Pakhtunkhwa Ordinance No.iiI of 2019) are hereby repealed.

- (2) Notwithstanding the repeal of the Federal Levies Force Regulation, 2012, under subsection (1), the Federal Levies Force (Amended) Service Rules, 2013 shall continue to remain in force and the terms and conditions of service of all the members of the Levies Force shall be governed thereunder until new rules are made under this Act.
- (3) Anything done, action taken, rule made or notification or orders issued under the Khyber Pakhtunkhwa Levies Force Ordinance, 2019 (Khyber Pakhtunkhwa Ord, No. III of 2019), and the Federal Levies Force Regulation, 2012, shall be deemed valid and the same shall not be called in question in any Court of law.


