#### JOINT PARAWISE COMMENTS ON BEHALF OF RESPONDENT NO. 1 TO 4

## Respectfully Sheweth:- that the respondents submits as under.

- That the Appellant has got no cause of action and locus standi, hence the titled
   Appeal is not maintainable on this sole legal ground.
- That the Appellant did not approach this Hon'able Tribunal with clean hands and suppressed material facts and had tried to twist the factual as well as legal position of the case.
- 3. That the Appeal is barred by law.
- 4. That the Appeal of the appellant is pre-mature.

#### **FACTS:-**

1. Correct upto some extent. That initially the appellant was appointed as Dental Surgeon (BS-17) during the year dated. 26.12.1995. and presently working as Principal Dental Surgeon (BS-19) at Type-C-Hospital Takht-e-Nasrati along-with the charge of Incharge/medical Superintendent/DDO at Type-C-Hospital Takht-e-Nasrati District Karak (under transfer).

- 2. Correct upto some extent. That actually in light of the complaint regarding Ghost Doctors in District Karak an inquiry committee was conducted by the DGHS KPK(Respondent No-3) consisting of Dr. Hidayat Ullah Deputy Director (Dev/Coord-I) office of the DGHS KPK & Dr. Muhammad Saleem Medical Superintendent (BS-19) DHQ Hospital Karak & in light of the Inquiry recommendations the appellant was transferred by the competent authority i.e (Respondent No-2) vide Notification No. SOH (E-V)/2-2/2022 dated 06.10.2022 (Inquiry report attached).
- 3. Pertains to record. Moreover Govt: servants are bound to comply with the orders issued by the Govt;/competent authority & then submit departmental appeal while in the instant appeal the appellant has not complied the orders of the competent authority and has not yet submitted his departure report on account of his transfer.
- 4. Incorrect. However para-2 of the facts is self-explanatory.

### **GROUNDS:-**

- A. Incorrect. As stated in Para-2 that, in light of the recommendations of the inquiry committee the appellant has been transferred & as stated in Para-3 of the facts that, Govt: servants are bound to comply the orders issued by the Govt:/competent authority & then submit departmental appeal while the appellant has not complied the orders of the competent authority and has not yet submitted has departure report on account of his transfer.
- B. Pertains to record.
- C. Incorrect. That initially the appellant was assigned the duty of t I/C of Type-C-Hospital Takht-e-Nasrati District Karak during the year dated 26.02.2020 & has exercised the power of DDO since 25<sup>th</sup> October, 2021 vide Govt: of Khyber Pakhtunkhwa Health Department Notification No. SOH –II/HD/1-4/DDO Powers dated Peshawar the 25<sup>th</sup> October, 2021 & District health officer Karak endst: No. 5199-204/Admn dated 16/11/2021.

D. Incorrect. However inquiry report is the base of the transfer of the appellant.

E. Incorrect. As stated in Para-3 of the Facts that, Govt: Servant is bound to comply

the orders issued by the Govt"/competent. So the appellant has been treated by

the order of the Govt: as the inquiry was conducted by the Govt: not by the

private person.

F. Incorrect. That the inquiry report is self-explanatory, proper written statement of

the appellant have been recorded by the inquiry committee as evident from the

inquiry report.(Attach statement of Appellant).

G. Incorrect. Para-2 of the facts is self-explanatory.

H. That the respondents may be allowed to raise additional grounds at the time of

arguments.

**PRAYER:-**

In light of the above submission, it is humbly prayed that as stated in para-

2 & Para-3 of the facts that, the transfer order of the appellant has been issued by the

competent authority in light of the recommendations of the inquiry committee & the

appellant has not complied the orders of his superior Officers/competent authority and

has not yet submitted his departure report on account of his transfer, so the appeal of

the appellant is devoid of the merits and has no legal value, therefore may graciously be

dismissed.

GHOST DOCTORS IN KARAK SUPPORTING BY ACTING DHO 1.Dr saad arshad belong KARAK FOR HIS PERSONAL BENEFITS from charsada absent since his arrival report attached to type c hospital Takhti Nasrati as he is giving 50000 per month to dho karak. 2.Dr ijaz anwar SMO attached to type c hospital Takhti Nasrati absent since his posting. 3.Dr baseer MO surgery attached to type c Takhti Nasrati absent. 4.Dr inam on general duty at Takhti Nasrati absent as he giving 30000 per month. 5.dr kiramat wazir came for 1 day attached to type c Takhti Nasrati then remained absent. 6.dr noreen shabana gynaecologist only came on Saturday and monday then remained absent and gynae ward is closed as she pays money to incharge and dho karak. 7. Nadia nurse absent since 8 months as she pays 15000 per month. 8. Samina nurse absent since 8 months as she pays 15000 per month. 9.dr Noor Anwar is in Saudi Arabia and he left the duty station without sanction of leave but dho is silent. 10.dr tahir saeed district surgeon absent since long attached to THQ bdshah. 11. Dr sidra baig attached to THQ bdshah absent since long.12.dr umer khyiam is in America attached to bdshah. 13. Dr habil khan attached to bdshah is in Kuwait but he has paid all salaries till june 2021 despite of the fact that his name is also not included in adhoc extension. 14.Dr shahid rehman attached to THQ bdshah only perform sunday duty in month as he paid 30 thousands to incharge and dho karak. 15. Four dental surgeons are working in THQ bdshah but opd less than 10 per week as each dental surgeon perform only 1 day duty per week. 16. Dho karak,incharge THQ bdshah and concerned clerk have purchased various medicines and other items on local purchase basis without MCC lists for their commissions etc.

## INQUIRY REPORT REGARDING GHOST DOCTORS IN KARAK

In compliance to the DGHS Khyher Pakhtunkhwa office order hearing office order No. 14010-13/HRIA dated 10/09/2021, the inquiry report is submitted as under:

## Backaround:-

A complaint received to DGHS Kligher Pakhtunkliwa that there are ghost Doctors in Karak who are being supported by acting DHO Karak for his personal benefits. The following Doctors and other staff were mentioned in the complaint.

- 1. Dr. Saad Arshad (Type-C Hospital Takhti Hasrati) is absent since his arrival and giving 50000 per to DHO Karak.
- 2. Dr. Ijaz Anwar SIAO (Typu-C Hospital Takhti Hasrati) is absent since his posting-
- 3. Dr. Baseer IAO Surgery (Typo-C Hospital Takhti Nasrati) is absent.
- 4. Dr. inam on general duty (Takhti flasrati) absent giving 30000 per month.
- 5. Dr. Kiramat Wazir (Takhti Hasrati) came only for one day and then remained absent.
- 6. Dr. Horeen Shabana Gynaecologist is coming only on Saturday and Monday and then remains absent in rest of the week and gives money to incharge and DHO Karak.
- 7. Hadia Nurse is absent since 8 months as she pays 15000 per month.
- 8. Samina Nurse is absent since 8 months as she pays 15000 per month.
- Or. Noor Anwar is in Saudi Arabia and he has left duty station without sanction of leave but OHO is silent over it.

inquiry of the remaining officers/officials including in the above mentioned complaint who belongs to THQ Hospital Banda Oaud Shah, Karak have already been carried out by another inquiry committee.

The Inquiry committee visited Type-C Hospital Takhti Nasrati and the office of the District Health Officer Karak on 20/09/2021 to record the statements of Incharge Type-C Hospital Takhti Nasrati, DHO Karak and the above mentioned staff.

#### Statement of Dr. Niaz Ali Khan (DHO):

Dr. Niaz Ali Khan (DHO) totally denied the allegations leveled against him in the complaint and submitted a detailed report along with (documented proofs) of actions taken against the officer/officials mantioned in the complaint (Annex-A).

#### Statement of Incharge Type-C Takht-e-Nasrati:

incharge Type-C Hospital Takht-e-Nasrati also denied all the allegations against him and DHO Karak. He stated that all the Doctors and staff of his hospital are regularly performing their duties. About 400 patients are being seen daily in the OPD, 50-80 emergencies being conducted in the casualty and about hundred deliveries per month in labour room (Annex-B).

## Statement of Medical Superintendent, Type-C Hospital Karak.

The MS Type-C Hospital stated in his written statement stated that Dr. Noor Anwar Medical Officer submitted application for 730 days EOL (without Pay) which was regretted by the competent authority and he wrote to DAO Karak for stoppage of pay and informed the MO concerned accordingly through a letter on his home address (Annex-C)

#### Findinas:

- According to DHO Karak; satisfactory performance report of Dr. Sand Medical Officer has been received from Incharge Medical Superintendent Takhte Nasrati and forwarded to DGHS Khyber Pakhtunkhwa for his contract renewal while on the other hand he has stated that according to IMU he was found absent several times due to that explanation was called and salary was deducted accordingly. It needs to be mentioned that during the inquiry committee visit, the said Medical Officer was found absent too.
- According to duty roster of August & September 2021 (Annex-D) only three duties of 8
  hours were assigned to Dr. Seed Medical Officer by MS Takht e Nasrati and according to
  MS he is satisfied from his duties.
- Dr. Ijaz Ahmad SMO was found present during the visit of the committee to the above hospital and he was attending promotion training at DHQ Hospital Karak since 10/09/2020 to 09/12/2020 vide DGHS office order No/ 15474-75/A.E-I dated 08/09/2020 (Annex-E).
- Dr. Baseer Ahmad Medical Officer was found absent during the visit of the inquiry
  Committee and according to duty roster of August 2021, only three duties of 8 hours
  were assigned to him by the MS Takht a Nasrati while he was not assigned any duties in
  the duty roster of September 2021 and according to MS he is satisfied from his duties.
- Dr. Inam was found present during the visit of the inquiry committee and he is regular
  in performing of his duties.
- Or. Kiramat Wazir was found absent from his duties on the day of inquiry committee visit, he was mentioned in general OPD Duty roster in August 2021 while no duty was assigned to him in the month of September 2021 but despite of these facts the DHO and MS stated that he is regular in his duties.
- Dr. Noreen Gynacologist was found present during the visit of the committee but according to the IMU in charge she was found absent several times during IMU Monitoring staff visits. She was marked as tick \( \forall \) by the incharge Type-C Hospital Takhte-Nasrati instead of signature about which she stated that this is her initial (Annex-F).
- Samina Akhtar and Nadia Sultan Charge Nurses; both of them were absent during the
  committee visit to the said hospital and according to DHO Karak, proper action
  regarding long absent has been taken against them.
- Dr. Noor Anwar; according to Medical Superintendent Type-C Hospital Karak, he had applied for 730 days EOL (Without Pay) through online to DGHS Khyber Pakhtunkhwa which was forwarded to Secretary Health Khyber Pakhtunkhwa vide letter No. 9195/E.I dated 23/06/2021, which was regretted by Secretary Health vide letter No. SOH(E-II)/4-1/2021 dated 03/08/2021 but the Doctor concerned has submitted his departure on 15/07/2021 after confirming that his application is forwarded to Secretary Health. MS Type-C Hospital Karak stopped his pay vide letter No. 805 dated 03/08/2021 and also informed the doctor concerned through a copy of the letter on his home address regarding regretting of his leave application and report for duty vide letter No. 941-44 dated 15/09/2021 but the reply of the concerned doctor is still awaited.

## Recommendations:

As per duty roster prepared by the Incharge Type-C Hospital Takht-e-Nasrati, some of the doctors and nurses were found absent on the visit day as well and the duty roster developed according to the convenience of the staff, almost all of the staff are performing two days duties per week, therefore strict disciplinary action may be taken against the doctors/staff and the Incharge due to not following the government

directives regarding no of hours per week. Therefore they may not be given / entitled for Health Professional Allowance and Conveyance allowance for their absent period.

- Incharge Type-C Hospital Takht-e-Nasrati may be transferred immediately on account of poor performance and negligence.
- The DHO Karak (Acting) seems to have closed his eyes on these irregularities & negligence, being responsible for the above mentioned facts may be transferred from the post of DHO.
- Salary of Dr. Noor Anwar may be stopped immediately and disciplinary action may be initiated against him under E&D Rules 2011 and also over payments made to him in salaries may be recovered.
- In case of salary received by Dr. Noor Anwar after July 2021 strict action may be taken against the Medical Superintendent, Type-C Hospital Karak.
