Appellant alongwith counsel present.

The appeal is disposed of with the direction to respondents to include the case of appellant for promotion in the next Departmental Promotion Committee meeting positively as provided in the memo referred to by learned counsel, failing which the appellant may have recourse to legal remedy, if need be.




