Brief facts of the case are that appellant is serving as Senior Subject Specialist in G.G.H.S.S No.2, Mansehra. She submitted E-Transfer application form vide application NO.5523 for transfer to G.G.H.S.S Havailian, Abbottabad. She also applied through proper channel to respondent No.2 for her transfer but instead of transferring the appellant, respondent No.5 was transferred from G.G.H.S.S Ghari Pulgran to G.G.H.S.S Havelian vide impugned transfer order dated 03.09.2020. As per Section-4 of the Khyber Pakhtunkhwa Service Tribunal Act, 1974, any civil servant aggrieved by any final order, whether original or appellate, made by a departmental authority in respect of any of the terms and conditions of his service may, within thirty days of the communication of such order to him, prefer an appeal. In the instant case, there is no impugned order and the appellant has challenged the transfer order of Sadia Afsheen on the strength of her request addressed by one Abdul Kareem Tordher to Zia Ullah Khan Bangash Advisor to Chief Minister. Learned counsel failed to show any order which has made the appellant aggrieved as she has not been transferred.

For what has been discussed above, instant service appeal being incompetent, is hereby dismissed in limine. No order as to costs. File be consigned to the record room.

THE APPELLANT IS ELIGIBLE TO BE POSTED IN G.G.H.S.S HAVELIAN DISTRICT ABBOTTABAD AS PER TENURE POLICY AND AGAINST THE VACANT POST OF HISTORY CUM CIVICS. HENCE, IMPUGNED TRANSFER OF RESPONDENT NO. 5 IS AGAINST WRONG POSTING, DISCRIMINATORY, AGAINST THE LAW AND THE SAID ORDER DATED 03.09.2020 IS LIABLE TO BE SET ASIDE.

PRAYER: ON ACCEPTANCE OF THE INSTANT SERVICE APPEAL, IMPUGNED TRANSFER ORDER DATED 03/09/2020 TO THE EXTENT OF RESPONDENT NO. 5 MAY GRACIOUSLY BE ASIDE SET RESPONDENTS MAY BE DIRECTED TO TRANSFER THE APPELLANT FROM G.G.H.S.S NO. 2 TO G.G.H.S.S HAVELIAN DISTRICT ABBOTTABAD. ANY **OTHER** WHICH RELIEF THIS **HONOURABLE** TRIBUNAL DEEM APPROPRIATE IN THE CIRCUMSTANCES OF THE CASE MAY ALSO BE GRANTED TO THE APPELLANT.

Respectfully Sheweth;-

Following are the facts, giving rise to the instant service appeal.

- 1. That the appellant is serving as Senior Subject Specialist (BPS-18) in the subject of History Cum Civics in G.G.H.S.S No. 2 Mansehra and has completed his period of service tenure required for transfer.
- That the appellant is resident of District Abbottabad and a post of Senior Subject Specialist was lying vacant in G.G.H.S.S Havelian District Abbottabad which is near to the place of her abode. Therefore, the appellant submitted E-transfer application form vide application No. 5523 for transfer from G.G.H.S.S No. 2 Mansehra to G.G.H.S.S Havelian, Abbottabad vide application dated 16/03/2020. Copy of E-transfer application is attached Annexure "A".

- 3. That the appellant also applied through proper channel to respondent No. 2 for her transfer from Mansehra to Havelian. Copies of applications of the appellant are attached as Annexure "B".
- That there is vacant post of History Cum Civics in GGHS Havelian and the appellant being the only candidate of Senior Subject Specialist in History Cum Civics, but respondents' Department instead transferring the appellant, transferred respondent No.5 from GGSS Ghari Phul Gran to GGHSS Havelian vide impugned transfer order dated 03.09.2020. Copy of impugned transfer order dated 03.09.2020 is attached as Annexure "C".
- 5. That the appellant filed departmental appeal against the impugned transfer order to respondent No.1 vide departmental application bearing diary No. 5630 dated 01/10/2020 but of no avail. Copy of

departmental dated appeal 01/10/2020 is attached as Annexure "D". Therefore, the instant service appeal is filed inter alia on the following grounds.

GROUNDS;-

- a. That impugned transfer order is illegal against the law as well as against E-transfer, policy, discriminatory, perverse and the impugned transfer dated 03.09.2020 to the extent of respondent No.5 is liable to be set aside.
- b. That it is a sorrow state of affairs that respondent No.5 has been transferred the against post of History Cum Civics having a degree of Pakistan Study which is in other words is called a wrong posting. Therefore the appellant having degree in history Cum Civics is eligible to be posted in place of respondent No.5.

- c. That the respondents' department has used a sledge hammer to crack the nut which destroyed savory of the nut, when nut cracker is available crack the nut.
- d. That it has now been settled by Apex

 Court, that when law prescribed a

 thing which is to be done in a

 particular manner that must be done
 in that manner and not otherwise. The

 respondents with malafide intentions
 are defeasing the rights of the
 appellant. The posting/ transferred of
 respondent No.5 is wrong posting
 which is not maintainable at law.
- e. That the Honourable Tribunal should not fold up its hands while granting relief to the aggrieved party. Besides, respondent No.5 is blue eyed and particularly an influential employee.

 Therefore, the impugned transferred

order dated 03.09.2020 is particularly motivated and the same is liable to be cancelled.

- That respondents' department has led the appellant to the place which is utterly unknown, to the principle of jurisprudence, natural justice, fair play and good governance. The impugned transfer order to the extent of respondent No.5 is a result of cherry picking and a wrong posting against the post of History Cum Civics which is nullity in the eye of law.
- g. That the mater relates to the terms and conditions of service, therefore, the Honourable Tribunal has jurisdiction to entertain the instant service appeal of the appellant being within the period of limitation.

It is, therefore, humbly prayed that on acceptance of the instant service appeal, impugned transfer order dated 03/09/2020 to the extent of respondent No. 5 may graciously be set aside and respondents may be directed to transfer the appellant from G.G.H.S.S No. 2 to G.G.H.S.S Havelian District Abbottabad. Any other relief which this Honourable Tribunal deem appropriate in the circumstances of the case may also be granted to the appellant.
