Counsel for the appellant present. Preliminary arguments heard.

The appellant has impugned the order of his transfer dated 24.03.2021 from GSSC, Peshawar to GDC Gandaf Swabi. The impugned order include as much as 117 transfers of other individuals. The appellant has taken up a specific ground that except his transfer, almost all of the transferees on cancellation of their transfers made vide impugned order, have been allowed to serve in their previous stations but only the appellant has been victimized and his transfer order has been kept intact. Thus the appellant purports a discriminatory treatment to him and malafide on part of the respondents among other grounds. With this position, there are arguable points in the appeal, making it fit for full hearing. The appeal is, therefore, admitted for full hearing, subject to all just and legal objections. The appellant is directed to deposit security and process fee within 10 days. Thereafter, notices be issued to the respondents for submission of written reply/comments in office within 10 days after receipt of notices, positively. If the written reply/comments are not submitted within the stipulated time, or extension of time is not sought through written application with sufficient cause, the office shall submit the file with a report of non-compliance. File to come up for arguments on 21.09.2021 before the D.B.



**Respectfully Sheweth,**

1. That the Appellant is a naturally born  
bonafide citizen of Islamic Republic of  
Pakistan & hails from a respectable family  
of District Peshawar.

2. That after going through the ordeal-some mandatorily required written examinations and interview, the Appellant got inducted into service as lecturer in Pakistan Studies back in the year 2006. (Copy of Appointment letter is annexed herewith as Annexure "A")
3. That being highly pragmatic and professional and highly devoted towards duties, the appellant had been able to get accelerated promotions to the post of Assistant Professor (BPS-18).
4. That the petitioner had been posted at Government Superior Science College, Peshawar, that out of the blue and without any rim or reason the appellant was ordered to be transferred and posted to GDC Gandaf District Swabi vide impugned office order/ Notification No: S.O(C-11)/HED/2-5/ 2021 TRANSFER/APS DATED: 24/03/2021. (Copy of the impugned office order dated 24/03/2021 is annexed as Annexure "B")
5. That the appellant preferred in appeal which went futile. (Copy of Appeal is annexed as Annexure "C")
6. That feeling highly aggrieved, the appellant hereby moves the instant appeal for setting aside the transfer and posting order dated 24/03/2021 to the extent of appellant, upon the following grounds inter-alia:-

GROUNDS:-

- A. That the impugned transfer and posting order, to the extent of the appellant is wrong, illegal and is liable to be struck down / modified.
  
- B. That except the appellant, the transfer and posting orders of almost all of the candidates, mentioned and transferred/ posted in the impugned transfer and posting order have been cancelled and have been let to serve in their previous stations, but only the appellant is victimized and his transfer order has been kept intact which shows a high degree of discrimination and malafide.
  
- C. That even the summary moved for affecting and ordering the transfer/ posting of different teaching staff had not mentioned the name of the appellant, but when the impugned transfer order was issued in the name of Appellant was figured therein, which shows the malafide of the respondents. Above all when the transfer and posting orders of all those candidates, who had been mentioned in the summary moved, have been cancelled later on while the name of the appellant was left whose name was not even mentioned in summary, where against the department cannot present a plausible explanation.

- D. That the appellant had been Chief Proctor at Government Superior Science College for a long period, who had been able to bring peace and tranquility in the ibid college by banishing all the illegal student unions operating under the umbrella of different political parties and vanishing the Kalashnikov culture and evaporating sense of cravancy and despondency from the college and bringing back teaching and peaceful environment to the college, but as every noble deed has its own evil repercussions, so is the case of the appellant and the opponents of the appellant have been able to prevail over and have been able to bring the name of the appellant in the impugned transfer order.
- E. That this whole drama of transfer and posting was staged to oust the appellant from Peshawar as all other transferred candidates have been reverted back to their previous station except the appellant.
- F. That from every angle the impugned office order/ Notification No S.O(C-11)/HED/2-5/2021 TRANSFER/APS DATED: 24/03/2021 of the office of Secretary to Government of Khyber Pakhtunkhwa, Higher Education Department is wrong, illegal and unlawful and hence liable to be set aside.

G. That the Appellant seeks permission of this Hon'ble Tribunal to advance other relevant grounds at the time of arguments.

It is therefore, most humbly prayed that on acceptance of the instant Service Appeal, the impugned office order / Notification S.O(C-11)/HED/2-5/ 2021 TRANSFER/APS DATED: 24/03/2021 of the office of Secretary to Government of Khyber Pakhtunkhwa, Higher Education may graciously be set aside only to the extent of appellant.

Any other relief not specifically asked for may also graciously be extended in favour of the Appellant in the circumstances of the case.

**Facts: -**


- 1) Pertain to Record.

**Grounds:-**


- A. Incorrect. That the order is in accordance with transfer/posting policy.





E. Para E of the comments/ reply is incorrect, hypocritic and misleading, hence denied.






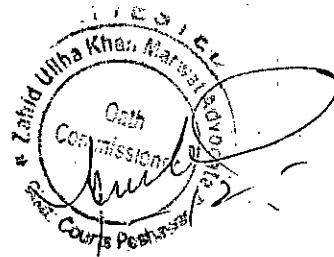
