Service Appeal U/S 4 of The Khyber Pakhtunkhwa Services Tribunal Act, 1974 against the impugned seniority list issued by respondents dated 13.12.2017 & order of departmental authority dated "Nil" whereby he did not pass any order over the departmental appeal of the appellant with in the stipulated period of ninety (90 days).

Prayer in Appeal

By accepting this Appeal, the impugned seniority list of subject specialist (BPS-17) of Elementary & Secondary Education Peshawar, dated 13.12.2017, and the impugned inaction of the appellate authority whereby he did not decide the departmental appeal may please be set aside and consequently the appellant be placed senior to respondent No.4 to respondent No.434.

Respectfully Sheweth:

1. That the appellant was inducted in the Education Department as subject specialist on contract basis in the year 2005 and thereafter his services were extended from time to time. (Copy of the Appointment order is attached as annexure "A").
2. That it was in the year 2009 when The Khyber Pakhtunkhwa Employees (Regularization of Services) Act, 2009 was enacted where under section 3, services of all the employees who were employed on adhoc or on contract basis were regularized and who were holding their post on 31 December 2008 or till the commencement of this Act i.e. 24.10.2009 (when Act was published in the official Gazette). Similarly section 4 of the Act ibid laid down a criteria to determine the seniority of employees who are to be regularized under the Act as well as of those employees who were already serving in the same cadre. (Copy of the Khyber Pakhtunkhwa Employees (Regularization of Services) Act, 2009 is attached as annexure "B").
3. That as per the mandate of the Act, ibid the services of the appellant was regularized w.e.f 24.09.2009 vide notification dated 31.05.2010.

(Copy of the notification is attached as annexure "C").

4. That it is also pertinent to mention here that the NWFP Public Service Commission vide notification dated 15.09.2010 recommended to the Provincial Govt. for appointment of fifty eight (58) subject specialists in Islamiat. Similarly through another notification dated 11.06.2010 thirteen (13) subject specialists in Urdu were recommended to the provincial Govt. Similarly through another notification dated 14.01.2010, thirty five (35) subjects specialists in history-cum-civics were recommended to the Provincial Govt. (Copies of the recommendation letters are attached as annexure "D" & D/1 & D/2 respectively).
5. That similarly on 27.03.2010, respondents issued another notification whereby 242 Male S.E.Ts were promoted to the post of Head Master on regular basis. (Copy of the Notification is attached as annexure "E").
6. That as stated above that section 4 of The K.P Employees (Regularization of Services) Act, 2009 specifically say that employee whose services are regularized shall be ranked junior to all civil servants belonging to the same cadre who are in

services on the regular basis on the commencement of this Act and shall also rank junior to all those who is pursuance of the recommendation(s) of the commission, made before the commencement of this Act, however in clear and sheer violation of the aforesaid provision, respondent No.1 has placed, (vide impugned seniority list dated 13.12.2017 notified on 01.01.2018) respondent No.4 to respondent No.434 senior to the appellant, despite the fact that their recommendations were made much after the commencement of Act ibid. (Copy of the final seniority list is attached as annexure "F").

7. That the appellant submitted departmental representation/appeal to the appellate authority within the statutory period of thirty (30) days, however, he did not decide the same within the prescribed period of (90) ninety days. (Copy of the departmental appeal is attached as annexure "G").
8. That thereafter the appellant approached the Hon'ble Peshawar High Court, Peshawar for the redressal of his greivences as by then this Hon'ble Tribunal was not functional, due to the retirement of its chairman and the Hon'ble Peshawar High Court, Peshawar was pleased to entertain the

same and transmitted the original record of the Case/petition to this Hon'ble Tribunal vide order dated 07.06.2018. (Copy of petition and order dated 07.06.2018 is attached as anenxrue "H").

9. That after transmission of the record of the case the appellant was directed to submit individual service appeal, by this Hon'ble Tribunal vide order dated 26.11.2018.
10. That the appellant now prefers this Service Appeal before this Hon'ble Tribunal for the following amongst other grounds:-

GROUND:-

- A. That as stated in the body of the appeal that the appellant was performing his duty as Subject Specialist since 2005 and continued the same till the crucial date(s) i.e. 31.12.2008 and 24.10.2009, therefore his seniority is to be reckoned from 31.12.2008 whereas respondent No.4 to 434 whose recommendations were made in the year 2010 i.e. much after the commencement of The K.P (Regularization of Service) Act, 2009, therefore, their seniority is to be reckoned from the date when they were recommended to the subject cadre (BPS-17) on regular basis. In this view of the matter, the impugned seniority list is liable to

be corrected as the appellant is senior to respondent No.4 to 434.


- B. That placing respondent No.4 to 434 senior to the appellant is prima facie illegal, unlawful against the clear cut provision(s) of section 4 of The Khyber Pakhtunkhwa Employees (Regularization of Services) Act 2009, therefore, this Hon'ble Tribunal needs to direct the respondents to place the appellant senior to respondent No.4 to 434.
- C. That by now it is an established law that when the law requires something to be done in particular manner then it should be done in that manner. In case in hand, only those recommendees could be made senior to the appellant whose recommendations were made prior to the commencement of the Act i.e. The KP Employees (Regularization of Services) Act 2009 i.e. from 24.10.2009 (date of publication in the official gazette) however as against this crystal clear language of the statute respondents have placed the private respondents senior to the appellant whose recommendation(s) were made much after the commencement of the Act therefore by no stretch of imagination, private respondents could be placed senior to the appellant.
- D. That the impugned final seniority list is prima facie illegal, unlawful and has defeated the cause of


justice and through the same, they have perpetuated illegality and has defeated the purpose of law governing the rights of the parties.

- E. That all public functionaries including respondents are obliged to adhere to the object, spirit and purpose of the law of land in letter and spirit but in the case in hand, they have miserably failed to discharge their statutory obligation (s).


It is, therefore prayed that by accepting this Service Appeal, the impugned seniority list dated 13.12.2017 which was notified on 01.01.2018 may please be corrected, rectified by placing the appellant senior to respondent No.4 to 434 and the inaction of the respondents who did not act as per law may also be held as illegal and unlawful. OR.

Any other relief deemed fit and proper in the circumstance of the case may kindly be granted in favour of the appellant

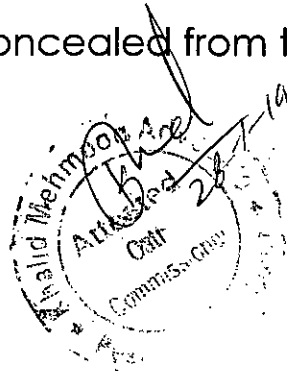

to provide for the regularization of the services of certain employees appointed on adhoc or contract basis.

WHEREAS it is expedient to provide for the regularization of the services of certain employees appointed on adhoc or contract basis, in the public interest, for the purposes hereinafter appearing;

It is hereby enacted as follows:-

1. **Short title and commencement.**---(1) This Act may be called the ⁷[Khyber Pakhtunkhwa] Employees (Regularization of Services) Act, 2009.

(2) It shall come into force at once.

2. **Definitions.**---(1) In this Act, unless the context otherwise requires,-

(a) "Commission" means the ⁸[Khyber Pakhtunkhwa] Public Service Commission;

(aa) "contract appointment" means appointment of a duly qualified person made otherwise than in accordance with the prescribed method of recruitment;

(b) "employee" means an adhoc or a contract employee appointed by Government on adhoc or contract basis or second shift/night shift but does not include the employees for project post or appointed on work charge basis or who are paid out of contingencies;

- (c) "Government" means the Government of the ⁹[Khyber Pakhtunkhwa];
- (d) "Government Department" means any department constituted under rule 3 of the ¹⁰[Khyber Pakhtunkhwa] Government Rules of Business, 1985, and does not include any section of a Department or an organization which is federally funded;
- (e) "law or rule" means the law or rule for the time being in force governing the selection and appointment of civil servants; and
- (f) "post" means a post under Government or in connection with the affairs of Government to be filled in on the recommendation of the Commission.

(2) The expressions "ad hoc or contract appointment" and "civil servant" shall have the same meanings as respectively assigned to them in the ¹¹[Khyber Pakhtunkhwa] Civil Servants Act, 1973 (¹²[Khyber Pakhtunkhwa] Act No. XVIII of 1973).

3. Regularization of services of certain employees.---All employees including recommendees of the High Court appointed on contract or ad hoc basis and holding that post on 31st December, 2008 or till the commencement of this Act shall be deemed to have been validly appointed on regular basis having the same qualification and experience for a regular post:

Provided that the service promotion quota of all service cadres shall not be affected.

4. Determination of seniority.---(1) The employees whose services are regularized under this Act or in the process of attaining service at the commencement of this Act shall rank junior to all civil servants belonging to the same service or cadre, as the case may be, who are in service on regular basis on the commencement of this Act, and shall also rank junior to such other persons, if any, who, in pursuance of the recommendation of the Commission made before the commencement of this Act, are to be appointed to the respective service or cadre, irrespective of their actual date of appointment.

(2) The seniority interse of the employees, whose services are regularized under this Act within the same service or cadre, shall be determined on the basis of their continuous officiation in such service or cadre:

Provided that if the date of continuous officiation in the case of two or more employees is the same, the employee older in age shall rank senior to the younger one.

4A. Overriding effect.---Notwithstanding any thing to the contrary contained in any other law or rule for the time being in force, the provisions of this Act shall have an overriding effect and the provisions of any such law or rule to the extent of inconsistency to this Act shall cease to have effect.

5. Repeal.---The North-West Frontier Province Employees (Regularization of Services) Ordinance, 2009 (N.-W.F.P. Ordinance No. VII of 2009) is hereby repealed.
