

The appellant (PSHT) has filed the present service appeal being aggrieved against the order dated 13.03.2019 to the extent of his transfer to GPS Bala Soor Asharay, and against the order dated 12.04.2019 to the extent of transfer of private respondent to GPS Durshkhela Cham Tehsil Matta District Swat.

Learned counsel for the appellant argued inter-alia that the appellant is senior from private respondent, and having served more than the private respondent at one station, the appellant should have been appointed at GPS Durshkhela Cham Tehsil Matta District Swat instead of private respondent.

Points urged need consideration. The present service appeal is admitted for regular hearing subject to all the legal objections. 

IT IS WORTH MENTIONING HERE THAT THE APPELLANT WAS ACTUALLY PERFORMING HIS DUTY AT GPS CHUM DRUSHKHELA, BUT IN THE SAID ORDER PRESENT PLACE / SCHOOL OF THE APPELLANT IS MENTIONED GPS SPINA KHPA.

PRAYER:

On acceptance of this service appeal;

Firstly, the impugned order issued by Respondents No.1 Dated: 13/03/2019 to the extent of transferring / promoted posting the Appellant at GPS Bala Soor Asharay Tehsil Matta District Swat, and posting / transfer order No. 1852-83 / Promotion/PSHT Dated: 12/04/2019 to the extent of Respondent No.4 wherein Respondent No.4 is posted at GPS Drushkhela Cham Tehsil Matta District Swat may kindly be declared illegal, unlawful and against the policy, and the Respondents be directed to issue promoted posting order of the Appellant on GPS Cham Drushkhela Tehsil Matta District Swat.

Secondly, it is further prayed that in the said order Dated: 13/03/2019 of Respondent No.1 present place/ school of the Petitioner has been wrongly mentioned as Spina Khpa Tehsil Matta District Swat, which is incorrect because the Appellant has been performing his duties at GPS Chum Drushkhela Tehsil Matta District Swat, therefore, to this

extent the amendment / corrigendum in the said order be made.

Finally, any other order(s) (mentioned in the grounds), passed in respect of transferring the appellant may also be declared illegal and unlawful.

Any other relief, deemed fit and necessary in the given circumstances of the case may also be awarded in favor of Appellant against Respondents.

Respectfully Sheweth:

The Appellant submits as under;

1. That the Appellant is bonafide resident of Chinala Bara Drukhela, Tehsil Matta District Swat.
2. That the Appellant was serving on the post of SPST BPS-14 at GPS Chum Drushkhela Tehsil Matta District Swat. (Copies of reports along with copy of service book is attached herewith as annexure "A").
3. That the Appellant along with others have been promoted to PSHT-BPS 15 through order Dated: 12/03/2019 by posting him at GPS Bala Soor Asharay. Moreover, present place/school of the Petitioner has been mentioned as GPS Spina Khpa Matta Circle District Swat in the aforementioned order, however, the Petitioner was actually

performing his duty at GPS Chum Drushkhela Tehsil Matta District Swat. (Copy of the order Dated: 12/03/2019 is attached herewith as annexure "B").

4. That as per policy Dated: 18/01/2013 of Respondent No.2 (Para 4 and 5), the Respondent No.1 is bound to issue promoting posting order of the Appellant on the same school i.e. Chum Drushkhela Tehsil Matta District Swat, whereby the Appellant was already performing his duty to the entire satisfaction of his superiors, but the Respondent No.1 for the reason best known to him, while violating the said policy issued promoting transfer order of the Appellant by transferring him to BPS Bala Soor Asharay. (Copy of PST posting policy is attached herewith as annexure "C").

5. That the Appellant being aggrieved from the order Dated: 12/03/2019, filed an application before the Respondent No. 1 for correction in the said order as mentioned above. Thereafter filed another application before the Respondent No.2 on 18/03/2017 for the same, but in vain. (Copies of applications are attached herewith as annexure "D").

6. That the Respondent No.1 issued another order Dated: 12/04/2019 in respect of Respondent No.4 and others, whereby Respondent No.4 has been transferred from GPS Ochrai to GPS Druskhela Chum Tehsil Matta District Swat (in question). (Copy of order Dated: 12/04/2019 is attached herewith as annexure "E").
7. That the impugned order Dated: 12/03/2019 of Respondent No.1 to the extent of transfer and wrong mentioning of present place of duty of the Appellant is illegal, unlawful and unconstitutional inter alia on the following grounds amongst others.

GROUND:

- i) That the impugned order Dated: 12/03/2019 of Respondent No.1 to the extent of transfer and wrong mentioning of present place of duty of the Appellant is illegal, unlawful and unconstitutional.
- ii) That the impugned order has been passed in violation of PST Posting policy.
- iii) That the Appellant approached the Respondents No. 1&2 time and again in this regard personally, upon which the Appellant was transferred from GPS Bala Soor Asharay

to GPS Malak Patay, and thereafter issued another transferred order from GPS Malak Patay to GMPS Gulabad Drushkhela which was later on cancelled and the Appellant was then re-transferred to GPS Malak Patay.

- iv) That the impugned order has been passed in violation of Article 4, 10(A) and 25 of the Constitution of Islamic Republic of Pakistan, 1973.
 - v) That other grounds not specifically raised will be argued with the permission of this Honorable Tribunal at the time of arguments.
8. That this appeal is being filed against the order Dated: 12/03/2019 of Respondent No.1, hence this Honorable Tribunal has got the jurisdiction and this appeal is well within time.

It is therefore humbly prayed that as under on acceptance of this service appeal;

Firstly, the impugned order issued by Respondents No.1 Dated: 13/03/2019 to the extent of transferring / promoted posting the Appellant at GPS Bala Soor Asharay Tehsil Matta District Swat, and posting / transfer

order No. 1852-83 / Promotion/PSHT Dated: 12/04/2019 to the extent of Respondent No.4 wherein Respondent No.4 is posted at GPS Drushkhela Cham Tehsil Matta District Swat may kindly be declared illegal, unlawful and against the policy, and the Respondents be directed to issue promoted posting order of the Appellant on GPS Cham Drushkhela Tehsil Matta District Swat.
