Preliminary Objections

Respectfully Sheweth:-

- 1. That the appellant has got no cause of action/locus standi to file the instant appeal.
- 2. That the instant Service Appeal is badly time-barred.
- 3. That the appellant has concealed material facts from this Honorable Tribunal.
- **4.** That the instant service appeal is against the relevant provisions of law.
- 5. That the appellant has filed the instant appeal on mala-fide intentions.
- 6. That the appellant has not come to this Honorable Tribunal with clean hands.
- 7. That the instant appeal is liable to be dismissed for mis joinder & non-joinder of the necessary parties to the present appeal.
- 8. That the appellant is estopped by his own conduct to file the instant appeal
- 9. That the instant Service Appeal in not maintainable in its present form.
- 10. That the impugned Notifications/orders dated 20-10-2022 is legally competent.
- 11. That the appellant has been treated as per law, rules & relevant policy by the Department.
- **12.**That no Departmental appeal has been filed by the appellant against the Notification dated 20-10-2022.
- 13. That the competent authority has got jurisdiction to transfer & post a regular Civil Servant U/S-10 of Civil Servants Act 1973.

14.That the post of the appellant is a Provincial Cadre Teaching Cadre in the Department.

ON FACTS.

- 1 That Para-1 pertains to record & subject to proof.
- 2 That Para-2 is also pertains to record & subject to proof.
- 3 That Para-3 is correct that vide Notification dated 19-12-2018 the Respondent No.4 was appointed as SST in BPS-16 on school based policy & was adjusted at GCHS Kohat against the vacant post of SST by the Department upon the rejection of the application of the appellant vide order dated 10-06-2022 by the DEO (M) Kohat on the grounds that there is only one SST Teacher available in shape of the appellant for students at GHS Mandori Kohat , hence, he can be adjusted GCHS Kohat. (Copies of the order dated 27-08-2022 & 20-10-2022 are Annexure-A & B).
- **4** That Para-4 is correct, hence, to the extent of the Notification dated 27-08-2022 of the Respondent Department.
- 5 That Para-5 pertains to the residential record of the appellant.
- 6 That Para-6 is correct that the appeal/application of the appellant for his adjustment at GCHS Kohat against the SST post was rejected by the competent authority vide order dated 20-10-2022 on legal grounds.
- 7 That Para-7 is correct, that vide Notification dated 20-10-2022, the Departmental appeal against the order dated 27-08-2022 has been rejected by the competent authority.
- 8 That Para-8 is also incorrect & misleading. Therefore, the appeal in hand is liable to be dismissed on the following grounds inter alia:-

- **E.** Incorrect & not admitted. The appellant has been treated as per Law, Rules & policy by the Department vide Notification dated 20-10-2022 in the titled case.
- **F.** Incorrect & not admitted. However, the Respondents also seek leave of this Honorable Tribunal to submit additional grounds, record & case law at the time of arguments on the date fixed.

In view of the above made submissions, it is most humbly requested that this Honorable Tribunal may very graciously be pleased to maintain the order dated 20-10-2022 & dismiss the instant Service Appeal in favor of the Respondents in the interest of justice.
