FACTS

- 1) That, appellant was appointed as a "Junior Clerk, at the office of Commissioner Hazara Division Abbottabad, District Abbottabad on 18/05/1992. (Copy of First appointment order dated 18/05/1992 is attached as Annexure "A")
- 2) That, on 07/09/2002 Govt of NWFP dissolved the Commissionaire System due to which the appellant was kept in surplus pool and all the surplus staff was left upon the proposal of then DCO Haripur for further adjustment. (Copy of order dated 07/09/2002 is attached as Annexure "B")
- 3) That, on 20/09/2002, the then DCO Haripur write a letter to then EDO (Now DEO) E&SE (Male) Haripur for further adjustment of the appellant. (Copy of order dated 20/09/2002 is attached as Annexure "C")
- 4) That, on 26/09/2002 EDO (Now DEO) E&SE (Male) Haripur adjusted the appellant at GHS NoorPur District Haripur. (Copy of order dated

26/09/2002 of EDO (Now DEO) E&SE (Male) Haripur is attached as Annexure D")

- 5) That, on 02/04/2007, respondent No.2 transferred the appellant from District Haripur to District Abbottabad at GGHS Sialkot vide letter No.4821-56. **(Copy of letter No.4821-56 dated 02/04/2007 is attached as Annexure "E")**
- 6) That, in the seniority list, prepared for promotion from Junior Clerk to Senior Clerk, by the respondent No.2, the appellant was granted seniority w.e.f. 02/04/2007 and after vide corrigendum order the seniority of the appellant was converted into 26/09/2002. **(Copy of seniority list dated 31/03/2018 is attached as Annexure "F")**
- 7) That, respondents illegally ended over the service of appellant w.e.f. 08/05/1992 to 26/09/2002 and the most junior "Junior Clerks" were promoted to Senior Clerks vide order dated 15/02/2021 who were appointed upto 1998. **(Copy of promotion order dated 15/02/2021 is attached as Annexure "G")**
- 8) That, on 14/03/2021, appellant filed a departmental appeal before the respondent No.1 against the impugned promotion order dated 15/02/2021 issued by respondent No.2 which was not honored. **(Copy of departmental appeal is attached as Annexure "H")**

- 9) That, the appellant assails the impugned promotion notification on the following amongst other grounds:-

GROUND:

- a. That, the seniority of any employee is to be considered from the date of first appointment of the employee according to the Rules, Law and Policy.
- b. That, according to the Judgment of August Supreme Court of Pakistan (2004 PLC (C.S) 1228) any permanent basis appointed employee, could never become underside from his junior in seniority.
- c. That, the impugned Notification/order was issued only at the basis of malafide intention in which law and Rules were not followed.
- d. That, the appellant was thrown into Surplus pool by the Government / respondents and nothing has been done wrong from the part of appellant hence, the appellant is innocence in the matter.
- e. That, respondents differed the appellant from promotion which act of respondents is clear cut violation of Article 25 of the constitution of Islamic Republic of Pakistan.
- f. That, there no such kind of order was issued against the appellant under section-4 of the E&D Rules 2011, by the competent or Hire

authority due to which the promotion of appellant was liable to be stopped.

- g. That, respondents ignored the appellant from promotion which is not in the jurisdiction of respondents thus, respondents exceeded their power and intentionally ignored the appellant from promotion only to mentally torture the appellant.
- h. That, the instant appeal is well within time.
- i. That, the other point shall be raised at the time of argument with the prior permission of Hon'ble Tribunal.

It is therefore, respectfully prayed that the instant appeal may graciously be accepted, and the appellant may kindly be promoted w.e.f. the date at which the most junior, Junior Clerks from the appellant, were promoted to Senior Clerks with all back benefits. Any other relief for which the appellant is entitled and same is not asked/prayed specifically, may kindly be granted in the favour of the Appellant too.

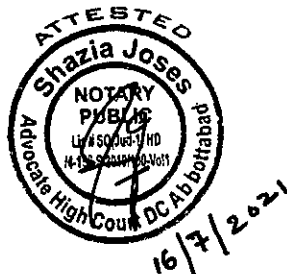



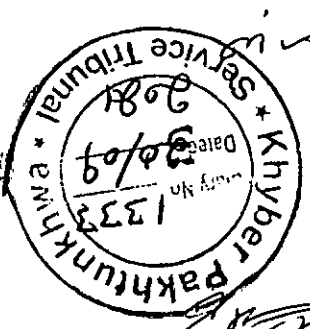
