Counsel for the appellant present. Preliminary arguments heard and record perused.

Learned counsel for the appellant argued that the appellant was initially appointed as PST in the year 1995 and, after marriage in 2004, transferred from Karak to Peshawar in the light of spouse policy of Government of KPK and posted at Sharif Abad in the year 2012 where-after she was transferred to Postal Colony Peshawar Girls Primary School.

Learned counsel for the appellant further argued that the appellant is entitled to promotion at District Peshawar and that for the purpose of promotion she is to be considered serving at Peshawar with effect from the date of her initial appointment at Karak i.e 10.9.1995 as her posting to Peshawar was her entitlement in view of the spouse policy of Provincial Government.

Arguments of learned counsel for the appellant are not found forceful as the posting/transfer policy of the Provincial Government would not entitle a spouse to claim seniority against PSTs serving in district cadre Peshawar. The relevant rule is reproduced for facilitation and ready reference:


Posting/Transfer Policy of the Provincial Government

ix) "Regarding the posting of husband/wife, both in Provincial services, efforts where possible would be made to post such persons at one station subject to the public interest."

Since the afore-stated rule provides for facilitation to the extent of posting of spouse as such the same cannot be made basis for seeking seniority and promotion against the interest of teachers serving in the district cadre of Peshawar more particularly when such a spouse is not absorbed in the said district cadre.

For the above mentioned reasons, the appeal is found devoid of merits. The same is, therefore, dismissed in limine. File be consigned to the record.

PRAYER:

On acceptance of this appeal, the relief may kindly be granted as prayed for in the departmental appeal dated 20.03.2015.

Respectfully Sheweth;

The appellant states as under:-

- 1) That the appellant was appointed as a P.S.T. on 10.09.1995 in District Karak and passed M.A B.Ed Examination. (Annexure "A").
- 2) That the appellant was married in 2004 in that time the appellant was serving in Education Department in the GPS Karak Kurshki Killa Karak upto 11.11.2012. Annexure "B").
- 3) That the husband of the appellant is/ was serving in technical college Kohat Road, Peshawar since long.
- 4) That the appellant was transferred from Karak to Peshawar in the light of spouse policy of Govt. KPK and posted at Sharif Abad on 12.11.2012 and later on transferred to postal colony Peshawar Girls Primary School. (Annexure "C").
- 5) That in meanwhile various notifications were issued and according to the seniority PST (females) teachers were promoted from BPS 12 to BPS 15 and the appellant was not promoted to BPS 15 and the same scale BPS 15 was allowed/ granted junior PST (female) teachers.
- 6) That the appellant filed a W.P.NO.1161/2013 which was disposed off on 05.03.2015. (Annexure "D").
- 7) That the appellant filed a departmental appeal dated 25.03.2013 which was not decided in stipulated period in the light of directions of Hon'ble High Court. (Annexure "E").

- 8) That the appellant filed another W.P.No.2015-P/2015 which was decided on 8.07.2015 with some directions. (Annexure "F").
- 9) That aggrieved with the acts and actions of the respondents the appellant has come to this Tribunal on the following grounds:

GROUND:

- a. That all the acts and actions of the respondents are against law, facts and material on record, hence not tenable in the eyes of law.
- b. That the notification of promotion of P.S.T. (female) teachers have been issued by the respondents dated 26.03.2013 and 28.05.2013 from BPS 12 to BPS-15 and the name of the appellant was ignored but junior to the appellant were promoted in the notification dated 28.05.2013 proper place of the appellant in seniority is S.No.26.
- c. That the respondents have promoted junior to the appellant in the light of notification dated 31.08.2012 ignoring the spouses policy.
- d. That the disputed notification is ultra vires of the constitution 1973 and against the fundamental and vested rights of the appellant granted to her under constitution 1973.
- e. That the acts and actions of the respondents are discriminatory, malafide and malicious one and is against the natural justice.
- f. That due to the discriminatory, malafide notification the respondents are going to snatch the fundamental valid, legal rights of promotion from the appellant.
- g. That the respondents have ignored the fact and law that policy of Govt. of KPK has over riding effect on notification issued by the respondent dated 12.08.2012.

- h. That it is pertinent to mention here that the respondents have not allowed/ granted any lien in District Karak to the appellant in her service record.

Therefore, it is requested that on acceptance of this appeal, the notification dated 31.08.2012 may kindly be struck down declaring the same ultra vires of the constitution 1973 illegal, without jurisdiction, discriminatory, ineffective on the right of promotion of the appellant in due place and time by the respondent whereby junior PST (female) have been promoted, ignoring the appellant.

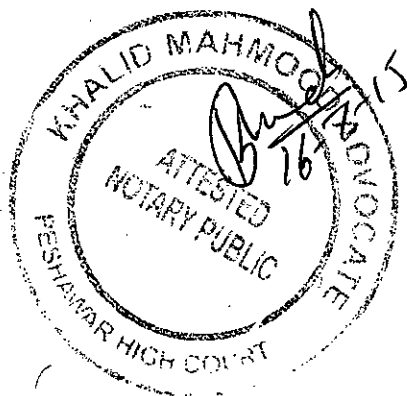

Posting and Transfer

Statutory Provision.

Section 10 of the NWFP Civil Servants Act, 1973.

Posting and Transfer. Every civil servant shall be liable to serve anywhere within or outside the Province, in any post under the Federal Government, or any Provincial Government or Local authority, or a Corporation or body set up or established by any such Government:-

Provided that nothing contained in this section shall apply to a civil servant recruited specifically to serve in a particular area or region;

Provided further that, where a civil servant is required to serve in a post outside a service or cadre, his terms and conditions of service as to his pay shall not be less favourable than those to which he would have been entitled if he had not been so required to serve.

Posting/transfer policy of the Provincial Government.

- i) All the posting/transfers shall be strictly in public interest and shall not be abused/misused to victimize the Government servants
- ii) All Government servants are prohibited to exert political, Administrative or any other pressures upon the posting/transfer authorities for seeking posting/transfers of their choice and against the public interest.
- iii) All contract Government employees appointed against specific posts, can not be posted against any other post.
- iv) Existing tenure of posting/transfer of three (03) years for settled areas and two (2) years for unattractive/hard areas shall be reduced to two (02) years for settled areas, 01½ years for unattractive areas and one year for hard areas.
- v) ⁷⁹[]

- vi) ⁸⁰ While making posting/transfers of officers/officials in BS-17 from settled areas to FATA and vice versa approval of the Chief Secretary, NWFP needs to be obtained. Save Tehsildars/Naib Tehsildars within a division in respect of whom the concerned Commissioner will exercise the same power. Whereas, in case of posting/transfer of officers in BS-18 and above, from settled areas to FATA and vice versa, specific approval of the Governor, NWFP shall be obtained.

Provided that the power to transfer Political Tehsildars and Political Naib Tehsildars within FATA between different divisions shall rest in Additional Chief Secretary FATA.

- vi (a) All Officers/officials selected against Zone-I/FATA quota in the Provincial Services should compulsorily serve in FATA for at least eighteen months in each grade. This should start from senior most scales/grades downwards in each scale/grade of each cadre.
- vii) Officers may be posted on executive/administrative posts in the Districts of their domicile except District Coordination Officers (D.C.Os) and DPOs/Superintendent of Police (SP). Similarly Deputy Superintendent of Police (DSP) shall not be posted at a place where the Police Station (Thaana) of his area/residence is situated.
- viii) No posting/transfers of the officers/officials on detailment basis shall be made.
- ix) Regarding the posting of husband/wife, both in Provincial services, efforts where possible would be made to post such persons at one station subject to the public interest.
- x) All the posting/transferring authorities may facilitate the posting/ transfer of the unmarried female government Servants at the station of the residence of their parents.
- xi) Officers/officials except DCOs and DPOs/SPs who are due to retire within one year may be posted on their option on posts in the Districts of their domicile and be allowed to serve there till the retirement

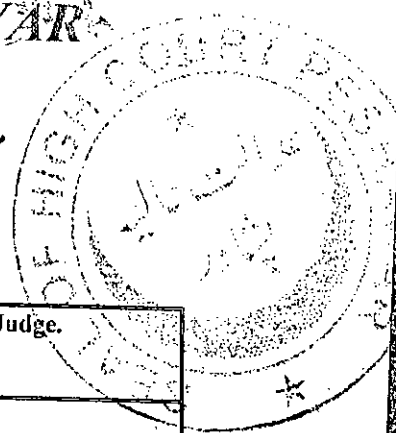

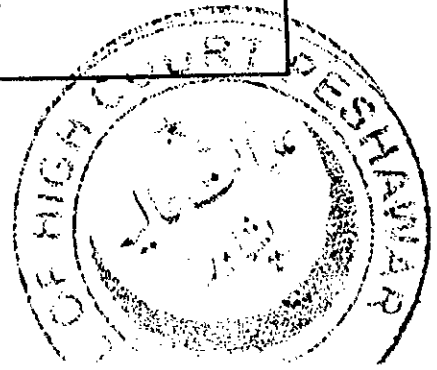

I am directed to refer in your letter No .11005 dated 23-8-2012 on the subject noted above and to inform you as under :-

1. The seniority cannot be considered from the date of appointed as untrained teacher .
The seniority is considered from the date of regular appointment post or from the date of passing the prescribed professional qualification in case of untrained appointment
(Copy of the rules attached)
2. The name of the teacher transferred from one district cadre post to other Distt: cadre post on his own request will be placed at the bottom of the seniority list i.e according to the date of taking over charge after the date of issue of his inter Distt: transfer order .
3. The name of the untrained teacher cannot be enlisted in the seniority list unless he passes the prescribed professional qualification .
4. The seniority of the teacher who was transferred to his own District due to devolution of Divisional Directorate will not e disturbed .
5. The new upgraded posts i.e BPS - 14 , BPS -15 & BPS- 16 will be filled by promotion etc as & when the new Service Rules are notified by the Govt : of Khyber Pakhtunkhwa . The notification for constitution of DPC will be issued soon after the new Service Rules .
6. The ACRs/ PERs are not required in fixation of pay due to up gradation of scales of PST/Qari Teachers (M& F) in BPS 12 as well as up gradation of scale of CT/DM/PET/AT/TA teachers (M&F) in BPS -15. The ACRs will be required for their promotion in next scale against the newly upgraded posts in BPS -14 BPS-15 & BPS-16 .
7. The new service rules / amendment are under process .
8. Before the Service Recruitment Rules 2011 , the teachers having FA & F.Sc (in 3rd division) already appointed according to the prescribed rules at that time, will be considered for seniority , but their promotion against the newly upgraded posts will be considered if allow the new Service Recruitment Rules which is under process

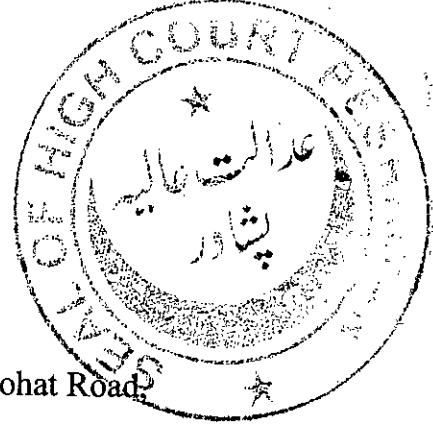

WAQAR AHMAD SETH, J.- Petitioner through the instant writ petition has asked for the issuance of an appropriate writ declaring the Notification dated 31.8.2012 promoting junior to the petitioner, being ultra-vire and is of no legal effect for having been passed without jurisdiction and lawful authority.

2. We have gone through the available record and considered the submissions of the learned counsel for the petitioner.

3. Since the points urged before us being related to the terms and conditions of service can well be urged before the Departmental Authority and then before the Service Tribunal, jurisdiction of this Court in view of the provision contained in article 212 (2) of the Constitution of Islamic Republic of Pakistan, 1973 is barred. In the cases of

Miss Rukhsana Ijaz-Vs- Secretary, Education, Punjab and others (1997 SCMR 167), Ayyaz Anjum-Vs- Government of Punjab, Housing and Physical Planning Department through Secretary and others (1997 SCMR 169), and Rafique Ahmad Chaudhry-Vs- Ahmad Nawaz Malik and others (1997 SCMR 170), it has been

consistently held by the Hon'ble Supreme Court that such grievances being related to the terms and conditions of service would fall within the exclusive domain of the Service Tribunal and that this Court cannot step in to interfere therewith under Article 199 in view of an express bar envisaged by Article 212 (2) of the Constitution.

4. For the reasons discussed above, this writ petition being not maintainable is dismissed in limine.

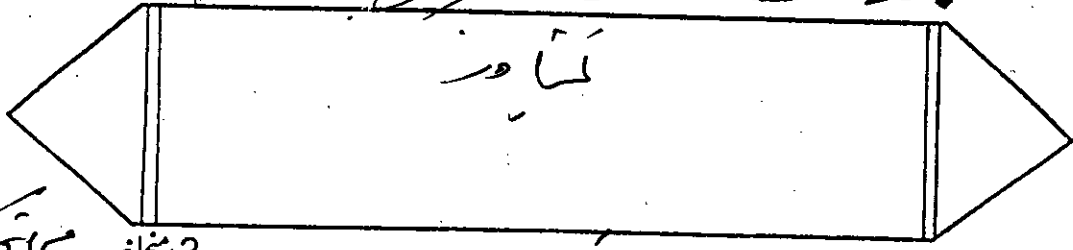
